### **KOTKAPURA FIRING CASE**

### Sukhbir Badal appears before Special Probe Team

CHANDIGARH: Shiromani Akali Dal chief Sukhbir Singh Badal appeared before a special investigation team (SIT) probing the 2015 Kotkapura police firing incident.

Sukhbir Badal reached the Punjab Police Officers Institute at Sector 32 in Chandigarh at around 11 am following a summons by the SIT.

Badal was the Deputy Chief Minister and holding the state Home Ministry portfolio when incidents of desecration of religious texts and the subsequent police firing at people protesting against it had taken place in Faridkot in 2015.

Several senior Shiromani Akali Dal (SAD) leaders, including Bikram Singh Majithia, Balwinder Singh Bhundar, NK Sharma and Daljit Singh Cheema, reached the Punjab Police Officers Institute in a show of support to Sukhbir Badal. On Tuesday, the SIT led by Additional Director General of Police (Vigilance Bureau) LK Yadav had questioned Shiromani Akali Dal patriarch and former Punjab Chief Minister Parkash Singh Badal for two-


and-a-half hours. The Punjab government had formed the new SIT to probe the Kotkapura police firing incident following the directions of the Punjab and Haryana High Court.



The new SIT is investigating the two FIRs registered on October 14, 2015 and August 7, 2018 in connection with the Kotkapura incident.

The high court had on April 9 this year quashed a report by an earlier Punjab Police SIT into the firing at people protesting in Kotkapura in 2015 over the alleged desecration of the Guru Granth Sahib in Faridkot district. Police had also opened fire at a similar demonstration in Behbal Kalan, also in Faridkot, where two people were killed. A separate probe is underway in that case.

#### PSPCL procures 879 MW power from outside state during paddy season



### UT police detain 80-yr-old protester at Matka Chowk, release soon after

The UT police on Monday detained Sardar Labh Singh, the 80-year-old man who has been holding a sit-in at Matka Chowk for the last few months. He was later released after the police allowed him to continue with his dharna at the roundabout.

On Monday morning, cops rounded up Singh for "illegally" putting up his tent at Matka Chowk where he is sitting since December to support the farmers' protest currently raging on the Delhi borders. They asked him to move to some other place, which the octogenarian refused. Following this, the police took him to Sector 17 police station while his tent was also



before too when area cops had arrived at the scene and asked Labh Singh to shift. Sources claimed the police have received orders from higher-ups to remove him from Matka Chowk.

As the news of his detention spread, a large number of people gathered outside the police station, demanding his release. "Baba ji has inspired so many of us to stand with the farmers and more so, with what is right. He is being unnecessarily harassed as the administration can't bear a strong man raising his voice. # Flower farming disappoints farmers in Haryana suffering heavy loss

since beginning as compared to cultivation of other seasonal crops like wheat, paddy, maize, Sugar cane and vegetables since entire production of flowers was consumed at country's biggest Gazipur market at Delhi. But flower growers in Haryana has suffered heavy losses in cultivation of flowers due to COVID-19 epidemic outbreak in the country when sale of flowers was adversely affected in past over a year due to frequent lock down and curfew declared by the government. Moreover, there was complete ban over visiting religious places, restrictions on marriage celebrations, private as well as political functions in which flowers are consumed as such farmers involved in flower cultivation had to suffer a lot due to demand recession and most of the flowers dried in agriculture farms, destroyed and farmers had to throw incurring them heavy financial loss.

According to information Jind, Faridabad and Gurugram districts are famous for cultivation of flowers in the

markets especially at Gazipur the biggest wholesale flower market throughout the year. According to farmers, marigold flower cultivation is being done in nearly 100 acres area at and around village Aahirka in Jind district facing severe harm in past over a year in the absence of demand of flowers and farmers suffered heavy loss even unable to recover cost of production of flowers. Similarly, farmers cultivated flowers including marigold, rose and jasmine in large number of villages in hundreds acre area around Fatehpur and adjoining area in Faridabad district and over 400 growers cultivated Rajnigandha, gladium, rose and marigold flowers too suffered heavy set

In-spite of lock down, night curfews and nigh domination claimed by the police, crime graph in Haryana state has witnessed drastic hike in past five and half months during present year 2021.

State police busted four gangs in the state involved in cyber crimes running fake call centres just in a period of last one week at Ambala City, Faridabad and Sonepat. Chief Minister Flying Squad on a clue raided a call centre at Kundli functioning in a commercial building at Sushant City Kundli in Panipat district on Tuesday early morning and arrested three persons the owner Inderjit Malik alias Bablu resident of Piplikheda in

Sonepat district and his two employees Anshu resident of Jahangir Puri Delhi and ChanderKant resident of Pitampura Delhi, Police recovered six Laptops, Ear phones, Head phones, POS Machine, Desktop and other accessories. Inspector Ravi Kumar of Kundli Police Station told that during preliminary investigation Inderjit Malik admitted crimes and told that they used to search telephone numbers on google and yellow pages and misguide customers that their computer sets is having severe virus in the software in the country as well as in other countries along with other cyber crimes hacking their bank account number. A case was registered with police at Kundli police station.

During a study of crime record in Ambala district known as one of the safest town in the state on National Highway No. 1 for a period of five and half months with effect from January 1 to June 16, 2021, in-spite of lockdown, night curfews, night domination claimed by district police

crime graph has witnessed heavy rise in this period. A study on the crimes reveals that 440 theft cases, 15 murders, 95 cases of cybercrimes and on-line cheating, 48 snatchings were reported to police in this period apart from large number of rape, kidnapping and other cases.

# BJP seeks cancellation of Mukul Roy's nomination for PAC

KOLKATA: The saffron party on Thursday sought cancellation of Mukul Roy's nomination for the Public Accounts Committee (PAC) and urged the Assembly secretary to reject his candidature as his name has not been proposed by the BJP Legislature party and the TMC is ineligible to advance his nomination as he has been elected on a BJP ticket. Roy was among the 20

MLAs who filed nominations for memberships of the Public Accounts Committee (PAC) of the West Bengal Assembly on Wednesday amid speculations that he may be appointed its chairman. The TMC has submitted 14 names and the BJP has put forward six names. Roy featured in the list of 20.

Roy, officially a BJP MLA from Krishnanagar Uttar, switched over to the TMC last week but did not resign from the assembly or was disqualified under the anti-defection law.



"We have submitted a letter to the assembly secretary objecting Mukul Roy's nomination for the PAC membership. According to the assembly rules, either his name has to be submitted by the TMC or the BJP. "The list doesn't state on whose behalf Mukul Roy has filed nomination," a senior BJP MLA said. Roy's name has been proposed by independent member Ruden

Sada Lepcha and TMC MLA

Tarun Kumar Maity. Citing Rule no-302 of the Rules Procedure and Conduct of Business in the West Bengal Legislative Assembly, the letter by the BJP noted that the norm of electing members to the PAC is based on the Principle of Proportional Representation. "Proportional Representation means election of the PAC members from amongst the proportional ratio of the

parties. The BJP has not recommended his name. "The TMC also can't recommend his names as he has been elected on a BJP ticket. Hence, his nomination should be cancelled," another BJP MLA said.

Reacting to the development, TMC chief whip Nirmal Ghosh had said the letter by the BJP neither has any legal nor constitutional sanctity. "The BJP leaders don't know the rules and proceedings of the House. When the nominations for the PAC membership are submitted, it is done as members of the house and not as a member of any party," Ghosh said. Meanwhile, according to sources, all the 20 nominations, including that of Roy, have been accepted after the scrutiny.

However, the list will be officially announced later. The BJP legislature party is appre-

go to Roy as there have been instances when Congress MLAs switching over to TMC were appointed to the important posts, party sources said. "As per the norm, the PAC

# China's amassing of troops, attempt to altar status quo responsible for eastern Ladakh row: India



**NEW DELHI:** The Ministry of External Affairs (MEA) counterpart over the amassing of troops in eastern Ladakh, even as it kept mum on the possibility of diplomatic talks this week

Reacting to Chinese Foreign Ministry Spokesperson Zhao Lijian stating that the high level of troop and military equipment was a "normal defence arrangement" to prevent and respond to encroachment and threats on China's territory, MEA spokesperson Arindam Bagchi said, "It is well recognised that it has been the Chinese actions over the last year, including amassing of a large number of troops close to border areas in the Western Sector, and trying to unilaterally alter the status quo along the LAC, which have seriously disturbed peace and tranquility in the border areas"

"These acts are in violation of bilateral agreements, including the 1993 and 1996

agreements that mandate that the two sides shall strictly respect and observe the Line of Actual Control (LAC) and that two sides will keep their military forces in the areas along the LAC to a minimum level," he added.

As regards the WMCC meeting, Bagchi said there were no updates to share for the moment. "We will certainly keep you informed as and when there are further developments," he said.

In an indication of the stalemate between the two sides. the WMCC has not met for over three months over disengagement in Gogra, Hot Springs, Demchok and Depsang Plains. On the contrary, the PLA is reported to have converted temporary ammunition dumps, helipads and surface-to-air missile positions into permanent positions.

The two sides had disengaged from the North and South banks of Pangong lake in February, but there has been no movement in other flashpoints.

### BJP changes candidate for zila panchayat chief's post after Unnao rape victim writes to President, PM



**UNNAO:** The BJP on Thursday changed its candidate for the post of the district panchayat chief here after the Unnao rape victim objected to the party's choice, alleging that he is "very close" to former MLA Kuldeep Singh Sengar, who was convicted for the crime.

Sengar, a former BJP MLA  $\,$ from Unnao's Bangarmau seat, was accused of rape by the victim in 2017. A Delhi court had sentenced Sengar to life imprisonment in the case in December 2019.

The party's decision came after the rape victim wrote to President Ram Nath Kovind, Prime Minister Narendra Modi and Uttar Pradesh Chief Minister Yogi Adityanath in this regard.

The rape victim also claimed danger to her life if the BJP gives ticket to Arun Singh, who held the post of the Nawabganj block panchayat chief. The elections for the post of the zila panchayat chairman are scheduled for July 3.

The BJP had earlier denied the charge, with its district president Raj Kishore Rawat terming it "baseless" and suggesting that the allegations may be a part of a "conspiracy" by the Opposition.

Later. Rawat in a statement said, "On directions of the party leadership, the candidature of Arun Singh has been cancelled. Now Shakun Singh, wife of the late former MLA Ajit Singh, will be the Sengar.

A Bulk Drug Park (BDP) is coming up in Raigad district of Maharashtra with capacity to provide medicines to the entire nation and should involve the locals, according to state chief minister Uddhav Thackeray.

This ambitious project is proposed to be established on land across 17 villages in Murud and Roha Talukas of Raigad -- in which no village will be relocated - Thackeray said while noting that this Rs 30,000-crore project will generate75,000 jobs with priority for locals.

Highlighting 'sons of the soil' being employed and given required skills training in this project, he urged for a ground level survey to protect horticultural land wherever possible and also for preparation of a comprehensive blueprint with the locals to ensure they got the best compensation for their land.

Minister of industries Subhash Desai said that that this project will be set up under the Indian Bulk Drug Park Development alongside follow up with the union government, besides compensation for land acquisition and 10 percent developed land being provided for PAP. While this land can be used for commercial, industrial and residential purposes, skill development centers will be set up for locals

to assure them of getting jobs, he said. Minister of state for industries, Aditi Tatkare said that processed sewage water would be disposed 10 kilometers



away from the coastline to avoid affecting fishing activities. The bulk drug parks would be utilizing their corporate social fund (CSR) for strengthening civic amenities and welfare schemes for the villages, she said.

With the park project implementation under the Central chemical and fertilizer ministry, this will boost setting up

nly 11 months after the Government notified the Consumer Protection (E-Commerce) Rules, 2020, the Department of Consumer Affairs has come up with a set of sweeping amendments, ostensibly "to protect the interests of consumers... and encourage free and fair competition in the market". Among them is a norm stipulating the appointment of a chief compliance officer, a nodal contact person for 24x7 coordination with law enforcement agencies, and another requiring e-commerce entities offering imported goods or services to 'incorporate a filter mechanism to identify goods based on country of origin and suggest alternatives to ensure a fair opportunity to domestic goods'. A third mandates a fall-back liability on online marketplaces in the event of non-delivery of goods or services to the consumer. Registration has also been made mandatory for all e-commerce players; specific 'flash sales', including 'back-to-back' ones, are set to be banned; and all entities must provide information within 72 hours on any request made by an authorised government agency probing any breach of law including cybersecurity issues. The fact that the latest changes expressly seek to ensure that none of an e-commerce entity's 'related parties and associated enterprises is enlisted as a seller for sale to consumers directly' could also impact several platforms that retail products supplied by vendors with arm's length ties. The enforcement of many of these norms is bound to spur protracted legal fights. In trying to address shortcomings in its rules from last year, the Government appears to be harking back to an era of tight controls. Overregulation with scope for interpretative ambiguity risks retarding growth and job creation in the hitherto expanding e-commerce sector. Welfare of the consumers is imporant. So is the well-being of businesses is also crucial.

## A dark chapter in India's democracy

n the history of Independent India, there are many important dates which are both eventful and historic. November 26 is one such historic day — also known as Constitution Day. The Constituent Assembly of India adopted India's Constitu-

tion on this day, in 1949. To make this day ever more significant, and to make the ethos of Indian Constitution memorable, the Narendra Modi government, in 2015, decided to celebrate the day officially. Post Independence, the leaders of our great country firmly decided that the fruits of Independence have to be enjoyed by all sections of society. The result was: universal adult suffrage and India emerging as the world's biggest democracy. To strengthen our unity amid diversities, establishing a political system based on the strong edifice of democracy was the only priority at that time. The architect of the Indian Constitution, Dr. B.R. Ambedkar, once said, "Political democracy cannot last unless there lies at the base of it social democracy. What does social democracy mean? It means a way of life which recognizes liberty, equality and fraternity as the principles of life."

A journey into our history also shows India's persistent efforts towards imbibement of greater democratic values. This democratic tradition of India was first infringed upon during British Rule. Second, one has the actions of the Congress during Indira Gandhi's time. In this context, B.R. Ambedkar's statement is relevant and contextual when he said, "However good a constitution may be, if those who are implementing it are not good, it will prove to be bad...." This observation was vindicated when a national emergency was declared in India on the midnight of June 25, 1975. Even after 46 years, in 2021 we are reminded of this attempt to murder our democracy and the democratic rights of its citizens.

#### Obtuse politics

The history of the world has seen many ups and downs in connection with human values, racial and social discrimination, apartheid, and war-time treatment to name a few. The strong democratic tradition of our country suffered a blow when Prime Minister Indira Gandhi decided to send all Opposition leaders to prison on the pretext of Emergency. Its imposition was not done to thwart any attempt of political violence or sedition, but was a manifestation of her anger and an obtuse attempt to enjoy political supremacy. It was a great disappointment



to see that the Congress Party, which had committed to uproot the British Rule in 1947, to establish democracy, and subsequently gain the support of innumerable Indians, now became a subservient tool. Government machinery was misused. Mrs Gandhi justified her actions: "The deep and widespread conspiracy which has been brewing ever since I began introducing certain progressive measures of benefits to the common men and common women of India in the name of democracy, the plot sought to negate the very functioning of democracy. Duly elected governments have not been allowed to function, and, in some cases, force has been used to compel members to resign in order to dissolve lawfully elected assemblies." However, her statements left two unanswered questions. After the verdict of the Allahabad High Court, why did she have to impose Emergency? Second, why did the Congress government in power override the Allahabad High Court and use force against the Opposition leaders?

#### The background

Mrs Gandhi's fears emanated from legal and political problems which resulted in her dark act under the garb of national security. The happenings in the aftermath of the general election of 1971, when her political opponent, Raj Narain, filed a case in the Allahabad High Court, the subsequent judgment that went against her, the declaration of her election being illegal, and her being deprived of holding any government post for a period of six years, are evidence of this. Instead of obeying the court order, she preferred to cling to power. With the Opposition leaders resorting to a civil dis-

obedience movement, she raised sedition charges against them. She did everything to make the democracy weak.

It was on the midnight of June 25 that Jayaprakash Narayan (JP), who was spearheading a movement against corruption, found himself in the cross hairs of the police. He had demanded Mrs Gandhi's resignation following her conviction by the Allahabad High Court. He was resting at the Gandhi Peace Foundation when a member of the Foundation tried to telephone a journalist to convey the news of JP's arrest. Little did he know that electricity supply to all newspaper offices had been cut. Mrs Gandhi was trying to subvert the voice of the fourth pillar of democracy. Veteran journalist Kuldeep Nayar had this to say: "For long, he (JP) had an uncle-niece relationship [with Mrs Gandhi] and he called her Indu. But over the years, especially the previous two, they had drifted apart. He considered her the fountainhead of corruption and the destroyer of basic values." And after the Allahabad High Court judgment, he said she had no moral right to continue as Prime Minister. He was of the opinion that she had to quit office immediately. Her clinging to office was "against all public decency and democratic practice"

follower of 'non-violence', he accepted his detention gracefully. When a journalist from Italy had earlier spoken to him about the possibility of his arrest, Morarji Desai had said, "She will never do it...." Once arrested, he said, "When God wants to destroy people, he first makes them mad."

Instructions were sent from the Prime Minister's Office to arrest leaders in the States,

under different Acts and Sections. The Research and Analysis Wing was also used for this purpose. Consequently, the Maintenance of Internal Security Act (MISA) was amended. During this amendment, the Government had made the assurance in Parliament that the Act would not be used for political vendetta. But the reality was far different.

Ashok Mehta, leaders from the Jana Sangha, Atal Bihari Vajpayee and Lal Krishna Advani were also sent to jail. The Government's list of the number of detainees featured 676 arrests. The arrest of JP and banning the Jana Sangha was a long-drawn plan of Mrs Gandhi. West Bengal Chief Minister Siddhartha Sankar Roy also proposed a ban on the Rashtriya Swayamsevak Sangh through an ordinance.

A total ban was implemented on the publication and circulation of a weekly newspaper, Panchajanya, published by the Jana Sangha along with the publication and circulation of a news daily, Tarun Bharat, and a monthly magazine, Rashtra Dharma. The attack on the fourth pillar of democracy was obvious; in some instances, police personnel entered the offices of these publications without a search warrant and locked the offices. Even lawyers were intimidated not to aid publishers. Those who defied the government's gag order to help publishers were also arrested under the National Security Act.

In Assam, the then Congress government arrested several leaders — Renuka Devi Borkataki, Debeswar Sharma, Khagen Gogoi, Purnanarayan Singha, Dulal Baruah, Golap Borbora, Nibaran Bora, Ramani Barman, Lakheshwar Gohain, Bhubaneswar Barman, Indreswar Goswami were some of the prominent names. Democracy and its virtues were trampled during those fateful years. To eminent journalist K.T.J. Menon, Mrs Gandhi was the 'first woman autocratic leader of the world'. Every year, on June 25, we remember this black chapter in India's democracy.

On this day, we should resolve to take steps to avert the repetition of such a mindless and draconian act that affected politics and the fourth pillar of democracy. Let us undertake a firm resolution to remain committed to the Indian Constitution, its values and the country's democratic ethos.

## More than half a year later, farmers protest still rages on

ine months and countingthis is how old the farmers protest currently raging on Delhi borders, is in Punjab. Often termed as the cradle of the peasant's movement, the agrarian state has it into a revolution. What started on the rail tracks of the northern state with only Punjabi farmers revolting against the new farm laws, soon spread to as far as southern states. The scale may be small and the agitation on the outskirts of the national capital where farmers from Punjab, Haryana and Uttar Pradesh are camping, grabbing all the limelight, the truth is that farmers are taking the incumbent government head-on. Supporters and naysayers have acknowledged their presence, determination, steel and resolve to continue with their peaceful sit-in in the face of vagaries of weather, brute police force, indifferent political will among other obstacles. They are no longer persona non-grata, buried in the headlines of suicides, droughts and floods. They are, in fact, the scriptwriters of a never-seen-before movement post-Independence, one that they have



successfully carried forward with patience and wisdom. An awe-inspiring combination of the old and the young, each generation is learning and unlearning from each other, sifting what is best for the morcha.

For the first three months before the Punjab

farmers decided to be heard louder and move to Delhi, thousands of them were living on railway tracks. And then made the roads on Singhu, Tikri, Ghazipur and Shajahanbad border their home. Fellow comrades from Haryana and western Uttar Pradesh showed alacrity in joining them, propelling the hitherto Punjab-centric stir to a pan-India agitation. From sub-zero temperatures in one of the harshest winters in decades to sizzling north Indian summers, they are weathering it all for "haund di ladai" (fight for existence). A most prominent and common sentiment that runs through the protest sites is that the farmers are not going back without getting the laws repealed. "We have not come this far to go back dejected," they avow. Three quarters of a year under it, the farmers' movement is going on as strong. It has found enormous solidarity beyond the farming community too—salaried class, students, teachers, artists, retired and serving bureaucrats and defence personnel. The humble sentiments of farmers struggling to salvage their land has resonated beyond borders too where NRIs are drumming support for them. To them, the farmer is a hero sitting in 48 degrees Celsius and cooking food using firewood, washing utensils with cold water in zero degrees Celsius. Tell this to the anndata and he would probably be embarrassed because in his simplistic prism of the world, he is a kisan and they don't give up,

"Bloodstone - Legend of the Last Engraving" is Narzary's latest book of fiction wherein the various legends of Kamakhya find themselves threaded with the story of a Newar family, in more recent times, in the remote village of Tilibham in Nepal where the Mother Goddess is worshipped with equal fervor.

"The story projects the power of the female, the strengthening of the subdued and the sheer capacity of a mother's love and I have high-

lighted this against the backdrop of the temple's famed annual ritual celebrated as the festival of fertility and creation-the Ambubachi Mela," Narzary told PTI.

The author said that she grew up understanding that Kamakhya's lore had some historical basis to it. "There have been mythologies,

"There have been mythologies, legends and tales which may just be pure fictitious stories, probably stories told by grandparents around the fire ages ago and I thought of adding my own story-by-the-fire to it," she said.

The author often visited the revered Kamakhya Temple and everything around it, and it never ceased to give rise to a whole lot of questions in her mind each time.

Kamakhya temple, which is one of the 'shaktipeeth', the pilgrims worship a stone fissure in the ground shaped like a vulva, believed to be the genital of goddess Dakshyayani, lord Shiva's consort. The fissure is believed to bleed once every year during the Hindu month of 'Aashaar'. Against the backdrop of this legend, the tale of the Bloodstone spans across centuries in time and embraces both the divine and the mortal.

"This is the tale of a copper engraving etched by Dakshyayani's friend Princess Ambaa of Nepal as she mourns the death of her only friend. Centuries later, the ancient buried engraving is unearthed while a virgin land is tilled by the ruins of the palace, which threaten to alter prehistoric beliefs," Narzary

pointed out.

Asked about the connection between Kamakhya and Nepal in the book, the writer said that she happened to see a small family from Nepal at the temple yards and they had a very charming, happy little girl with them who looked almost like a little goddess herself.

"This sparked off an idea and of course, Kumaris or pre-pubescent girls, are as much worshipped here as in Nepal. Thus, there already existed a connection and also because the neighbouring country, too, had so much of Shiva and His consort woven into its history and culture, that little stray stories around them were more probable," she said.

The writer, who is also the joint secretary of North East Writers' Forum (NEWF), said that she had drawn from "just one of the many tales that surround the many 'shaktipeeths' where every clan, tribe and community have their own intriguing story to tell about age-old practices but at the end of it all, I see that the truth and lore often merge into each other, giving a new perspective to the original truth".

**NEW DELHI:** The Enforcement Directorate (ED) transferred seized assets worth Rs 9.371.17 crore in the cases related to Vijay Mallya, Nirav Modi, and Mehul Choksi, to Public Sector Banks (PSBs) and Central Government.

Assets worth Rs 18,170.02 crore have so far been seized by the ED. "Enforcement Directorate (ED) not only seized assets worth Rs 18,170.02 crore (80.45% of the total loss to banks) in the case of Vijay Mallya, Nirav Modi, and Mehul Choksi under PMLA but also transferred a part of attached/ seized assets of Rs 9371.17 crore

rav Modi has been in London iail for the last two years and three months on the basis of an extradition request by India. Nirav Modi and Vijay Mallya have also been declared Fugitive Economic Offenders by PMLA Court in Mumbai.

The ED has recently transferred shares seized worth approximately Rs. 6,600 crore to State Bank of India (SBI) led consortium as per the order of PMLA Special Court, Mumbai. "Today, Debts Recovery Tribunal (DRT), on behalf of SBI led consortium, has sold shares of United Breweries Limited for Rs 5824.50 Crore," the release said.

800 Crore by the sale of shares is expected by 25th of June. It is pertinent to mention here that due to the cooperation and help extended by ED, Public Sector Banks have already recovered Rs 1357 Crore by selling the shares earlier. ### Cases against fugitives, economic offenders to be actively pursued: FM

Minister Nirmala Sitharaman said on Wednesday the government will actively pursue cases against economic offenders to bring back defrauded money from banks.

The remark came soon after the Enforcement Directorate (ED) said the Debts Recovery Tribunal (DRT) has sold shares worth over Rs 5,800 crore of United Breweries Limited (UBL) that were earlier attached under the anti-money laundering law as part of an alleged bank fraud probe against fugitive liquor baron Vijay Mallya.

"Fugitives & economic offenders will be actively pursued; their properties attached & dues recovered #PSBs have already recovered Rs 1357 Cr by selling such shares. A total of Rs 9041.5 Cr shall be realised by banks through sale of such attached assets" the Finance Minister said in a tweet.

According to ED, Vijay Mallya, Nirav Modi and Mehul Choksi have defrauded public sector banks by siphoning off the funds through their companies which resulted in total loss of Rs 22,585.83

### I-T Dept functionality to identify non-filers on whom higher TDS will be levied from July 1

**NEW DELHI:** The income tax department on Tuesday said its new utility developed to help TDS deductors and TCS collectors identify non-filers or "specified persons" on whom a higher rate of taxes will be levied will help ease the compliance burden.

From July 1, non-filers of income tax returns for the past two fiscal years would be subjected to higher tax deducted at source (TDS) and tax collected at source (TCS) rate if such tax deduction was Rs 50,000 or more in each of those two years. The provision was introduced in the 2021 Budget.

The TDS deductors and TCS collectors would be required to check on the functionality of the PAN of the vendor from whom TDS is to be deducted or TCS to be collected, only at the beginning of the financia

The Central Board of Direct Taxes (CBDT) had on Monday issued a circular on the implementation of Sections 206AB and 206CCA with respect to higher tax deduction/collection for certain non-filers.

In a statement on Tuesday,



the CBDT further said that to implement these two provisions, tax deductor or collector was required to do a due diligence of satisfying himself if the deductee or collectee is a 'specified person'. This would have resulted in extra compliance burden on such tax deductor or collector.

"To ease this compliance burden, the Central Board of Direct Taxes has issued a new functionality "Compliance Check for Sections 206AB & 206CCA". This functionality is already functioning through reporting portal of the income tax department (https://report. insight.gov.in)," the statement **AGENCIES**

NEW DELHI: In order to incentivise states who are operating their e-point of sale (e-POS) devices judiciously and manage to generate savings while ensuring transparency in the public distribution system (PDS) the Government has facilitated changes in the food security legislation, where any savings accrued by such states can be used for purchasing electronic weighing scales and integrate them with e-POS devices. The Ministry of Consumer Affairs has amended the Food Security (Assistance To State Government Rules) 2015, so that states are encouraged to generate savings through judicious use of e-POS devices. The amendment has also been effected to ensure greater transparency in the PDS regime. While distribution through ePoS devices ensures that subsidised foodgrains are provided to the rightful beneficiary through biometric authentication, the integration of ePoS devices with electronic weighing scales would ensure that the beneficiary is given the right quantity of foodgrains by the fair price shop dealer.

#### Exam fees, supply of food to Anganwadis exempt from **GST levy**

**NEW DELHI:** The Central Board of Indirect Taxes and Customs (CBIC) has stated that Goods and Services Tax (GST) is not levied on services like supplying food to Anganwadis and schools under the ambit of Mid-day Meal scheme. It has further clarified that fees paid by students to sit in any examination conducted by Central Board of Secondary Education (CBSE) or state boards, will also not attract any GST levy. Even fees paid by students for sitting in any entrance examination is also exempted from GST levy, the board has clarified. CBIC recently had clarified these points through its Twitter handle, which had emerged from the GST Council meeting. The board said that it had received several representations from educational institutions, seeking to know whether supplying food in schools under government schemes would be exempted from GST, if it is funded by government or supported by donations from private bodies.

Steps taken for FDI policy reforms including investment facilitation and ease of doing business have resulted in increased FDI inflows in the country, according to the commerce ministry.

In 2020, India received \$64 billion in foreign direct investment, the fifth-largest

**MUMBAI**: The second wave of Covid worsened 'shecession' as twice as many working women in India are worried about the availability of jobs, time for job-seeking compared to working men, according to the LinkedIn Workforce Confidence Index report released on Tuesday.

Shecession -- an economic downturn where job and income losses are affecting women more than men. The term was coined by C. Nicole Mason, president and chief executive of the Institute for Women's Policy Research (IWPR), a think tank.

survey responses of 1,891 professionals from May 8 to June 4, revealed how the aftermath of the pandemic's second wave has left Indian professionals -- particularly Gen Z and working women -- increasingly vulnerable to economic uncertainty in today's evolving job market.

The finding showed that working women's confidence level dipped four times more compared to working men. This uneven impact has also bruised the financial stability of working women as one in four

The report, based on the (23 per cent) female professionals are concerned about growing expenses or debt, in contrast with just one in 10 (13 per cent) working men.

The pandemic's recent peak in India has also amplified the importance of work experience and professional connections, as young Indians were found more than twice as worried as their older counterparts, about the impact of Covid-19 on their careers.

About 30 per cent of Gen I professionals were found to be troubled due to lack of jobs, compared to 18 per cent baby boomers. AGENCIES

# Moody's cuts India growth forecast for 2021 to 9.6 pc

**NEW DELHI:** Moody's Investors Service on Wednesday slashed India's growth projection to 9.6 per cent for 2021 calendar year, from its earlier estimate of 13.9 per cent, and said faster vaccination progress would be paramount in restricting economic losses to the June quarter.

In its report titled 'Macroeconomics - India: Economic shocks from second Covid wave will not be as severe as last year's'. Moody's said high-frequency economic indicators showed that the second wave of Covid infections hit India's economy in April and May. With states now easing restrictions, economic activity in May is likely to signify the

### **Centre extends food grains** allotment by 5 months under 'Garib Kalyan Yojana'



**NEW DELHI:** In order to provide relief to the poor from the after-effects of the prevailing Coronavirus pandemic, the Union Cabinet on Wednesday approved allocation of additional food grains under Pradhan Mantri Garib Kalyan Yojana for another five months. Subsequently food grains would be provided from July to November 2021 at five rupees per person per month to around 81 crore beneficiaries, who are covered under National Food Security Act.

According to official sources, this move would entail an estimated food

subsidy of Rs 64,031 crore. However as the Centre is bearing the entire expenditure of the scheme without any contribution by states, an additional expenditure of about Rs 3,234 crore would be required to be met towards transportation and handling and the margins of fair price shops owners. Thus, the total estimated expenditure to be borne by the Government will be Rs

67,266 crore The allocation in terms of wheat and rice shall be decided by the Department of Food and Public Distribution, official sources



# Pen, ink, and action: 100 years of Satyajeet Ray

he birth centenary f Satyajeet Ray was blurred amid the much hyped hoopla around Bengal elections. The political frenzy not only overshadowed the filmmaker's unparalleled craft but also served as a missed opportunity to look at Ray's legacy on the other side of the celluloid. The artist (not a filmmaker) in Ray caught my attention after the demise of Soumitra Chatterjee the tallest cinestar of Bengal's cinema who under Manik Da's (as Ray was fondly known) tutelage in film Charulata altered his entire handwriting because camera tricks fell short to detail the evolution of Bengali scriptwhat it had been, what it was then, how the words changed over the years, what was the role of Rabindranath Tagore and later writers

A multifaceted artist extraordinaire, Ray was a genius and is still remembered for his graphic designs and illustrations. From capturing the emotions of Jibananda Das the dark, brooding contemplative loner bard of Bengal, next to Rabindranath Tagore and Kazi Nazrul Islam in the cover of 'Rupasi Bangla' (collection of poems by Jibananda Das) to designing film posters, illustrations of children's book and mastery over calligraphy and typography, his style reflected the depth of his intellectual understanding that set him apart. He was also credited for creating numerous new fonts in Bengali and four Roman ries by creating riddles and



designing the typeface for Ray

Recently, I chanced upon Ray's artistic work through a digital exhibition 'Aap Kya Sandesh Laya' at Delhi's India International Center that brought alive a selection of Ray's illustrations in covers of Sandesh an iconic Bengali children's magazine started by Ray's grandfather, Upendrakishore Raychaudhury in 1913. As a prolific illustrator and editor of the magazine, he designed and painted each piece to narrate his own sto- pattachitra style of narrative

tions of contributors also. Each piece reflected sophisticated experimentation with various artistic styles and traditions, both local and foreign without compromising on aesthetics or authenticity.

The cover designs incorporated colourful geometric and floral patterns in saturated primary colours with lines and textures similar to woodblock printing. Often using different folk motifs, motifs from traditional day-to-day rangolis (in Bengal, alpana) or the painting. Experimenting with

fonts, receiving an award for puzzles and creating illustra- creative illustrations, he created four comic strips for Sandesh. However, these comic strips were 'silent', the characters did not converse with each other, leaving the narrative to the reader's imagination.

Constantly experimenting, using ink and pen, pencil, watercolours, and ordinary poster paint in different stylisations, Ray's illustrations are striking in the way they marry playfulness with strong lines. For readers, every cover of Sandesh was a constant source of surprise and delight, as with each issue, Ray played around with the word 'Sandesh' using different
