'Amnesty' announced across Afghanistan, women urged to join government

KABUL: The Taliban declared an "amnesty" across Afghanistan and urged women to join their government, seeking to convince a wary population that they have changed a day after deadly chaos gripped the main airport as desperate crowds tried to flee their rule.

Following a blitz across Afghanistan that saw many cities fall to the insurgents without a fight, the Taliban have sought to portray themselves as more moderate than when they imposed a brutal rule in the late 1990s. But many Afghans remain skeptical.

Older generations remember the Taliban's ultraconservative Islamic views, which included severe restrictions on women as well as stonings, amputations and public executions before they were ousted by the US-led invasion that followed the Sept 11, 2001, terror attacks.

While there were no major reports of abuses or fighting in the capital of Kabul as the Taliban now patrol its streets, many residents have stayed home and remain fearful after the insurgents' takeover saw prisons emptied and armories

Many women have expressed dread that the two-decade Western experiment to expand their rights and remake Afghanistan would not survive the resurgent Taliban.

Corruption case: Former DGP Sumedh Saini freed from VB after 24 hours of arrest

¬he Punjab and Haryana High Court ordered Sumedh Singh Saini, Punjab's former Director-General of Police, to be released immediately just over 24 hours after he was arrested by the Vigilance Bureau.

Saini, who faced allegations of human rights abuse during terrorism in Punjab, is also facing two murder cases. Despite immense pressure on the Capt Amarinder Singh government from public and within his party to deal with Saini strictly, he was never arrested. He managed to give the slip to teams of the Vigilance Bureau on several occasions. Saini's name also figures in the Behbal Kalan/Kotkapura police firing cases. His arrest is likely to trigger a political flurry in the state as he was considered close to the Shiromani Akali Dal.

A Vigilance official said Saini reached the VB office around 8 pm to join investigation in the corruption case. He had not informed officials that he would visit the Vigilance office. and 120-B of the IPC at the After questioning, the officials ordered his arrest. Saini's law- in Phase-I, Mohali.

JALANDHAR: Farmers laid siege at Dhannowali on not raise the sugarcane SAP Jalandhar-Phagwara stretch along the NH-1 blocking all direct links between major cities, including Jalandhar, Amritsar and Pathankot.

Police have given diversions via longer routes. All 32 farmers unions are participating in the dharna and have termed the Rs 15 per quintal hike announced by the state government on sugarcane SAP as a "cruel joke".

They said that they were expecting at least Rs 70 per quintal hike since the prices have been revised after four years. The farmers have announced to sit on rail track at 4 pm and block the railway line for an indefinite period. This is Delhi-Amritsar rail line.

They have also said that they would lay a 'pucca morcha' on the highway in case

the state government does up to their demand.

Though farmers are already present in thousands, Manjit Rai, president, Bharatiya Kisan Union (Doaba), says that so far only 15 per cent farmers have converged and various farmer convoys from across Punjab were still on the way. Commuters from across the region, including those from Delhi, Jammu, Chandigarh, Amritsar and Pathankot. were harried a lot as they got stuck in road and rail traffic due to the farmers' protest.

Is economy seeing a harder to redress state of stagflation?

team of the Reserve Bank of India officials has provided an optimistic assessment of the 'State of the Economy' in the August issue of the central bank's monthly bulletin. Pivoting from what the bank posited on August 6 when it said, "the outlook for aggregate demand is improving, but still weak and overcast by the pandemic", the officials led by Deputy Governor Michael D. Patra asserted that aggregate demand conditions had been buoyed by pent-up demand released by unlocking and vaccination. And, evidence that the economy was gaining traction could be seen in "manufacturing activity gradually turning around even as the contraction in services had moderated", they wrote. The authors of the article have arraved several high-frequency indicators including E-way bills, toll collections, fuel consumption, automobile dispatches and registrations, and rail freight volumes to buttress their view that demand is regaining momentum. The team has also pointed to a private forecaster's data showing a sizeable sequential decline in the unemployment rate last month — to 6.95% from 9.17% in June, and that with a pronounced rural bias — to posit that this reflects the "resilience of the rural sector on brightened agricultural prospects". But the authors elide over the fact that the CMIE, whose survey-based unemployment rate they have cited, is far less sanguine about the addition of approximately 16 million jobs in July. CMIE MD Mahesh Vyas contends in an analysis that "all the additional employment provided by India in July was of poor quality" while better quality salaried jobs shrank by 3.2 million, noting that the bulk of the rural jobs added were of temporary farm labour linked to delayed kharif sowing. Monetary authorities need to be fair in their analysis of the situation on the ground. Else, the country risks losing focus on ritht policies and may put the economy

Regional identity vs mainstream ID



started my political-administrative career as Chairman of a Kannada watchdog committee after being elected, in 1983, from Chamundeshwari constituency. Fighting for the regional identity of Karnataka has always been a part of my political and personal agenda. The question of regional identity, in the realm of nationalism, has become prominent since 2014. A myopic view of "nationalism" by certain sections needs to be countered effectively to protect our dignity and identity. Modern India is conceptualised on the idea of unity in diversity, and all our actions should be sensitive to protecting this beautiful idea.

It is unfortunate that the Bharativa Janata Party (BJP) has derived its political ideology from Veer Savarkar's Hindutva instead of the supreme Constitution of India. Its politics focuses on centralisation, with special attention to undermining the interests of non-Hindi States. The BJP government is intruding into the economic, political, cultural and educational autonomy of States. Modern India has evolved to be more than just the Union of States. We should be moving toward cooperative federalism and not coercive federalism. The policies of the BJP government are inconsistent with the vision of the Constitution drafting committee with respect to Centre-State relations.

Revenue deficit State

Karnataka is one of the States most harassed by the central government of the day. Karnataka has seen a drain of wealth due to the inconsistent policies of the BJP. From being a revenue surplus State, it is now a revenue deficit State. Karnataka's share of tax devolution has been reduced from 4.72% in the Fourteenth Finance Commission to 3.64% in the Fifteenth Finance Commission due to a skewed preference to the 2011 population. Unfortunately, States such as Karnataka which gave special attention to population control, were and have been penalised severely. Special grants of Rs 5,495 crore which were recommended by the Fifteenth Finance Commission for 2020-21 were denied by the Union Finance Minister. In 2019-20, Karnataka got just



Rs 30,919 crore as its share of central taxes instead of Rs 48,768 crore as recommended by the Fourteenth Finance Commission. In 2020-21, it got just Rs 20,053 crore as share of central taxes instead of Rs 31,180 crore as recommended by the Fifteenth Finance Commission. Karnataka contributes more than Rs 2.2-lakh crore to central taxes but in return receives less than Rs 30,000 crore. If the States get 41% share of the central taxes, Karnataka should have ideally got at least Rs 70,000 crore -Rs 80,000 crore on a pro rata basis for its contribution.

It is a known fact that the South has been subsidising the north. Six States south of the Vindhyas contribute more taxes and get less. For example, for every one rupee of tax contributed by Uttar Pradesh, that State receives more than Rs 1.79. For every one rupee of tax contributed by Karnataka, the State receives less than Rs 0.47. Karnataka has also been hit by a denial of Goods and Services Tax compensation cess as promised by the central government through the Goods and Services Tax (Compensation to States) Act, 2017. Having presented 13 Budgets, my heart is saddened to see Karnataka deviating from the provisions of the Fiscal Responsibility and Budget Management Act — thanks to the step motherly treatment by the Narendra Modi-led BJP government.

Specific issues

The problems are more than just the finances of State governments. Many issues of federalism are affecting the identity, social structure and political economy of our State. Our government had requested the central government to include the Karnataka flag in the schedule of the Emblems and Names (Prevention of Improper Use) Act, 1950, based on the recommendations of the committee for the Karnataka flag. It is unfortunate that the central government is still procrastinating over the recommendation without granting formal inclusion. Is the desire of the people of Karnataka to have a flag for their State, to give primacy to the Kannada language and to have greater say in the running of their own lives inconsistent with the objective of building a strong nation? It is no more a secret that a conspiracy is being hatched by the leaders of certain regions to systematically prevent the selection of non-Hindi candidates to government posts and professional courses. A recent example of this can be seen in the Institute of Banking Personnel Selection notification where the examinations were notified to be conducted only in English and Hindi, thereby depriving lakhs of non-Hindi medium candidates an opportunity to apply. About 407 vacant posts in the notification were to be filled in banks located in Karnataka — this means 407 Kannada medium candidates will lose the chance to work in Karnataka.

Centralisation of education

The National Education Policy is another tool of the BJP to proliferate Hindi in non-Hindi States and to take away the rights of the States by promoting centralisation with respect to education. The policy negates the spirit of the Constitution and is inconsistent with Article 246 of Indian Constitution. Under the new three-language formula, it is consequential for the students from the south Indian States to choose Hindi as the third language. Schools will not have enough resources to arrange for faculty to teach more subjects for third languages, which means Hindi will be the only choice. It is important to recollect that in 1947, India was a young nation and we needed to be cautious of any divisive or secessionist tendencies. India, therefore, became a Union of States with a strong Centre. When Sardar Vallabhbhai Patel went about integrating the princely States into the Union, a strong Centre did make sense.

A perspective

Today, over 70 years down the line, we have done admirably well as a nation. The Constitution of India has stood the test of time. We have also learnt useful lessons from turmoil in Tamil Nadu over Hindi language imposition and demands of autonomy from certain States such as Punjab and Assam. From a Union of states, we are evolving into a federation of States.

Therefore, I do not think the demands for greater federal autonomy and recognition of egional identity are inconsistent with our nation. Karnataka prides itself in its Kannada identity. The oldest written document (in stone) in Kannada found at Halmidi, Hassan district, dates back to the Second century AD. The oldest Kannada Kingdom under the Kadamabas of Banavasi ruled the State during the Fourth century AD. We have been using a red and yellow flag for decades. Yet, Karnataka, as our Poet Laureate Kuvempu said, is the daughter of Bharata, the Indian nation — Jaya Bharatha Jananiya Tanujathe.

The Abraham Accords as India's West Asia bridge



e recent visit by the Indian Air Force chief, Air Chief Marshal R.K. Bhadauria, to Israel offers a window to study how New Delhi is taking advantage of the Abraham Accords deal signed between Israel and a consortium of Arab States led by the United Arab Emirates (UAE) in 2020 According to reports, an Indian contingent of the Indian Air Force (IAF) will now visit Israel in October to take part in multilateral military exercises.

In the same week as ACM Bhadauria's visit, India also conducted the 'Zayed Talwar' naval exercises with the UAE off the coast of Abu strategic cooperation between the two countries. In December 2020, Indian Army chief, General M.M. Naravane, visited the UAE and Saudi Arabia, becoming the first chief of the Indian Army to do so. The foundation for these visits was set by the (now former) chief of the Indian Navy, Admiral Sunil Lanba, in 2017, who visited the UAE and Oman, the latter being home to Duqm Port where New Delhi signed a deal with Muscat for access to the facility, including dry dock use by the Indian Navy. The above examples show the pacey developments on the defence front between India and the West Asian region. The signing of the Accords has removed a significant strategic obstacle for New Delhi — that of a trapeze wire delicate balancing act India has had to play out between the Arab Gulf and Israel over the decades. This status quo is now witnessing a change, with Israel inaugurating its first diplomatic mission in Abu Dhabi and direct flights, business and



tourism picking up between the two countries over the past few months. New Delhi had welcomed the Accords, highlighting its support for mechanisms that offer peace and

Bahrain's Foreign Minister Abdullatif Al Zayani, Israel's Prime Minister Benjamin Netanyahu and United Arab Emirates (UAE) Foreign Minister Abdullah bin Zayed display their copies of signed agreements while U.S. President Donald Trump looks on as they participate in the signing ceremony of the Abraham Accords, on the South Lawn of the White House in Washington, U.S., September 15, 2020.

India's trajectory towards an increased strategic footprint in West Asia has been in development for some time now. Starting from the relatively low-key staging visit to Saudi Arabia conducted by the IAF in 2015, to hosting visiting Iranian naval warships in 2018, defence of the critical waterways in and around the Persian Gulf, the Arabian Sea and the extended Indian Ocean Region (IOR) has taken a driving seat in Indian strategic thinking.

Recently, as tensions between Iran, Israel

and the United States flared up in the Persian Gulf, the Indian Navy orchestrated Operation Sankalp, which saw Indian warships escort on an average 16 Indian-flagged vessels a day. This comes as covert attacks on merchant vessels in the region expand, with tensions between Iran and Israel spilling across the region. Till a certain extent, the Accords, from the UAE's perspective, were to make sure the emirate along with its international centres of trade such as Dubai and Abu Dhabi do not become targets between Jerusalem and Tehran. However, not all Arab States have been on board with the geopolitical shifts the have pushed through. Despite a l of effort from Israel, under the (now former) Prime Minister Benjamin Netanyahu, Saudi Arabia has maintained a distance from this arrangement. More recently, Riyadh has praised the Accords, but said that the resolution of the Palestinian State remains at the forefront of its requirements.

It is imperative to remember here that despite India's rare but arguable successes in a 'non-alignment' approach in West Asia, it has taken one-sided decisions in the past, such as training Iraqi Air Force cadets on MiG aircraft in Tikrit between 1958 and 1989. while also maintaining good relations with former President Saddam Hussein, seen as a critical part of India's energy security thinking. The rationale behind such thinking back then has not changed even in 2021, as India still imports more than 80% of its annual oil requirements, much of which still comes from suppliers such as Iraq and Saudi Arabia. Iran, as part of India's 'West Asia' con-

struct, will also play a significant part in India's outreach in the months to come as the crisis in Afghanistan deepens. The fact that New Delhi used Iranian airspace and facilities when evacuating its diplomatic staff from Kandahar in July showcases a level of strategic commonality, interest and play on certain issues in the region. Keeping this in mind, connectivity projects such as Chabahar Port and Chabahar-Zahedan rail project (project discussions are still on) amongst others remain critical. Recent multiple visits by India's External Affairs Minister S. Jaishankar, and Defence Minister Rajnath Singh followed by Iranian Do Brigadier General Amir Hatami's visit to India highlight a revitalised strategic cooperation between the two countries despite multiple obstacles in the bilateral relations, led by U.S. sanctions against Tehran and the general tensions between Israel, the Gulf and Iran via proxy battles in theatres such as Yemen, Syria and beyond.

India's strategic play in West Asia will be reflective of its economic growth, and by association, an increasingly important place in the global order. From the UN Security Council to the Indo-Pacific, New Delhi will be expected to be more assertive, diplomatically and militarily, in its posturing and shed the cloaks of its foreign and strategic policies being conducted from a stage balanced on a fence.

New book explores lives of Hazrat Mahal, Lakshmibai

new book explores the lives of two valiant freedom fighters, Begum Hazrat Mahal of Awadh and Rani Lakshmibai of Jhansi, who 'never met' but found themselves embroiled in the same struggle -- the Indian Rebellion of 1857. 'A Begum and A Rani: Hazrat

Mahal and Lakshimibai in 1857', published by Penguin Random House India (PRHI), is written by historian Rudrangshu Mukherjee.

The book, capturing the different trajectories of Begum and Rani's lives and struggles, tells the story of the 'two women in a rebellion'. Notably, they both got married into royal houses and decided to uphold traditions of ruling and culture that their husbands had established but subverted by the policies of Lord Dalhousie who had annexed and 1856, respectively.

'I have been fascinated by the uprising of 1857 from the time I became a research student some forty years ago. I have tried in my other books to reconstruct the actions and consciousness of the rebels. In this book, I try to retrieve the actions and leadership of two remarkable women and also seek to understand how one is iconised the other almost forgotten,' said Mukherjee, who is the chancellor and professor of History at Ashoka University.

Both Rani (1828-58) and Begum (1820-79) sacrificed their lives trying to overthrow the British rule, which they considered to be 'alien and oppressive'.

Their resistance and their deaths are heroic and poignant, he noted.

the publishers in a statement. These are two women who never met each other, but led similar lives, with a common goal: to overthrow British rule in India. While one has been hailed a nationalist icon, the other remains shadowed in forgotten accounts. Right from their eventual rise during a pivotal moment of India's colonial history — the Revolt of 1857 — to their heroic yet poignant deaths, author Rudrangshu Mukherjee's latest non-fiction work, A Begum & A Rani — Hazrat Mahal and Lakshmibai in 1857, (published by Penguin), captures

what makes them feminist icons. Mukherjee has been researching the 1857 uprising for nearly 45

years and this is his sixth book on the subject. His area of research was largely on Awadh and Kanpur, but this time, he decided to shift his focus to Jhansi.

"I noticed the contrast -Lakshmibai was treated as a nationalist icon, whereas Hazrat Mahal, also a woman leader of the rebellion in Awadh, was relatively a forgotten figure," speaks Mukherjee of the inception of the book.

The seed has been in Mukherjee's mind for at least five to six vears. "It was when I became housebound, with all this archival work here with me, that I decided to give it a structure,' he recalls, adding that he started writing in February 2020.

Mukherjee's previously authored books include 'Nehru & Bose: Parallel Lives', 'Awadh in Revolt 1857-58: A Study of Popular Resistance' and 'Spectre of Violence: The Massacres in Kanpur in 1857'

Court asks Renault-Nissan to pay workers \$9.5 million interim dues

court has asked Renault-Nissan to pay its 3,542 workers at its Chennai plant an average of over Rs 7,100 per month in additional wages as interim relief, according to a copy of the order reviewed by Reuters.

Workers at the Renault-Nissan plant in Chennai filed an industrial arbitration suit demanding 20,000 rupees as a monthly interim settlement after the expiry of a previous wage agreement in March 2019.

The consortium had agreed to pay on an average 2,250 rupees every month ending March 2021.

Nissan had told the court its business in India could become "unviable in the long run" if it were to give in to demands of higher pay from its factory workers, according to a court filing by the Japanese automaker.

Nissan and its union have been locked in a legal arbitration dispute since July after the two sides failed to reach a mutual agreement higher wages. over several issues including



At the current pace, 2021 would exceed the all-time record of \$11.8 billion. Founders, bankers, lawvers and advisers are racing to cash in on fervent demand for fresh public

The catalyst, in a word, is Zomato Limited, the fooddelivery startup went public in July and, despite deep losses and mediocre prospects for profitability, shares have soared more than 70 per cent. That has fuelled the idea that similarly

could find a strong reception from investors.

Oyo Hotels & Homes Private Limited, a longtroubled lodging giant, started work last week on its draft prospectus and aims to file in October, according to people familiar with the matter. The ride-hailing leader Ola and fintech startup Pine Labs Private Limited have also begun talks with investment bankers, according to other people aware of the situation.

Byju's, a digital education startup valued at \$16.5 billion, is in early discussions about an IPO and bankers are encouraging the company to take advantage of the red-hot market, according to people familiar with the

Byju's is in the midst of absorbing several substantial acquisitions and is likely to hold off on any listing for at least a vear

that PhonePe, a payments startup Walmart acquired as part of its Flipkart deal, is considering shifting its incorporation back to India from Singapore to capture local investor attention, according to two people familiar with the matter who did not want to be identified. The regulatory upheaval in China has also sent investors looking for promising opportunities in countries with more predictable government policies.

"If global investors have to pick an emerging market, the balance is tilting in India's favor after the regulatory action in the China internet ecosystem," said Pankaj Naik, executive director and co-head, digital & technology at consultancy, Avendus Capital Pvt. "India may not be as attractive as China in the broader economic sense but it's looking like a safer bet.'

SEBI slashes lock-in period for promoters to 18 mths post-IPO **NEW DELHI:** Markets regu-

lator SEBI has reduced the minimum lock-in period for promoters' investment post an initial public offering (IPO) to 18 months from three years, under certain conditions.

said if the object of the issue involves offer-for-sale or financing other than for capital expenditure for a project, then the minimum promoters' contribution of 20% would be locked-in for 18 months from the date of allotment in the IPO. Currently, the lock-in period is three years.

Wholesale price-based inflation eases to 11.16 per cent in July; food, crude prices soften

NEW DELHI: The wholesale price-based inflation softened for the second straight month to 11.16 per cent in July on cheaper food items, even though prices of manufactured goods and crude oil hardened. However, WPI inflation remained in double digit for the third consecutive month in July, mainly due to a low base of last year. WPI inflation was (-) 0.25 per cent, in July 2020. "The high rate of inflation in July 2021 is primarily due to low base effect and rise in prices of crude petroleum and natural gas; mineral oils; manufactured products like basic metals; food products: textiles: chemicals and chemical products etc as compared the corresponding month of the previous year,' the Commerce and Industry Ministry said in a statement.

Housing sales may rise 30 per Power ministry circulates draft rules for cent in 2021; to remain below pre-Covid levels: Report

NEW DELHI: Housing sales are likely to rise by 30 per cent across seven major cities to nearly 1.8 lakh units in 2021, but demand will still be lower than the pre-Covid levels, according to property consultant Anarock

According to Anarock research, housing sales are expected to increase 30 per cent year-on-year (y-o-y) to 1,79,527 units across seven cities in 2021 from 1,38,344 units last year.

In 2019, housing sales stood at 2,61,358 units across seven cities-Delhi-NCR, Mumbai Metropolitan Region (MMR), Pune, Bengaluru, Hyderabad, Chennai and Kolkata.

The consultant also estimated sales to further rise in 2022 and 2023 to 2,64,625 and 3,17,550 units, respectively

Anarock Chairman Anuj Puri said: "The residential sector was showing healthy year-on-year growth since 2017 until the latest peak year of 2019, but this traiectory was derailed by the COVID-19 pandemic. Otherwise, 2020 was expected to be a watershed year for the housing sector"

allowing gencos to sell electricity to 3rd party **NEW DELHI:** The Ministry of Power has proposed to amend

producers to sell power to third party, which can reduce fixed costs and cut retail tariff for end consumers, according to a statement.

The Ministry of Power circulated the draft Electricity (Late Payment Surcharge) Amendment Rules, 2021, seeking comments for the same, the power ministry said in the statement.

The draft amendment rules are placed on the website of the Ministry of Power. The ministry proposes to take one more step towards reducing the burden of the distribution licensee (discoms) in order to reduce the retail tariff for the electricity consumers, the statement said. It added that the power gen-

erating companies are being given an option to sell power to third parties and recover their costs. To this extent, the fixed cost burden of the distribution licensee shall be reduced, the ministry stated.

If a distribution licensee has any payment, including late payment surcharge, outstanding after the expiry of 7 months from non-payment of outstanding the due date as prescribed in the dues, the distribution licensees



PPA (power purchase agreement), the generating company may sell power to any consumer or any other licensee or power exchanges, for the period of such default, the statement said.

It added that the claim will be retained on payment of fixed charges or capacity charges from the distribution licensee, after giving a notice of at least 15 days to the distribution licensee. "The claim, if any, shall be reconciled on an annual basis and shall be limited to only under recovery of the fixed charges or capacity charges." Further, the statement also said that due to

are burdened with the increase in the late payment surcharge.

"In order to boost the confidence of the investor in generation projects, the generation project developer and also to reduce the burden of the distribution licensee, the order of payment ie the principle of first in and first out for payment of bills has been proposed," it said.

The statement said that all the bills payable by a distribution licensee to a generating company or a trading licensee for power procured from it or to a transmission licensee shall be time-tagged with respect to the prescribed date of payment specified in PPA. AGENCIES

Retail Inflation for rural and farm labourers rose slightly in July 2021

NEW DELHI: Retail inflation for agricultural and rural labourers went up slightly to 3.92 per cent and 4.09 per cent respectively in July 2021 as against June 2021, when it was 3.83 per cent and 4 per cent, respectively.

All-India Consumer Price Index for agricultural labourers and rural labourers for July 2021 went up by four points and five points to stand at 1,061 points and 1.070 points respectively, as compared to June 2021.

Food inflation based on the indices stood at 2.66 per cent and 2.74 per cent in July 2021, which was lower compared to 2.67 per cent and 2.86 per cent, respectively, in June 2021.

Food inflation was at 7.83 per cent and 7.89 per cent, respectively, during the corresponding month of the previous year.

"Point-to-point rate of in-(Consumer Price Index for



Agricultural Labourers) and **CPI-RL** (Consumer Price Index for Rural Labourers) stood at 3.92 per cent and 4.09 per cent in July 2021, compared to 3.83 per cent and 4 per cent, respectively, in June 2021," the labour ministry said in a statement. The major contribution

towards the rise in general index of agricultural labourers and rural labourers came from food and miscellaneous group with 1.78 points and 1.79 points, and 1.30 and 1.31 points, respectively. cooking gas LPG price was increased by Rs 25 per cylinder - the second straight month of increase in rates. Subsidised LPG now costs

Rs 859 per 14.2-kg cylinder in Delhi, according to a price notification of oil companies. This is the second straight month of a price increase. Rates were hiked by Rs 25.50 per cylinder on July 1. Nonsubsidised LPG rates were increased on August 1 by the same proportion, and now the subsidised cooking gas prices have been raised. There is hardly any difference in the rate of subsidised and nonsubsidised cooking gas.

Industry sources said the subsidised LPG price was not raised on August 1 because Parliament was in session and the government could have been attacked by the opposition. The latest increase in subsidised LPG price now has taken the cumulative rate hike since January 1 to Rs 165 per

Asian shares slide, Dollar climbs as taper and virus fears combine

NEW DELHI: Asian stocks slumped to their lowest levels this year and the dollar hit 10-month highs as a doublewhammy of worries about global growth and an end to central bank support drove nervous investors toward safe assets.

Commodities were also sold with oil down for a sixth straight session and at three-month lows, while growth bellwether copper fell to a two-month

MSCI's broadest index of Asia-Pacific shares outside Japan dropped 1.63 per cent to its lowest level since December. S&P 500 futures fell 0.4 per cent and Euro STOXX 50 futures were off 0.86 per cent towards

the end of the Asia day.

Japan's Nikkei share average fell 1.1 per cent to its lowest since early January pulled down by Toyota Motor whose shares tumbled on news that it will slash its output by 40 per cent next month due to a chip shortage.

"You can't find a bull out there," said Kay Van-Petersen, a global macro strategist at Saxo Capital Markets in Singapore.

He said "an accumulation of things," from the spread of the Delta virus variant to a tech crackdown in China and the impression from Federal Reserve minutes that a slowdown in asset purchases looms, was enough to hit fragile sentiment
















4X400M RELAY U-20 WORLD **C'SHIPS**
