PM calls for effective contact tracing, strengthening health infra amid Omicron scare

NEW DELHI: Prime Minister Narendra Modi, chairing a high-level meeting on Thursday to review the public health response measures for containing and managing Covid-19 and strengthening health infrastructure including availability of drugs and oxygen cylinders amid the growing Omicron scare, called for prompt and effective contact tracing, ramping up of testing, and accelerating vaccination.

He was briefed about the emerging scenario globally driven by the new variant, with an overview of surge in cases in countries having high vaccination coverage and presence of Omicron variant. He was also apprised of the technical brief and priority actions recommended by the WHO in the context.

A snapshot of the status of Covid-19 and its Omicron variant in the country, including states reporting a higher number of cases, districts reporting higher positivity, and higher number of clusters was



briefed about the actions taken when the first advisory of the Health Ministry was shared with the states. The PM directed the officials to maintain a high level of vigil and alertness at all levels. He directed the Centre to

Former GJM leader Binay Tamang joins TMC

KOLKATA: Months ahead of the Gorkhaland Territorial Administration (GTA) election, former GJM leader Binay Tamang, who had quit the Hills-based party earlier this year, joined the ruling TMC on Friday. Rohit Sharma, an

ex-legislator of the Gorkha Janmukti Morcha (GJM), also followed suit.Both of them were handed over TMC flags by state ministers Moloy Ghatak and Bratya Basu.

Asked about his stance on the Gorkhaland issue, Tamang said development of Darjeeling and Kalimpong hills tops the list of his priorities. "Development of hills is my top priority. The BJP is issue to fool the people of the Darjeeling and Kalimpong.

NIA files chargesheet in Dera follower's targeted killing case



NEW DELHI: The National Investigation Agency (NIA) on Thursday chargesheeted four Khalistan Tiger Force Operative in connection with the case of targeted killing of 'Dera Saccha Sauda' follower Manohar Lal. The chargesheet was filed before a special NIA court in Mohali under sections 120B, 109, 201 and 302 of IPC, sections 16, 17, 18, 18B, 20 and 23 of Unlawful Activities (Prevention) Act, and section 25 (1A), 25 (6), 25 (7) and 27 Arms Act against.

Those who are chargesheeted by NIA are Kamaljeet Sharma alias Kamal, Ram Singh alias Sona, Arshdeep Singh alias Arsh and Hardeep Singh Nijjar. The NIA officials said that Nijjar and Arsh are presently living in Canada.Initially, in November 2020 a case was filed with Dyalpura Police Station of Punjab in connection with the targeted killing of Dera Saccha Sauda follower Manohar Lal by two persons identified as accused Kamaljeet Sharma and Ram Singh alias Sona. Later on the case was transferred to NIA to further probe the matter.

NIA found in the probe that accused Hardeep Singh Nijjar, self-styled chief of Khalistan Tiger Force (KTF), a designated terrorist, along with his associate Arshdeep Singh alias Arash had formed a gang and recruited gangsters Kamaljeet Sharma, Ram Singh and others. He chose the Punjab based people. After recruiting them, the persons were given task go threaten and extorting money from Punjab based businessmen. Later they indulged in target killing of the persons to disturb the communal harmony in Punjab. The NIA collected evidences against the accused. After making a foolproof chargesheet they filed it before the concerned court.Further investigation in the case is continued. AGENCIES

IAF's MiG-21 plane crashes in Rajasthan's Jaisalmer JAIPUR/DELHI: A MiG-21

anarchy in Punjab: Channi; Oppn leaders condemn Ludhiana blast

CHANDIGARH: Punjab Chief Minister Charanjit Singh Channi on Thursday said as the Assembly polls are drawing near, some anti-national forces are trying to spread anarchy in the state. He said this after a bomb blast in the Ludhiana district courts complex left one person dead and six injured. Meanwhile, Punjab Congress chief Navjot Singh Sidhu, Union Minister Gajendra Singh Shekhawat, former CM Amarinder Singh, Delhi CM Arvind Kejriwal and Shiromani Akali Dal president Sukhbir Singh Badal also condemned the attack.Talking to reporters in Chandigarh soon after the incident, Channi termed the alleged sacrilege bids and the Ludhiana blast a "big conspiracy".

"As the elections are nearing, some anti-national and anti-state forces are trying to commit such disgusting acts and for this, the government is alert and people should also be alert," he said.Channi said earlier sacrilege attempts were made but they did not succeed. Now, this blast has been carried out, the CM said.Later in the

He said the body has not been removed from the site so that the crime concerns over the challengexpressed fear that an attempt is

being made to "spread anarchy" ahead of the state Assembly polls.Channi later at a public meeting in Ludhiana's Mullanpura Dakha sought to draw a parallel between the registration of an FIR against Akali leader Bikram Singh Majithia, the blast and the recent alleged

sacrilege bids. He questioned as to why such a horrendous incident took place only after Majithia was cornered by the law.Majithia (46) was on Monday booked under the Narcotic Drugs and Psychotropic Substances Act on the basis of a 2018 status report of a probe into the drug racket in the state. Asked if it appears to be a suicide bomber and why would have this particular day been chosen, Channi said, "Sometimes, it appears we are doing political talk. Anti-national forces trying to spread Man believed to be carrying explosives killed in Ludhiana blast: Punjab CM

CHANDIGARH: A man, who is believed to be carrying ex-

plosives, was killed and five others were injured in a suspected IED blast in the district court complex in Ludhiana on Thursday, Punjab Chief Minister Charanjit Channi said.The state has been put on high alert after the blast. It is learnt that the Home Ministry has sought a report from the Punjab government on the incident. Channi, who reached the spot to assess the situation along with Home Minister Sukhjinder Randhawa and other Cabinet colleagues, told the media that such incidents have seen a rise after the government tightened its noose against the drug traffickers.Channi, who smelt a plot before the Assembly elections slated early next year, also called it a 'conspiracy' by those trying to polarise the voters.

The blast took place at around 12:22 pm in a washroom on the second floor of the court complex when the court was functioning. The court is located close to the district commissioner's office.Putting the state on



alert after the incident, DGP Siddharth Chattopadhyaya said, "We cannot comment on anything. Only the experts can tell the kind of explosives used, but the district, state, and central forensic agencies are on it. Every crowded place is on alert, the public should also be careful.'

Condemning the incident, Channi said inimical forces seeking to vitiate the peaceful atmosphere of the state would never succeed in their nefarious designs."Everybody knows the timing and the handiwork of these forces as the gating the matter," Bhullar Assembly polls are drawing

Kejriwal slams Punjab govt over sacrilege, drugs cases

CHANDIGARH: Aam Aadmi Party (AAP) national convener Arvind Kejriwal on Friday alleged a conspiracy behind the recent cases of sacrilege and explosion, and said the weak government ruling Punjab has failed to crack the whip.The Delhi chief minister, who is on a visit to Punjab, also called the drug case against Shiromani Akali Dal leader Bikram Singh Majithia a political stunt .A bomb exploded in the district court complex in Ludhiana on Thursday, killing one person and injuring six others, prompting the Punjab government to declare a high alert in the state.

Police suspect that the man killed in the blast may have been trying to assemble or plant the explosive device. Few days ago, there were cases of sacrilege. Now, there is a blast in Ludhiana. Such incidents before polls are being done under and stable government that vitiate the

state. It is the handiwork of a few people, Kejriwal said during an interaction with reporters in Amritsar.He said he has full faith in the people of Punjab and that they will defeat the nefarious designs of those trying to foment tension.Hitting out at the Channni-led dispensation, he said, There is a weak government in Punjab. They (ruling party leaders) are fighting amongst themselves. Punjab needs an honest strong government which can act against those indulging in conspiracies.He said the person who attempted sacrilege at the Golden Temple must must have been sent by someone influential to foment tension and that there were several cases of sacrilege over the last five years.Such incidents will keep taking place until a strong government takes over, he said.He promised an honest, strong

Probe deeply into Pegasus surveillance

t is difficult to disagree with the argument that there cannot be a parallel probe by any inquiry commission into the allegations of unlawful surveillance using the Pegasus spyware after the Supreme Court ordered an independent inquiry. It is no surprise, then, that the top court has stayed the functioning of the Commission constituted by the West Bengal government and headed by retired judge, Justice Madan B. Lokur. Chief Minister Mamata Banerjee had taken note of the allegations of surveillance that possibly targeted personages in West Bengal, and was on good legal ground when she took the first legal step towards unearthing the truth. It was a step that was warranted by the circumstances then, given the Union government's refusal to acknowledge that it possessed such spyware or whether those identified by an international media investigation as targets were subject to any sort of surveillance in the country. Reports by an international consortium of journalists said that 300 out of 50,000 likely targets of Pegasus spyware were Indians. Subsequently, the Government also refused to cede any ground in the Supreme Court, and declined to give a simple 'ves' or 'no' reply to the Court's questions. The Government inevitably invited an order from the Court for an independent investigation. It is significant that the Bench, headed by the Chief Justice of India, N.V. Ramana, ruled that the bogey of national security was not an adequate reason not to have a credible inquiry into the allegations. A fresh report suggesting that Pegasus was used to target jailed activist Rona Wilson's mobile phone underscores the urgent need to persist with the investigation into the illegal use of the spyware in India. There is much riding on this judicially overseen inquiry, and it behoves the government of the day to extend its full cooperation and not pose any impediment to its independent functioning.

DR ANAND KRISHNAN BELIEVES COMPREHENSIVE NATIONAL SURVEYS WILL HELP MORE THAN OMNIBUS NFHS Needed, a public health data architecture

n a country perennially thirsty for reliable health data, the National Family Health Survey (NFHS) is like an oasis. It has a large volume of data that is openly accessible. The report of the fifth round of the NFHS was recently released (covering phase 2 States where data collection was delayed due to the novel coronavirus pandemic). Since then, we have had a spate of articles by journalists and scientists covering different aspects (malnutrition, fertility, domestic violence to name a few). It is the go-to source for many researchers and policy makers and is frequently used for various rankings by NITI Aayog.

For the uninitiated, the NFHS is a large survey conducted in a representative sample of households throughout India which started in 1992-93 and is repeated at an interval of about four to five years. It is the Indian version of the Demographic and Health Surveys (DHS), as it is known in other countries. Currently, the survey provides district-level information on fertility, child mortality, contraceptive practices, reproductive and child health (RCH), nutrition, and utilisation and quality of selected health services. The respondents are largely women in the reproductive age group (15-49 years) with husbands included. The fifth round covered 6,36,699 households, 7,24,115 women, and 1,01,839 men across the country. Each survey costs upwards of Rs 250 crore and the funding for different rounds of NFHS has been provided by the United States Agency for International Development (USAID), the Department for International Development (DFID), the Bill and Melinda Gates Foundation (BMGF), UNICEF, the United Nations Population Fund (UNFPA), and the Ministry of Health and Family Welfare, Government of India.

Over the years its scope has been expanded to include HIV, non-communicable diseases, or NCDs (tobacco and alcohol use, hypertension, blood sugar, etc.), Vitamin D3. It has now become an omnibus train where anyone and everyone is free to climb into for a ride. It offers something for everyone. While there is a level of efficiency in adding some questions to an existing survey, this has been lost a long time ago in the NFHS. In NFHS-4, the household questionnaire had 74 questions, the women's questionnaire was 93 pages long with 1,139 questions and the men's questionnaire



was 38 pages long with 843 questions. The NFHS-5 questionnaire was even longer. The size of the survey has obvious implications for data quality.

The NFHS is coordinated by the International Institute for Population Sciences (IIPS Mumbai) and the actual survey is outsourced. There is an entrenched set of agencies which survive on this survey. Issues have been raised on the quality of these agencies and their workers. The NFHS is not the only survey that the Health Ministry conducts. In the last five years, it has conducted the National NCD Monitoring Survey (NNMS), the National Mental Health Survey (NMHS), the Global Adult Tobacco Survey (GATS), the alcohol survey, the Comprehensive National. Nutrition Survey (CNNS) and many others. Many of these have been implemented by premier academic institutions at costs below Rs 25 crore, though none of these generated district-level estimates

Some of these surveys are done to meet the global commitments on targets (NCDs, tobacco, etc.). However, the requirements for the monitoring of NCD targets are not met by the NFHS, as it covers an age group different than that needed for the global set of indicators. Yet, efforts to get the NNMS sanctioned met with stiff resistance as decision-makers felt that the NFHS was enough to answer those questions. As already said, for tobacco we have another vertical survey. Then why do we have questions on these in the NFHS? It is because

we are confusing research with programme monitoring and surveillance needs. Questions on domestic violence and blood collection for vitamin D3 levels are good examples of this lopsided thinking.

There have been previous attempts to align these surveys but they have failed as different advocates have different "demands" and push for inclusion of their set of questions. While the Department of Planning, Statistics and Programme Monitoring is supposed to take a final call, it lacks the technical capacity and the heft to do so and ends up using a "please-all" approach of accepting all requests with some effort at alignment. Everyone is happy, except perhaps the stakeholder with no power of negotiation - the household which is selected for the survey

Another reason why these questions are not dropped altogether is that the NFHS is the only major survey that India has a record of doing regularly. One does not know if and when the other surveys will be repeated. For example, we do not have any surety that the second round of the NNMS will be conducted, though it is due. So, the general thinking is that "do whatever is possible, as something is better than nothing". Multiple surveys also raise the problem of differing estimates, as is likely, due to sampling differences in the surveys. We noted this for example in tobacco, where differences in tobacco use estimates of the Global Adult Tobacco Survey (GATS) and the NNMS needed a lot of effort at reconciliation and explanation. Another example is the issue of wide divergence in sex ratio at birth reported by the NFHS and the Sample Registration System (SRS). The SRS is a better system for it as it continuously enumerates the population unlike the NFHS which is a crosssectional survey well known for recall biases.

It is time we questioned this rationale and end the over-dependence on one omnibus survey to provide all public health data for India. The experience of the NFHS and other surveys has conclusively demonstrated our capacity to conduct large-scale surveys with computer-assisted interviews and reasonable quick turnaround and cost. Can we now show that we have the capacity to plan the public health data needs for the country and ensure that these data are collected in an orderly and

regular manner with appropriate budgetary allocation? This requires clarity of purpose and a hard-nosed approach to the issue. Some tough calls will have to be taken including questioning the need for vertical surveys, ir-

respective of national or international funding. We have to identify a set of national-level indicators and surveys that will be done using national government funds at regular intervals I propose just three national surveys — an abridged NFHS focusing on Reproductive and Child Health (RCH) issues, a Behavioral Surveillance Survey (focusing on HIV, NCD, water sanitation and hygiene (WASH)-related and other behaviours) and one nutritionbiological survey (entails collection of data on blood pressure, anthropometry, blood sugar, serology, etc.) done every three to five years in a staggered manner. We need to look at alternate models and choose what suits us best. This does not include data sources on mortality and the health system.

I also propose, as was done for the NNMS, that we take a national-level sample for such surveys and ask States to invest in conducting focused State-level surveys. States have to become active partners including providing financial contributions to these surveys. For a detailed understanding on some issues, each round of survey can focus on a specific area of interest. Other important public health questions can be answered by specific studies (which may or may not need a national-level study), conducted by academic institutions on a research mode based on availability of funding. It is also very important to ensure that the data arising from these surveys are in the public domain. This enables different analyses and viewpoints to be presented on the same set of data enriching the discussion and unlocks the full potential of the survey.

Are we ready to establish a public health data architecture that a country of our complexity needs? We have the technical capacity to do so. All it requires now is the political will.

Pocker Sahib, a Muslim League member from Kerala in the Constituent Assembly, was prophetic when he outlined his concerns about the possible impact of centralisation of powers. In 1948, he said: "Now after we have won freedom, to do away with Provincial Autonomy and to concentrate all the powers in the Centre really is tantamount to totalitarianism, which certainly ought to be condemned." Today, amid the pandemic, some elenents of this sta e quite stron ent resona the States with some of them raising complaints about the Union government's anti-federal moves. Prior to the pandemic, a series of steps by the Union government undermined the principles of federalism, especially fiscal federalism. This manifested in the increasing monetary share of the States in Centrally Sponsored Schemes (CSS), the terms of reference of the 15th Finance Commission, imposition of demonetisation without adequate consultation with the States, institutionalisation of the Goods and Services Tax (GST), outsourcing of the statutory functions under the Smart Cities Mission, a delay in transfer of GST compensation, 'One Nation One Ration', etc. Besides tightening the purse strings of States, administrations also witnessed an onslaught on the principles of federalism during the pandemic. States were curtailed in aspects relating to COVID-19 management such as procurement of testing kits, vaccination, the use of the Disaster Management Act, and the unplanned national lockdown. Ironically, Union Ministers used the 'health is a State



These coercive policies, coming on top of the pandemic-induced economic shock, have worsened the fiscal situation of State governments. The impact of COVID-19 on fiscal federalism deserves to be understood in greater detail, and tax collection is a good place to start. Enlarging the non-divisible pool of taxes in the form of cess in petrol tax and instituting the Agriculture Infrastructure and Development Cess have resulted in a situation where the Union continues to exclusively benefit ion. As the economic co Vivek Kaul said, the share of non-divisible pool cess and surcharge in total taxes collected by the Union government jumped from 12.67% in 2019-20 to 23.46% in 2020-21. On December 6, 2021, the Union government informed Parliament that its share in the total contribution of the petroleum sector to the exchequer for 2020-21 was 68%. which left only 32% to the States. In 2013-14, the Jnion:State share was almost 50:50. The story is the same with GST. During the pandemic, the Union government repeatedly violated the compensation guarantees to the States under the GST regime. Delay in paying the States their due worsened the impact of the economic slowdown. The crisis was aggravated in July 2020, when the Union government proposed borrowing as an option to address the shortfall in GST compensation. Most States, forced by economic pressure, had to accept the proposal. In effect, this meant that they were not only getting the share of GST collections due to them, but were now forced into debt which they would have to

service. The GST compensation period expires in 2022, and despite multiple requests from the States, the deadline has not been extended. The Comptroller and Auditor General found that the Union government, in 2018-19, wrongly retained Rs 47,272 crore of GST compensation cess in the Consolidated Fund of India - money that was supposed to be transferred to the States. It is also pertinent to recollect that the 2021-22 Budget Estimates indicate that the States' share of Union tax has reduced to 30% against the mandated 41% devolution prescribed by the 15th Finance Commission Cash-starved States have been seeking nontax avenues to generate funds to sustain their programmes. And at this point, the Union government issued a clarification that funding to the Chief Minister's Disaster Relief Funds will not be considered as CSR expenditure, unlike the case with PM-CARES. This was followed by decisions like the suspension and transfer of the Member of Parliament Local Area Development (MPLAD) funds to the Consolidated Fund of India. This led to a major crisis situation for most States and resulted in demands for increasing borrowing limits under the Fiscal Responsibility and Budget Management Act (FRBM), from 3% to 5%.

Bengal advisor seeks urgent GST council meet to scrap tax hike in textile

MUMBAI: Amit Mitra, the advisor to West Bengal Chief minister Mamata Banerjee, on Friday requested Union Finance Minister Nirmala Sitharaman to hold an urgent meeting of the GST Council and rescind the seven per cent tax hike in the textiles sector to prevent job loss and closure of small units.The union government had notified to increase the tax on natural fibre products from 5 per cent to 12 per cent, including apparels in the lower tax bracket with effect from January 1, 2022. If the tax is not reversed then the impact will be huge with job loss to 15 lakh people, including those engaged in ancillary industry and closure of one lakh small units. A lot of units will revert to the informal sector, Mitra told reporters in a virtual media meet.He accused the Centre of not discussing the issue in the GST council before announcing the hike in tax.

Mitra, who is the former finance minister of the state, said that at a time when wholesale inflation in the country is already 14 per cent, the additional burden of seven per cent tax on textile will push it up and cause loss of job. The sector engages 39 million people. He said that the government is hurting 80 per cent of the textile industry to correct the inverse tax issue in the man made textile sector. Natural fibre segment constitute 80 per cent of the Rs 5.4 lakh crore textile sector and its net profit margin is between one and three per cent making them vulnerable to any kind of cost impact.The cotton sector is already reeling under 70 per cent inflation, he

NEW DELHI: The Centre on Friday imposed stock holding limits on soyameal, which is used as a raw material in the poultry feed industry, till June 2022 to curb hoarding as well as check price rise. The limits will be in place till June 30, 2022 and an order in this regard was issued with effect from December 23. an official statement said. Besides, the government has notified an order under the Essential Commodities Act to declare 'soyameal' as an essential commodity up to June 30, 2022 by amending the Schedule of the Essential Commodities Act, 1955. Soyameal processors, millers and plant owners can hold a maximum stock of 90 days production and they are required to declare the storage

cation. Government-registered trading companies, traders and private chaupals can hold a maximum stock of 160 tonne with a defined and declared storage location.If stocks held by legal entities are higher than the prescribed limits, then they have to declare the

same on the food ministry's portal http://evegoils.nic. in/soya_meal_stock/login' and bring it to the prescribed stock limits within 30 days of the issue of the notification. It should be ensured that soyameal stock is regularly declared and updated on the portal, the statement said. The data on the portal will be regularly monitored and any follow-up action will be taken by the Department of Animal Husbandry and Dairying.

"The above measures are expected to stop any unfair actices (like hoarding, black marketing etc) in the market having the potential to hike the prices of soyameal," the statement said. The stock limits have been set in consultation with the Department of Animal Husbandry and AGENCIES Dairying.



WASHINGTON: The US will lift travel restrictions on eight southern African countries that it imposed to try to blunt the spread of the Covid omicron variant, the White House announced on Friday.

The variant, which was first detected by scientists in South Africa, has since spread around the world. The World Health Organisation and leaders in southern Africa criticised the travel ban as ineffective and unfairly damaging to local economies.

The November 29 ban barred nearly all non-US citizens who had recently been in South Africa, Botswana, Eswatini, Namibia, Lesotho, Malawi, Mozambique and Zimbabwe. The restrictions will be lifted on New Year's Eve


