Punjab CM orders probe into whopping debt of ₹3 lakh cr

CHANDIGARH: Punjab Chief Minister Bhagwant Mann on Monday ordered an inquiry into how the state has a whopping public debt of Rs 3 lakh crore and where was

"We will inquire as to where the money was spent and will order recovery into where this money was spent. This was the public money, "Mann said in a tweet.

As per official figures, the total outstanding debt of Punjab as on March 31 was projected at Rs 2, 52, 880 crore, which is 42 per cent of the GSDP for 2020-21 and the outstanding debt is likely to be Rs 2, 73, 703 crore in 2021-22, which is 45 per cent of the GSDP.

Twenty per cent of the annual budget is being spent only to pay the interest on the loans.

As per the latest findings of the Comptroller and Auditor General of India, the state's financial crisis is set to worsen with the debt likely to reach Rs 3.73 lakh crore by 2024-25. Government officials that the state's debt has increased

by Rs 1 lakh crore in the past five years under the previous Congress government, largely owing to populism. Responding to the Chief Minister's decision, the Shiromani

Akali Dal (Badal) welcomed the decision to order a probe into the Rs 3 lakh crore debt acquisition but said the inquiry should not be used to

SC sets aside Allahabad HC order granting bail to Ashish Mishra



NEW DELHI: Supreme Court of India on Monday cancelled the bail granted by the Allahabad High Court to Ashish Mishra, son of Union minister Ajay Mishra, in the Lakhimpur Kheri violence case. A special bench of Chief Justice N V Ramana and Justices Surva Kant and Hima Kohli also asked the accused to surrender in a

The top court on April 4 had reserved its order on a plea of

farmers seeking cancellation of bail to Mishra. Earlier, the high court had granted bail to him. On October 3 last year, eight people were killed in Lakhimpur Kheri during violence that erupted when farmers were protesting against Uttar Pradesh Deputy Chief Minister Keshav Prasad Maurya's visit to the area.

Four farmers were moved down by an SUV, in which Ashish Mishra was seated, according to the Uttar Pradesh Police FIR. Following the incident, the driver and two BJP workers were allegedly lynched by angry farmers.

A journalist also died in the violence that triggered outrage among opposition parties and farmer groups agitating over the Centre's now-repealed agricul-

India, UK decide to deepen defence, trade ties

NEW DELHI: In the backdrop of the rapid geopolitical turmoil, Prime Minister NarendraModi and his British expanded India-UK defence partnership and vowed to seal an ambitious free trade agreement by the end of the year.

After his wide-ranging talks with Modi on the second and final day of his India visit, Johnson said the UK is creating an Open General Export Licence (OGEL) for India to "reduce bureaucracy and slashing delivery times" for defence procurement.

The British prime minister said both sides agreed to work together to meet new threats across land, sea, air space and cyber domains and that the UK will partner with India on new fighter jet technology as well as in the maritime sphere to detect and respond to threats in the oceans.

"Today, we have agreed on a new and expanded defence and security partnership, and decades-long commitment to not only forge tighter bonds between us but to support your goal Narendra of Make in India (in defence)," Johnson said, describing Modi as his "khas dost" (special friend).

Alongside Harris and Zuckerberg, the ban includes top defense and justice officials: the CEOs of LinkedIn and Bank of America: high-profile foreign affairs commentators; as well as the editor of the Russia-focused Meduza news website.

India extends duration of USD 400 mn currency swap facility with Sri Lanka

COLOMBO: In an unstinted and multi-faceted support to Sri Lanka which is grappling with its worst-ever economic crisis, India has extended the duration of the USD 400 million currency swap facility which had been concluded with the island nation in January.

This was the first extension of an international debt instrument to Sri Lanka after the government led by President Gotabaya Rajapaksa on April 12 temporarily suspended debt servicing. The embattled government had announced an orderly default until the country came to an agreement with the International Monetary Fund (IMF) for a possible bailout package. India's unstinted and multi-faceted support to Sri Lanka continued. As ongoing currency support, @RBI extended the duration of the US\$ 400 million currency swap for @CBSL which was concluded in #January this year, the High Commission of India said on Twitter. However, the debt service suspension was not applicable to currency swap arrangements with other central banks. The debt default came as the island nation was grappling with its worst-ever economic crisis compounded by forex shortages and a balance of payments crisis. Sri Lanka had also drawn on Indian credit lines worth USD 1 billion for essential imports and separate ones for the importation of fuel.

The island nation's central bank started borrowing from other central banks and the market through swaps as reserves were lost due to money printed to keep rates down, the Economy Next news service said in a report. Sri Lanka's economists have printed money under various pretexts, delayed market rate rises through various monetary instruments and triggered currency crises for 72 years and blamed them on budget deficits and imports, the **AGENCIES**

Adopt 'nation-first' approach to decision making: PM Modi to civil servants NEW DELHI: Emphasising a

"nation-first" approach to decisionmaking, Prime Minister Narendra Modi on Thursday said there cannot be any compromise on the unity and integrity of the country and even decisions at the local level should be made on this touchstone.

Addressing civil servants on the 15th Civil Services Day at Vigyan Bhawan here, he said every decision should be evaluated on the basis of its capacity to strengthen the country's unity and integrity. PM Modi said in the country's democratic set-up, "we should be committed to three goals".

"The first goal is that there should be a change in the life of the common people in the country, their life should be easy and they should also be able to feel this ease. The common people should not have to struggle in their dealings with the government, benefits and services should be available to them without hassle," he said.

Secondly, given the growing stat-



ure and changing profile of India, it is imperative that things should be done in the global context, he said. If we do not follow the activities at the global level, it will be very difficult to ascertain our priorities and focus area. "We need to develop our schemes and governance models keeping this perspective in mind. he added.

Thirdly, Modi said, "Wherever we are in the system, our prime responsibility is the unity and integrity of the country, there cannot be any compromise. Even local

decisions should be measured on this touchstone". Every decision should be evalu-

ated on the basis of its capacity to strengthen the country's unity and integrity, Modi said, adding "nationfirst (approach) should always inform our decisions". The prime minister also underlined the need to update systems and governance models regularly, saying "we cannot deal with the challenges of today with systems of the last century".

Referring to 'Amrit Kaal', the 25-year lead-up to the centenary year of independence in 2047, Modi said it cannot just be a "routine" or simply for celebration or praising the journey from the 75th year to the 100th year of independence. "India @100 cannot be routine. This $2\bar{5}$ -year period should be seen as one unit and we should have a vision from now onwards itself. This celebration should be a watershed," he said. Every district of the country should move with

Assam Govt to approach SC for Aadhaar to NRC applicants

an Interlocutory Application in Supreme Court for providing Aadhaar cards to National Register of Citizens (NRC) applicants whose biometrics have been locked in the updating process of the citizenship document.

The decision was taken at a Cabinet meeting, chaired by Chief Minister Himanta Biswa Sarma, here on Wednesday evening.

Later Sarma tweeted: Approval to filing of an IA (Interlocutory Application) in the Supreme Court for relaxation of Para 9 of the SOP and for providing Aadhaar cards to NRC applicants whose Aadhaar cards are kept on hold because of existing SOP.

This, he said, will benefit a large section of people below poverty line, students, pensioners, job seekers who do not have Aadhaar cards.

Over 27 lakh NRC applicants in the state had submitted their biometrics during the claims and objections phase for updating the state's NRC. Of these 19 lakh names were not included in the final draft of the NRC published on August 31, 2019, and these people are now facing problems in generating

Aadhaar as their biometrics

Assam Government will file have been locked due to a Supreme Court directive.

The state government had said in the Assembly last month that it has written at least twice to the Centre in the last two years requesting them to allow the Aadhaar card issuing authority to access the biometrics of at least those people whose names had figured in the NRC final draft.

Niti Aayog releases draft battery swapping policy **NEW DELHI:** Government

think tank Niti Aayog on Thursday released a draft battery swapping policy under which all metropolitan cities with a population above 40 lakh will be prioritised for development of battery swapping network under the first phase. The Aayog in its draft policy

further said all major cities such as state capitals, UT headquarters and cities with population above 5 lakh will be covered under the second phase, given the importance of the two-wheeler and three-wheeler vehicle segments in growing cities

According to the draft policy, vehicles with swappable batteries will be sold without a battery, providing the benefit of lower purchase costs to potential EV owners. It said any individual or entity is free to set up a battery swapping station at any location, provided that the specified technical, safety and performance



standards are adhered to. Considering the constraint of

space in urban areas for setting up charging stations at scale, Finance Minister in her Budget speech 2022-23 had announced that the Centre would be introducing a battery swapping policy and interoperability standards in order to improve efficiency in the EV ecosystem.

According to an official statement, in this regard, Niti Aayog held an inter-ministerial discus-

sion to formulate a robust and comprehensive battery swapping policy framework in February

2022. It also held an extensive pre-draft stakeholder discussion with a wide spectrum of stakeholders representing battery swapping operators, battery manufacturers, vehicle OEMs, financial institutions, think tanks and other experts. Congress in its existential crisis is not good for democracy

ongress has been consistently decimated after every election. When the BJP under Narendra Modi and Amit Shah swept power at the Centre in 2014, the Congress ruled in nine states. Now with the loss of Punjab, the number of States where it is in power of its own is down to just two. In the last eight years since 2014, the Congress has won just five of the 45 elections held in the country.

The most ironic is its fading in Punjab where it looked all set to win, less than a year ago. Call it infighting or mishandling by party high command, it lost badly and its Chief Ministerial candidate Charanjit Singh Channi who contested from two seats, lost from both.

The PCC President Navjot Singh Sidhu too lost. Similarly in Uttarakhand, it was hopeful for a victory but the party lost with its former Chief Minister, Harish Rawat losing elections from Lalkuan. From Uttar Pradesh where party leader, Priyanka Gandhi Vadra contested on the slogan of "ladki hun, lad sakti hun" and crisscrossed the entire state and from Goa and Manipur there was no consolation for the party. It is becoming increasingly clear that Nehrus and Gandhis seem to have entirely lost to charisma to pull in votes but just targets for dynastic whipping.

The rout of the Congress does not bode good for the party and for a healthy democracy which needs a strong opposition because the recent elections were fought on the premise of a "semi-final" for the 2024 parliamentary election. The results of the latest round of assembly elections show that the BJP is well placed to win again in 2024. There now remains no doubt that come 2024 and it would pit the BJP not against the Congress but a coalition of regional parties, may be sans Congress. The Gujarat and Himachal Pradesh elections, later this year, the Karnataka election in mid-2023, and polls in in Chhattisgarh, Madhya Pradesh and Mizoram in November and Rajasthan in December the same year, could well decide the party's future. Its hope of wresting back Himachal Pradesh from the BJP later this year in the absence of six time chief minister, Virbhadra Singh, who died last year, stands little slim chance. In the two states it still rules, Rajasthan and Chhattisgarh which go to the polls next year, there is huge infighting. It is a grim reminder for the grand old party to reform or else by the 2024 General Election, it may be in power in no state at all. Democracy needs a strong Opposition to hold the government to account. Indeed regional parties are gearing up and so is Aam Aadmi Party but a motley collection of parties each eying the Prime Ministership, does not suit the best interests of a vibrant democracy. Less than a decade old AAP is the only political party other than the BJP and the Congress that is in power in two States and it has to be an important constituent of the political grouping that comes together to take on the BJP in 2024.

It is time for the Congress to act fast to check the existential crisis and set its house in order by ending adhocism. For instance, after Rahul Gandhi's resignation as president in 2019, Sonia Gandhi has been interim president and she still continues as such. Notwithstanding the complete rout in five states, the Congress still has around over 692 MLAs in the country, compared to BJP's 1,373 which confirms that everything is still not lost but Congress has to resurrect in the best interests of democracy.

West Bengal best under MGNREGA but awaits Rs 2786 crore

est Bengal has become the best performing State both in terms of allotting jobs and utilising funds under the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA). However, when it comes to receipt of funds, it has yet not received Rs 2786 crore amount due from the Centre.

"Under @MamataOfficial's exemplary leadership, Bengal ranked first among all States in 'Total Persons Worked' (Employed) in MGNREGA (2021-22). Bengal Govt. gave work to nearly 1.1 Cr people through MGN-REGA! This is the #BengalModel that @narendramodi ji could only dream of!" it tweeted.

"Bengal ranked 2nd among all States in Person-Days-Generated (2021-22), having generated 36.4 Cr of person days. Rs 2,876 Cr is PEND-ING from the Central Govt upto March 31st, 2022. We're still awaiting payment and wondering if the Govt spends more time sleeping or spewing venom!" the party said in another Twitter post.

According to statistics recently provided in Rajya Sabha by the Minister of State for Rural Development Ram Kripal Yadav, West Bengal generated more than 28.21 crore work days under the scheme so far and spent more than Rs 7,335.31 crore for it.

The Minister was replying to a question from Trinamool Congress MP Manas Ranjan Bhunia. He also said that Tamil Nadu occupied the second spot with 22.17 crore work days and spent Rs 5,981.75 crore. Andhra Pradesh was third with 18.16 crore work days, and funds worth Rs 5054.17 crore.

BJP ruled states slacken

Bhunia pointed out that the performance of BJP-ruled States such as Goa, Gujarat and Uttar Pradesh was "not impressive." Goa is ranked at the bottom of the list with 94,000 work

days and spent funds worth Rs 2.47 crore. Gujarat generated 2.93 crore work days and spent funds worth Rs 793.50 crore, while Uttar Pradesh generated 15.6 crore work days and utilised funds worth Rs 3701.54 crore.

TMC in protest mode

West Bengal's ruling party Trinamool Congress will start a massive agitation against the Union government on the issues of MGNREGA and GST dues and BSF excesses in the border areas of the state. Soon after the upcoming by polls for one Lok Sabha and one Assembly constituency, the party would launch these protests. The by polls in West Bengal will be conducted on April 12, and the results will be announced on April 16.

Besides, the Trinamool Congress leadership will also contact the chief ministers of non-BJP ruled states and urge them to be a part of a joint nationwide movement on the issues.

Political observers feel that this initiative is prompted by Banerjee's long-term plan to ensure that her party

plays a key role in forging a unity of the anti-BJP forces in the country.

Wondering whether the Centre spends more time "sleeping or spewing venom", Trinamool Congress has claimed that West Bengal was yet to receive MGNREGA dues amounting to Rs 2,786 crore from the BJP-led Union government.

The party, quoting a list recently issued by the Centre, said that the eastern state has topped the chart in providing employment under the Mahatma Gandhi National Rural Employment Guarantee Act (MGN-REGA), giving work to 1.1 crore people in 2021-22, and has come second in generating mandays under the scheme.

Government to take call on LIC IPO timing this week

NEW DELHI: Union government is likely to take a call on the timing of LIC initial public offering within this week, a senior official said.

The sale of 5 % stake or 31.6 crore shares in the country's largest insurer was originally planned for in March, but was postponed in view of the geopolitical tension.

The government has time till May 12 to launch the IPO without filing fresh papers with markets regulator SEBI.

The official said it would be a tough call to decide whether to go ahead with the retail and domestic investor demand or to wait for geopolitical tension to ease and FIIs to return to



market. A decision on timing the IPO would be taken this week, LIC's embedded value, which is a measure of the consolidated shareholders' value in an insurance company, was pegged at

about Rs 5.4 lakh crore as of September 30, 2021, by international actuarial firm Milliman Advisors. There were estimates made in certain quarters that LIC's market valuation would

be about 2-3 times its embedded value. The official said that for a company of the magnitude of LIC, such high multiplier to embedded value may not be correct. The official further said the IPO price would have to be fixed in a way that on the listing day there is an upside to the stock and investors get

Govt of India bound by assurance given to Portugal on Abu Salem: Union home secy

The Government is bound by the assurance given by the then deputy Prime Minister L K Advani to the Portugal government that the maximum sentence handed out to gangster Abu Salem will not exceed 25 years, the Union home secretary has told the Supreme Court.

In an affidavit filed in pursuance to the apex court's April 12 order, Union Home Secretary Ajay Kumar Bhalla said the assurance would come into effect once the period of 25 years expires on November 10, 2030.

"It is respectfully submitted that the Government of India is bound by the assurance dated December 17, 2002. The period of 25 years, which is mentioned in the assurance, will be abided by the Union of India at an appropriate time subject to the remedies which may be available, the affidavit said. The home secretary submitted that Salem's contention about non-compliance of assurance is premature and based on hypothetical surmises and



can never be raised in present proceedings

He also stated in his affidavit that judiciary is independent in deciding all cases including criminal cases in accordance with the applicable laws without in any way being bound by any position taken by the executive. The matter is listed for hearing before a bench of Justices S K Kaul and M M Sundresh on April 21. The top court had earlier asked the Centre to make its stand clear on the issue.

It had said that the stand on the commitment made by the Union of India would have wide ramifications the next time the

country wants to bring back any fugitive.

The top court had said that it is not satisfied with the affidavit filed by the Central Bureau of Investigation (CBI) which said that the assurance given by India to Portugal on the maximum sentence during the extradition of Salem, a convict in the 1993 Mumbai serial blast case, is not binding on Indian courts.

On February 2, the top court had sought a response from the Centre on a plea filed by Salem, serving life imprisonment for his role in the 1993 Mumbai that his imprisonment cannot

extend beyond 25 years as per the terms of the extradition treaty between India and Portugal. It had granted four weeks to the Centre to respond on a plea by Salem claiming that the 2017 judgement of TADA court sentencing him to life imprisonment was against the terms of the extradition treaty.

Salem had contended that life imprisonment awarded to Salem is against the assurance given by the Indian government to Portugal from where he was extradited.

His plea said, "Even despite the categorical assurances by the Government of India that the appellant will not be sentenced for more than 25 years which assurances formed part of judicial proceedings right till the Supreme Court of Portugal and upon which the extradition order was passed, there was a complete and gross violation by the TADA Court when it imposed sentences of serial blasts case, contending life imprisonment for certain




