The Congress leader said there is a fight between two ideologies in the country. The Congress says that we have to move forward while connecting with all, respect and protect the culture of all. The BJP works to divide, 'crush' and



'suppress'. (BJP) works to remove history and culture of tribals, he said in the tribal dominated area of southern Rajasthan. We work to connect while they work to divide. CBI raids wrong, party stands behind Chidambaram: Congress

Congress today put its weight behind party leader P Chidambaram, saying the CBI raids against him and his son in connection with an 11-year-old case are "wrong" and aimed at diverting attention from the key issues of inflation and unemployment.

The party also said P Chidambaram is a nationalist and patriot whose commitment to the country is beyond question.

The CBI registered a fresh case against Lok Sabha MP Karti Chidambaram to probe the allegation of facilitating visas of 250 Chinese nationals in lieu of Rs 50 lakh when his father P Chidambaram was Union home minister. The agency also conducted coordinated searches at 10 locations in multiple cities including the Chidambarams' residences in Chennai and Delhi.

Cong tried to suppress my nationalist Joint committee on Sikh prisoners decides voice, says Jakhar after joining BJP to meet Prime Minister & Home Minister

Former president of the Punjab Congress, Sunil Jakhar, who joined the Bharatiya Janata Party (BJP) on Thursday, said that an attempt was being made to suppress his nationalist voice in the grand old party.

BJP's national president JP Nadda inducted Sunil Jakhar into the party at the national headquarters in New Delhi.

Talking to the media after joining the BJP, Jakhar said that it was not easy to break 50 years of relationship with the Congress, from 1972 to 2022 my three generations worked considering the Congress as their family. "Stood with the party in every good and bad time. But an attempt was made to suppress my nationalist voice in the Congress. I was given a notice to speak in the interest



of Punjab and the country, he said.

Jakhar said that fingers were pointed at him because he talked about not dividing Punjab through caste and religion.

Taking a jibe at the Congress high command, Jakhar said that he did not leave the Congress because of any individual or any personal dispute, but an attempt was made to suppress his voice. He said that his voice cannot be stopped, neither can it be mortgaged.

Referring to his meeting with Prime Minister Narendra Modi in the past, Jakhar said that although it is not constitutionally possible, he has given special status to Punjab in practical terms. Thanking the BJP high command for the open-hearted welcome, he said that he never used politics

for his personal gain. "I have always worked not to break but to unite and even after joining the BJP, I will always work for the betterment and unity of Punjab, " he added.

Welcoming Sunil Jakhar into the BJP, the party's na-tional president J P Nadda said that due to Punjab being a border state and the attitude of Pakistan, it is necessary to strengthen the nationalist forces in Punjab.

Pakistani woman, separated during Partition, reunites with Indian siblings after 75 years

Seventy-five years after she was separated from her family during the violence at the time of the Partition, a woman born in a Sikh family who was adopted and raised by a Muslim couple met her brothers from India at Kartarpur in Pakistan's Punjab province, according to a media report on Wednesday. At the time of the Partition, Mumtaz Bibi, who was born in a Sikh family, was an infant who was lying on the dead body of her mother killed by a violent mob, the Dawn newspaper reported.

A couple named Muhammad Iqbal and Allah Rakhi adopted the baby girl and raised her as their own daughter, naming her Mumtaz Bibi. After the Partition, Iqbal settled at Varika Tian vil-



lage in Sheikhupura district of Pakistan's Punjab province.

Iqbal and his wife did not tell Mumtaz that she was not their daughter. Two years ago, Iqbal's health suddenly deteriorated and he told Mumtaz that she was not his real daughter and she belonged to a Sikh family.

SC orders release of Rajiv Gandhi assassination case convict A G Perarivalan

Invoking its extraordinary power under Article 142 of the Constitution, the Supreme Court Wednesday ordered the release of A G Perarivalan, who has served over 30 years in jail in the Rajiv Gandhi assassination case

A bench headed by Justice L Nageswara Rao said the Tamil Nadu state cabinet's advice recommending the premature release of all seven convicts in the case was binding on the governor. The apex court also discarded the Centre's argument that the president exclusively has the power to grant pardon in a case under section 302 the Indian Penal Code, saying this would render article 161 (power of governor to grant pardon) functionless.

The bench, also comprising Justice B R Gavai, held that states have the power to advise and aid the governor in case of



pleas of pardon under article 161 made by convicts in murder cases. Article 142 of the Constitution deals with the Supreme Court's power to exercise its jurisdiction and pass order for doing complete justice in any cause or matter pending before it. The article was also used in the Ram Janmabhoomi-Babri Masjid land dispute case.

SAS NAGAR: Punjab Minister for Animal Husbandry, Fisheries and Dairy Development Kuldeep Singh Dhaliwal today held a meeting with progressive dairy farmers and fish farmers at livestock complex here. In this meeting, they discussed the problems being faced by dairy farmers and fish farmers.

Speaking on the occasion, the Cabinet Minister said that the Government is committed to diversify agriculture, for which a massive campaign will be launched across the state to promote the allied occupations of agriculture, dairy farming and fisheries, and animal husbandry in a big way and to make the state a leader in this field.

The minister also appealed to the youth to opt for these allied farming practices and said that the government will extend maximum help to those who are willing to dopt these practices.

Earlier, Daljit Singh, president of the PDFA Committee, dairy farmers have also taken up suggestions for setting up a stabilization fund for milk prices, besides increasing the rates of milk, providing cheap feed, etc. It also demanded a stringent law to crack down on adulterated milk trade by existing dairy farmers. Minister Dhaliwal said that still



GYANVAPI SURVEY Report submitted to Varanasi court

A commission appointed by a court here to conduct a survey of the Gyanvapi Mosque-Shringar Gauri complex filed its report on Thursday, submitting documents, videos and photographs.

Special Advocate Commissioner Vishal Singh said he has submitted the report on the survey conducted on May 14, 15 and 16.

"I do not have the right to tell what is in the survey report. Now the court will take further action on it," he told the media outside the court.

The Supreme Court, meanwhile, asked the Varanasi court to not proceed with hearing the Gyanvapi case till the apex court takes up the matter on Friday. Some parts of the complex

were also surveyed on May 6 and 7 under a team led by advo-



cate Ajay Mishra, who has since been removed by the court as the advocate commissioner.

Mishra also filed a report on the survey he conducted in the court of the District Civil Judge Ravi Kumar Diwakar late Wednesday evening, said Madan Mohan Yadav, who represents the Hindu side in the case.

SC in Sheena Bora murder case

Appeal filed in SC against Delhi HC's split verdict on criminalisation of marital rape

NEW DELHI: An appeal has been filed in the Supreme Court challenging the Delhi High Court's split verdict on the issue of criminalisation of marital rape on a batch of petitions challenging the exception in the law that exempts husbands from being prosecuted for nonconsensual sexual intercourse

with their wives. The appeal has been filed by Khushboo Saifi, one of the petitioners before the high court.The high court on May 11 had delivered a split verdict on the issue. However, both the judges

-Justice Rajiv Shakdher and Justice C Hari Shankar--on the bench concurred with each other for granting a certificate of leave to appeal to the Supreme Court in the matter as it involves substantial questions of law which requires a decision



from the top court.

The Supreme Court on Thursday sentenced Congress leader Navjot Singh Sidhu to one year rigorous imprisonment in a 1988 road rage case, saying victims of crime are humiliated when the offender is let off with a relatively minor

punishment. In 2018, Sidhu was let off with a meagre fine of Rs 1,000. The review plea was filed by the family members of 65-year-old Gurnam Singh, who had died in the road rage incident involving Sidhu.

A bench of Justices A.M. Khanwilkar and Sanjay Kishan Kaul said: "A disproportionately light punishment humiliates and frustrates a victim of crime when the offender goes unpunished or is let off with a relatively minor punishment as the system pays no attention to the injured's feelings."

It observed that indifference to the rights of the victim of crime is fast eroding the faith of the society in general and the victim of crime in particular in the criminal justice system.

The bench pointed out that the sentencing philosophy for an offence has a social goal that the sentence has to be based on the principle that the accused must realise that the crime committed by him has not only created a dent in his life but also a concavity in

the social fabric. Allowing the review petition, the bench said: "We consider it appropriate to impose a sentence of imprisonment for a period of one-year rigorous imprisonment to be undergone

Samajwadi Party MP Shafiqur Rehman Barq on Thursday said the claimed discovery of a Shivling in Varanasi's Gyanvapi mosque complex was false propaganda and urged opposition parties to counter it. The local MP said Hindus and Muslims should ensure that such propaganda

is stopped as every mosque is now being seen with suspicion. He asked why Muslims would keep a Shivling at their place of worship as this would be idol worship, which is against the Shariat. Earlier this week, Hindu lawyers had claimed that a structure found in the `wazookhana' reservoir at the mosque during a court-ordered survey was a Shivling.

The mosque committee mem-

bers disputed the claim, saying the structure was part of the fountain mechanism at the wazookhana, where people perform ritual ablutions before offering namaz. The MP termed the BJP an RSS organisation and accused both bodies of trying to spoil the atmosphere in the country. He said the Waqf board and the All India Muslim Personal Law Board and other responsible people should work together to save the country and the Muslim community. Barq also questioned the Uttar Pradesh government's recent decision not to provide grants to new madrassas. "This is the result of a conspiracy to hurt Muslims. This is propaganda so that Muslims can't get education," he claimed.

Fiscal dilemmas and GST concerns of various states

ronouncing its verdict on a protracted dispute over the levy of Goods and Services Tax (GST) on ocean freight charges paid by importers, the Supreme Court recently held that such a tax was untenable. Its 153-page judgment has also dwelt at length on the nature of the recommendations of the GST Council, the constitutional body set up to oversee the operations of the indirect tax regime. Invoking the spirit of cooperative federalism, the Court has held that both the Union and State legislatures have "equal, simultaneous and unique powers" to make GST laws, and the recommendations of the Council, where they have a one-third and two-thirds voting share, respectively, are not binding on them. While amending the Constitution to pave way for the tax system that subsumed multiple central and State levies, Parliament had intended for the Council's recommendations to only have 'a persuasive value', as per the Court. This has sparked fears that individual States can start vetoing the Council's recommendations that they do not agree with, and refuse to implement them, thus threatening the 'One Nation, One Tax' edifice of a reform that took years to bring about. Oppositionruled States have hailed the verdict as upholding their rights vis-à-vis what a few termed as the 'arbitrary imposition' of Centre's decisions in the Council. While North Block undertakes a detailed review of the verdict, it is pertinent that it had argued that if the Council's recommendations were not binding, it would lead to an impasse and the entire GST structure would crumble. This does not hold water, the Court averred. That it has struck down a tax notified two days prior to the launch of the GST regime just as it is on the verge of completing five years, is perhaps, a fortuitous nudge for introspection on its journey and the way ahead. he recent South Indian films, Pushpa, RRR, and KGF 2 are rewriting Indian film history. A few years ago, it would have been unthinkable that a Telugu and Kannada film, dubbed in Hindi, would become the highest all-time grossers in Hindi. This has led to an animated discussion about not only the supposed decline of Bollywood but also the emergence of a new "pan-Indian" cinema.

The rise of the southern film industries, hitherto marginalised as "regional" cinema, and the challenge to the domination of Hindi cinema is indeed a welcome development. But its celebration as pan-Indian cinema, breaking language and culture barriers, is premature without discussing what these films represent. These three recent films (two of which have crossed the stratospheric collection record of 1,000 crore), and Baahubali before, indicate that they do not challenge dominant ideas of a homogenous nationalism, caste hierarchies, toxic masculinity, or gratuitous violence. Neither do they offer any cultural authenticity.

Neither do they offer any cultural authenticity. Such "massified" commercial films (albeit in new linguistic registers and with vastly superior technical quotient and cinematic experience) targeting the national market and the "lowest common denominator", may in fact be counterproductive to the idea of linguistic/ cultural plurality and the exploration of novel and progressive themes. Because the barriers to better, and world-class cinema is not merely the domination of Hindi films. Recently, Telugu superstar Chiranjeevi spoke about the insult he felt in the 1980s at a national award function where Indian cinema was portrayed as Hindi cinema, and how the recent South films have become a vehicle to correct that notion. The same was also reflected in Kannada star Sudeep's comments on the claim of Hindi as the national language.

Yet, this "regional" claim for an equal place in Indian cinema does not refer to the exclusions, and cultural homogenisation performed by the mega-budget, pan-Indian film emerging from the South.

Thus, RRR, for example, is steeped in a religious-inflected nationalism with a cartoonish and melodramatic take on colonialism:



the evil British versus the good Indians. It is perfectly in sync with the present climate of aggressive nationalism even though it seeks to speak from a linguistic marginality. In this nationalism, while Subhas Bose, Sardar Patel, Bhagat Singh, Shivaji, and others from the South are unsurprisingly present, Gandhi, Ambedkar and Nehru are missing.

More seriously problematic is the appropriation of the trope of Adivasi liberation to the nationalist cause, and thus making it seem that the oppressors of Adivasis were merely the British. This is a move, as I have argued before, seen in movies like Lagaan. One of the two heroes Bheem, who is purportedly based on the legendary – but ignored – Gond leader Komaram Bheem, is shown in the film as asking the other protagonist Ram, a savarna Hindu, to educate him. This, writer Akash Poyam (a Gond himself) points out, casts Bheem as an innocent "noble savage" while in reality it was Komaram Bheem who coined the slogan, "Jal, Jangal, Jameen" which is shown as being inscribed by Ram in the film. Other films like Pushpa and KGF are also not breaking any new ground, but reinforcing many of the tired masala conventions like a poor hero taking on the state-criminal nexus and as a saviour of the toiling masses,

etc. Yet, they have been lauded as cater-

ing to small-town India, and the so-called

masses, something which Bollywood has largely moved away from with its focus on the urban middle classes, the elite, NRIs and multiplexes. But this is a reductive understanding which posits the masses as capable of appreciating cinema only with excessive violence, misogyny and the low brow, and the urban rich as not the purveyors of the same. Yet, the recent blockbusters drew big crowds in the multiplexes as well as in the diasporic audiences.

Similarly, some scholars have argued that the success of Pushpa and KGF is that they exemplify the local against the nationalist rhetoric of the Hindi cinema, a contention that is questioned by the success of Baahubali and RRR.

There is a need to go beyond such simple/ only binaries of local vs. national, class vs. mass and Hindi vs. non-Hindi, or the anointing of new formulaic productions with monster budgets and targeting the national market as a pan-Indian film. Instead, there is a need to conceive pan-Indian cinema as one which is socially and cinematically expanding boundaries, culturally rooted and yet nationally/globally resonant, and as one which is a conversation among the languages. The seeds of such a pan-Indian cinema were already present before the market success of the recent South blockbusters.

Pushing the envelope

For a decade now, the "new generation" films in Malayalam have rewritten Indian cinema history in their own way, and have captured national attention, especially since the flourishing of OTT platforms. There has been an explosion of films, especially small ones, dealing with an array of subjects and pushing the envelope in so many directions. Films like Maheshinte Prathikaram, Ozhivudivasathe Kali, Ottal, Angamaly Diaries, Kumbalangi Nights, Jallikattu, The Great Indian Kitchen, Pada, and so many others became successful because they moved away from male superstar-driven formulas.

Yet, if new Malayalam cinema has not fully contended with caste, there has been a veritable revolution in tackling caste oppression in Tamil cinema from the 2010s with films like Attakathi, Madras, Kabali, Kaala, Pariyerum Perumal, Asuran, Karnan, Sarpatta Parambarai and Jai Bhim. They also showed that films with radical themes are not dichotomous with superstars starring in them or mass commercial success. The latter was also proved with the huge all-India success of the Marathi film Sairat.

An empty celebration of the present southern blockbusters as pan-Indian cinema is scotching the above trends besides ignoring other possibilities within Kannada and Telugu industries themselves which produced excellent small films and cultural nuggets like Thithi and C/oKancharapalem.

Thus, the scope for a real pan-Indian cinema is immense but can be only realised by the infrastructure (theatrical, and not just OTT) to experience the best cinematic content across different Indian languages. Until the Indian audience is able to, for instance, watch the National Award winning Byari, in the tiny Beary language, or the internationally acclaimed Khasi film lewduh in their own languages (not just in English), the idea of a real pan-Indian cinema would be stillborn.

South Asia has a very diverse set of ecosystems. To begin with, Bhutan, India and Nepal combined have thousands of glaciers, surrounded by lakes and alpine ecosystems.

The Khangchendzonga Biosphere Reserve, established in 2018, is a good model. It includes some of the highest ecosystems in the world, with elevations up to 8,586 metres. The reserve is home to orchids and rare plant species. At the same time, more than 35,000 people live there. Their main s are crop production animal husbandry, fishing, dairy products and poultry farming. Bangladesh, India, the Maldives, and Sri Lanka all have extensive coastlines, with coral reefs and mangrove forests. These areas are exposed to extreme weather events (storms, floods, droughts), and sea-level rise. The Maldives are recognised as the lowest-lying country in the world, with a mere elevation of 1.5 metres above the high tide mark. Together with UNESCO. the archipelago has embarked on a plan to establish pilot sites for the conservation and restoration of coastal ecosystems, and to enhance the population's knowledge on climate change adaptation. Separately, three biosphere reserves have already been created in the Maldives.

climate, environmental education, and water and waste management, supported by scientific research and monitoring. The aim is to detect changes and find solutions to increase climate resilience.

All biosphere reserves are internationally recognised sites on land, at the coast, or in the oceans. Governments alone decide which areas to nominate. Before approval by UNESCO, the sites are externally examined. If approved, they will be managed based on an agreed plan, reinforced by routine checks to ensure credibility. but

Because of our collective excesses, the ecological carrying capacity of planet earth has largely been exceeded. This trend needs to be redressed, with cleaner air, high quality drinking water, and enough food and healthy habitats to ensure that ecosystem services continue to benefit humanity without critically affecting nature's balance. Whether we look at nature from an environmental, from a cultural or even from a religious point of view, it is our responsibility and clearly in our interest to respect the environment.

In fact, the possibilities exist, and all is not lost. In the last 50 years or so, much has been accomplished for the protection of nature, including the establishment of conservation areas, and a number of international conventions have been signed and ratified.

One of the best mechanisms that has been created is the World Network of Biosphere Reserves, created in 1971 by UNESCO. Biosphere reserves are plac-

es where humans live in harmony with nature, and where there is an effective combination of sustainable development and nature conservation. They represent pockets of hope and proof that we are not inexorably headed towards a doomsday

ecological scenario, provided we take appropriate action. In South Asia, over 30 biosphere reserves have been established. The first one was the Hurulu Biosphere Reserve in Sri Lanka, which was designated in 1977 and comprises 25,500 hectares within the tropical dry evergreen forest.

In India, the first biosphere reserve was designated by UNESCO in 2000 within the blue mountains of the Nilgiris. It stretches across the States of Tamil Nadu, Karnataka and Kerala. The network has gone from strength to strength, and it now counts 12 sites, with Panna, in the State of Madhya Pradesh, as the latest inscription in 2020. We need many more biosphere reserves and pockets of hope, and the region offers



MUMBAI: Equity benchmarks fell sharply on Thursday, mirroring a sell-off in global markets, with the Sensex and Nifty tumbling over 2.60 per cent on across-the-board selling.

Persistent foreign fund outflows also continue to dampen sentiment. The 30-sĥare BSE benchmark Sensex dived 1,416.30 points or 2.61 per cent to settle at 52,792.23. During the day, it tumbled 1,539.02 points or 2.83 per cent to 52,669.51.

The broader NSE Nifty tanked 430.90 points or 2.65 per cent to end at 15,809.40. From the Sensex firms, HCL Technologies, Wipro, Infosys, TCS, Tech Mahindra, Tata Steel, IndusInd Bank and Kotak Mahindra Bank were the major laggards. ITC and Dr Reddys emerged as the gainers. Barring Shanghai, other Asian markets ended lower, with Seoul, Hong Kong and Tokyo settling in the red. Equity exchanges in Europe were also trading sharply lower in the afternoon session. Stock markets in the US had ended deep in the red on Wednesday.

NEW DELHI: Cooking gas LPG price was on Thursday hiked by Rs 3.50 per cylinder, the second increase in rate this month following the firming of international energy rates.

costs Rs 1,003 per 14.2-kg cylinder in the national capital, up from Rs 999.50 previously, according to a price notification of state-owned fuel retailers. This is the second increase in LPG rate this month and the third in less than two months. The price was hiked by Rs 50 per cylinder on March 22 and again by the same quantum on May 7. Since April 2021, prices have risen by Rs 193.5 per cylinder. Petrol and diesel prices however continue to be on freeze for the 43rd day in a row. The pause followed rates being hiked by a record Rs 10 per litre in a matter of 16 days beginning March 22.

UK Foreign Secretary Liz Truss said on Monday evening that the two Nordic countries should be integrated into NATO, which operates on a collective defence basis under which an attack against any one ally is considered as an

attack against all allies. The UK strongly supports applications for NATO membership from Finland and Sweden. They should be integrated into the alliance as soon as possible; their accession will strengthen the collective security of Europe, said Truss.

Russia : Nearly 1,000 Ukrainian fighters left Mariupol plant

The Russian Defence Ministry says that nearly 1,000 Ukrainian troops holed up in their last stronghold in Mariupol have handed themselves over.

Russian Defence Ministry spokesman Maj. Gen. Igor Konashenkov said Wednesday that 694 Ukrainian soldiers at the Azovstal steel plant have surrendered over the past 24 hours.

That brings the total of Ukrainian troops who have left the plant this week to 959. The Russian Defence Ministry reported Tuesday that 265 Ukrainian troops, including

51 wounded, had surrendered during the previous 24 hours. Ukrainian authorities did

not confirm the latest numbers. Konashenkov said that there were 29 wounded soldiers among the 694 troops

While it may seem somewhat astounding that a country has managed to get so far into the pandemic without an outbreak, North Korea has reportedly had its borders sealed since January 2020, with no movement in or out of the country. So it is plausible that they've had no COVID until now.

But now, the country, which has a population of roughly 26 million people, looks to be facing a very sizeable and rapidlyspreading outbreak of the omicron variant

As of May 17, 1.4 million cases of fever had been reported, with 56 deaths since late April. The country is treating fever as indicative of COVID infection owing to reported shortages of testing supplies.

Of course, we don't know how many of these cases of fever

declared COVID-19 a pandemic theory could lead to an overestimation of case numbers. At the same time, a proportion of cases are likely to be asymptomatic, and a lack of reporting coupled with limited surveillance means there is a likelihood of underreporting. The healthcare system in North Korea is reported to be fragile, especially away from the capital city of Pyongyang. An outbreak could easily

overwhelm the health facilities in some areas. This would have a knock-on effect to other areas of healthcare, further limiting access to care for non-commu-

nicable diseases, for example. A lockdown will at least buy the country some time to implement other public health measures, such as vaccination campaigns. It is thought that North Korea has a lower prevalence of some of the conditions which we know increase the

risk of severe COVID, such as obesity, compared with many other Asia and Pacific countries. However, more than ten mil-

lion people in North Korea are considered to be food insecure (where having access to suffi-

dered the army to distribute cient safe and nutritious food is medicines and supplies, while not guaranteed). And we know malnutrition increases the risk of severe disease with COVID. Another factor which increas-

es risk is older age. An estimated 10 per cent of the population in North Korea is aged 65 or over, and roughly another 19 per cent aged between 50 and 64. So there are a large number of people who may be vulnerable to severe illness if they contract COVID.

How will things play out ? New variants of concern may emerge from this outbreak, though given the lack of contact with the rest of the world, they may not be easily exported.

There have been several humanitarian catastrophes related to uncontrolled COVID outbreaks, perhaps most notably in India, where it is likely that hundreds of thousands, if not millions, died in just a few months.

With uncontrolled outbreaks on such a large scale, the true death tolls can only ever be estimated. The situation in

North Korea threatens a similar humanitarian catastrophe. We know infection numbers can get very large very quickly, particularly with omicron being even more infectious that previous variants.

Routine datasets, such as death registers and certificates indicating cause of death, are likely to be limited and of low quality. Public reporting may be non-existent, and if surveillance data is revealed, the accuracy of the findings should be given very careful consideration. This COVID outbreak is likely to create a high burden of disease in North Korea, putting huge pressures on the health system. The population will undoubtedly suffer greatly, whether or not public reporting of health outcomes shows the full fallout.

There is an urgent need for widespread COVID vaccination, particularly of older and vulnerable people. Now would be a very good time for North Korea to overcome its usual suspicion of the outside world, and accept international offers of help.

But Hans Grundberg was wary of making any prediction, saying that agreement on an extension would depend on the talks that he and his office are having with the warring parties. During these past six

weeks we have seen considerable positive impact on the daily lives of many Yemenis, he told reporters after a closed briefing to the UN Security Council. First, and most importantly, the truce is holding in military terms.

The two-month truce is the first nationwide cease-fire in six years in Yemen's civil war, which erupted in 2014. That vear, the Iranian-backed Houthis seized the capital, Sanaa, and forced the internationally recognised government into exile. A Saudi-led coalition entered the war in early 2015 to try to restore the government to power.
