Punjab CM fulfilling another guarantee promised with the people of state during elections, the Punjab Chief Minister Bhagwant Mann announced providing free electricity up to 300 units per month to the power consumers in the state. In a statement, the Chief Minister said that the guarantee of providing free electricity up to 300 units has started from today i.e July 1 2022. He said that this means that people will get free power as

they will have zero amount electricity bills. Bhagwant Mann also said that in a major relief to common man in the state, all electricity bills prior to 31 Dec 2021 will be waived off.

celebrations, Finance Minister Nirmala Sitharaman said Rs 1.4 lakh crore is the "rough bottom line" for monthly GST revenue collections.

This is the fifth time that the monthly GST collections crossed the Rs 1.40-lakh-crore



mark since inception of GST and fourth month at a stretch since March 2022, the ministry said in a statement. During June, revenues from

import of goods were 55 per cent higher and the revenues from domestic transactions (including import of services) were 56 per cent higher than the revenues from these sources during the same month last year. The total number of e-way bills generated in the month of May 2022 was 7.3 crore, which is 2 per cent less than 7.4 crore e-way bills generated in the month of April 2022, the ministry added.

GST collections in May was Rs 1.41 lakh crore and in April hit a record high of Rs 1.68 lakh crore.

Forex reserves rise



The country's foreign exchange

reserves increased by USD 2.734 billion to USD 593.323 billion for the week ended June 24 on the back of a surge in the core currency assets, the Reserve Bank of India (RBI) said on Friday. In the previous reporting week, the overall reserves had declined by USD 5.87 billion to USD 590.588 billion. In the week ended June 24, the forex reserves swelled due to an increase in Foreign Currency Assets (FCAs), a major component of the overall reserves, and also in gold reserves, RBI said. FCA increased by USD 2.334 billion to USD 529.216 billion, according to the Weekly Statistical Supplement released by RBI. Expressed in dollar terms, FCAs include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves.

Govt hikes gold import duty to 15 %

The government has hiked gold import duty to 15 per cent from 10.75 per cent to check current



low metal. The duty changes came into effect from June 30. Earlier, the basic customs duty on gold was 7.5 per cent, now it will be 12.5 per cent. Along with agriculture infrastructure development cess (AIDC) of 2.5 per cent, the effective gold customs duty will be 15 per cent. There has been a sudden surge in imports of gold. In the month of May, a total of 107 tonnes of gold was imported and in June also the imports have been significant e surge in gold imports is putting pressure on the current account deficit, the finance ministry said.

Army, Navy begin recruitment under Agnipath scheme

NEW DELHI: The Indian Army and Navy began their recruitment processes under the Agnipath scheme on Friday, the defence ministry stated. The Indian Air Force had on June 24 started its recruitment process under the scheme and it received 2.72 lakh applications till Thursday, the ministry said. Violent protests against the scheme had rocked several states for nearly a week after it was unveiled on June 14 and opposition parties demanded its rollback. The Ministry of Defence on Friday said on Twitter, "Registration for Agniveers in Indian Navy begins from Friday. 'Join the Indian Army. Fulfill your dream of serving the country as Agniveer. Registration open for Agnipath recruitment scheme from July 1," it said. Under the Agnipath scheme, youths from 17-and-a-half years to 21 years will be inducted into the armed forces for a four-year tenure, while 25 per cent of them will

Encounter between ULFA(I)-security forces in Assam

A suspected ULFA(I) cadre was killed in an encounter with security forces in Kakopathar area of Assam's Tinsukia district on Friday, a police officer said. Five members of the group managed to escape.

Tinsukia superintendent of police Debojit Deuri said, There was a group of six militants holed up in a house. In a joint operation by the police and army, one militant has been killed. The deceased has been identified as ULFA(I) member Gyan Asom, Deuri said. Another official said the area near the house where the encounter took place had been cordoned off and a search operation was on for the militants who managed to flee. The police and army had launched the operation against the militants earlier in the day. The militants had reportedly lobbed a grenade at the security personnel and opened fire on them, leading to retaliatory action by the police and the army team.

Sebi fines Rs 11 cr on NSE, others in algo trading case



Capital markets regulator Sebi on Thursday imposed penalties totalling Rs 11 crore on 8 entities, including National Stock Exchange (NSE) and its former chiefs Chitra Ramkrishna and Ravi Narain, in a case pertaining to software related to algorithmic trading.

The regulator has levied a fine of Rs 1 crore each on NSE, Ramkrishna and Narain. Also, a fine of Rs 1 crore has been imposed on Suprabhat Lal. who was a NSE official at the time of violation.

Assam's flood situation remained grim with eight more people losing their lives while a population of over 30 lakh are affected.

Most parts of Cachar district headquarter town Silchar remained waterlogged. The toll due to floods and landslides this year increased to 159 with eight more people dying in six districts Nagaon, Lakhimpur, Barpeta, Biswanath, Dhemaji and Morigaon, according to a bulletin issued by the Assam State Disaster Management Authority (ASDMA).

One person was also reported missing in Cachar district. An Inter-Ministerial Central Team has reached Assam to assess the damage caused by the calamity. Rivers such as the Brahmaputra, Beki, Kopili, Barak and the Kushiyara are flowing above the danger level at various places.

Chief Minister Himanta Biswa Sarma held a virtual conference with the deputy commissioners of the floodaffected districts and directed them to pay Rs 3,800 to each

In Silchar, several areas are still waterlogged and the situation is still critical with a shortage of food, drinking water and medicines being faced by the affected people.

Cachar Deputy Commissioner Keerthi Jalli said that continuous work was going on to repair the damaged portion of the dyke breached at Bethukundi which led to the waterlogging in the town. Work is also going on to by August 15, Sarma said. Our

repair the breached dyke at Barjuri under Katigorah revenue circle of Cachar district, she added.

Meanwhile, the ASDMA bulletin said that 2,608 villages under 75 revenue circles have been affected across the state while 3,05,565 people have taken shelter in 551 relief camps. Relief materials were distributed from 355 delivery points among flood-hit people who have not taken shelters in the relief camps. The worst affected districts include Cachar with a total population of 14,31,652 followed by Nagaon with 5,19,463 and Barpeta with 4,00,502.

Two embankments were breached, one each in Biswanath and Udalguri, while 221 roads and five bridges have been damaged. According to the bulletin, 557 houses were fully damaged while 602 have been partially damaged due to the floods. A crop area of 76,115 hectares has been inundated while 51 animals were washed away and 10,39,293 affected.



Ban on single-use plastic kicks in from July 1

As the ban on certain single-use plastic items kicks in from Friday, state governments will initiate an enforcement campaign and close down units engaging in production, distribution. stocking and sale of such items, Union Environment ministry officials said.

Violation of the ban will invite punitive action, including a fine or a jail term or both, detailed under Section 15 of the Environment Protection Act (EPA) and under bylaws of respective municipal corporations, they said.

For effective enforcement of the ban, national and state-level control rooms have been set up and special enforcement teams formed to check illegal manufacture, import, stocking, distribution, sale and use of banned SUP items, officials in the ministry said. States and Union Territories have been asked to set up border checkpoints to stop the interstate movement of any banned SUP items.

The Central Pollution Control Board has also launched a grievance redressal application to empower citizens to help curb the use of plastic. Officials said plastic used for packaging in the FMCG sector is not banned but will be covered under the



Extended Producer Responsibility (EPR) guidelines. The EPR is a producer's responsibility to ensure environmentally-sound management of the product until the end of its life.

According to the CPCB, India generates around 2.4 lakh tonnes of SUP per annum. The per capita SUP production is 0.18 kg per year. On August 12 last year, the ministry had issued a notification prohibiting manufacture, import, stocking, distribution, sale and use of identified SUP commodities, including polystyrene and expanded polystyrene from July 1, 2022.

The identified SUP items include earbuds, plastic sticks for balloons, flags, candy sticks, ice-cream sticks, polystyrene (thermocol), plates, cups, glasses, forks, spoons, knives, straws, trays, wrapping or packaging films around sweets boxes, invitation cards, cigarette packets, plastic or PVC banners of less than 100 microns, and stirrers



Assam - the largest state of Northeast India, suffers every year the tragedy of horrific rains and incessant floods. Everyone knows that there will be floods during the monsoon season. This has been happening for decades. The floods are also so severe that delivery of relief material becomes a big task for the armed forces and NDRF. Millions of people become homeless and get upset because every time their property gets ruined hopelessly. Houses get submerged in the flood water, as is happening this time again in Assamand elsewhere. Floods continue to wreak havoc in 28 districts of the state of Assam, with Silchar district being the most affected, where more than one lakh people are trapped on the second or third floors of their houses, or on the roofs, as the lower floors are submerged in flood waters and are completely submerged. Moreover, thieves come stealthily in boats and flee after robbing closed shops and houses.

In Assam, the Indian Air Force is providing necessary help to citizens in flood-hit areas as part of a flood relief drive, but food packets and water bottles are running out as the demand is ever-growing. The Air Force is in need of more water bottles and food packets that are being dropped from helicopters. Relief materials are not reaching the needy people properly, who say that black marketing is at its peak in the area. There a bottle of drinking water is being sold at an exorbitant price of Rs 500 each, while a simple candle is selling at Rs 50 each. There is no electricity in the flood-



affected areas in Assam, so in are being forbidden to go the dark of night, the candle becomes the support of the suffering people. When the tragedy of floods repeats itself every year, and everyone knows about it, then why not some long-term plans are worked out to combat the misery? The state government should think about it along with the central government. So that the citizens there do not have to be a victim of floods every year. Something similar is the

case with Uttarakhand, where the Char Dham Yatra is at its peak, but some flaws have been found in the all-weather road built for this journey leading to Kedarnath and other spiritual destinations in the Himalayas. Geologists and other experts opine that several water bodies were buried under the debris. Due to which water is seeping into the huge stationary rocks and reaching inside, due to which there is a danger of the rocks slipping down. 

Even after 5 years, GST remains a work in progress

he Goods and Services Tax (GST) Council met over two days this week – its first 'regular' meeting after a ninemonth break – with much on its plate, stemming from four ministerial groups' recommendations to fix various aspects of the indirect tax regime that remains a work in progress five years on. It ratified three of the four reports, put off one for further deliberations based on concerns flagged by a State, with a commitment to reassemble and resolve the impasse holistically in little over a month. A new ministerial panel is being tasked with figuring out the long-pending constitution of an appellate tribunal for GST disputes, to move ahead. Based on an 'interim' report of a panel to rationalise tax rates, exemptions have been scrapped on several items and rates altered for others to correct inverted duty structures. This may translate into higher prices on many goods and services (and reductions for a few) from July 18, although their impact on inflation is difficult to ascertain. However, a larger restructuring of the GST's multiple rates' structure, with an increase in levies to bolster revenues that have fallen short of expectations, partly due to rate cuts earlier effected as electoral tools, has been put off. With inflation expected to remain buoyant, that exercise may have to wait longer. Apart from the fine print of the Council's decisions, which include tighter norms on the horizon for registering new firms and closing of tax evasion loopholes, there is a more critical takeaway. That the deliberations were constructive and not combative, especially amid the brewing trust deficit between the Centre and States in the past few meetings and the prolonged pause since it last met, bodes well for the necessary next steps to make GST deliver on its original hopes. All said, the Centre and States need

ndia's record as a 'first responder' is improving by the day. Just 24 hours after a massive earthquake hit Afghanistan, the Indian Air Force moved in with tonnes of relief. That is impressive. It is also badly needed, given that the worst earthquake in 20 years hit a region that has been at war for decades. Desperate people are always open to adopting any means to survive. Apart from India, other countries will soon weigh in with aid. This might be the time to either make friends or renew hostility with old enemies

The massive earthquake was centred around Khost along the Afghanistan-Pakistan border, and measured 5.9 on the Richter Scale. Clearly, the Pakistan side would have suffered as well, though there has been no reportage on this in the Pakistani media. Like other news from the tribal areas, this one also appears to have been damped down. The proximity to the affected area also meant that Pakistan was able to send relief aid quickly. Trucks decked with banners entered Afghanistan declaring that the aid was from "the people of Pakistan". Iran also sent relief material by air. Both these efforts and the Pakistan Foreign Ministry's statement expressing condolences were reported by Xinhua There was nothing about India's effort. There was also nothing on Qatar, which is in negotiations to manage Kabul, Kandahar and Herat airports.

Stressing "historical and civilizational relationship ties" with the Afghan people, Delhi announced the arrival of a technical team to "closely monitor and coordinate the efforts of various stakeholders" for the effective delivery of humanitarian assistance. This followed the arrival of a delegation led by a senior official to Afghanistan. Afghan officials welcomed not only aid, but called for the restarting of small projects across the country. Prior to this, there were reports that Indian aid was being hoarded and diverted back to Pakistan. This meant that only a fraction of some 50,000 MT of wheat

and medicines was actually reaching the country. Delhi seems to have asked for aid to flow through the Iranian route, instead of across Pakistan, so that it would reach Afghanistan. Iran is on board, as was evident during Foreign Minister Dr. Hossein Amir Abdollahian's recent visit to Delhi, where issues discussed included provision of aid to Afghanistan.

Meanwhile, countries are responding to the United Nations' appeal for aid. That includes Taiwan, which has offered \$1 million despite not being a member of the world body due to Beijing's objections. Japan, South Korea, and the UAE have also responded to the UN's appeal. The U.S. and its primary agency, the United States Agency for International Development, made brief and similar statements without making any specific commitment. U.S. aid stands at \$512,208,314 in the current financial year, after the U.S. Treasury Department broadened the types of activities authorised under U.S. licences, and the UN Security Council allowed sanctions exemption for delivery of humanitarian aid. However, the U.S.'s response indicates the difficulties involved given the broken Afghan banking and financial systems and lack of infrastructure. A range of institutions is involved in actual aid delivery, and U.S. instructions

are that all aid should be in cash, since no banks will do business or accept letters of credit to the Afghan central bank (DAB). UN organisations also provide cash, and aid agencies have long had to use reliable local hawala networks for transfers. The main benefit to this is that money is spent within the country, rather than in physical aid sourced from the neighbourhood. The trouble is that a notoriously strait jacketed Finance Ministry will never agree to largescale Indian aid being spent in this manner. Cash transfers to the DAB are possible, but its own reach to the furthest parts of the country is doubtful.

While 'buy local' may work with food and immediate aid, the requirements for reconstruction, particularly in the present case, will have to be sourced from Pakistan. Pakistan cement companies such as Lucky Cement made their fortunes out of U.S. construction in Afghanistan, of everything from airfields to culverts, when operations were ongoing. A 2004 study reported not just the huge amounts of money being made by all those concerned, but also revealed that Afghan companies were being sidelined in favour of Turkish or Chinese ones in the country.

Also, most UN activity for Afghanistan is slotted through Pakistan. U.S. listings show that major UN agencies and the Interna-

tional Organization for Migration are present in Pakistan, where they are funded to source supplies. This includes smaller NGOs such as Red Crescent or the hundreds of others operating on the ground. Any Indian attempt at reconstruction has to take this reality on board. India also needs to encourage Afghan cement plants and related industries, and ensure optimal use of coal, which is now being exported to Pakistan at cheap prices.

Then there exists the ever-present issue of security, which was apparent from the recent attack on a gurdwara in Kabul, apparently by the Islamic State Khorasan (IS-K). The IS-K is a group of many parts, with a presence in the north, along the Pakistan border, and in Kabul. In the north, the Russians accuse the Americans of assisting the group, while in Kabul, the IS-K's worst attack was against withdrawing U.S. troops in August 2021. In recent times, IS-K has become strongly anti-India, along with al-Qaeda, which put out a video where chief Ayman Al Zawahari was een praising a Karnataka girl for defending the hijab. Even more vicious language was used in the threat made against Nupur Sharma, former BJP spokesperson, for her controversial remarks against the Prophet. A recent UN report notes that both groups are operational, and may see increased recruitment of young men with no alternatives.

India has around 400 projects in all the 34 provinces of Afghanistan. With the Taliban offering protection to foreign embassies, and acting quickly in the recent gurdwara bombing, it is possible that the Indian effort will continue unimpeded. It is also important to remember that the Taliban have never actively been anti-India. Difficulties in implementation are more likely to arise from intra-Afghan tensions rather than any hostility to India.

umour is ubiquitous; it bursts out even in the face of death. Niccolò Machiavelli, Italian political mastermind, cracked a joke before his last breath: "I desire to go to Hell and not to Heaven. In the former I shall enjoy the company of popes, kings and princes, while in the latter are only beggars, monks and apostles!" As a double-edged sword, humour is capable of inducing light-hearted moments and heavy thoughts. It is a mighty weapon in political and social discourse, an example being Socrates and his subtle and scorching critiques of decaying Athenian and politics. Like the glory that was Greece fell apart, the wonder that is India is in danger of imploding. India's constitutional cornerstone, which is the Rock of Gibraltar of the Republic, is being shaken. The darkness of totalitarianism seems to be falling upon the edifice of our Republic. We can either cry over the evidence of the downfall of the beloved country or crack jokes to detonate the darkness. Arvind Narrain, in his book, India's Undeclared Emergency: Constitutionalism and the Politics of Resistance, is of the opinion that India is slouching towards a totalitarian future. He observes: "the ambitions of a totalitarian government are far wider and its abilities far deeper than those of an authoritarian one. A totalitarian rule goes beyond retaining total control over the State to trying to 'politicize the masses' and shaping individuals in accordance with its ideology. It draws its strength and support not just from its control over the levers of the State but also from organizational



humour. Humour can inspire hope, as theses and antidotes for totalitarianism. hope is a powerful thing. It inspires us to do the impossible and helps us carry on during difficult times.

Three days after the Emergency, there was this obituary published among the classified advertisements in The Times of India, on June 28, 1975. It read: "O'Cracy, D.E.M., beloved husband of T. Ruth, loving father of L.I. Bertie, brother of Faith, Hope and Justicia, expired on June 26." Journalist Ashok Mahadevan, then 26, punched the authoritarian regime with an obituary of 22 words that mourned the demise of democracy a

Anarchism conceives the state to be unnecessary and any form of government undesirable. It presumes that man is basically a rational, honest and just animal. Therefore, if society is organised properly, then there will be no room for any kind of coercion. It is a utopian ideology indeed but it has some practical relevance.

An anarchic vision of society is nonviolent, self-managed and non-hierarchical. Anarchist thinkers hold dear to the ideal of democracy - rule by the people. "The State represents violence in a concentrated and organized form. The individual has but as the State is a soulless machine, it can never be weaned from violence to which it owes its very existence," said Mahatma Gandhi, who was a blissful anarchist. Democracy would be perfected by imbibing some idyllic dreams from anarchism. Anarchism and democracy espouse humour; whereas totalitarianism demands the silence of the grave. Works like The Good Soldier Švejk, by the Czech anarchist author, Jaroslav Hašek, which is a hilarious satire of military life, ridicules war and the state. So is Ivan the Fool by Leo Tolstoy who was a Christian anarchist, a pacifist who renounced the state as violent and deceitful. Charlie Chaplin's film, The Great Dictator, and Sacha Baron Cohen's film, The Dictator (2012), are black comedy films that underscore that humour can mercilessly humiliate totalitarian and authoritarian despots and debunk their larger-than-life image.

fronts which work at the societal level, aiming to transform society in terms of its ideology. A combination of these factors - of having an ideology as well as many organizational fronts - results in totalitarianism having an 'appeal', compared with the 'generally passive acceptance of authoritarian regimes'." India experienced an authoritarian regime during the Emergency. But the Republic's metamorphosis into a totalitarian political system is a dark novelty that demands innovative paraphernalia for the politics of resistance.

In her Origins of Totalitarianism, Hannah Arendt discerned two contradictory popular responses towards totalitarian $ism - a \mod of 'reckless optimism' and$ a belief in 'unavoidable doom'. Arvind Narrain points out that in "India today, where the dominant mood in progressive circles is hardly one of 'reckless optimism', what one is left with is 'reckless despair'. To find hope in the midst of this despair is difficult." Here lies the weightiness of

allied ideals of truth, liberty, faith, hope and justice. The death of democracy was duly dated in 1975.

In our times, constitutional democracy is inching towards a persistent vegetative state, a death without a date of demise, an obituary, mourning, and a funeral. 'Operation Lotus', a machination to torpedo elected governments in States, has become a quotidian affair and elections and democratic civility, in danger of becoming a black comedy. The citizenry cannot laugh at the Gallows speech of constitutional democracy; nor can it be a silent spectator.

Mahatma Gandhi said, "If I had no sense of humour, I would long ago have committed suicide." He exposed the vanity and the pomp of the British Empire at the cost of India's destitution by explaining why he had so little clothes on. In this example attributed to an event around the Round Table Conference in London, he said: 'The king had enough [clothes] on for both of us'



India needs to form Green Hydrogen Corridors: NITI Aayog

India needs to form Green Hydrogen Corridors and governments can look at providing grants to startups as well as support entrepreneurs to promote green hydrogen, NITI Aayog said on Wednesday. In a report titled 'Harnessing Green Hydrogen - Opportunities for Deep Decarbonisation in India', the Aayog also suggested that there is a need to facilitate investment through demand aggregation and dollar-based bidding for green hydrogen.

"Three hydrogen corridors should be developed across the country based on state grand challenges ... The governments

can provide grants and loans to startups and projects, support entrepreneurs through incubators and investor networks, and put in place regulations that manage firstmover risks," the report said. The government can also use public procurement and pur-



chase incentives (for green hydrogen) to create demand in niche markets and crowd in private investment, it added. The report suggested that the government should promote export of green hydrogen and green hydrogen-embedded products through a global hydrogen alliance. Green Hydrogen/Green Ammonia is defined as hydrogen/ ammonia produced by way of electrolysis of water using renewable energy, including renewable energy which has been banked and the hydrogen/ammonia produced from biomass. Most large economies including India have committed to net zero targets. The report predicted that hydrogen demand in India could grow more than four-fold by 2050, representing almost 10 per cent of global hydrogen demand.

The Primary Agricultural Cooperative credit societies (PACS) constitute the lowest tier of the three-tier Short-term cooperative credit (STCC) in the country comprising of approx.13 Cr. farmers as its members, which is crucial for the development of the rural economy. PACS account for 41 % (3.01 Cr. farmers) of the KCC loans given by all entities in the Country and 95 % of these KCC loans (2.95 Cr. farmers) through PACS are to the Small and Marginal farmers. The other two tiers viz. State Cooperative Banks (StCBs) and District Central Cooperative Banks (DCCBs) have already been automated by the NABARD and brought on Common Banking Software



However, majority of PACS have so far been not computerized and still functioning manually resulting in inefficiency and trust deficit. In some of the states. stand-alone and partial computerization of PACS has been done. Core sector output expands by 18.1 per cent in May

The growth of eight core infrastructure sectors expanded by 18.1 per cent in May against 16.4 per cent in the year-ago period, accord-ing to official data released on Thursday.

The output of eight infrastructure sectors of coal, crude oil, natural gas, refinery products, fertiliser, steel, cement and electricity had expanded by 9.3 per cent in April 2022, the data showed. In May, the output of coal, crude oil, refinery products, fertiliser, cement and electricity rose by 25.1 per cent, 4.6 per cent, 16.7 per cent, 22.8 per cent, 26.3 per cent and 22 per cent, respectively.

Growth rate in the production of natural gas and steel slowed down by 7 per cent and 15 per cent in the month under review as compared to 20.1 per cent and 55.2 per cent, respectively in May 2021.

Cumulatively, during April-May 2022-23, the output of these eight sectors declined to 13. 6 per cent as compared to 36.3 per cent during April-May 2021-22.

Govt Imposes Cess of Rs 23,250 per **Tonne on Export of Petrol & Diesel**

Union government today slapped an export tax on petrol diesel and jet fuel (ATF) shipped overseas by both private companies and imposed a windfall tax on crude oil produced locally by both private and state-owned companies.

"Special additional excise duty/cess has been imposed on exports of petrol and diesel at the rate of Rs 6 per litre on petrol and Rs 13 per litre on diesel," the government said. Crude prices have risen sharply in recent months and domestic crude producers sell crude to domestic refineries at international parity prices. As a result, domestic crude producers are making windfall gains.

Canadian Prime Minister Justin Trudeau warned Saturday that the US Supreme Court decision to overturn a constitutional right to abortion could lead to the loss of other rights and indicated his country would continue to allow Americans to get abortions in Canada. Trudeau called the court's decision "horrific" and voiced concern that the ruling could someday allow a rollback of legal protections for gay relationships, including the right for same-sex couples to marry. "We know that this is an extremely, not just scary, but disheartening time for so many women," Trudeau said at a news conference in Kigali, Rwanda, at the Commonwealth Heads of Government Meeting.

"Women for generations have fought for more rights in the United States, (only) to see this setback, to worry as well about how this can be expanded to more rights be taken away in the United States," he said. "This is a reminder of how we need to be



unequivocal in our defense of people's rights, in not taking anything for granted, in staying vigilant, and always standing up for woman's rights, for LBGT rights, for the rights of people who are disenfranchised and marginalized," he added. "We have a commitment in Canada to ensure, first of all, that every women has full, safe legal access to the full suite of sexual health and reproductive services, including safe and legal abortions and we've been working hard to increase access to women across the country," Trudeau said.

While Russia's invasion of Ukraine is certain to dominate an upcoming NATO summit in Madrid, Spain and other member nations are quietly pushing the Western alliance to consider how mercenaries aligned with Russian President Vladimir Putin are spreading Moscow's influence to Africa.

As the host of the summit taking place from Tuesday to Thursday, Spain wants to emphasise its proximity to Africa as it lobbies for a greater focus on Europe's southern flank in a new document outlining NATO's vision of its security challenges and tasks.

The Strategic Concept is NATO's most important working document after the North Atlantic Treaty of 1949, which contained the key provision holding that an attack on one member is viewed as an attack upon all. The security assessment is updated roughly every decade to reset the West's security agenda. The current version, approved in Lisbon in 2010, stated the risk of a conventional war on NATO territory was low.

It did not explicitly mention concerns about instability in Africa. At the time, the alliance viewed apathy as its biggest military threat; U.S. complaints that some European

members were not paying their due featured heavily in summit talks. Fast forward a dozen years, and the view looks very different from NATO headquarters in Brussels.

After Russia brought war close to NATO's eastern borders, the alliance has worked to provide Ukraine with an assortment of more powerful weapons and to avoid the very real risk of getting drawn into the fighting. But there ap-

pears to be a consensus among NATO members heading into the Madrid summit that while Russia remains concern No. 1, the alliance must continue to widen its view globally. Spain's position for an increased focus on the South is shared by Britain, France and Italy.

In their view, the security challenges in Africa arise from a Putin apparently dead-set on restoring the imperial glories of Russia as well as from an expansive China.


