

An official statement issued here today stated that an employee of Spicejet who came after entering Flight no. SG56 from Dubai to Amritsar on 15-16.09.2022 was intercepted by officers of Customs, SGRDJI Airport, Amritsar at 4:20AM.

During checking, two packets wrapped in Black adhesive tape were found in his possession. Nine Gold Biscuits weighing 1050 grams valuing Rs. 54,70,500/- were found concealed in those packets. On further interrogation, he admitted that the gold was collected



left there by an international passenger, said the official. The said employee disclosed

### Weaker sections have no hedge against inflation

he latest retail inflation data from the National Statistical Office is a sobering reminder that accelerating price gains still remain the single biggest challenge to policymakers as they try to steer Asia's third-largest economy to a more durable recovery from the pandemic-induced slump. Inflation based on the Consumer Price Index (CPI) quickened in August to a provisional 7%, from 6.7% in July, as the pace of gains in food prices as measured by the Consumer Food Price Index accelerated by a sizeable 93 basis points to 7.62%, from July's 6.69%. And rural consumers bore a disproportionately higher burden: with month-on-month changes in both food prices and overall inflation appreciably greater at 0.88% and 0.57% respectively, compared with the 0.50% and 0.46% rates of urban inflation. Of particular concern is that inflation in the prices of cereals — staple grains in every household — surged to 9.57% from the preceding month's 6.9% rate. Monthon-month the pace was a disconcerting 2.4%. The Finance Ministry has asserted that the increase in headline inflation was "moderate", even as it sought to downplay the significance of food price pressures by terming food and fuel prices as "transient components". It also pointed to the steps by the Government to cool prices. And it cited oils and fats and pulses as two items where prices had begun to ease in response to the Centre's steps. However, the prices of pulses and products quickened by 1.7% month-on-month. Services categories including housing, health, education, recreation and personal care too witnessed sequential increases in price gains. The challenge going forward would be for providers to tread carefully so as not to yet again depress consumption by raising prices too quickly. Policymakers would do well to heed the dictum of a former RBI Governor, who never tired of reiterating that 'containing the build up of price pressures is the best anti-poverty programme' as the poor 'have no hedge against inflation'.

## Climate action & cooperative federalism

ndia's procurement of 5,450 electric buses and subsequent increase in ambition to have 50,000 e-buses on the country's roads by 2030 represent the immense potential for progress on climate and

development goals through close collaboration between the Union and State governments. With the shared aim to rapidly electrify a key pillar of India's public transportation, recent governance efforts have created a new business model for e-buses. If this sector is further developed, it can reduce air pollution in cities and fuel import bills, improve the balance sheets of State transport companies, and spur domestic manufacturing and job creation.

#### State of State-owned buses

There are currently around 1,40,000 registered public buses on India's roads, with large numbers of them having sputtering engines that spew planet-warming fumes into the atmosphere. At least 40,000 of these buses are at the end of their lifespan and must be taken off the roads

However, most buses are owned and operated by State transport undertakings, which are in poor financial health. In part, they incur large losses because they play an important social function by providing subsidised fares to crores of Indians each day. With a few exceptions such as Mumbai's Brihanmumbai Electric Supply & Transport Undertaking (BEST) of the Brihanmumbai Mahanagarpalika, when State transport undertakings go to the market to buy buses, they face problems of fragmented demand and high prices. Furthermore, there are limitations to nation-wide action on this issue as State governments control issues such as transit, urban governance and pollution control.

#### A success story

Until recently, there had never been a unified



tender to address some of these challenges Cooperative federalism can easily become a fraught issue. However, in the case of the Grand Challenge 1, a tender for 5,450 buses (across five major Indian cities — Kolkata, Delhi, Bengaluru, Hyderabad and Surat), the opposite happened. Instead of a race to the bottom, the respective expertise, strengths and needs of Union Ministries and States informed the process and the successful outcomes.

Convergence Energy Services Limited (CESL), a nodal agency of the Union government, acted as the programme manager in this effort at centralised procurement in concert, with State-led demand and customisation. Coordination between a range of Union government Ministries and State governments standardised demand conditions across these five cities and discovered prices that beat the increasingly outmoded internal combustion

On a cost-per-kilometre basis, the prices discovered were 40% lower than diesel and 34% less than CNG (without factoring in the subsidy through FAME-II). A note on FAME: the Faster Adoption and Manufacturing of

(Hybrid &) Electric Vehicles in India (FAME-India) Scheme was launched under the National Mission on Electric Mobility in 2011/National Electric Mobility Mission Plan 2020, and unveiled in 2013. The scheme encourages the progressive induction of reliable, affordable and efficient electric and hybrid vehicles.

With high fuel prices and energy security challenges in the wake of the war in Ukraine, the switch to electric vehicles appears even more sensible and lucrative.

This inflection point in unit economics was enabled by three key factors: collaboration, pace and transparency. First, the tender itself was a fully consultative process and varied contributions by participants already influenced the design of future tenders. Second, there was a shared sense of urgency that shaped this collaboration, which leveraged the bureaucracy's power when working on time-bound and measurable schemes and increased receptivity to creative and new ideas. Finally, transparency was the most resilient quality of a public process. From the outset, there was clarity about the intention to engender trust and build a publicly available process and tender that invited bids from automakers and operators.

In the wake of the first tender, it was incredibly gratifying to share a feeling of success with five States, five Transport Ministers, five State Secretaries and the heads of a range of State transport undertakings, each of whom had played a part in the process

To be clear, excessive centralisation can have limitations and contradict the federal principles enshrined in the Constitution. For instance, India's States and districts vary vastly in their vulnerability to climate impacts, and decentralised decision-making and locally-led adaptation will help reduce potential damage to lives and livelihoods. Urban local bodies and

gram panchayats can be the heart of climate action.

However, in certain areas where India must move the needle quickly or where States lack size and financial clout, such as the electrification of mass mobility, centralised procurement and programme management can deliver architectural transformations rather than just incremental transitions.

#### There is much work ahead

Although a good start has been made, much work remains to be done to enable the electrification of mass mobility in India. The country's shift to clean public transportation will require a suite of efforts, from ramping up manufacturing capacity to domestic battery production to building out charging infrastructure (ideally plugged in to a grid powered by renewables) to capacity building of State transport undertakings to developing financial instruments and structures.

Nonetheless, the progress we have made on electric bus tendering is a harbinger of climate action made possible by cooperative federalism. As India now ramps up its demand to deploy 50,000 buses across 40 cities, it will need to continue the spirit of true inter-ministerial and Union-State collaboration to fulfil its ambitious targets for green and inclusive economic development. The combined clout and strength of the federal compact can enable large strides being made towards innovative models that not only improve transit, the quality of life in cities and progress towards national climate goals but also uild models for the rest of the world to emulate


### The Brunt of Unpaid work! if women stop, the world will stop



This devaluation of women's work and its exclusion has led to the reinforcement of the gendered division of paid and unpaid labour, leaving women without wages and little bargaining power in the household and allowing the vicious circle to continue where men, economy, and country prosper at their expense.

It is argued that engagement in unpaid domestic and care work is one of the prime reasons for women's low participation in economic activities. Women do an average of 75 % of the world's total unpaid care work. Women's unpaid domestic work is often invisible but has immense value. According to the International Labour Organisation (ILO), a huge 16.4 billion hours are spent by women on unpaid care work daily. This is equivalent to two billion people working eight hours per day, without payment. The actual value of this work amounts to 9% of the global GDP, which is equivalent to \$11 trillion.

Similar differences also exist in women's time allocation to paid and unpaid work by geography. In rural areas, Indian women spend more time in unpaid activities in comparison to urban areas. Women are more likely to spend less time in unpaid work and men are less likely



between 15-59 spending just 15 minutes on unpaid housework every day while women of the same age do 269 minutes of unpaid houseunpaid labour in India and the consequences for straying from the norm can be harsh. OXFAM India's 2019 household care survey found that one in three survey respondents thought that it was acceptable to beat a woman for failing to care well for the children or not attending to a dependent or ill adult member in the household . For failing to prepare a meal for the men in the family, 68 % of survey respondents thought women should be harshly criticized and 41.2 % thought they should be beaten .About 66 % of the working women surveyed in Delhi by the Institute of Social Studies Trust ( ISST ) reported an increase in household chores and 36 % stated an increased burden of child and elderly care work during the pandemic.

In this Perspective, we discuss the societal, organisational, institutional and psychological factors that explain why time poverty is often under appreciated. We argue that scientists, policymakers and organisational leaders should devote more attention and resources toward understanding and reducing time poverty to promote psychological and economic well-being. Therefore, the strong message emerging is that policymakers and employers need to act fast to

for greater gender equality in the labour market

The story of women in India being overburdened with unpaid work is centuries old. The time use survey conducted by the National Sample Survey Office (NSSO) in 2020-21 confirm a persistent pattern of "time poverty" suffered by women in India. The NSSO survey showed that women spent 84 % of their working hours on unpaid activities, while men spent 80 % of their working hours on paid work. One of the repercussions of their unpaid work burden is their lack of participation in paid work. Indian women's participation in paid employment is much lower than their male counterparts. Only 21.8 % of women aged 15-59 years were engaged in paid work in comparison to nearly 70.9 % of the men. However, if we were to take into account both paid and unpaid work, women's participation reaches 85 % men's is just 73 %.

In 2019, the time spent by Indian women on unpaid work was 10 ten times more than men. TUS 2019 shows that women participation in unpaid domestic services for household members - cooking, cleaning, household management - is as high as 81.2 per cent each day compared with 26.1 % for men. It also states that there is a wide gender disparity, with only  $18.4\ \%$  women participating in employment activities compared with 57.3 % of men; also, while men spend an average of 459 minutes (7 hours and 39 minutes), women spend only 333 minutes (5 hours and 33 minutes). There is a stark difference in the time spent by men and women in caregiving activities for a dependent child or an adult. While only 14 % of men participate in unpaid caregiving services for household members spending on average 76 minutes a day (1 hour and 16 minutes), the share of women ((2 hours 14 minutes) is almost double at 27.6 % Unlike in international TUS in India, the

reporting of time spent on various activities was not done separately by each person in the household, but often by a central respondent for all members of the household. It is entirely possible that male respondents overstated their contributions to domestic chores and understated their wives' contributions to economically productive work. In India, the 2021 state assembly elections

ffered a unique and unexpected opportunity for the recognition of women's UDCW through promises of unconditional cash transfers. Hower, direct benefit transfers (DBT) are not magic bullet for achieving women's economic empowerment. There is a fundamental need to secure an adequate financial infrastructure and financial literacy. Although some of the negative consequences anticipated by the critics of such transfers were not borne out in reality, it was noted that the patriarchal social norms around UDCW are so deeply entrenched that explicit feminist messaging on the part of the government is necessary to shift social norms towards the recognition and eventual reduction and redistribution of UDCW. In short, unconditional cash transfers like the scheme are an innovative means of recognising women's UDCW which could potentially rewrite the relationship between women and the Indian welfare state and hold critical insights for international debates on the vexed relation between paid work, unpaid work, and social reproduction. LFPR should increase. Females should not be replaced by men rather more employment opportunities should be increased for both to absorb the increasing population.



#### Japan logs record Aug trade deficit on weak yen, costly oil



Japan posted a record trade deficit in August as costs for imports of oil and gas soared, the government reported on Thursday. The 2.82 trillion ven (USD 19.6 billion) deficit. the 13th in a row, was triple the deficit logged in the same month a year earlier. Customsdata showed exports rose 22 per cent from a vear earlier as regional economies recovered from pandemic-related disruptions while imports soared 50 per cent. Energy-related imports from the Middle East accounted for about half of the deficit. Japan's currency, the yen, has weakened sharply against the US dollar as the Federal Reserve has raised interest rates to counter inflation. Surging prices for many commodities and other products are also pushing Japan's imports higher.

### Joe Biden approval rises sharply ahead of midterms

President Joe Biden's popularity improved substantially from his lowest point this summer, but concerns about his handling of the economy persist, according to a poll from The Associated Press-NORC Center for Public Affairs Research.

Support for Biden recovered from a low of 36 per cent in July to 45 per cent, driven in large part by a rebound in support from Democrats just two months before the November midterm elections

During a few bleak summer months when gasoline prices peaked and lawmakers appeared deadlocked, the Democrats faced the possibility of blowout losses against Republicans.

Their outlook appears better after notching a string of legislative successes that left more Americans ready to judge the president on his preferred terms: Don't compare me to the Almighty. Compare me to the alternative.

The president's approval rating remains underwater, with 53 per cent of US adults disapproving of him, and the economy continues to be a weakness for Biden.

Just 38 per cent approve of his economic leadership as the country faces stubbornly high inflation and Republicans try to make household finances

Still, the poll suggests Biden gaining momentum right as generating voter enthusiasm

Average gas prices have tumbled 26 per cent since June to USD 3.71 a gallon, reducing the pressure somewhat on family budgets even if inflation remains high. Congress also passed a pair of landmark bills in the past month that could reshape the economy and reduce carbon emissions.

Republicans have also faced resistance since the Supreme and its abortion protections. And Biden is openly casting



former President Donald Trump as a fundamental threat to democracy, a charge that took on resonance after an FBI search of Trump's Florida home found classified documents that belong to the US government.

This combination of factors has won Biden some plaudits among the Democratic faithful, even if Americans still feel lukewarm about his leadership.

I'm not under any belief that he's the best person for the job he's the best from the people we had to choose from. said Betty Bogacz, 74, a retiree from Portland, Oregon. He represented stability, which I feel President Trump did not represent at all.

Biden's approval rating didn't exceed 40 per cent in May, June or July as inflation surged in the aftermath the axis of the upcoming vote. of Russia invading Ukraine.

The president's rating nilar to what it w throughout the first quarter of the year, but he continues and turnout takes precedence. to fall short of early highs. His average approval rating in AP-NORC polling through the first six months of his term was 60 per cent.

Driving the recent increase in Biden's popularity is renewed support among Democrats, who had shown signs of dejection in the early summer. Now, 78 per cent of Democrats approve of Biden's job performance, up from 65 per cent in July. Sixty-six percent of Court overturned Roe v. Wade Democrats approve of Biden on the economy, up from 54 per cent in June.

### Amid inflation, Turkey launches massive housing project for low-income families

in combat and the disabled, according to Erdogan.

More than 250, 000 people have submitted their applications on the first day of its launch on Wednesday, according to Environment, Urbanization and Climate Change Minister Murat Kurum.

In Istanbul, the country largest city of 16 million people, long queues of applicants were seen outside public banks. The project was launched at a time when housing and rental costs larly in the major cities, were rising rapidly. Housing prices increased by 160 per cent in June compared to a year earlier, according to the Turkish Central Bank's latest Housing Price Index. The growth rate was 184 per cent in Istanbul and 165 per cent in Ankara. According to the Turkish

Statistical Institute, around 820, 300 homes were sold from January to July this year, a 24.2 per cent increase year on year despite high borrowing

India's economic linkage with the GCC has increased steadily, especially due to the growth in oil imports.

During 2020-21, India's exports to GCC were USD 28.06 billion. The bilateral two-way trade during the period was USD 87.36 billion.

Earlier this year, there was an unease in India's ties with some Muslim-majority countries. including Gulf nations, over the controversial remarks of two former BJP leaders on the Prophet Mohammad. All six GCC nations had condemned the remarks.
