Delhi High Court reserves order on plea opposing permission to Sikhs to carry kirpans on flights

Court on Thursday reserved its order on a plea opposing the permission given to Sikhs to carry kirpans while travelling on civilian flights

The plea, filed in a form of public interest litigation (PIL) by lawyer Harsh Vibhore Singhal, challenges the Centre's notification issued on March 4 allowing Sikh passengers to carry kirpans having blade length of no more than six inches and total length of no more than nine inches while travelling anywhere in India.

A division bench of Chief Justice Satish Chandra Sharma and Justice Subramonium Prasad said: "Arguments heard. Order reserved. We will pass an appropriate



"How can we interfere with such a policy decision? We can't interfere. It is a policy decision of the government of India, "it said.

The petitioner claimed that a committee of stakeholders should be constituted to apply its mind to the issue.

At this, the court said: "Your mind might not be the government's mind. Therefore when the government has applied its mind and has come with a policy, we ought not to interfere unless it is so arbitrary.'

No separate law yet to regulate digital media, says IT Ministry

no proposal yet to enact a separate law to regulate the digital media, and the matter is currently under consideration, said the Ministry of Electronics and IT on Friday. To help achieve the aim of

making Internet Open, Safe and Trusted and Accountable and to regulate the intermediaries, including social media intermediaries, and in exercise of powers conferred by the Information Technology Act, 2000, the Central Government has made the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021, said the Ministry in a written reply to Rajya Sabha on Friday.

These rules cast specific obligation on intermediaries to observe diligence and provide that if they fail to observe such diligence, they



shall no longer be exempt from their liability under law for third-party information or data or communication link hosted by them, it said.

Such diligence includes informing the said rules to their users to make reasonable efpublish, transmit, store, up- of the IT Act.

The Jammu and Kashmir administration will allot the families in the union territory a unique alpha-numeric code. According to the officials quoted by the PTI, the database called JK Family ID will be used to determine eligibility of beneficiaries of various social welfare schemes. Once the data in the JK Family ID database is authenticated and verified, a beneficiary will not be required to submit any more document to avail a service." Prerna Puri, the commissioner secretary of the Informa-Jammu and Kashmir, told PTI The move is part of the "Digital J&K Vision Document" unveiled by Lieutenant Governor Manoj Sinha. The Bharatiya Janata Party has hailed the move but the other parties have raised privacy concerns. "Creating 'a unique family ID' for J&K residents is emblematic of the widening trust deficit esp post 2019. Kashmiris are viewed with deep suspicion & this is another surveillance tactic to tighten the iron grip on their lives," PDP president Mehbooba Mufti said.



ShiromaniAkali Dal (Badal) president Sukhbir Singh Badal today appealed to the Sikh community to defeat forces bent on breaking Sikh institutions and wresting control over them by installing their

'Made in Pakistan' toffees with beef gelatine seized in Rajasthan

JAIPUR: Rajasthan government officials have seized 'Made in Pakistan' toffees made with beef gelatine which were being sold in a shop in Udaipur.

In the wake of complaints made by several people, a team under the Food Inspector checked a shop named Chocolate and Birthday Decoration Items located in the city's Delhi Gate Square area.

Three big packets were found in the shop. While two closed packets contained 24 'Chili-Mili' toffees each, an open packet had 23 of the candies. The team then sent samples of the toffees to a lab for examination on Wednesday evening. Results of the test are awaited.

It is being said that from this shop, goods are also supplied to other stores in the city.

Priced at Rs 20, the toffees come in a colourful pouch which has 'Made in Pakistan'



the pouch is Baii Ismail Industry Limited C-230, HITE Hub, Balochistan, Pakistan, with additional information is in Urdu language. Along with this, there is also a red mark on the toffee, which is used for non-vegetarian items. Food Inspector Ashok Ku-

mar Gupta said that the toffees were seized on the basis of a complaint, as beef gelatin is mentioned as an ingredient. Food safety lab in -charge Dr Ravi Sethi said that an investigation will be made based on label.

Solar power won't offer solutions to all energy needs

t the core of India's energy transformation is its bet on solar power. Based on a commitment to address the global climate crisis, India has promised to source nearly half its energy from non-fossil fuel sources by 2030 and, in the shorter term, source of at least 60% of its renewable energy from solar power. However, a disclosure in Parliament by the Minister for Power, New and Renewable Energy suggests that India faces a significant headwind in this quest. A key central policy to source solar power is facilitating the establishment of large solar parks; small solar power projects usually translate to higher per-unit production costs. And so, in 2014, the Centre announced the 'Solar Parks and Ultra-Mega Solar Power Projects' policy to facilitate the creation of large parks. The initial plan was to set up 25 parks capable of generating at least 20,000 MW by 2019. In 2017, the Government scaled this to 61 parks with a target of 40,000 MW. It emerges, however, as of 2022, that only a fourth of the capacity has been achieved as projects worth 10,000 MW have been commissioned. Four projects have been cancelled due to tardy progress. The roadblocks, in the Centre's estimate, have been challenges in acquiring land with a clear title, setting up the infrastructure necessary to transmit power produced at these parks to the grid and, in an unusual disclosure, "environmental issues" in Rajasthan and Gujarat, where projects have been halted because their transmission lines encroach upon the habitat of the critically endangered Great Indian Bustard. Notwithstanding its claims on international podia that it is on track to meet renewable energy targets, it is no secret that India is lagging behind. Also, solar power may be a valuable tool in India's energy transformation story, but it cannot be the panacea for all requirements.

Census: A mirror of past & present

recent study of India's experience under colonial rule by Dylan Sullivan and Jason Hickel concludes that data from the Census of India reveal that between 1880 and 1920 approximately 100 million Indians died due to British policy in India. Their method is to calculate the excess mortality, being the difference between the actual deaths and the deaths that may be expected on the basis of some benchmark. While they

used Census data for actual deaths, the

duo arrived at the deaths to be expected using two alternative benchmarks - the

mortality rate for India in 1880 and that

for England in the 16th and 17th centuries.

The assumption implicit in the choice of the latter as a benchmark is that before colonial rule, the mortality rate of India is unlikely to have been very different from that of contemporary England. The resulting estimates for excess deaths during 1880-1920 are 50 million in the first case and 160 million in the second one, respectively. The authors settle for the midway figure of approximately 100 million for the deaths caused in India due to colonial policy. For perspective, they point out that this figure is greater than the death from famine in "the Soviet Union, Maoist China, North Korea, Pol Pot's Cambodia,

and Mengistu's Ethiopia". In their view,

this provides a direct assessment of the

consequences of the Raj for India. Attempts to quantify the impact of colonial rule in India have mostly relied on the change in national income. But reliable income data for the nineteenth century are almost non-existent. Population figures, though, are available from the time of the first Census of India in 1871. The age-wise population distribution in the census has been used to estimate the mortality rate, which Sullivan and Hickel utilise to draw conclusions about the evolution of economic conditions in colonial India. Their figure for excess deaths is of course only as good as the benchmarks chosen, and the mortality rate itself is the result of estimation and not enumeration, for the registration of births and deaths became established practice in India only much later on

Subject to these caveats, the Sullivan-Hickel study does draw attention to something not so widely recognised. The mor-



tality rate in British India is seen to rise steadily after 1881, recording an increase of close to 20% by 1921. As it is unusual for the mortality rate of a country to rise continuously due to natural causes, this suggests that the living conditions worsened during this period. The mortality rate dipped in 1931, which was the last census conducted in British India, but the last famine recorded in the country was yet to come. It took place in Bengal in 1943, in the last five years of the close to two centuries of British colonial rule.

Recurring famines

British arguments for the empire, including "English forms of land tenure, the English language, banking, the common law, Protestantism, team sports, the limited state, representative assemblies, and the idea of liberty", have been advanced by the Harvard historian Niall Ferguson. But in this statement, there is no mention of the famines which started almost at the onset of rule by the East India Company in Bengal, the de-industrialisation of India in the nineteenth century, the drain of wealth, or the worsening food security as India's peasants were forced to grow commercial crops for export so that Britain could balance its trade. Indian economic historians have recorded and astutely analysed these developments. Yet, by drawing our attention to a sustained rise in the death rate at the height of the Raj, the Sullivan-Hickel study vindicates Dadabhai Naoroji's claim of the immiserisation of India under British rule.

The belief that British policy in India caused repeated famines is bolstered by the fact that there has not been a single famine since 1947. This is despite a population explosion following a sharp fall in death rates. The decline in the mortality rate surely signals improved living conditions. The Census shows that in the 1950s, life expectancy at birth of Indians increased by more than it did in the previous seventy years.

A double-edged sword

But the Census, from which we know all this, can be a double-edged sword in the hands of nationalists. The population numbers recorded after 1947 point to the extent to which the lives of Indians improved since the end of colonial rule in dimensions other than mere income. However, the mirror it holds up is not always flattering to us. It points to worsening gender inequality in India. A simple

indicator of this would be the ratio of females to males in the population. It is believed that in the absence of factors that lower the life chances of women, including foeticide, this ratio would tend to one. The Census of India shows that we have not attained that level in our recorded history,

except in pockets within the country. While this is disturbing in itself what is more so is that this ratio has steadily declined after 1947. After declining for four decades from 1951 it started inching up in 1991. But in 2011, it was yet lower than what it was in 1951. So, even though life expectancy increased soon after Independence, in the early years at least it increased faster for men than it did for women. So, though India became free of foreign rule, some Indians grew more free than others. As India chants Vasudhaiva Kutumbakam at the G-20. implying that the nations of the world are family, it behooves us to ensure that all the persons in our own family enjoy the same freedoms.

75 per cent of insect species wiped out

ave you ever noticed that there are very few species of birdsseen now around us? The number of avian species that we used to witness three-four decades ago has decreased to an alarming level. M species of birds have disappeared from the urban surroundings completely. One of the major reasons behind this change is the declining number of insects and moths, as a heavy amount of chemical fertilizers and insecticides are used in farming. This trend is seen as a global phenomenon. It is estimated that 75 percent of insect species have been wiped out from the agriculture fields. These insects and moths used to be the basic food of most birds. Obviously, the number of birds that survive by feeding on insects has also decreased. This has happened due to the excessive use of pesticides in agriculture fields. This practice not only killed the pests but also deteriorated the quality of agricultural soil.

He tries to call her but his mouth is dry from shock and from the heat. He forms the syllables of his daughter's name and whispers it into the heavy air.


Kneeling on the ground, his white salwar streaked with dust and mud. he holds on to Munia's limp feet, crying like a child, his breath rasping and hard.

Once they're gone, so is your audience", another said: "When are you going suspend @weatherchannel & @JMichaelsNews for doxxing the real live locations of all these tornado survivors in Gretna, Louisiana? You promised a dedication to free speech & now you are the suppressor."

Meanwhile, the micro-blogging platform also suspended the official account of Mastodon, a platform for people seeking a Twitter-like alternative.

BharatPe CEO enjoying life with money I raised but fails to grow company: Ashneer

Despite Delhi High Court's order to restrain from making defamatory statements against the company and its executives amid the ongoing Rs 88.6 crore fraud case, former BharatPe Co-founder and Managing Director Ashneer Grover on Monday took a serious dig at CEO Suhail Sameer, saying the CEO allegedly spent money on personal expenditures that he raised, but is unable to help the fintech firm grow.

In a tweet, Grover alleged that Sameer allegedly spent money raised by him to travel to Australia for the recentlyconcluded T20 World Cup. "Suhail (CEO) -- bahut aish kar li Ashneer ke raised funds pe. Ladkiya bhi ghuma li Australia. Par hai to hum nalle - hiring, product, tech, UNITY bank, PA license, mkt share -- kuchh nahi hil raha humse. Kya karenge? (Had a gala time with money Ashneer raised in Australia but I am unable to help the company on the hiring, product, tech UNITY Bank, payment aggregator (PA) license and market share fronts, what to do?)", tweeted Grover.

Grover then targeted Sumeet Singh, a partner with Shardul Amarchand Mangaldas who joined BharatPe as its general counsel (GC) last year. "Sumeet (GC): Case karenge! case karenge! Case karenge! (But Sumeet went ahead to file case (against me), "Grover further posted. The Delhi Hight Court last week issued notice and summons to BharatPe's former Managing Director and his kin in a plea filed by the company, seeking orders to restrain them from making defamatory statements against the company. In April this year, Grover had threatened legal action against CEO Sameer and the board for his comments on professional networking platform LinkedIn against his sister Ashima Grover, along with seeking a resignation from Chairman Rainish Kumar.

Grover last week attacked the fintech platform's co-founder Shashvat Nakrani, saying he once asked him to bunk office for a whole year in order to complete his IIT degree while remaining on the payroll. He also alleged that his book "Doglapan" created panic among BharatPe executives and this is the reason the fintech company had apparently filed

One Nation One Ration Card: Financial assistance of Rs. 46.86 Cr released to States

Their family members back home, if any, may also lift the part/ balance foodgrains on the same ration card.



One Nation One Ration Card (ONORC) plan for nationwide portability of ration cards is implemented by this Department under the Central Sector Scheme i.e. Integrated Management of Public Distribution System (IM-PDS), which was

sanctioned in April 2018 with total outlay of Rs. 127.3 Crore. The scheme is extended till 31st March 2023. So far, financial assistance of Rs. 46.86 Crore has been released to States/UTs, NIC/NICSI, etc. during last three financial years 2020-21 (Rs.12.65 crore), 2021-22 (Rs.23.76 crore) and 2022-23 (Rs. 10.45 crore). The world is not stupid, the world is not forgetful" when it comes to recognising Pakistan as the "epicentre" of terrorism, India's External Affairs Minister S. Jaishankar has said.

Pakistan, therefore, has to clean up its act and take up the global agenda of development instead of terrorism, he said on Thursday at a news conference outside the UN Security Council chamber where he had just wrapped up a special session that heard briefings on counterterrorism.

Responding to a question from a Pakistani TV journalist about how long would it take for terrorism to end in South Asia, Jaishankar said: "You're asking the wrong Minister!"

"It is the minister of Pakistan who will tell you how long Pakistan intends to practice terrorism, "he said.

Pakistan cannot confuse anyone any longer because people have figured it out" that is the "epicentre" of terrorism, the Minister added.

"So my advice is, please clean up your act to be a good neighbour. Please try and contribute to what the rest of the world is trying to do, which is economic growth, developof radicalisation and terrorism. ment." Jaishankar added that

he hoped to get this message across through the journalist's TV channel.

Asked about Pakistani Interior Minister Rana Sanaullah preparing a dossier on what he called India's involvement in terrorism, Jaishankar said it is ironic he should be making the claim.

It is because about a decade ago when Rana was a Minister, Hillary Clinton who was visiting Pakistan warned him about terrorism and said that if you have snakes in your backyard, you can't expect them to bite only your neighbours because eventually, they will bite the people who keep them, Jaishankar said.

But Pakistan is not good at taking advice, he added. At the time of the visit by Clinton who was then US Secretary of State, Rana was Law Minister of the Punjab province.

Jaishankar said that at the end of Thursday's meeting, the Council adopted a presidential statement that affirmed that any act of terrorism or crime is unjustifiable regardless of the motivation and who committed it.

The statement also stated that "terrorism in all its forms and manifestations constitutes the most serious threats to international peace and security", he said

A presidential statement is adopted by consensus and although it does not have the power of enforcement like a resolution, it carries moral

Canada's immigration backlog shrinks to 2.2 mn: IRCC



Canada's immigration backlog came down to just over 2.2 million from last month's 2.4 million, according to new data revealed by the Immigration, Refugees and Citizenship Canada (IRCC).

With this, the citizenship inventory stands at 3,14,630 applicants as of November 30, compared to 3, 31, 401 on October 31, CIC News reported.

The permanent residence inventory stands at 5,12,342 people as of December 2, compared to 5, 06,421 as of November 3.

was seen in the temporary residence inventory, which stood at 14, 16, 125 people on December 2, compared to 15, 37, 566 persons as of November 3.

As of December 2, there are 43,326 applications for Express Entry programs waiting in the queue -- an increase of over 3, 500 since November 3 data, which stood at 39, 589.

The inventory for all family class immigration programs has dropped slightly to 1, 27, 091 compared to November 3 when it was 1, 28, 112.

The Spouses and Partners sponsorship program is among the largest inventories among all lines of business, at 62, 106, a minimal increase compared with November 3.

The Parents and Grandparents Program (PGP) has an inventory of 53, 770 persons compared to 55, 653 persons waiting for decisions in November.

September 30 data showed that there were 1.5 million applications in the backlog, meaning that IRCC cleared over 3, 50, 000 applications from the backlog.

This comes while the number of applications in inventory has risen for permanent residency, CIC

News reported IRCC says that between January and October 2022, they produced 4.3 million final decisions for permanent residents, temporary residents and citizenship compared to 2.3 million final decisions in the same period last year. The Canadian citizenship body says it wants to have a less than 50 per cent backlog across all lines of business by the end of March 2023.

Vijesh also allegedly received hundreds of dollars per month from August 2019 to December 2021 in return for ordering laboratory tests from Labtech Diagnostics LLC (Labtech), in Anderson, South Carolina.

"Kickbacks can undermine a physician's medical judgment, result in unnecessary testing, and increase health care costs borne by taxpayers, "said Principal Deputy Assistant Attorney General Brian M Boynton, head of the Justice Department's Civil Division, in a statement.

"We will continue to pursue physicians, laboratories, and others responsible for schemes that violate rules intended to feguard the integrity of fe eral health care programmes,

New Zealand recorded 40,098 new community cases of Covid-19 and 35 more deaths from the pandemic over the past week, the country's Ministry of Health said on Monday.

On average, new cases per day reached 5,721 in the last week. The country has seen the number of daily cases going down steadily from over 10,000 cases nationwide in early July, Xinhua news agency reported

With the fresh cases, New Zealand has reported 2,019,685 confirmed cases of



Covid-19 and 2,257 Covid-19-related deaths since the pandemic hit the country in

early 2020, the ministry said. Currently, 514 Covid-19 patients are being treated in hospitals in the country, including 14 in intensive care units or high dependency units, according to official data.

The British economy is estimated to have grown by 0.5 % between September and October, statistics showed, but a lengthy recession is still expected in the UK October's rebound followed

a fall of 0.6 % in September, which was affected by the extra bank holiday for the funeral of Queen Elizabeth II, Xinhua news agency quoted the Office for National Statistics (ONS) as saying on Monday.

Car sales rebounded after a very poor September, while the health sector also saw a strong month, said ONS director of economic statistics Darren Morgan.

Meanwhile, construction continued its strong trend over the last year and stands at its highest level on record, with new housebuilding driving growth, At least 0.3 percentage points

of the rise was due to a return to the normal number of working falling GDP. days in October after September's bank holiday, making the economy look stronger than it really is, said Ruth Gregory, senior UK economist at Capital Economics consultancy.

However, aside from this factor, the country's gross domestic product (GDP) probably rose by 0.2 percent month on month, so it appears that GDP growth had more momentum at the start of the fourth quarter than previously thought, Gregory added.

Despite the monthly rebound, concerns mounted. Looking at the broader picture, the UK's GDP fell by 0.3 per cent in the three months to October compared with the three months to July. A decline was also seen across services and manufacturing, Morgan noted.
