



National capital Delhi minimum temperature 1.4 degree, season's lowest : IMD Amid a fresh cold wave, the

national capital on Monday plunged to 1.4 degree Celsius, the season's lowest so far, according to India Meteorological Department (IMD).

While the Safdarjung Observatory recorded 1.4 degrees, the minimum temperature around the Palam area was recorded at 5.3 degree Celsius.

The IMD has predicted a fresh spell of dense to very dense fog and cold wave conditions very likely over northwest India till January 18.

"The minimum temperatures are in the range of 7-10 degrees over many parts of Punjab, Haryana, Chandigarh, Delhi, Uttar Pradesh and Bihar; in some parts over East Rajasthan and West Madhya Pradesh. They are in the range of 3-7 degrees over many parts of West Rajasthan. The lowest minimum temperature of -0.7 degrees observed over Churu (West

Haryana state government has now started investigation of all passports prepared in the state in past five years from 2017 to 2022 under the supervision of Alok Kumar Mittal Chief CID in Haryana state.

The Regional Passport office for the states of Haryana, Punjab and Chandigarh UT is situated at Chandigarh having other passport offices at Ambala, Karnal, Sonipat and Rohtak in Haryana state. Information reveals that maximum number of fake passports were prepared at Chandigarh and Ambala offices on the basis of fake documents, fake police verifications, and those falsely introduced address of the applicants caused not only danger to national security but

Curbing freedom of Fourth Estate will be dangerous

proposal by the Ministry of **Electronics and Information** Technology that seeks to force social media platforms to take down content "fact-checked" by the Government's Press Information Bureau (PIB) as false needs to be opposed without even a second look. The proposed amendment to the IT Rules opens the door for the PIB or any other agency "authorised by the central government for fact checking" for the purpose of such takedowns. This is problematic at many levels, with deep implications for free speech and information. At the most basic level, the question to be asked is how a wing of the "nodal agency of the Government of India", whose job is "to disseminate information to the print and electronic media on government policies, programmes, initiatives and achievements", could be the deciding authority on what is factual and what is not. The disturbing absurdity of an interested party also playing the judge cannot be missed. It is a really nasty world of disinformation out there but one would have to be delusional to think that governments do not have an axe to grind. If the proposal is implemented, the government can play the super censor at will. While this proposal signals a new low in the administration's thinking on matters of regulating news and information, things were not rosy prior to this either. The government in recent years has given enough indications that it wants to control the news sphere. The reworked IT Rules in early 2021 are an example of this. A similar mindset was reflected in the provisions of the data privacy Bill that gave government agencies a free pass. Fake news has to be dealt with in an appropriate manner, but the proposal in question will only make the task harder. The freedom of the Fourth Estate is crucial for a

Pak Hockey: Learning from mistakes

ince the hockey world cup begins in Odisha, hockey fans across the subcontinent are concerned about Pakistani hockey's future. The team failed to earn a spot in the 2023 World Cup.

The Pakistan hockey team had titles like "World champion," "World beater," "hockey giant," and "champion-of-champions." It was once one of the world's leading hockey nations, dominating the last quarter of the 20th century and winning all major tournaments, but Since winning the World Cup in Sydney in 1994, the team has lost its lustre and has failed to qualify for 2023 World Cup.

Pakistan Hockey has missed the multisport competition Olympics games twice in a row, most recently in Tokyo (2021). Additionally, it also failed to qualify the 2014 World Cup and placed a dismal 12th in the 2018 competition.

In Pakistan, the end of this sport is near, and hockey's collapse seems to be practically complete. With the exception of a few victories on the Asian stage, the Pakistani hockey team hasn't been able to win any international hockey titles in the twenty-first century.

Poor management, a lack of professionalism, and government apathy are killing hockey in Pakistan. Even the Dutch coach of the Pakistan national hockey team, Siegfried Aikman, has returned home after not being paid his salary for months.

The green-shirt failed to cope with the new pace of the game, and inconsistent policies of the concerned agencies to revive the game have damaged Pakistan hockey badly. Poor sports administration, a collapsing economy, religious fanaticism, and terrorism have all ruined sports in Pakistan, including hockey. Ironically, the Pakistani sports fraternity, despite knowing the root causes of the decline of the game, is passively watching it die.

Between 1978 and 1994, Pakistan

dominated the world of hockey and won every major championship. Despite these achievements, however, Pakistan did little to create a system that would allow them to develop and sustain talent over the long term. They had lost their way and had no infrastructure in place. They did not work to develop new talents and heavily depended on those they were born with.

In order to revitalise Hockey in Pakistan, there needs to be a framework that can draw new sponsors and offer financial stability to the players. The Pakistan Hockey Federation needs a vision, just like the hockey federations in Belgium and India did. The Pakistani athletic community must persistently work on it. As the hockey teams from Belgium and India are demonstrating, it takes more than ten years to accomplish the desired outcome.

The game has changed over the years and became more fitness demanding, but according to commentators, Pakistan was left far behind in the race. Hockey would not be Pakistan's national sport if events kept going in the current way since there would be no prospect for the Pakistani hockey team to win important competitions in the future.

On the other hand Indian hockey has improved since the 2008 disaster when it failed to qualify for the Beijing Olympics because lessons were learned from that experience. The Indian Hockey Association tried to not only revitalise the sport but also to gather money to support both the game and its participants financially. The Indian Hockey Federation, which was once insolvent, is today one of the most powerful countries in the hockey world

and offers its players the best facilities.
Only through the perseverance of hockey players, supporters, and the system has Indian hockey been brought back to life. The results also reveal the narrative.

The Pakistan Hockey Federation must locate sponsors eager to support their game. Hockey players will benefit from new sponsors' financial incentives, which will increase their financial, economic, and psychological security. Furthermore, the PHL can develop local and club level players, allowing Pakistan to attract more talent, much as the Pakistan Super League

Senior Citizen Scheme, in which a minimum
pension of Rs 3000 to a maximum of Rs



10,000 per month is given. It is a pension scheme for citizens above 60 years of age in which 8 percent interest is given on deposits for ten years. Basic medical facilities for senior citizens in government hospitals and government health centers are given either free of cost or at very subsidized rates. There is a separate window for senior citizens for priority in medical tests and other government works etc. Indian

Railways gives a concession of 40 percent to men above 60 years, and a 50 percent discount to women above 58 years, on tickets in all types of trains. Similarly, almost all airlines offer senior citizen discounts of up to 50 percent on domestic flights. The front two seats are reserved for senior citizens in roadways buses of all states. Legal disputes related to senior citizens are heard in the courts on a priority basis and efforts are

made to expedite the procedure. In Himachal Pradesh, anold age pension

is being given to citizens above 60 years of age. Earlier this pension was available only to those who attained the age of 70 years, which has now been reduced by ten years. The amount of monthly pension is Rs 1000 for the 60 to 69 years age category and Rs 1700 per month for those above 70 years. To avail of this pension, senior citizens need to apply in the office of the District Welfare Officer. Age is sure to grow with time and physical weakness is happily and with dignity, depends on the individual. Some people consider old age to be a curse and they keep themselves and others unhappy. On the other hand, there are many senior citizens who spend this phase of life with laughter, joy and enthusiasm. Post-retirement life can be lived happily if preparation is done in advance for financial, mental and physical matters. 

BUDGET 2023

under section 194R

FW DESK New Delhi

The Government of India in the Budget for 2022 introduced a new section 194R -"Deduction of tax or perquisite in respect of business or profession." Which became

applicable from July 01, 2022. In accordance with the provisions of this new section, a person (or corporate entity) who is responsible for providing any benefit or perquisite to a resident, should deduct tax at source @ 10% of the value or aggregate of value of such benefit or perquisite before providing such benefit or perquisite in cash or in kind.

One of the business activities that get impacted due to these new provisions is the national and international trips or events that are organised by business entities to motivate or felicitate their employees

While we appreciate the rationale behind introducing this new provision however, we would like to request the following amendment in the same - As per the newly inserted provision, all events where the recipients or the beneficiaries are provided free participation or where their trips are sponsored, shall now come under the purview of TDS deduction.

In our opinion, considerpandemic created havoc on the above suggestion shall be the Indian hospitality sector, the Government of India should encourage organizing of domestic events and trips. if required.



This would result in increase

in revenue of our domestic players and to the revival of the hospitality sector.

In order to achieve the same, one initiative could be to provide an exemption under Section 194R only to those events or trips that are organized within India. In the present scenario where both national and international events or trips are being brought under the purview of Section 194R at the same rate, corporate entities shall not find any merit in organizing such events of trips within India as organizing the same in a foreign country adds aspirational value to it.

If an exemption is provided for events and trips within India, the corporate entities shall feel encouraged to organise the same within India which'll add to the revenue of the domestic hospitality players thereby increasing the tax contribution by the sector.

According to National Consumer Helpline (NCH) recent report, three times increase in on-line frauds has been identified in past five years in the country, most of these cyber crime cheatings have been found due to on-line purchases and miscellaneous business transactions through bank. Information reveals that during year 2018 there were nearly 60000 on-line fraud cases reported to police in the country which have now been increased to 184000 complaints reported to police stations during year 2022, on an average nearly 15320 on-line fraud cases were registered by police every month in the country, which include maximum number of on-line fraud cases reported in Uttar Pradesh, Maharashtra, Delhi, Bihar, Haryana and Himachal states. Although, the population of Delhi is much lesser as



compared to other state yet it ranks at the third position in the country as regard on-line frauds.

According to NCH report, on-line fraud cases reported at the police stations is being forwarded to police Cyber Crime Cell operating in the district for investigation and action against cheats. 

"The price of 24 carat gold is expected to touch Rs 60, 000/10 grams in couple of days. On Monday, the price was Rs 58, 550/24 carat 10 grams including taxes, " Madras Jewellers and Diamond Merchants Association President and Challani Jewellery Mart partner Jayantilal Challani told IANS.

According to Emkay Global Financial Services, the recession fear in the West and the geo-political tensions will keep gold in focus.

"Gold has been trading in a range of \$1, 800-1, 880 in the last one month. The cues from the US Fed on likely slowdown in rate tightening has helped gold prices rally from levels of \$1, 680-1, 730 to \$1, 850-1, 880 currently, Emkay Global said.

"In India, the prices are trading near an all-time high aided by the marriage season demand. Globally, it is trading 5-6 per cent lower than the all-time high level recorded in September 2022, the company said.

al, a major reason for the rally in the prices of gold has been the cues from the US Fed. After a relentless tightening on the rate as well as liquidity front, the central bank has indicated a slowdown in the pace of rate hikes as key economic indicators, and inflation has stabilised.

A slower rate hike of 25 bps

going forward has softened the US dollar, leading to a rally in gold prices. Gold is an international commodity, priced in US dollars - so a softness in the greenback lifts the prices of the yellow metal. The US dollar index, from its high of 114 level witnessed in September, has softened to 103 levels. Gold is considered a safe haven and often attracts investments in times of uncertainty and slowdown, recession in the economy. In addition, institutional buyers like the cCentral banks bought a net 50 ton of gold in November, up 47 per cent month-on-month, Emkay Global said. "This led to a rise in de-

Statistical Office Crisis-related effects, such as supply bottlenecks and significant price increases at economic upstream stages, were "characteristic of the entire year", Destatis President Ruth Brand said in a

Energy prices rose 34.7 per cent year-on-year, with prices for heating oil and natural gas even soaring 87.0 per cent and 64.8 per cent. respectively, according to Destatis.

Prices for food also outgrew overall inflation and were up 13.4 per cent, reports Xinhua news agency.

Excluding energy and food prices, Germany's annual inflation rate in 2022 would have been around half as high at 4 per cent, according to Destatis.

To ease inflationary ressure on consumers and businesses, the German government set up relief packages totaling 95 billion euros (\$102 billion).

Among the measures were a fuel discount and regular social benefits increase.

In addition, a "protective umbrella" worth 200 billion euros was set up to finance a cap on electricity and gas prices that took effect at the eginning of the year.

For the month of December last year, the state even covered consumers' heating bills in full

High inflation was "partly mitigated" through the government's relief measures, Brand stressed.

India progressing fast on energy transition

NEW DELHI: As the entire world is trying hard to find solutions to mitigate climate change, India is putting its plans together faster to conserve energy and move towards alternative ones.

"India is the front-runner in mitigating climate change globally and is progressing fast on its energy transition agenda. Today's event marks the extent to which India is willing to innovate to keep its pledge of protecting the environment while simultaneously addressing the growing demand for energy, "said Hardeep S. Puri, Union Minister for Petroleum and Natural Gas.

Talking about the progress made by India in terms of ethanol blending, the minister said, "We have increased ethanol blending in petrol from 1.53 per cent in 2013-14 to 10.17 per cent in 2022, vember 2022 deadline, and have advanced its target to achieve 20 per cent ethanol blending in petrol from 2030 to 2025-26.

Puri said that this has resulted not only in augmenting the country's energy security, but also translated into a forex savings of over Rs 41, 500 crore, reduced GHG emissions of 27 lakh MT and has benefitted farmers with expeditious payment of over Rs 40, 600 crore made to them.

The minister also mentioned about the reduction in security deposit amount from 5 per cent to 1 per cent, extending a benefit of around Rs 400 crore to ethanol suppliers for 'ease of doing business', along with reduction of GST on bio-fuel from 18 per cent to 5 per cent.

UN has urged the authorities to "stop the alleged abuse and kidnapping of teenagers, who are trafficked far from their homes and made to marry men sometimes twice their age". Rights experts, while reporting to the UN Human Rights Council (UNHRC), presented many reports, giving clear indications of outright involvement of religious authorities and the complicity of security forces and the justice system, in cases of kidnapping, forced conversions

Russia hints headway in TAPI gas pipeline project after Putin key aide visits Kabul



WASHINGTON: US President Joe Biden will deliver his State of the Union address to a joint session of the Congress on February 7, the White House has said. White House press secretary Karine Jean-Pierre told reporters that Biden had accepted House Speaker Kevin McCarthy's invitation to address a joint session of Congress on February 7, Xinhua news agency reported. This would be Biden's second State of the Union speech and the first before a divided Congress with Republicans taking control of the House of Representatives and Democrats still running the Senate.

President Vladimir Putin's Special Envoy to Afghanistan Zamir Kabulov returned home from another trip to Kabul, Moscow has indicated that the Turkmenistan-Afghanistan-Pakistan-India (TAPI) gas pipeline project, which has been facing an uncertain future after the return of Taliban in Afghanistan, could finally see some progress in the coming months.

Even though the new regime in the Afghan capital gave signals that it remains keen to continue the work on TAPI project, which has already seen more lows than highs since the first TAPI Summit held in Ashgabat in December 2010, no efforts were made to show any progress on the ground.

However, Kabulov's two-day visit to Kabul last week has fuelled a renewed push to revive the stalled project.


