Modi's Mother Heeraben Modi cremated in Gandhinagar, PM Performs last rites



NEW DELHI: Prime Minister Narendra Modi's mother Heeraben Modi, who dies early this morning, has been cremated in Gandhinagar. PM Modi, who reached Gujarat early this morning, performed the last rites. Heeraben Modi was 99.

"Smt Heeraban Modi passed away on 30/12/2022, at 3:39 am (early morning, during the treatment at UN Mehta Heart Hospital," the hospital where

she had been admitted since Wednesday said in a statement. Informing about her death, the Prime Minister posted a heartfelt tweet early this morning, "A glorious century rests at the feet of God... In Maa, I have always felt that trinity, which contains the journey of an ascetic, the symbol of a selfless Karmayogi

and a life committed to values. PM Modi, who was scheduled to launch the developmental

projects in West Bengal, may join the events through video conferencing. Heeraben Modi lived with PM Modi's younger brother Pankaj Modi at Raysan village near Gandhinagar.

The Prime Minister would regularly visit Raysan and spend time with his mother during most of his Gujarat visits.

77 major projects of education, health, PWD implemented by Delhi govt: Manish Sisodia

The Government of Delhi has implemented 77 major infrastructure projects of the education, health and the public works departments in the last five years, said Manish Sisodia, deputy chief minister, Delhi.

As per an official statement, reviewing the projects with senior officials of PWD and the other departments concerned, Sisodia said that the city infrastructure, health and education have been the top most priorities of the Delhi government.

Furthermore, the projects include the construction of over 20,000 classrooms, new sports complexes, hostels for students, hospitals, six new and two double-decker flyovers, two new university campuses, installation of more than two lakh CCTV cameras, road beautification, installation of 500 flags and the Signature Bridge in Wazirabad.

"After coming into power, it has been a priority of the Delhi infrastructure, facilities of eduhini and Dheerpur. For Training cation and health to the citizens. Delhi is a national capital and deserves the best urban infrastructure. This was neglected by the previous governments but Arvind Kejriwal made this his priority," Sisodia said.

Sisdodia further added that out of the 77 projects, 26 of them, worth Rs 8,683.81 crore, have been approved for the education sector in the past five years. "The Delhi government is also

constructing two new campuses government to provide the best of Ambedkar University in Ro-

and Technical Education (TTE) the government has constructed many new academic blocks and hostels in several technical universities. Most of these projects have either been completed or are currently ongoing," he said.

The deputy chief minister said the Delhi Government has approved 25 major infrastructure projects in the health sector in the last five years and hospital bed capacity will be increased by 20,000.

"In the health sector, the Delhi Government approved

25 major projects at a cost of Rs 4,452.72 crores which includes the construction of various new hospitals and Intensive Care Units. Road infrastructure has been given a boost with 26 projects worth Rs 6,409.33 crores," he said.

In PWD, the Delhi Government has approved 26 major projects at the cost of Rs 6.409.33 crores which include streetscaping projects in pilot phase, construction of double-decker flyovers between Bhajanpura-Yamuna vihar and Azadpur-Rani Jhansi Road.

It also includes flyovers at Shastri Park, Asharam to DND flyway, ANVT to Apsara Border, at Nagari and Gagan Cinema Junction and elevated corridor at Loni Chowk.

...Apart from these, there are various corridor development projects including the Ashram Chowk underpass and many other underpasses across the city, various bridges, subways, installation of nearly two lakh CCTV cameras, free Wi-Fi and installation of 500 tricolours across the city," he said.

Now, post-mortems allowed even after sunset: **Delhi Government**

In a significant decision, the Delhi government has now allowed authorities to conduct post-mortems even after sunset, according to an official statement. «Enabling a landmark reform in the national capital, the Delhi Government as made the post of dead bodies possible even after sunset in Delhi,» the release stated. According to the statement, the move will be a big help for relatives of the deceased, who often have to wait long hours to receive their dead. It will also encourage and facilitate organ donation and transplantation.

However, a provision has been made to only examine the dead bodies during the day in cases where there is a suspicion of murder, suicide, rape, or foul play, he added. On Tuesday, Deputy Chief Minister Manish Sisodia directed Health department officials to conduct post-mortems even at night in hospitals with adequate facilities. He also asked the hospital in-charges to ensure all necessary infrastructure at mortuaries for conducting post-mortems.

«The Delhi government had sent a proposal to the Union government for conducting post-mortems in hospitals after sunset. They will be carried out at hospitals that have adequate facilities for the medical examination. Post-mortems related to organ donations will be done on priority, he said.

He said bodies brought for post-mortems at night will be attended to without delay.

«Earlier the bodies would be kept in safe custody at night. Bereaved relatives had to wait the whole night to claim and bury their dead, making their losses even harder and more painful to bear. But now, bodies are being brought for postmortem even at night and they are being processed promptly,»

He also informed videography of the post-mortems would be done all through the night.» To avoid any doubt or confusion on the bodies, all the post mortems done at night will be video-recorded and the footage will be preserved for legal purposes.

Fresh cold wave conditions likely to continue in January: IMD



NEW DELHI: The northern parts of the country will witness fresh cold wave conditions from December 31 onwards, said India Meteorological Department (IMD). R.K. Jenamani, senior scientist at the IMD, said cold days and severe cold days are western Uttar Pradesh.

"The cold to severe cold wave is expected to continue over Punjab, Haryana, north Rajasthan and Delhi. Dense to very dense fog will continue to prevail in the belt. From December 28, there will be improvement due to western disturbance and on December 29, fresh snowfall is expected in Jammu & Kashmir, Leh and some parts of Himachal Pradesh, "said Jenamani. Drizzle can be expected in parts of Punjab on December 29, said the IMD.

Delhiites woke up to a chilly morning on Tuesday and dense fog lowered visibility in some areas of the city, affecting road and rail traffic. "A minimum temperature of 7 degree Celsius was recorded in Delhi, said the Meteorological (MeT)

The MeT office said that a layer of dense fog and moderate icy cold winds from the North were responsible for this steep fall in temperature.

"Northwesterly dry and cold winds will continue over Northwest India. However, intensity of fog may decrease leading to marginal increase in day temperatures and abatement of cold wave from parts of West Uttar Pradesh, Delhi and Haryana. Minimum temperature may also increase marginally, "said

Nearly 5000 persons die in every year in road accidents in Haryana

Bahadurgarh & Sirsa

Information reveals, nearly 5000 persons die in road accidents every year in Haryana state and life of between 80-90% accident victims can be saved in case immediate medical aid s provided to accident victims. As usually seen, over 40% accident victims succumb to their injuries unable to get first aid and timely treatment after the mishap. There are 12 Trauma Centers in Haryana state set up by state health department in districts to provide immediate treatment to accident victims which include eight Trauma Centers located in district civil hospitals at Ambala City, Karnal, Yamunanagar, Panipat, Sonipat and Rewari apart from other districts Gurugram, Hisar and Palwal functioning in private hospitals authorized by the state government.

It has been observed that these Trauma Centers are functioning merely as referral centers since most of the serious accident victims brought to these Trauma Centers are referred to PGI at Chandigarh or Rohtak or General Hospital Chandigarh after first aid, since these Trauma injured accident victim on way centers are unable to treat serito nearby Trauma Center sucous patients struggling for life cumbs to their injuries before after sustained serious injuries reaching destination generally

in road mishaps because of nonavailability of senior doctors as well as surgical instruments in these Trauma centers as a result large number of accident victims die on the way. Information also reveals that in 30-40% cases the patients are not provided even first aid and blood oozing from injuries l on the ways causes death due to excessive bleeding from the body. It is usually seen that most of the Trauma Centers are situated at a distant place

Most pharmaceutical industries in Himachal sick, on verge of closure

Kala Amb/ Baddi

Himachal Pradesh known as hub for pharmaceutical manufacturing industries have 618 units which include nearly 90% micro and small units involved in manufacturing Pharmaceuticals products holding nearly 35% share in the country. The Financial World correspondent had a talk with the entrepreneurs of large number of pharmaceuticals producing units at Kala Amb and Baddi area near Chandigarh who told that the industries in Himachal need to inject energy in their arms since most of the units especially micro and small manufacturers in the area are on the verge of closure in the absence of government support blaming hostile government policies act as hurdles and with no cure coming by sickness grips the industry. The entrepreneurs in this sector feel neglected and now look forward to the coming budget to remain alive



The General Secretary of Himachal Pharmaceutical Industries Association ManeeshThakur told that micro and small pharmaceutical industrial units in the state are facing severe financial crisis and over 50% of these have become sick and few have been closed down unable to meet tough competition among manufacturers, unable to get raw material and some other reasons. He said, most of the units were set up in the state due to tax rebates in Himachal state which have now been withdrawn by the government after GST was introduced.

Thakur said, among other maior reasons for the sickness of pharmaceutical industry in the state, especially in Kala Amb and Baddi area include shortage as well as costly labour, less amenities available to industry, no connectivity with any highway, non-availability of transport in few areas including Kala Amb and Baddi having maximum number of pharmaceutical manufacturing units, tough competition among manufactures, no research and development centre related to industry in the area and above all lack of support by the government.

3 women to be attached in Haryana **SATISH HANDA**

Haryana state government has prepared a list of properties of value worth over Rs 50 crore owned by nearly 128 drug smugglers, suppliers including three women in the state. Talking to the Chief of Haryana State Narcotics Control Bureau (HSNCB) Shrikant Jaghav also holding the charge of ADGP Ambala police range said that initially State Action Plan prepared by the state government has been launched in three districts Sirsa, Ambala and Panchkula neighboring Rajasthan and Punjab states known as Hot spots for drugs smuggling and addiction in the country. A meeting in this regards was held recently at CDhandigarh in which Haryana Chief Secretary, Director General Police Haryana and senior police Bureaucrats were present.

HSNCB Chief Shrikant Jaghav said that on the order of State Home Minister Anil Vij strict action is being taken against drug smugglers and suppliers as per State Action Plan and a list of 128



smugglers including three women against whom cases under NDPS Act have already been registered in past has been prepared whose properties of value over Rs 50 crore will be attached by the state government similar to bulldozer campaign in which large number of properties of drug smugglers built illegally in the state were demolished in past sometime. Jaghav said that there are still large number of illegal properties constructed by drug smugglers, suppliers and hard core criminals on encroached government land likely to be demolished in future also. Information also reveals that there are as many as 18 drug smugglers in the list having 93 cases registered against them under NDPS Act in different

police stations in the state.

reveals that seven districts in Haryana state have been identified in which maximum number of drug smugglers and suppliers are active which include Gurugram, Kurukshetra. Sirsa, Faridabad, Fatehabad, Hisar and Hansi have large numbers of illegal properties which are likely to be attached by the state government or demolished under bulldozer scheme. According to data prepared by HSNCB, there are six properties of value worth Rs 4 crore at Faridabad, seven properties of value worth Rs 5 crore at Sirsa, seven properties each of value worth about Rs 50 lakh at Fatehabad, seven properties each of value worth about Rs 10 lakh at Kurukshetra owned by drug smugglers likely to be attached by the state government shortly. Jaghav told that data of nearly 175 drug smugglers having illegal properties in the state has been prepared by HSNCB which would either be attached by the government or demolished with bulldozers in Haryana state.



Researcher Ajay to present paper in Nagpur on flaws in 336 years old Newton's 3rd law

Prominent researcher Ajay Sharma will highlight the limitations of 336 Year old Newton's Third Law of motion Indian Science Congress 2023 at R.T.M. University, Nagpur. The Prime MInister Narendr Modi will inaugurate the event on January 3 next vear.

The Indian Science Congress 2023 (ISC) will take place at R.T.M. University, Nagpur from January 3 to 7, 2023. In this paper, Sharma modified Newton's third law of motion, as the law neglects the shape of the body. For final confirmation of the modification of the law, scientists suggest some specific experiments be conducted. According to a press release the editor of the Physical Sciences Section of ISC 2023, has accepted the paper and the same will be published in the proceedings. This event will be funded by the Department of Science and Technology, New Delhi. Prime Minister Narender Modi will inaugurate the

mega-event on 3rd January 2023. Ajay Sharma had also presented similar paper on Newton's third law at the American Association of Physics Teachers, Washington conference. This presentation not only

The committee has asked Sharma for the required equipment and detailed methodology of the experiments. Sharma submitted the same in November 2022.

3,15,962 posts lying vacant in Railways, reveals RTI query



BHOPAL: At present, 3, 15, 962 posts are vacant in the Railways, which has been revealed under the Right To Information. RTI activist Chandrashekhar Gaur of Neemuch district in Madhya Pradesh sought information about the vacant posts, by submitting an application in the Ministry of Railways. According to the information provided to Gaur by the Ministry, 3. 12, 944 posts were vacant in Group C of the Railways till November 1 (Provisional). Similarly, in another reply received on December 27, the Ministry apprised that 2,092 posts of Group A,926 of Group B were vacant as of September 15, 2022. The country has been struggling with an increase in unemployment, which makes the fact of lakhs of government jobs in the Railways lying vacant, quite surprising.

While at first flush this would be reason for cheer, this growth came on the back of the pandemic-hit year, when economic activity including demand for loans was depressed. However, credit momentum seems to be sustaining in the current fiscal year too with loan growth logging a decade high in the first half. And in the fortnight to December 2, credit expanded 17.5% from a year earlier. Still, disappointingly, deposit growth lagged behind, increasing by only 9.9% in the period. With retail inflation and concerns about price stability eroding savers' real returns as well as confidence to save, banks have found themselves needing to redouble efforts to shore up deposits to help fund credit demand. Banks' due diligence on borrowers and solid credit appraisal will help keep NPAs under control even while credit growth helps fund capital expenditure (capex). The Chief Economic Adviser had noted this month that private capex had touched Rs 3 lakh crore in the first half of the year and if the same pace were maintained, full-year figures would be the highest in the last few years. Worryingly, he had also hinted that government capex need not continue to maintain the pace so as to allow private players the space to borrow and invest. However, even given the constraints of fiscal discipline, the Government should keep the tempo up on capex as it may take a while for private capex growth to find consistency. With industrial production still on a bumpy ride, having contracted in two of the seven months, policymakers must ensure credit flow and all-round capital spending stay supportive.

How To Reap Demographic Dividends

he world is rapidly ageing, but India is still young. In the next few decades, India will be a talent powerhouse and the largest contributor to the global workforce. According to a CII report, if India's demographic dividend is productively employed, growth prospects will brighten, helping it to jump its GDP from the current \$3 trillion to \$9 trillion by 2030 and \$40 trillion by 2047. India is projected to surpass China as the world's most populous country in 2023. The report of The Confederation of Indian Industry (CII) warns, that If India does not create enough jobs and its workers are not adequately prepared for those jobs, its demographic dividend may turn into a liability. education and skill development will be the biggest stimulants for reaping this dividend.

The report points out that India will add another 183 million people to the working age group of 15-64 years between 2020-50 as per the UN Population Statistics database. Thus, a huge 22 per cent of the incremental global workforce over the next three decades will come from India.

Although investment, reforms and infrastructure are likely drivers of India's economic growth, no growth driver is as certain as the availability of people in India's working age group. According to Chandrajit Banerjee, Director General, CII" India's young population, its demographic dividend, gives India the potential to become a global production hub as well as a large consumer of goods and services".

The period of 2020-50 provides India with a short window of opportunity to harness its demographic dividend. However, India does not have much time to utilise this dividend.

The report said that high quality school education, relevant higher education and skill development aligned to industry needs are some of the pre-requisites, if India is to become an economic powerhouse which not only creates good quality jobs for its youth, but also services the rest of



the world.

The report analyses India's labour market imbalances, and highlights how the skill mismatch and shortage can impact productivity growth, which is critical for India to enhance its long-term growth. In 2019-20, only 73 million of India's 542 million strong workforce received any form of vocational training (whether formal or informal). To put it in global context, the proportion of formally skilled workers as a percentage of total workforce stands at 24 per cent in China, 52 per cent in USA, 68 per cent in UK and 80 per cent in Japan, against a paltry 3 per cent in India, the report stated. In 2019-20, only 73 million of India's 542 million strong workforce received any form of vocational training (whether formal or informal). To put it in global context, the proportion of formally skilled workers as a percentage of total workforce stands at 24% in China, 52% in USA, 68% in UK and 80% in Japan, against a paltry 3% in India. To overcome such challenges, the report suggests that youth may be offered skill tickets and scholarships which can be linked to the national skill qualification framework.

Forward-looking policies Countries like Singapore, Taiwan and South Korea have already shown us how demographic dividends can be reaped to achieve incredible economic growth by

adopting forward-looking policies and programmes to empower the youth in terms of their education, skills and health choices. There are important lessons from these countries for India.

The first is to undertake an updated National Transfer Accounts (NTA) assessment. A child in India consumes around 60% of the consumption by an adult aged between 20 and 64, while a child in China consumes about 85% of a prime-age adult's consumption. The NTA data for India needs to be updated to capture the progress made on such investments since 2011-12. State-specific NTAs need to be calculated every year and States need to be ranked for investing in the youth.

The second is to invest more in children and adolescents. India ranks poorly in Asia in terms of private and public human capital spending. It needs to invest more in children and adolescents. particularly in nutrition and learning during early childhood. Given that India's workforce starts at a younger age, a greater focus needs to be on transitioning from secondary education to universal skilling and entrepreneurship, as done in South Korea

The third is to make health investments. Health spending has not kept pace with India's economic growth. The public spending on health has remained flat at around 1% of GDP. Evidence

improved economic production. Hence, it is important to draft policies to promote health during the demographic dividend. We need more finance for health as well as better health facilities from the available funding. Fifth, education is an enabler to bridge

gender differentials. Gender inequality in education is a concern. In India, boys are more likely to be enrolled in secondary and tertiary school than girls. In the Philippines, China and Thailand, it is the reverse. In Japan, South Korea, and Indonesia, gender differences are rather minimal. This needs to be reversed.

Sixth, India needs to increase female workforce participation in the economy. As of 2019, 20.3% of women were working or looking for work, down from 34.1% in 2003-04. New skills and opportunities for women and girls befitting their participation in a \$3 trillion economy is urgently needed. For example, a girl who passes Class 10 needs more choices to learn skills that will help her find appropriate work. She will need safe transport to travel to work. Finding work will likely delay her age of marriage and make her participate in the economy more productively, as also exercise her rights and choices. South Korea's female workforce participation rate is 50%. It is predicted that if all women engaged in domestic duties in India who are willing to work had a job, female laoour force participation would increase by about 20%.

Seventh, a new federal approach to overnance reforms for the demographic dividend will need to be put in place for policy coordination between States on various emerging population issues such as migration, ageing, skilling, female workforce participation and urbanisation. Inter-ministerial coordination for strategic planning, investment, monitoring and course correction should be an important feature of this governance arrangement.

How the G20 evolved



ndia's assumption of the 18th G20 (Group of Twenty) presidency underpins a new epoch for the grouping. For the first time, the 'Troika' will be comprised of three emerging market economies - Indonesia, India, and Brazil. The G20 chair is part of a rotating three-member group of immediate past, current, and succeeding presidencies, referred to as the Troika to ensure continuity in the agenda as there is no permanent G20 secretariat. The G20 summits are convened under a system of rotational presidencies and of countries. In fact, South Africa's elevation to the G20 presidency in 2025 will not only consolidate the voice of the Global South but will also mark the completion of one full circle for rotational presidencies among member countries. India has planned to hold the Summit in New Delhi on September 9-10, 2023. India has taken over the G20 presidency

on the occasion of the country completing 75 years of its independence and becoming the fifth-largest economy in the world. Thus, with an avowed objective of showcasing its rich cultural heritage and economic prowess to the outside world, it is setting unique precedence by holding more than 200 meetings in over 50 cities spread across country and not confining to a select few large cities.

The run-up to the Summit entails a preparatory process with several ministerial and working group meetings and discussions channeled on two tracks- the Finance Track and the Sherpa Track. In the Finance Track, discussions are centered on building consensus on attendant issues related to fiscal and monetary policies, macroeco-



nomic coordination, financial inclusion, international taxation, and investment. The deliberations under the Sherpa Track are both complementary and supplementary to those undertaken in the Finance Track as the scope of discussions expands to subjects like digital economy, trade, and investment, anti-corruption, agriculture, health, energy and environment, among others. Inception of G20: rise of emerging markets in the multilateral order With the G20 becoming a subject of intense debate and discussion in India, it is important to reflect on its history

To those unfamiliar with the G20 process, it is less well-known that the G20 was conceived in 1999 in the aftermath of the 1997 Asian financial crisis to discuss matters related to international economic and financial stability and align policies among the most significant and relevant industrialized and developing economies. Until then, the group of advanced countries - the Group of Seven (G7) - was the main forum that discussed international issues ranging from global financial governance to anti-corruption and terror financing, with the view to build consensus and policy response among developed countries. However, the Asian financial crisis brought to the fore the criticality and centrality of developing countries to maintain the multilateral order owing to their deep integration into the global economic systems and cross-border capital flows. Since the immediate context was to mitigate the ill effects of the contagion caused by the Asian financial crisis, the beginning of G20 (with the addition o to the G7 countries) was underpinned by the coming together of their Finance Ministers and central bank governors to discuss how a coordinated response to the emergent crisis and future crises could be made.

Evolution of the G20

Since then, the G20 has seen several points of inflection. The first happened in 2008 in the aftermath of the global financial crisis that emerged in the U.S. when the forum was elevated to the summit level with the participation of heads of state or government. The initial summits, held in the U.S., the U.K., and Canada focused on developing a coordinated response to the financial crisis and the consequent economic slowdown. including discussions on monetary and fiscal policy measures, preventing a reversion to protectionist policies and reforming of the Bretton Woods institutions. Other issues such as strengthening trade and investments were discussed in the larger context of their impact on ensuring financial stability and economic growth. Issues like food security which were

discussed at the G7 level till then also found their way in the G20 agenda.

The next pivotal moment was during the South Korean presidency in 2010 when development issues were introduced as a priority in the G20 agenda. In the subsequent years, as the effects of the global financial crisis waned and financial sector stability was restored to an extent, the mandate of the Sherpa Track expanded. Many new working groups were added to reflect the widened ambit. Successive presidencies - France, Mexico, Russia, Australia, Turkey, and China focused on various issues reflectir priorities and relevance to the G20 community. In 2017, amidst the U.S.-China trade war

and divergence of opinion on multiple issues including climate change, the G20 weathered the storm by following a majority over unanimity. For the first time, the G20 recorded a Leader's Declaration with 19 members supporting the agenda, alongside the dissent of one. While failure to build consensus may have set a bad precedent, from a global governance perspective it exemplified the point that no one nation is superior in the grouping. In that way, the German presidency in 2017 can also be regarded as critical for the G20. The Argentinian and Japanese presidencies also withstood turbulent times and widened the scope of the G20 agenda to reflect on new issues like the future of work, which had gained prominence and cast a long shadow on international policymaking.



SEBI: Many Mumbai IT defaulters operated from dingy 'chawls'!

MUMBAI: In a curious revelation, the Securities and Exchange Board of India (SEBI) has found that several 'missing' Income Tax defaulters were operating from dingy chawls. In a new announcement, the

SEBI has published a black-list of 'untraceable defaulters', some who are missing since 2014, and hence it has been unable to serve them the Notices of Demand. A few of the SEBI listers operating from tenements are: Prakash Gaurishankar Joshi, from Dilkhush Chawl No. 3 in Borivali east, untraceable since August 2018; Ashok Bhagat of H-19 Ramii Gupta Chawl in Santacruz west, unavailable since June 2014 and for another demand notice since August 2019. There is also Mahesh Mistry with an address at No. 1 Manraj Driver Chawl in Andheri east, and other addresses at Marine Lines, Fort, Vile Parle and in Thane, out of bounds since July 2014, August 2018 and May 2019 for multiple demand notices that remain

One Jayesh Shah has given an address at 82, Kishan Chawl in Borivali east, a commercial Bhayander town of Thane, but since he is not traceable, his demand notices of July 2014 and December 2017, could not be served.

Vinod Patel of Patel Building in Fort is 'missing' since December 2017; Kina Dilip Mewada of Naigaon in Mumbai and BP Road in Thane are not traceable since August 2018, according to SEBI.

The list has one Sunil D. Ingawale of Jain Nagar in Bhayander east, not available since August 2018: Pankai Saraiva with addresses of Andheri west and Vile Parle west, apparently gone 'missing' since June 2021; and the most recent addition, Hussain Sattaf of Cuffe Parade,



who is not traceable since March

These defaulters -- who have to cough out unspecified amounts of dues -- are missing for the past between eight years to eight months, from one or multiple addresses that are available with the market regulator.

Admitting to the 'untraceable defaulters', the SEBI said that it has not been able to serve the Notice of Demands on them "at their last known address".

The SEBI Recovery Officer Suchismita Sahoo has called upon these 'untraceable' nine defaulters and members of the public who have any information on them, to send letters or emails by January 14, 2023, though again, no telephone or

Global smart home devices market to shrink 2.6% in 2022



NEW DELHI: Worldwide shipments of smart home devices are expected to decline 2.6 per cent in 2022 to 874 million units with smart speakers and video entertainment devices such as TV and streaming devices facing the brunt of the decline.

Worsening macroeconomic conditions have led to a reduction in the outlook for global smart home device shipments, according to the International Data Corporation's (IDC) Worldwide Quarterly Smart Home Device Tracker'.

"Shipments of smart home devices have been impacted significantly by ongoing supply chain disruptions, "said Adam Wright, senior research manager, Smart Home and Office Devices

"Moreover, we're witnessing downward pressure on demand in 2022 as inflation continues to squeeze consumers' wallets. Looking ahead, we expect volatility will continue to inhibit the market's growth in 2023 and beyond,

forecast to return to growth in 2023, it will remain relatively low at 4.6 per cent with most of the growth coming from emerging markets as well as China. "Though smart speakers

arguably helped launch the smart home category, the shine of these products has largely worn off for consumers in developed markets such as the US and China with shipments expected to decline in the long run, " said Jitesh Ubrani, research manager for IDC's Mobility and Consumer Device Trackers.

Smart speakers will now rely on emerging markets and places like Europe where language and lack of services have been a barrier to adoption in the past, "Urban added.

IMF advises India to be cautious with interest rate hikes



NEW DELHI: Flagging headwinds, the International Monetary Fund (IMF) said on Friday that India should be carefully while consider its future interest rate hikes. It has recommended India to cautiously calibrate its intervention in the foreign exchange market should be limited to managing volatility. Since May, Reserve Bank of India (RBI) has raised its key policy rate by 225 basis points, taking the rate to the highest in over three years. IMF in its annual consultation report said that inflation pressures have led to an appropriate shift towards policy tightening. "Additional tightening should be carefully calibrated and communicated," it added. The IMF projected inflation at 6.9 per cent for the current fiscal year that ends on March 31, 2023 and said price

Credit offtake in elevated levels: CARE Ratings

offtake in India remained at elevated levels of 17.5 per cent year-on-year (YoY), reporting robust growth for the fortnight ended December 2, said credit rating agency CARE Ratings.

According to CARE Ratings report, the growth is driven by a low base, non-banking finance companies (NBFC), retail credit, higher working capital demand driven by inflation and improvement in capacity utilisation ratio, and rising demand for fresh capex.

The benefit of a lower base is expected to ease in the next few fortnights, optically leading to lower growth rates, CARE Ratings said.

With a large base, deposits saw a slower growth at 9.9 per cent y-o-y compared to credit growth of 17.5 per cent for the fortnight ended December 2.

The credit offtake expanded by over 1,000 bps due to a low base, retail credit, inflation-led working capital requirement and MSMEs. It also increased sequentially by 1.2 per cent from the immediate fortnight (ended November 18), CARE



Deposits rates are expected to go up further due to rising policy rates driven by higher inflation, intense competition between banks for sourcing deposits to meet strong credit demand, widening credit deposit gap, and lower liquidity in the market, said CARE Ratings.

Over the last couple of years, (i.e., from February 28, 2020) credit offtake has mostly overcome the Covid induced lag and has grown by around 29.7 per cent to almost catch up with deposit growth of 31.4 per cent over the period, the credit rating agency said.

In absolute terms, credit outstanding stood at Rs 131 lakh crore as of December 2, rising by Rs 19.5 lakh crore over the last 12 months.

According to CARE Ratings the credit offtake is anticipated to remain resilient in FY23, while the benefit of lower base will ease out in the next few fortnights, optically leading to lower growth rates.

A slowdown in global growth due to elevated interest rates, interminable pandemic restrictions in China, and multiple rate hikes in India could impact credit growth, the CARE Ratings report said.

US winter storm death toll reaches 62

Nearly 23.8 million people over the age of 60 in China are yet to receive their first shot of Covid-19 vaccine as the country goes through a massive surge in infections, the media reported on Monday.

According to the South China Morning Post, as China eased its zero-Covid policy, the country doubled down on vaccination drives but the vaccination rate for the elderly is worryingly low. The vaccination figure fell to "just 42.4 per cent for those aged 80 and over", the report mentioned.

The elderly, most of whom have other ailments, are most concerned about the effectiveness and safety of the vaccines.

Vaccination seemed less urgent for many elderly people, especially those in the country's vast hinterland, and out a second Covid booster years.

Global gas demand expected to decline by 65 bn cubic metre in 2022: Gazprom



NEW DELHI: The world's demand for gas is expected to decrease by 65 billion cubic metre in 2022, with 55 billion cubic metre falling on the 27 European Union countries, head of Russian gas giant Gazprom Alexei Miller said.

According to preliminary estimates, the decline in global gas demand in 2022 is equal to 65 billion cubic metre, and "55 billion cubic metre from these 65 billion fall on the 27 European countries, "Gazprom said in a statement, citing Miller as speaking at a year-end meeting on Wednesday.

Miller said 2022 turned out to be very difficult, with energy markets experiencing great changes, noting that at the start of the year, such changes could be described as extreme volatility, and by the end of the year, it became clear that the markets were undergoing turbulence, Xinhua news agency

According to preliminary long-term forecasts, global gas consumption would grow by 20 per cent over the next 20 years, he said, adding that in this context, Gazprom is reflecting on the future, the company's new projects and energy security in general.



Out of 26 reptile species five are endemic to India including Island Pit Viper whose habitat is limited to a single location in the Car Nicobar Island. Among amphibians, several species are limited to habitats in the Western Ghats, the northeast, and Andaman and Nicobar Islands. MoEFCC has also proposed that endangered species be included in various appendices of the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) to curb trafficking.

Secretary of Central Zoo Authority, India has been trying its best to conserve 73 endangered species. While talking in Mysuru, he also told the audience that India has successfully managed to conserve mouse-deer. International Union of Conservation of Nature (IUCN) has placed 132 species of plants and animals under the category of critically endangered.

Highlighting the role of the zoo in conservation efforts, if one wishes to see the efforts of Central Zoo Authority in conservation efforts, all that person has to do is check the exemplary record of CZA. He also said that if the zoos are not meeting the standards set by CZA, the authority terminates the licence immediately.
