Credit remains key challenge for MSMEs despite govt efforts: Survey

NEW DELHI: A new survey by Consortium of Indian Associations has revealed that credit challenge still exists in spite of government taking proactive measures to bring ease in credit flow to MSMEs.

The study noted that majority of the respondents felt the erformance of their business has either remained stagnant or declined and access to credit remained a key challenge.

Further it highlighted that 72 per cent of the respondents said their performance is either stagnant or decreasing or stopped or wound up during the last five years.

HSBC economists signal stretch in inflation due to rural recovery

MUMBAI: Owing to the revival of rural demand, India's economy is likely to witness another bout of inflation, said economists at HSBC Securities and Capital Markets (India).

It will also be driven by the informal sector as it recovers from the pandemic-lows, the experts reported.

For most of the January consumer price inflation remained above the central bank's upper tolerance band of 6 per cent before falling below it in the last two months of the year, only to resurge to 6.5 per cent in January.

Goods inflation in India is outpacing services in contrast to the global experience, while core prices remain elevated said Pranjul Bhandari economists.

Both the economists opined that it has much to do with the recovery in rural and informal sector demand

While rural demand was weak in the early part of last year, wage growth, adjusted for inflation, has now surpassed pre-pandemic levels, HSBC's research showed.

Further, strong sowing patterns in the winter season will also help incomes. The informal sector, closely linked to the rural economy, is seeing a revival in step.

"Already, there is pressure on food inflation, particularly across cereal and milk," the economists said pointing out towards the implications of ris-

ing rural incomes for inflation. "As we await the winter crop, due in March/April, food prices will likely remain elevated,"

they added. Producers will use the strong demand conditions to restore margins, raising the risk of inflation staying higher, the economists said.

on Friday announced that 150 public sand mines will be soon dedicated to people for ensuring pit head price of sand at Rs 5.50 per cubic feet. The Chief Minister, while inter-

ing 17 more Public mines to people here, said that so far 33 public mines have been dedicated in 14 districts and the state government of people. He said that 16 public mines

touching six districts were dedicated to people a few days back and today 17 more such mines have been dedicated which will involve eight districts. Bhagwant acting with the media after dedicat- Mann said that till now 61580 metric ton of sand have been used by people from these public mines adding that it has also given direct and indirect employment to several



The Chief Minister said that

the state government has eradicated the sand mafia which had flexed its muscles in the past to ensure that people get cheap sand. Bhagwant Mann said that now the sand will be sold at just Rs.5.50 in each of these public mining sites thereby giving a major reprieve to the people. He said that only manual excavation of sand will be permitted in these public mining sites and no mechanical excavation of sand will be allowed.

The Chief Minister categorically

said that no mining contractor will be allowed to operate in these public mining sites. Bhagwant Mann said that sand from public mining sites will only be sold for use in construction of non-commercial projects. He said that sale of sand will happen only till sunset and a government official will always be present to regulate the extraction of sand at each public mining site.

The Chief Minister said that the state government has built an app which will give complete informa-

sites and will even facilitate online payments. He said that it will ensure supply of cheap sand to the people and check their exploitation by contractors and transporters. Bhagwant Mann said that it is now one of the lowest rates at which sand is available to any person across the country.

Slamming the Akali Dal for producing and patronising the sand mafia in the state, the Chief Minister said that Bikram Majithia has no moral right to speak on this that Akalis were hand in glove with every mafia that plundered the state during their long misrule adding that the hands of those who are seen sitting on left and right of Majithia are drenched with atrocities against Punjabis. India's press freedom index has fallen to 150: Congress



NEW DELHI: The Congress on Wednesday criticised the Centre for the Income Tax department raids on BBC offices, and alleged that due to its high-handedness the press freedom index has fallen to 150.

SAS NAGAR: The ongoing war against anti-social elements launched on the directions of Chief Minister Bhagwant Mann got a major breakthrough after Punjab Police arrested Gurpinder alias Pindu, the key accused in the Rocket Propelled Grenade (RPG) attack case, said Director General of Police (DGP) Punjab Gaurav Yadav here on Friday. An RPG attack was carried out at Intelligence headquarters in Mohali on May 9, 2022, at about 1945 hrs.

New foreign trade dynamics call for sharp responses

ndia's goods exports, a key driver of its growth impulses and a major job creator, got off to a disappointing start in 2023. Merchandise ship-■ ments fell 6.6 percent year-on-year to \$32.91 billion in January. While this is the second month of contracting exports, the dip is more than double the 3 percent drop in December 2022 and marks a sharp 13.6 percent sequential decline. Along with an anticipated post-Christmas cooling off in demand, order books probably took a hit as much from actual slowing of economic activity as buyers' wary assessments about consumer confidence levels, with the new year kicking off amid a pall of gloom and doom on the global economic outlook. Engineering exports fell 10 percent; pharma products lost momentum as did 14 other products out of India's top 30 export items, including jewellery and textiles. The silver lining is that imports dipped too, bringing the goods trade deficit to a 12-month low of just \$17.75 billion, a far cry from the \$25-odd billion averaged in each of the previous six months and the record \$29.23 billion gap of September 2022. If this trend holds, India's current account deficit for 2022-23 may end up lower than the uncomfortable 3 percent-plus levels of GDP projected by most agencies. Yet, the drop in imports during January suggests domestic demand growth is fading. Finance Minister Nirmala Sitharaman has rightly flagged concerns about Indian exporters' prospects this year amid global slowdown fears. Her prescription that exporters keep closer tabs on developments in different markets to avoid being "demotivated" is also spot on. Amid the overall headwinds, trends are diverging in key markets. Industry bodies and the government must work in tandem to tap shrinking opportunities better and help exporters move across this river of uncertainty by feeling the pebbles along the way.

India has become more dependent on China now

't is a matter of immense pride that India has become the fifth largest economy in the world and it seems with some degree of certainty that leaving Germany and Japan behind is not going to be a herculean task. At present, the Indian economy is slightly less than 4 billion US dollars and the economy of Germany and Japan is just over 4 billion US dollars. That's why it seems possible that in the next few years, India will definitely make its mark as the third largest economy of the world. But the path ahead of US and China would be very difficult for India because even today China is 6 times bigger than the Indian economy, whereas America is 8 times. Since China comes from the continent of Asia and according to the size of the population, it has the same challenges like us, so many times it appears that the competition with China is little bit easier, but in reality it is a biased thinking.

The fact is China has dominated India a lot in global trade because India's imports are increasing continuously with China. According to data from a reliable source, India's imports with China have more than doubled in the last 10 years. In 2012, India imported about 39.3 billion US dollars from China, while in the first 9 months of 2022, the import figure was around 90 billion US dollars. It is clear from the above account that India's dependence on China is continuously increasing. In this context, one thing also emerges that since the size of the Indian economy is increasing continuously, it is justified to increase the imports continuously and this is a positive trend for the development of the economy. But statistics also show that India's imports have increased by 46 percent in the last 10 years, while India's imports with China have increased by 127 percent. Certainly this fig-



ure is shocking and also raises the question whether the ever-increasing dependence on China is appropriate for India according to international diplomacy?

For the past many years, India's international trade with China has been continuously running into losses as exports have remained the same. During the year 2021, India's trade deficit with China was equal to 70 billion US dollars, in which imports were more than 97 billion US dollars, while exports were only 25 billion US dollars. The reason for concern is that in the current financial year till now, imports have increased by 44 percent and exports have decreased by 30 percent. For this reason, the trade deficit with China is likely to be around 100 billion US dollars in the current financial year, which can also be seen as 25 billion US dollars per quarter. In this context, it is also necessary to mention that India's military and defence budget was 73 billion US dollars in the year 2021 and 76 billion US in the year 2022. This automatically explains that India is paying more to China in the form of deficit in international trade than what it is spending on its army and defence. This situation is also a major challenge in moving towards self-reliant India. In the midst of all this, when some mobile applications of China were banned by India, it seemed that the youth of India would achieve a new position by adopting entrepreneurship in this field, but the situation of the second of the second

ation still remains contradictory.

India mainly gives priority to capital goods while importing from China which are increasingly used by Indian industries in the construction sector, energy sector and in the nuclear sector. For the last many years, the import of capital goods from China is witnessing an increase of 4 percent every year. On the other hand, this figure is also very surprising that in the last financial year, there has been an increase of 37 percent in the import of various electronic and electricals products and it is clear that under the consumption of smartphones in the Indian

market, China imported raw materials and spare parts are the only contributor. This fact is also definitely a big hindrance towards the self-reliance that India gets through "Make in India", "Digital India" and "Startup India". Heavy machinery, chemicals are major contributors to other major imports from China. In the midst of all this, the question also arises whether India's imports from China are comparatively cheaper than other countries?

Now it is absolutely crystal clear that India>s dependence on China is very high and it is also increasing continuously. The relative economic performance of the two economies proves that China is at a much better position in the international division of labor than India. And obviously, China is in a very good position in the manufacturing sector. The contribution of the Indian manufacturing sector to the economy is not increasing beyond 15-16 per cent, while the National Manufacturing Competitiveness Council (NMCC) was set up by the government in the year 2006 with the sole objective of increasing the contribution of the manufacturing sector to around 25 percent in the Indian economy. Similarly, in 2014, when «Make in India» was launched with much excitement, the objective was to increase the contribution of the manufacturing sector to the economy. In this regard, it can only be regretted that economic policies have not made desired changes at the ground level to encourage India>s manufacturing ector, as a result of which today, on one hand, this sector is facing the ever-increasing unemployment problem in India and ,on the other hand, the demand related to this sector in the country has to be imported because domestic production is available in very limited quantity.

Union Budget and its response to Agriculture

griculture has remained the backbone of India's economy. The share of agriculture and allied sector in total Gross Value Added (GVA) has witnessed a declining trend. In 1950, the share was 65 percent and came down to 17 percent of GVA (at 2011-12 constant prices) in 2022.

Even with this lower share, the agriculture, and allied sectors, today provide the largest share of employment in the country. According to the PLFS report 2020-21, about 50 percent of rural households earn their livelihood from agriculture. These rural householdsconstitute 39 percent as self-employed and the rest, 11 percent as casually employed in agriculture. The agriculture sector has its own importance because of its connection with people's lives. It has the capacity to absorb the surplus labour force during an economic slowdown, though the sector employed this labour force at a smaller wage rate.

Agriculture is dominated bythe private sector as land, the primary input in the production processis mostly owned by private individuals. However, it is one of the poorest private sectors in the country. A larger sectioni.e., above 70 percent of rural agriculture households possess a land size of less than 1 hectare. Many cultivators are also landless. Above 50 percent of poor households live on agriculture as their primary source of income. This adds to the necessity of government interventions to provide basic inputs such as power, irrigation, seed, fertilizer, machinery, bank credit, etc.

Agriculture is a state subject. Because of its connection with society and the economy,



the union government intervenes to support the state in the development of the sector. In 2016-17, total union government spending was Rs.44,230 crores and it increased to Rs. 1.32 lakh crores in 2023-24(BE). The annual average growth of union government spending on the sector between 2016-17 and 2023-24 is 19.5 percent.

A major push of union public spending took place in 2019-20 when the budget allocation became almost doubled from its previous year. Total union spending on agriculture here includes only spending under the Ministry of Agriculture and Farmers' Welfare (MoAFW) and, the Ministry of Fisheries, Animal Husbandry and Dairy (MoFAD). The union government also spends on irrigation and fertilizer subsidies which fall under the other ministries contributing to the agriculture sector's development.

The priority of the sector in the union budget has not significantly changed in the last decade. As a share of the total union budget, in 2016-17, the spending on agriculture was 2.2 percent and it increased to 3.9 percent in 2019-20. Since 2019-20, the share follows a declining trend, and it came down to 2.9 percent in 2023-24(BE). In 2021-22 and 2022-23(RE), the share was 3.3 percent

and 3 percent respectively.

The total budgetary provision under the

MoAFW and the MoFAD in 2023-24(BE) was Rs. 1.16 lakh crores and Rs. 9,500 crores respectively. Compared to the previous year i.e. 2022-23(RE), the union spending under these two ministries has gone up by 4.8 percent and 9.8 percent respectively.

The total budget allocation for the MoAFW

is further divided into two departments namely, the Department of Agriculture and Farmers' Welfare (DoAFW) and the Department of Agriculture Research (DARE). A larger share of total funds allocation goes towards the DoAFW. In 2023-24(BE), this share is 92 percent. The rest 8 percent i.e. about Rs. 9,500 crores, goes to the DARE. In 2016-17, this share was 13.4 percent and over the years, it has followed a diminishing trend.

The DoAFW spends the allocated budget on various development schemes related to direct cash transfer scheme for the farmers, has a budgetary allocation of Rs. 60,000 crores, which is about 52 percent of the total budget of the DoAFW in 2023-24(BE). However, there is a reduction in budgetary allocation of about Rs.8,000 crores under this head compared to 2022-23(BE) but, the provision in 2023-24(BE) equalizes with the same in 2022-23(RE). Besides PMKisan, the Pradhan Mantri FasalBima Yojana (PMFBY) and Interest subsidy to farmers are two other major expenditure heads that constitute about 32 percent of the total budget allocation under the DoAFW. Rashtriya Krishi Vikas Yojana and RashtriyaKrishionnati Yojana are two centrally sponsored schemes that constitute about 12.3 percent of the total allocation for DoAFW in 2023-24(BE).

There is a 39 percent rise in budgetary allocation under the MoFAD in 2023-24(BE) from 2022-23(RE). Within this Ministry, the Department of Fisheries got a budgetary allocation of Rs. 2249 crores in 2023-24(BE) compared to Rs. 1624 crores in 2022-23(BE) which is a rise of over 38 percent. About 90 percent of the total allocation under the Department of Fisheries goes towards the Pradhan Mantri MatsyaSampad Yojana i.e. Rs. 2000 crores in 2023-24 (BE).

The Department of Animal Husbandry and Dairying (DoAHD) which fall underthe MoFAD received a budgetary allocation of Rs. 4328 crores in 2023-24(BE). In 2022-23(BE), the allocation was Rs. 3105 crores. The rise of allocation in 2023-24 is about 40 percent. A major share of the total budget allocation under DoAHDi.e. about Rs. 2350 crores in 2023-24(BE) goes towards the central sector scheme Livestock Health and Disease Control Program. Two centrally sponsored schemes, Rashtriya Gokul Mission and National Livestock Mission received an allocation of Rs. 600 crores and Rs. 410 crores respectively.

The union budget 2023-24 has covered a wide range of aspectsrelated to the agriculture and allied sector and has tried to give a harder push to the fishery and animal husbandry. However, the spread of the sector and its connection with life and livelihood expects higher priority in the union budget. The research and innovation for the agriculture and allied sector need more emphasis to accelerate the pace of growth and, enable its diversity, and productivity.

Israel's inflation rate hits 5.4%, the highest in over 14 years



Israel's year-on-year inflation rose to 5.4 per cent in January, the highest since October 2008, according to figures released by the country's Central Bureau of

The 12-month inflation figure continued to move away from the government target ranging from 1 to 3 per cent. The last time the figure was within the range was in December 2021,

Xinhua news agency reported. Israel's inflation rise has not been curbed even though the central bank increased the base interest rate from 0.1 per cent in April last year to the current 3.75 per cent. According to analysts, the interest rate may be raised again for the eighth consecutive time on February 20. Asher Blass, the former chief economist at the Bank of Israel, told the news agency that the main factor for the continuous inflation rise in Israel is the global high prices of raw materials like fuel, gas, coal, and steel. He explained that there were problems in the supply chain amid high demands, and it took a while to get everything running again, causing raw materials to become more expensive. However, the inflation rate in Israel is still lower than that in many other countries, such as the 8.5 per cent average in the eurozone countries. Omer Moay, a professor of economics at the University of Warwick in the UK and Reichman University in Israel, told the news agency that Israel's relatively low inflation is related to the country's export surplus, which has been strengthening the Israeli shekel. European LNG demand to drive competition for new supply and dominate trade in the long term Europe's increased

need for liquefied natural gas (LNG) looks set to intensify competition with Asia for limited new supply available over the next two years and may dominate LNG trade over the longer term, according to Shell's LNG Outlook 2023.

NEW DELHI: European countries, including the UK, imported 121 million tonnes of LNG in 2022, an increase of 60% compared to 2021, which enabled them to withstand a slump in Russian pipeline gas imports following its invasion of Ukraine. A 15 million tonne fall in Chinese imports combined with reduced imports by South Asian buyers helped European countries to secure enough gas and avoid shortages. Europe's rapidly rising appetite for LNG pushed prices to record highs and generated volatility in energy markets

With reduced Russian pipeincreasingly important pillar of European energy security, supported by the rapid development of new regasification terminals in north-west Europe. In contrast, China is evolving from being a rapidly growing import market to playing a more flexible role with an increased ability to balance the

global LNG market. "The war in Ukraine has had far-reaching impacts on energy security around the world and caused structural shifts in the market that are likely to impact the global LNG industry over the long term," Steve Hill, Shell's Executive Vice President for Energy

Marketing, said. "It has also underscored the need for a more strategic approach - through longer-term contracts – to secure reliable supply to avoid exposure to

The drop in Russian pipeline gas flows prompted unprecedented policy and regulatory intervention as governments energy security and shield their economies from high costs, including prioritizing LNG imports and quickly develop-

ing new import terminals. In 2022, Europe's LNG demand forced other buyers to reduce their imports and switch to other fuels, generating more emissions. High global LNG prices led to a drop in LNG imports in South Asia, with Pakistan and Bangladesh importing more fuel oil to minimize power supply shortages

and India using more coal. Total global trade in LNG reached 397 million tonnes in 2022. Industry forecasts expect LNG demand to reach 650 to over 700 million tonnes a year by 2040. The Pitch Battle: Border Gavaskar trophy **SUNIL THAPLIYAL**

India defeated Australia by an innings on the third day of the first test match in Nagpur to take a 1-0 lead in the four-test series of the Border-Gavaskar series. Since the beginning of the series, the greats of Australia and India have engaged in a verbal duel. Former Australian cricketer Ian Healy triggered a controversy when he asked India to prepare a fair pitch for the test series. He raises the ques-tion about Indian pitches. His insistence on fair pitches during the next series has reignited a discussion about what it really means to be fair and unfair in order to win a game.

Healy has predicted that Australia would win the first Test match if a «fair» pitch were created. Ravi Shastri, a former head coach of Team India, has, on the other hand, provided a wonderful rejoinder to Healy by stating that he would like to see a turn from the first day of the competition.

Sunil Gavaskar, the renowned



cricketer, has responded angrily, claiming that Australia has no right to complain about the condition of Indian pitches because their own wickets have been scrutinised. He emphasised that the Brisbane ground at Gabba, where the Test match between Australia and South Africa in December of last year ended in two days, was much more hazardous than any Indian pitch could ever be. The Australians are always this way; they were thrashed twice at home by India on bouncy wickets. Australians

Every home team has the right to arrange the pitch whatever they choose, rendering the whole debate over pitch doctoring pointless. When teams from the subcontinent go on tour in Australia, they don>t anticipate low bounce, dusty tracks; they expect bouncy fast pitches.

Australia used to be far ahead of the competition when it came to mind tricks. They>re now getare now looking for green turf in ting a taste of their own medi-India as well. The pitch is detercine. This is one of Australia>s

most humiliating overseas Test defeats. Australia appeared to have already lost the match by putting too much emphasis on the field. India batted expertly, as required by Test cricket, and scored 400 runs, but Australia was visualising a different wicket. Even though there has been a large disparity between the teams, the field can>t be that bad if one team scores 400 runs.

The Australian media has been constantly criticising the Indian team management and the Indian cricket board, refusing to discuss their own failings that contributed to an embarrassing loss.

The third Test has been moved from Dharamshala to Indore by the BCCI. Officials from the board concluded after a careful investigation that the outfield «lacks suitable grass density» and is not prepared to conduct a match of this magnitude on an international scale. The BCCI provided an explanation of the situation that compelled them to relocate the game to Indore via a press statement.
