NEW DELHI: Rahul Gandhi's disqualification from the LokSabha as an attempt to silence his voice by the Centre against whom the leader had been asking tough questions and said the party will launch nationwide protests over the issue. Congress leader Rahul Gandhi was disqualified as a member of the LokSabha a day after he was given a two-year jail term by a Surat court on March 23 in a 2019 defamation case involving his remarks on PM Modi. Rahul Gandhi had mentioned the names of fugitives NiravModi and LalitModi along with that of PM Modi to wonder "how was it possible that all the thieves had a common surname Modi" in a speech made during the 2019 LokSabha poll campaign in Karnataka's Kolar district.

The defamation case was then filed by former Surat MLA and ex-minister PurneshModi taking objection to Rahul Gandhi's remarks. According to the BJP leader, Rahul had defamed the entire Modh or Modi community through his remarks.

The jail-term gave fodder to the ruling BJP whose president JP Nadda attacked the former Congress chief saying he had insulted the backward classes. Rahul was granted a bail for 30 days and the Congress said it would appeal to get a stay on conviction in the Sessions Court, High Court and even Supreme Court, if needed.

PM launches multiple initiatives to eradicate tuberculosis by 2025 with 3 months short treatment programme YOGESH KANT

New Delhi

On the occasion of the World Tuberculosis Day, Prime Minister Narendra Modi launched a range of initiatives to eradicate tuberculosis and emphasized the need for public participation in the total eradication of TB. He said that India is working on the target of ending it completely by the year 2025 five years before the global target, at the World TB summit at aranasi on Friday

He also highlighted that the government is starting a 3 months treatment programme for the prevention of TB instead of a 6-month course. He informed that earlier, the patients had to take medicines for 6 months every day but now, in the new system, the patient will have to take medicine only once a week.

He also launched various initiatives including the TB-Mukt Panchayat, the official pan-India rollout of a shorter TB Preventive Treatment (TPT), the Family-centric care model for TB and the release of India's Annual TB Report 2023.

PM also laid the foundation stone of the National Centre for Disease Control and High Containment (BSL) Laboratory here and unveiled the site for Metropolitan Public Health Surveillance Unit (MSU). While speaking at the "One World TB Summit", held in his Parliamentary constituency in Varanasi, Uttar Pradesh, PM Modi said India had made appreciable progress in the eradication of Tuberculosis mainly due to



public participation.

After launching the TB-Mukt Panchayat initiative, PM asserted that the commitment and the determination with which country dedicated itself to tackling TB after 2014 is 'unprecedented'. " It is great initiative and under this campaign, every representative of the village panchayat will take a resolution that their villages will be completely TB- Free.

The India's efforts are important, the Prime Minister said, as this is a new model for the global war on TB. He elaborated on a multi-pronged approach against TB in the last

He listed people's participation, enhancing nutrition, treatment innovation, tech integration and wellness and prevention such as Fit India, Yoga, and Khelo India type of interventions

Regarding peopless participation, the Prime Minister talked about the Ni-kshay Mitra Campaign in helping TB patients. He informed that about 10 lakh TB patients have been adopted by citizens and even children aged 1012 years have come for-

ward. Financial help to the TB patient under the programme has reached up to one thousand crore rupees. He termed the movement 'inspirational' and expressed happiness that even Pravasi Indians are participating in this. Noting the major challenge

of nutrition for TB patients, the Prime Minister highlighted the contributions of Ni-kshay Mitra Campaign in helping TB patients. He underlined that the government had announced a Direct Benefit Transfer scheme for TB patients in 2018 and as a result, approximately Rs 2000 crores have been directly transferred into their bank accounts for their treatment, where more roughly 75 lakh TB patients have benefitted from this. "Ni-kshay Mitras have now become a new source of energy for all TB patients", the Prime Minister said. Noting that it is extremely

difficult to arrive at new solutions by practicing outdated ways, the Prime Minister said that the government has worked with new strategies so that TB patients do not fall out of their treatment.

Headache for Sukhu government as Punjab, Haryana oppose water cess move

SHIMLA: Himachal Pradesh Chief Minister Sukhwinder Singh Sukhu's biggest resource mobilisation move to tackle state's worst fiscal crisis seems to have hit a roadblock, as also possibly a legal tangle.

Within three days, after the state assembly passed a bill --Himachal Pradesh Water Cess on Hydropower Generation Bill, 2023 to levy cess on water being used by hydro-power producer companies in the state, two neighbouring states have come-out against the bill.

State Governor Shiv Pratap Shukla is yet to give his assent to the bill which Chief Minister claims will fetch an additional resource of Rs 4000 cr to the state every year from 172 hydel projects. Till now, the state has been getting a free power share of 12 percent from the independent power producers including Bhakra-Beas Management Board (BBMB), NHPC, NTPC,



SJVN Ltd and private power Himachal Pradesh also gets

a share of 7.19 percent from the BBMB as per decision of the Supreme Court as its legitimate right in the combined assets of three states -- Punjab, Haryana and Himachal Pradesh under Punjab State Reorganisation Act 1966.

This week, the Himachal Pradesh assembly passed a bill unanimously to levy water-cess on the hydro-power projects, located in the state. The bill replaced an ordinance which the Congress government had promulgated only a month back.

Quick to oppose the move, Punjab and Haryana state assemblies passed separate resolutions to strongly oppose hill state move to impose Water Cess on Hydropower Projects for nonconsumptive use of water for power generation.

In the Haryana assembly,

Chief Minister Manohar Lal Khattar said, "This water cess is illegal and not binding on the State of Haryana and therefore the same should be withdrawn immediately by the Himachal

Government. The resolution passed by the House even has urged the central government to prevail upon the Himachal Pradesh government to withdraw the bill/ordinance as the same is in violation of the Central Act i.e. Inter State Water Disputes Act, 1956.

"With this new levy there

will be an additional financial burden amounting to Rs 1, 200 crore per annum on partner states out of which around Rs 336 crore will be burden on the state of Haryana. This new levy is not only an infringement of the exclusive rights of the state over its natural resources but will also result in additional financial burden for generation of power resulting in the higher cost of generation of electricity, Khattar said.

On the same lines, Punjab Chief Minister Bhagwant Mann and Water Resources minister Gurmeet Singh Meet Hayer said they would not pay a single paisa to Himachal Pradesh and even warned that Punjab could also levy cess on apple trucks coming to the state from Himachal and also on tourists going to the hills.

Mann, while terming it an attack on the federal structure, said that it violates the Inter State River Water Disputes

In Shimla, adopting a firm stand, Chief Minister Sukhvinder Singh Sukhu told the state assembly on Thursday that Himachal Pradesh was well within its right to impose water cess on hydro-power generation as it didn't in any manner had violated the Inter State River Dispute Act 1956.

Where these conditions are not satisfied, alternatives like interrogation at fixed hours or at most house arrest be used to meet the demands of investigation.

"As for bail, the petitioners seek that the principle of bail as rule, jail as exception' be followed by all courts throughout, especially in cases where nonviolent offences are alleged, and that bail be denied only where the aforementioned triple-test is met, "the plea

It further contended that where special laws such as PMLA with stringent bail conditions are concerned, the petitioners seek that such bail provisions be harmonised with Article 21 of the Constitution.

"As such, therefore, where it appears that the trial is unlikely to complete within six months, the accused be released on bail even under special laws unless the conditions in the triple-test are not

NIA chargesheets Lawrence Bishnoi, Goldy Brar in terroristgangster nexus case

NEW DELHI: The National Investigation Agency (NIA) on Friday filed another chargesheet against 14 gangsters, including Lawrence Bishnoi, Goldy Brar and others, having links with the proscribed Babbar Khalsa International (BKI) and pro-Khalistani terrorist outfits, in a terrorist-gangster nexus case.

Till now, the NIA has chargesheeted 26 persons in the terrorist-gangster case. Lawrence Bishnoi, who is

in judicial custody since 2015, has been allegedly operating his terror-crime syndicate from jails in different states, along with Canada-based Goldy Brar, who is an accused in the killing of Pradeep Kumar, a Dera Sacha Sauda follower, at Faridkot in Punjab in November 2022.

"Lawrence Bishnoi's syndicate was also responsible for firing RPG at the Punjab Police's Intelligence headquarters in Mohali on May 9 last year, which was carried out on the directions of Harwinder Singh alias Rinda, a Pakistanbased BKI terrorist, "NIA said in the chargesheet.

Goldy Brar was found to be having direct links with Lakhbir Singh alias Landa, another BKI operative working closely with Rinda. Landa is also an



Investigation against Landa and three others is going on. "All the 14 accused have been charged with criminal

By 2036, about 15% of the population is likely to be affected by ageing-related skeletal muscle loss and frailty, while COVID-19. cardiovascular diseases and 'affected' genes provide a "fertile' ground for research since the COVID virus affects the cells and membranes in the human body, according to Researchers.

This finding is part of the evergrowing science of pathology in the detection of human diseases and medical solutions, that was highlighted at a global conference on oncology, reproductive medicine data analytics/bioinformatics (proteomics) computational pathology, artificial intelligence, data science etc. Professor Arvind Ramana-

than, Faculty, Head Research, Institute for StemCell Science and Regenerative Medicine (In-Stem), Bangalore highlighted this detail while speaking on the "Emerging Science" about 'Lipids in Human Diseases' at the two-day Pathfinders Global Pathology Conference 2023 held in Mumbai recently. Replying to questions, he said

the solution lay in "denying the virus entry into the human resource," while studies had shown that athletes often had a high fat layer in their muscles which was utilised well in their athletic efforts while also keeping away

Describing lipids comprising 40,000 molecules as a 'diverse class' of compounds deeply associated with the human system's



physiology and health, he said the structural database revealed that 47,000 lipids have been discovered till date.

"Hundreds of 'Triglycerides' play important roles in disease detection of the spectrum of even rare -- disorders noticed today," he said, adding "Lipids play an important role in identifying cardiovascular, cancer problems and mass-spectometry-based approaches help in identifying and quantifying such different lipids

- even if they are lying hidden at a rate of 2-per-million." "Genomes contain more details than Proteins," Dr Sridhar Sivasubbu, Senior Principal Scientist, CSIR: Institute of Genomics and Integrated Biology, New Delhi, said in answer to the question "Gene, RNA or Protein: what should one chase and when?" "Fish are in the same ge-

netic group like humans and the zebrafish was used by us in in research -- where a student discovered bleeding in its brain that was then knocked down by molecular docking," he said, adding that "Vascular Associated Endothilial RNA (VEAL2) was discovered and characterised high in BP patients.'

To a question why greater pathology efforts were not being

put in post-COVID-19 about this disease and its gene-altering risks, Dr Sandip Shah, Executive Director, Neuberg Diagnostics, said the Institute of Genomic Studies of India and the Pune Institute of Viral Research have been given this permission by the Indian Government.

"The second COVID wave has created a lot of problems with the protein formation in the body. So, knowing that genetic sequence messenger RNA -- and when it will come out - is necessary as it is having a coding for the protein formation and that change in the coding due to the virus has created a problem for the hypercoagulable state in which the blood vessels have been infected, resulting in clot formation and heart attack or strokes.

Global stagflation fears rise amid persistent inflation

ecent economic data in India and global financial developments are causing concerns of stagflation in major economies, including India. The retail inflation reading for February from India's NSO at 6.44 per cent contradicts the RBI's forecast of 5.7 per cent for Q4 inflation. Even though the RBI raised its benchmark interest rate by 250 basis points since May 2021, core inflation remains persistently elevated, indicating difficulty in controlling price gains. The Monetary Policy Committee members cited the persistence of core inflation as justification for continuing to tighten monetary policy at their last meeting in February. Food prices also show disconcerting trends, with key categories in the food basket registering high year-on-year inflation and sequential hardening. Cereals and products saw inflation accelerate to 16.7 per cent in February, while milk and products quickened to 9.65 per cent, fruits surged to 6.38 per cent, and spices slowed a tad to 20.2 per cent. The prediction of a likely El Niño this year raises concerns about the outlook for food prices. Policymakers need to focus on containing inflation, but the rising uncertainty about the growth momentum sustaining in the face of the heightened risks of a recession in advanced economies raises the risk that higher credit costs may further dampen consumption. However, failure to engender enduring price stability could lead to stagflation. Supply side measures such as GST rationalisation and fuel price cuts need to be expedited to address the overall macroeconomic outlook, which appears worrying. It is essential for policymakers to take proactive measures to address these challenges and ensure a sustainable and stable economic environment that supports growth and protects the well-being of citizens. This may require a combination of monetary policy measures. structural reforms, and targeted fiscal interventions to tackle the root causes of inflation and promote inclusive growth.

Healthy forests for healthy people

umanity today faces numerous global challenges. These include the COVID-19 pandemic and related economic hardships, international conflicts, food insecurity, poverty, climate change, land degradation, water pollution, and biodiversity loss. The world is now looking for solutions that are cost-effective, equitable, and can be easily implemented. Forests contribute significantly to addressing many of the challenges mentioned above. Forests have the ability to combat climate change and provide a range of ecosystem services that could support livelihoods for rural communities.

The United Nations General Assembly declared 21 March as the International Day of Forests (IDF) in 2012. The IDF raises awareness of the indispensable role of different types of forests in supporting a wide range of benefits to human health that include food security and nutrition, thereby aligning with the 2030 Agenda of the Sustainable Development Goals (SDGs), particularly SDG 3 (Good health and wellbeing) and SDG 15 (Life on land).

Forests are of global importance. Forests provide habitat for 80% of amphibian species, 75% of bird species, and 68% of mammal species. More than 18% of the total forest area is in legally established protected areas. Nevertheless, forest biodiversity remains under threat from deforestation and forest degradation. The Food and Agriculture Organization of the United Nations (FAO's) latest report on State of the World's Forests (2022) states that forests cover 31% of the Earth's land surface (4.06 billion ha) but the area is shrinking, with 420 million ha of forests lost due to deforestation between 1990 and 2020. The rate of deforestation is declining but was still 10 million ha per year during the period of 2015-2020.

Climate change is a major threat to forest health and this is manifested in a number of ways. For instance, there are indications that the incidence and severity of forest fires and pests are increasing. The COVID-19 pandemic also had a significant impact on

forest value chains and trade in early 2020. There is a possible longer-term link between forests and disease. More than 30% of new diseases since 1960 are ascribed to land-use change, including deforestation, and 15% of 250 emerging infectious diseases have been linked to forests. Deforestation, specifically in the tropics, has been associated with an increase in infectious diseases such as malaria and dengue. Moreover, worldwide almost 90% of deforestation is driven by agricultural expansion such as the conversion of forest to cropland or grassland for livestock grazing. FAO's report on the State of the World's Forests (2022) suggests three forest-based pathways as a means for tackling local to global challenges—first, halting deforestation and maintaining forests; second, restoring degraded lands and expanding agroforestry; and finally yet importantly, sustainably using forests and building green value chains.

The Government of India (GoI) has launched a global movement on Lifestyle for Environment (LiFE), or Mission LiFE. This is designed with the objective of mobilizing at least one billion Indians and other globa citizens to take individual and collective action for protecting and conserving the environment. In India, at least 80% of all villages and urban local bodies are intended to become environment-friendly by 2028.

As per the Economic Survey of India (2022-23), one of the quantifiable targets of India's nationally determined contributions (NDCs) is to achieve an additional carbon sink of 2.5 billion to 3.0 billion tonnes through additional forest and tree cover by 2030. The country ranks third globally with respect to the net gain in average annual forest area between 2010 and 2020. This gain is mainly attributed to the robust framework and policies of the GoI and State governments that have promoted and protected forests. Initiatives such as the National Afforestation Programme (NAP), Green India Mission (GIM), Compensatory Afforestation Fund Management and Planning Authority (CAMPA), Green Highway Policy-2015, Policy for enhancement of Urban Greens, National Agro-forestry Policy, and Sub-Mission on Agro-forestry (SMAF) are among the key ones.

A robust forest ecosystem acts as a vital carbon sink. The Indian State of Forest

(which is the quantity of carbon sequestrated from the atmosphere and stored in biomass, deadwood, soil, and litter in the forest) of forests to be about 7,204 million tonnes in 2019, which is an increase of 79.4 million tonnes of carbon stock as compared to the estimates in 2017. Among the Indian states, Arunachal Pradesh has the maximum carbon stock in forests (1023.84 million tonnes). followed by Madhya Pradesh (609.25 million tonnes).

The FAO bolsters GoI's efforts in the conservation of forest landscapes by fostering sustainable agrifood systems. FAO works in 8 States, viz., Chhattisgarh, Haryana, Madhya Pradesh, Mizoram, Odisha, Punjab, Rajasthan, and Uttarakhand, to promote the diversification of crops and restoration of landscapes. These efforts seek to mainstream biodiversity conservation, climate change. and sustainable land management objectives and practices into Indian agriculture to enhance multiple global environment benefits (GEBs). Such actions support harmonization between India's agricultural and environmental sector priorities and investments so that the achievement of National and GEBs can be fully realized without compromising India's ability to strengthen rural livelihoods and meet its food and nutrition security requirements.

Governments and business entities need to direct funding for a recovery towards long-term policies aimed at creating sustainable and green obs and further mobilizing private sector investment, and empowering and incentivizing local actors to take a leading role in the forest pathways. Healthy forests are crucial for all aspects of a healthy planet, from livelihoods and nutrition to biodiversity and the environment, but they are facing risk. It's up to us to afeguard these priceless natural resources.

A resilient India, but growth pangs for China



government report of Chinese Premier Li Keqiang before he stepped down, and in the backdrop of the reopening of the country after three years of zero-COVID-19 policies) has disappointed observers with the projection of a growth target of around 5% in 2023, which is lower than that of last year (5.5%) and even lower than the expected GDP growth for India in 2023 (6.1% according to the International Monetary Fund). This is all the more surprising if one considers that India is benefiting from the positive impact of the country reopening after COVID-19 lockdowns while benefit from its reopening only this year. Still, growth will remain rather meagre for a simple reason: the Chinese economy is in a process of structural deceleration while India is still enjoying its benefits of its demographic dividend.

On sustainable growth

It is clear that Mr. Li was being cautious about the growth target this year. But why? First, the Chinese government, especially the new Premier Li Qiang, does not want to run the risk of undershooting its growth target again, as it happened in 2022. Even if consumption is recovering, external demand remains weak and it is hard to know whether private investment will indeed rise given the doubts about the role of the private sector in the Chinese economy as well as increasingly cautious sentiment being expressed by foreign investors. Further, the real estate sector is



still dragging down growth.

a structural shift of the Chinese economy is still on the way. Over the last few years, tighter regulatory measures have been introduced to contain financial risks and achieve more social objectives such as a green economy, food security, etc. This is an important signal by the Chinese government, recognising that too high a growth is no longer possible nor desirable as it only aggravates financial imbalances. In fact, sustainable growth has become a key concept in China's new economic narrative. It is hard to tell if this relates to the government's firm belief that the quality of growth is what matters the most for Chinese citizens today, or an expression of the recognition that pushing growth up too much is only going to create additional imbalances.

Job creation and foreign investment Against such a backdrop, job security

is one of the most important objectives of enshrined in a higher target for new jobs (12 $\,$ million), compared to what it was in the last past years (11 million, except for the even lower target in 2020 after the COVID-19 pandemic in China). The revision of the employment target reflects the government's concern about the job market, especially young workers (the unemployment rate reached almost 20% in spring 2022).

The need for jobs explains China's recent charm offensive to retain foreign direct investment in China as it is an important source of job creation. The sentiment for supply chain diversification is not going to help China fulfil the employment objective as investors are looking at new pastures, with India likely to be a major beneficiary. India also needs to create as many jobs as possible (at least 13 million a year, which is more than China's target). Foreign investors are beginning to contribute more substan-

the country's sheer size in terms of market size and labour force could pose challenges for China as it tries to hold on to foreign direct investment within the country. The forces pushing foreign investors out of China are in plenty: from containment by the United States at the highest end of the value chain, which is forcing bifurcation, to higher wages at the lowest end. In addition, China's push for self-reliance is certainly not helping with the future plans that foreign investors have in mind for China.

All in all, the 5% growth target is consistent with the current challenges that government's more diversified objectives beyond economic growth. Creating more jobs is a quintessential part of China's new sustainable growth narrative, but China is confronted with more competition than before, especially from India because of its market size and the large labour pool. While India and China may not be too different in size and population, growth prospects differ substantially. At the National People's Congress, Premier Li had to lower the GDP target further; in contrast, India remains resilient. An acceleration of this pattern is to be expected in the next few years, especially if the reshuffling of the value chain continues, pushed by geopolitics and high costs in China.

BYJU's set to close \$250 mn funding round soon at a lower valuation

NEW DELHI: Edtech major BYJU's is in advanced stages to raise \$250 million at a valuation which is "lower than the \$22 billion valuation" it last announced as the company struggles to repay a \$1.2 billion term loan and turn profitable in 2023, reliable sources said on Thursday.

Sources told IANS that the latest funding round is in "final stages of discussion and will be closed soon".

BYJU's declined to immediately comment on the development.

However, the \$250 million round comes at a lower valuation and according to sources, it cannot be at a "flat valuation" and this is why the edtech company is unable to raise funds it was widely expected to (to the tune of \$500 million as reported earlier). DealStreetAsia was first to report about the latest funding round by BYJU's.

In order to turn profitable, BYJU's is winding up coding platform WhiteHat Jr, which it acquired for \$300 million, as part of restructuring and cut costs. The company had said it was "merely optimis-

ing it". Edtech firm BYJU's also appears not to be able to meet its March 2023 deadline to achieve group-level

in the current fiscal year are delayed once again.

Sources earlier told IANS that the company, which has sacked thousands of employees to date and has taken deeper cuts, is still unable to achieve profitability at group level amid mounting losses. In October after firing

2, 500 employees and consolidating its business in the



country, Mrinal Mohit, CEO, BYJU'S India business, had said that "these measures will help us achieve profitability in the defined time frame of March 2023". At a group level, BYJU's

had said its top priority is to achieve "overall profitability by March 2023".

However, this appears impossible now with the company still struggling to stem growing losses.

Between April-July 2022, the company logged a revenue of Rs 4, 530 crore. Post that, there has been no communication from the company about the pending results. The edtech unicorn profitability, as it envisioned reported a loss of Rs 4, 588 in its earnings in October last crore for the fiscal year that year and its quarterly results ended on March 31, 2021.

Online Frauds: Threat is not Subsiding

ven though **⊿**digitacreasing rap-

idly in India, but along with it the incidents of online frauds are also increasing rapidly. It was told in the Lok Sabha on 13 March 2023 that 65,045 cases of online fraud were registered in FY 2022, in which Rs 226.4 crore of customers were involved, while in FY 2021, 70,655 cases of fraud were registered and Rs 226.6 crore were involved in them. These cases of online fraud included transactions involving debit cards, credit cards, internet banking etc. These figures also show that the number of online frauds decreased in FY 2022 as compared to FY 2021, but the amount involved remained almost the same.

The analysis also revealed that ATM fraud cases are concentrated in a few states. In 5 states of the country, three fourth frauds are being done through cards. Maharashtra is on top in this matter. Here, 26,085 fraud cases were registered in FY 2022, involving an amount of Rs 74.62

crore, which means an average online fraud of Rs 28,606 was done every day in this state. 40 percent of the total fraud incidents in the country have happened only in Maharashtra. During this period, 8,075 cases involving Rs 24.35 crore were registered in Delhi, which was 12.4 per cent of the total frauds registered. This data also shows that even though Maharashtra is a developed state, its people are less financially aware, otherwise there would not have been so many incidents of frauds

If we analyse the online

fraud cases bank wise, 33,296 online fraud cases were registered in Kotak Mahindra Bank in FY2022, which was almost half of the total fraud cases. However, in FY 2021, 65 per cent of the cases were reported in this bank, amounting to Rs 57.72 crore. while during FY 2021, fraud incidents of Rs 64.23 crore were reported in this bank. Axis Bank had a fraud of Rs 25.07 crore in FY2022, which was 10 per cent of the total fraud incidents. 6,124 cases of online fraud were reported in

this bank during this period. During FY22, ICICI Bank reported 5,002 cases involving Rs 34.39 crore, while



HDFC Bank reported 3,866 cases involving Rs 10.61 crore. Whereas American Express Banking Corporation registered 2,258 cases involving Rs 5.83 crore.

ICICI Bank reported 1,390 fraud cases involving Rs 32.67 crore in FY 2021 and both amount and fraud cases increased in this bank in FY 2022. It is noteworthy that in the financial year 2021, the number of fraud incidents in the country's largest bank, State Bank of India, registered a decline of 40 percent and during the financial year 2022 only frauds of Rs 22.62 crore were committed in this bank. These figures show that public sector banks have achieved significant success in reducing online frauds as compared to

private banks.

In March 2023, Mr. Prafulla P. Sarda, a businessman from Pune, had sought information from the Reserve Bank of India in RTI about the incidents of online fraud in Indian banks, in response to which the central bank informed that from January 2014 to December 2022 in Indian banks A total of 1,40,736 cases of ATM and debit card frauds involving an amount of Rs 507.12 crore were reported, while 1,37,237 cases of credit card fraud involving an amount of Rs 514.90 crore were reported during the period. Whereas the number of frauds committed through internet banking was 61561 and Rs 354.78 cror was involved in these.

It is noteworthy that in the financial year 2014-2015, the number of ATM and debit

card frauds was just 71, which increased to 36,978 in the financial year 2019-2020 Similarly, the amount of ATM and debit card fraud in FY 2014-2015 was Rs 1.51 crore, which increased to Rs 102.13 crore in FY 2019-20. However, in the financial year 2022-23, the number of ATM and debit card frauds came down to 7,395 and the amount involved also came down to Rs 29.21 crore.

During the financial year 2014-15, only 119 cases of credit card fraud were registered, amounting to Rs 3.41 crore. In the financial year 2019-20, the number of frauds increased to 26.580 and the amount stuck was also Rs 74.69 crore, but in the financial year 2022-23, the number of credit card frauds came down to 20,017. However, the 'stuck amount' in the case increased to Rs 93.89 crore

The number of internet bank frauds was 42 in the financial year 2014-15 and the amount involved was Rs 2.20 crore, but in the financial year 2020-21 the number of frauds increased to 20,476 and the amount involved also increased to Rs 86.66 crore. However, in the financial year

2022-23, the fraud cases came down to 8,121 and the amount stuck also came down to Rs 69.96 crore.

It is clear from the data, despite all the efforts being made by the banks and the Reserve Bank of India, credit cards remain the easiest medium to commit frauds. Along with this, cyber fraudsters are also succeeding in committing fraud through internet banking, ATM, and debit cards.

Online fraud can be reduced only when people are made financially aware. For this, banks, government, and banking experts should be made aware to all through newspapers, television. cinema, and radio, as well as seminars/workshops should be organized regularly in schools, colleges, offices, villages etc.

It is clear from the above, caution is the only protection. Do not be greedy. This is the root of all problems. Do not come into psychological pressure. Do not hesitate to seek the help of the police in case of threats. Be fearless, only then online fraud can be avoided.

Canada's Consumer Price Index (CPI) rose 5.2 percent year over year in February, following a 5.9 per cent increase in January, the largest deceleration in the headline CPI since April 2020, the national statistical agency said.

Statistics Canada said on Tuesday that the deceleration in February was due to a base-year effect, for the second consecutive month. which is attributable to a steep monthly increase in prices in February 2022, reports Xinhua news

Excluding food and energy, prices were up 4.8 per cent year over year in February 2023, following a 4.9 per cent gain in January, while the all-items excluding mortgage interest cost rose 4.7 per cent, after increasing 5.4 per cent in January, it said.

According to Statistics Canada, on a monthly basis, the CPI was up 0.4 per cent in February, following a 0.5 per cent gain in January.

Compared with January, Canadians paid more in mortgage interest costs in February, which was partially offset by a decline in energy prices.

On a seasonally adjusted monthly basis, the CPI rose 0.1 per cent.

While inflation has slowed in recent months, having increased 1.2 per cent compared with six months ago, prices remain elevated.

Compared with 18 months ago, for example, inflation has increased 8.3 per cent, Statistics Canada added.

India will host the Hero trination international football tournament in Manipur to prepare for the upcoming Asian Football Confederation Cup, the quadrennial international men's football championship of Asia organised by the Asian Football Confederation (AFC). Team India will face Myanmar and Kyrgyzstan on March 22 and 28, respectively, at Imphal's Khuman Lampak Stadium. In the FIFA rankings, India is rated 106th, whereas Kyrgyzstan and Myanmar are ranked 94th and 159th, respectively.
