Punjab cabinet enhances crop compensation by 25 per cent at Rs.15000 per acre

CONSENT TO EXTEND THE **EXEMPTION OF 2.25%** STAMP DUTY AND FEES TO THOSE REGISTERING THEIR PROPERTY/LAND BY APRIL 30. THOSE OPTING FOR **REGISTRATION OF LAND** WILL NOW BE EXEMPTED FROM 1% ADDITIONAL STAMP DUTY, 1 % PIDB FEES AND 0.25 % SPECIAL FEES.

CHANDIGARH: In a major pro-farmer decision aimed at safeguarding their interests during natural calamities, the Punjab Cabinet led by Chief Minister Bhagwant Mann on Friday gave nod for hiking the compensation due to nature's fury by 25% per acre thereby giving a major respite to the food growers.

A decision to this effect was taken by the council of Minis-

ters in its meeting held here at the Punjab Civil Secretariat- I under the chairmanship of the

Chief Minister. Nod to extend exemption of 2.25% stamp duty and fees enhance the relief amount land registration by April 30

Keeping in view the larger public interest, the Cabinet also gave its consent to extend the exemption of 2.25% stamp duty and fees to those registering their property/land by April 30. Those opting for registration of land will now be exempted from 1% Additional stamp duty, 1 % PIDB fees and

0.25 % special fees.

The Cabinet also gave approval for hiring 2574 Kisan Mitras and 108 field supervisors in the Agriculture department. These Kisan Mitras and Field Supervisors will encourage the farmers to get out of the rut of wheat/ paddy circle and cultivate less water guzzling crops like Cotton and Basmati. This step will act as a catalyst to save precious groundwater of the state by boosting crop diversification program on one hand and providing employment to the youth of the

state on the other.

Election Commission in no hurry for Wayanad, announces bypolls to 1 LS, 4 Assembly seats



NEW DELHI: The Election Commission on Wednesday announced the date for the byelection to fill vacancies in one of Punjab and four Assembly constituencies in Odisha, Uttar Pradesh and Meghalaya.

However, the poll panel said that it is in no hurry to announce bypoll to the Wayanad Lok Sabha constituency after Rahul Gandhi's disqualification from the Lower

As per the Chief Election Commissioner (CEC), Rajeev Kumar, bypoll on the selected seats will be held on May 10 and the results will come out on May 13.

May 10 will also witness the Assembly polls in the southern State of Karnataka

However, the poll panel did not announce the bypoll schedule for Wayanad Lok Sabha constituency after Rahul Gandhi's disqualification from the Lower House.

The CEC on Wednesday said that the Election Commission is in no hurry to announce bypoll to Wayanad Lok Sabha constituency. Congress leader Rahul Gandhi has 30 days to exercise iudicial remedy in the 2019 defamation case. The CEC said the trial court in Surat has given Rahul Gandhi 30 days to seek a judicial remedy. "There is no hurry, we will wait, "he added.

The CEC said the vacancy in the Wayanad parliamentary party was notified on March 23 this year and as per the law, a bypoll has to be conducted within six months.

Referring to rules, he said that if the remainder of the term was less than one year, then the election will not be held. In the case of Wayanad, the remainder of the term is more than a year.

Punjab CM cleared a sum of Rs. 29,000 crore towards Cash Credit Limit for the procurement of Wheat CHANDIGARH: Due to concerted efforts of the Punjab gov-

ernment led by Chief Minister Bhagwant Mann, the Reserve Bank of India (RBI) has cleared a sum of Rs. 29,000 crore towards Cash Credit Limit (CCL) for the procurement of Wheat in Punjab during the ensuing Rabi Marketing Season (RMS). Meanwhile, the Chief Minister expressed satisfaction that the Union government has already released Rs 25,445 crore as CCL for the coming season. Bhagwant Mann said that with this, the bulk of the CCL sought by the state government for the purchase of Wheat for this season has been released by the central bank. Expressing gratitude to the Centre for timely release of CCL, he said that it will go a long way in ensuring seamless procurement of Wheat during the current

Meanwhile, the Chief Minister, while chairing a meeting of Food and Civil supplies department, directed the officers to ensure smooth and hassle free procurement of every single grain of the farmers. He categorically said that payment to the farmers for their produce must be ensured from the very first day of procurement i.e. April 1, 2023. Bhagwant Mann reiterated the commitment of the state government to procure every single grain of the golden harvest of the farmers. The Chief Minister said that elaborate arrangements will be made for the procurement of the wheat so that farmers do not face any sort of inconvenience. Bhagwant Mann said that the state government is duty bound to ensure procurement of the grains in a smooth and hassle free manner. Pertinently, the procurement of wheat will begin from April 1 and culminate on May 31 during the current RMS

GST collection likely to cross Rs 18 lakh cr this financial year

NEW DELHI: India's Goods and Services Tax(GST) collection is expected to cross Rs 18 lakh crore in the current financial year that ends on March 31, reported Hindustan Times quoting two officials aware of the development. In the first 11 months of

FY23, the GST collection has already surpassed Rs 16 lakh crore, witnessing a 22.7 per cent year-on-year growth, according to data from the finance ministry. It is expected that the

growth trend will be maintained even in the last month and at leastRs 1.50 lakh crore revenue is expected in March, the officials added. According to a co

estimate, even if the average Rs 1.49 lakh crore monthly GST collection (thus far in 2022-23) is maintained in the month of March, the total GST revenue for 2022-23 would be Rs 17.88

ShiromaniGurdwaraParbandhak Committee (SGPC) for the financial year 2023-24 has been passed during the general meeting held at Teja Singh Samari Hall in Amritsar today.

In the general meeting, SGPC General Secretary BhaiGurcharan Singh Grewal presented a budget of Rs 1138.14 crore, which was passed by the SGPC members amid resonance of Sikh slogan of high spirit - Bole So Nihal Sat Sri Akal. Head granthi (Priest) of Sachkhand Sri Harmandar Sahib GianiJagtar Singh, Jathedar of Takht Sri Kesgarh Sahib GianiRaghbir Singh, SGPC President Harjinder Singh Dhami, SGPC office-bearers and members were present during the budget meeting.

Sharing information to the media after the budget meeting, SGPC President Harjinder Singh Dhami said that the budget of SGPC has recorded a 17% increase as compared to last year. He said that the budget of the last financial year (2022-23) was around Rs 988 crore, while this year (2023-24) it is estimated to be about Rs 1138.14 crore. He said that the passed budget includes SGPC, DharamPrachar Committee, historical Gurdwara Sahibs under Section 85, educational institutions, printing presses, etc. Out of the total



budget, the budget of Gurdwara Sahibs is Rs 855 crore.

SGPC passes budget of Rs 1138.14 cr for 2023-24,

Dhami said that the basis of the entire budget of the SGPC is offerings made by the Sangat in Gurdwara Sahibs, and the annual expenses are determined accordingly. He said that in this budget, under the future plans, Rs 1 crore has been earmarked for Nishchai Civil Services Coaching Academy, Rs 7.09 crore for establishing Sikh Prachar Centre abroad. Rs 4.72 crore for installing solar plants at Gurdwara Sahibs in view of environment preservation, Rs 24 crore for building new sarais (inns) associated with Sachkhand Sri Harmandar Sahib, Amritsar, Rs 60 lakh for community welfare labs and medical stores, Rs 1.80 crore for Panthic matters and litigations, Rs 3.69 crore for DharamArth Fund and Panthic Welfare Fund, Rs 1.11 crore for natural calamities, Rs 1.70 crore for education of Sikh students.

Similarly, Rs 3.70 will be spent for Sikh preaching in

states outside Puniab, Rs 2 crore for upcoming centenaries, Rs 2.50 crore for Gurmat-Samagams (religious congregations), Rs 3.05 crore for sports academies. SGPC President said that a special amount has been arranged for the release of BandiSinghs (Sikh prisoners) and for pursuing their cases, as well as to support the families of BandiSinghs. The budget has also been kept for poor students. scholarships to Amritsar (initiated) students, Sikligar and Vanajara Sikhs.

He said that the priority future plans of the SGPC include pursuing Sikh issues, religious preaching, public welfare work, health facilities and education. He specifically mentioned the academy opened to prepare Sikh youths for competitive exams of civil and administrative services. Dhami said that 25 candidates will be given free coaching every year in SGPC coaching academy, for which, an amount of Rs 1 crore has been earmarked in the budget for the first year.

HAL Registers Highest Ever Revenue of Rs.26,500 Crores during FY 2022-23

HAL registers highest-ever revenue from operations of around Rs. 26,500 Crores (provisional and unaudited) for the Financial Year 2022-23 as against Rs. 24,620 for revenue growth of 8% during the year as compared to the previous year, 2021-22, state-

ment from HAL said. "Despite the challenges of supply chain disruptions due to geo-political situations, the Company could achieve the targeted growth in the top line. He said that the project includes multiple foot over bridges, sky walk plaza in front of GurudwaraShaheedan Sahib as suitable crossing facility for pedestrians and pick up points. The plaza will have a cluster of entry/ exit points through stairs, escalators, lifts for ease of pedestrian movement. He said that this project will ensure the safety and convenience of pilgrims.

Municipal Corporation Commissioner Sandeep Rishi said that provision of facilities like toilets for pilgrims, tourist information center and police post in the skywalk project will ensure safety and convenience for the congregation. He said that the plaza will be developed through landscaping and beautification which will increase its efficient use. He said that the length of this skywalk from RamsarGurdwara to ChatiwindChowk will be 460 meters, width 6 meters, height 6 meters from the road, Skywalk Plaza will have 16 stairs, 16 escalators and 7 lifts. He said that this project has to be completed by the company within one and a half years.

It may be mentioned here that sixty thousand is a daily footfall to the gurdwara and visiting devotees have to cross the busy road to pay obeisance in the Sikh shrine. With the construction of this project, the problem of bottleneck traffic congestion will also be resolved.

Is poverty a challenge in Punjab? DR. SRIDHAR KUNDU

Punjab is one of the resourceful states in India. Puniabis are known for their nature of giving and forgiving. They are well known for their good eating habits. The state serves as the food basket of the country. Food produced in the state is distributed across the country and exported to other nations. In a food surplus state like Punjab, it needs adequate courage to write something about poverty as a challenge. I. Poverty scenario in 2011-12

The nationwide household consumption survey by the NSSO held in 2011-12 says that 8.2 percent of the population of the state live below the poverty line, 7.6 percent in rural and 9.2 percent in urban. This ratio is relatively lower compared to 22 percent of national averagepoverty ratio which includes 25 percent of poverty in rural and 14 percent in urban. The people living below the poverty line is one of the important measures of poverty. This measure counts the number of people or household fall below a pre-defined income or consumption expenditure. As a result, under this measure, every household below this line is considered equal. The extreme or severity of poverty is not adequately explained by this measure.

The other measure i.e., Poverty Gap Ratio (PGR) as defined under the SDG national indicator framework 3.1 explains the extreme or severity of poverty in a state. PGR is defined as the gap ratio by which mean consumption of the poor living below poverty line falls short of the poverty line. It indicates the depth of poverty. A higher PGR ratio shows

a higher level of poverty intensity. By the measure of PGR index, Punjab stands far below the national average. With the help of NSSO

consumption expenditure survey after 2011-12. This creates problems to count poverty ratio in the recent past and track the development related to nation and state level poverty reduction. The Situation Assessment Survey (SAS) for agriculture households by the NSSO can provide some information about status of poverty in rural India and states. Estimation from SAS in the last two rounds i.e. 70th in 2013 and 77th in 2019 shows, that there is an increase in poverty percentage among agriculture farmers in Punjab. The agriculture poverty in the state was 2.7 percent in 2013 and increased to 7.3 percent in 2019. However, at all India level, there is

Punjab in a better position. The estimated MPI score for Punjab in 2018 stands at 0.024 compared to all India's MPI score of 0.4. However, at district level in Punjab there are wide differences in existence of poverty in terms of MPI. Firozpur stands first with the highest MPI of 0.047 whereas, Jalandhar ranks the lowest with MPI score of 0.008. III. Poverty as a challenge The above estimates show that

poverty is even harsh. The rising agriculture poverty is not a good sign of development. However, the comparative better-off position of the state in various poverty indices though serves as matter of relief.

Going ahead further, it is a challenge to make the state poverty free, not just to serve the commitment under SDG but to restore the selfrespect as a developed state in the country. The challenge can be even bigger in future as the state economy is not in a better position.

Economic growth which is important for addressing the issue of poverty is lower compared to many other states in India. During the pandemic year 2020-21, the GSDP growth in the state fell by over 7 percent. The post pandemic recovery in growth is also not satisfactory. In 2021-22, the registered growth rate is less than 6 percent whereas, the same in Telangana, Odisha and Andhra Pradesh is above 10 percent. cent during 2013 and 2019, which

Second, the state government is not in a better financial position to support the development programs which could better address the poverty exists in both rural and urban areas. The government debt has come closer to 50 percent of the GSDP and the fiscal deficit stands at 3 percent. A major share of the fiscal deficit is used to honour the existing debt burden. The state government is not in a position to expand the capital spending which could help generating local employment and contribute to poverty reduction. Therefore, poverty in the state though stands at a relatively lower level, it is a challenge to eliminate it in all forms by 2030 as SDG com-

Govt. aims to bring down logistics cost to a single digit at 9% by the end of 2024: Nitin Gadkari Lalit Modi threatens to sue Rahul Gandhi in UK

The main challenge in the Indian industry, trade and business is the high cost of logistics which is currently at 16%, whereas in European countries and America it is 12% and in China it is 8%. By the end of 2024, the aim of my ministry is to bring down logistics to a single digit at 9% which in turn will help us increase export, said Nitin Gadkari, Minister of Road Transport and Highways, GoI. He was speaking at the ASSOCHAM Annual Session 2023 held at Delhi.

"To accomplish this, the government is focusing on improving both roadways and railways. We are building green highways and industrial corridor with focus on reducing the distance between major cities and hubs." He further added.

Talking about some of the key national highway projects Nitin Gadkari said, "After completion of the Delhi-Mumbai expressway, people can travel between Delhi and Mumbai in just 12 hours; Nagpur Mumbai in 5 hours and Nagpur Pune in 6 hours. This will help reduce the logistics cost. We are



building tunnels in Jammu and Kashmir and Ladakh and these are going to reduce the distance drastically. For example from Manali to Rohtang pass it us to take a travel time of 3 ½ hours and now with Atal Tunnel, one can cross the tunnel in just 45 minutes and reach in 8 minutes after coming out of the tunnel."

Discussing about saving fuel cost by focusing on alternative fuel Gadkari said, "Our focus should be on converting waste to wealth. For example, Delhi has three mountains of solid waste. Within next two years this waste will be used in road construction, flattening the waste fields. We are focussing



the date of issue and no payment will be made to any payee political party if the bond is

validity period.

The electoral bond deposited by an eligible political party in its account can be credited on the same day.

The government had notified the electoral bond scheme on January 2, 2018 and as per its provisions, electoral bonds can be purchased by a person who is a citizen of India or incorporated or established in India. A person being an individual can buy electoral bonds either singly or jointly with other individuals.

Also, only political parties registered under Section 29A of the Representation of the People Act, 1951 (43 of 1951) and which have secured not less than one per cent of the votes polled in the last general election to the Parliament or state assemblies, are eligible to receive the electoral bonds.

The bonds can be encashed by an eligible political party only through a bank account with the authorised bank.

Revamped CGTMSE to come into effect from 1st April 2023





NEW DELHI: The revamping of Credit Guarantee Scheme for Micro & Small Enterprises (CGTMSE) announced by Union Finance Minister Nirmala Sitharaman in the Union Budget 2023-24 will come

into effect from 1 April, 2023. It will be applicable with an infusion of Rs 9,000 crore to the corpus to enable additional collateral-free guaranteed credit of Rs 2 lakh crore and the reduction in the cost of the credit by about 1 per cent.

CGTMSE has issued guidelines regarding reduction of annual guarantee fee for loans

upto Rs 1 crore from a peak rate of 2 per cent per annum to as low as 0.37 per cent per annum.

This will reduce the overall cost of credit to the Micro & Small Enterprises to a great

The limit on ceiling for guarantees has been enhanced from Rs 2 crore to Rs 5 crore.

For settlement of claims in respect of guarantees for loan outstanding upto Rs 10 lakh, initiation of legal proceedings will no longer be required.

CGTMSE created a new landmark by touching the milestone figure of approving guarantees worth Rs 1 lakh crore during FY 2022 - 23.

Questions on the significance of the 'old pension scheme'



Recently, the State Governments of Rajasthan and Chhattisgarh have re-implemented the Old Pension Scheme (OPS)

in their respective states. Subsequently, employees and political parties of other states of the country have started pressurizing the government to implement OPS in their states, as this scheme makes the life of employees easier after retirement and political parties may get lakhs of votes in every election. The basic reason for the abandonment of OPS by the Central or State Governments was the steady increase in the expenditure on pension head. In some states, due to increase in expenditure on pension head, their fiscal deficit has increased to a great extent.

The Old Age Social and Inwas introduced in the year 1999 financial reforms and financial good governance. In this report, it was clearly said that the central and state governments need to cut unnecessary expenses, so that a balance can be maintained between expenditure and earnings. It was said in this report that the facilities being provided free of cost should be banned on priority basis. Based on this report, in the budget speech of FY 2003, the then Finance Minister said that National Pension Scheme (NPS) would be implemented in place of OPS for central employees

Under OPS, retired employ-

ees are given 50 per cent of their last drawn salary plus dearness allowance as monthly pension, while under NPS employees have to contribute 14 per cent of their salary every month, which is payable on attaining the age of retirement. After that, it is given to the employees in the form of pension. According to the NPS trustees, by December 2022, 59.78 lakh state government employees had opted for NPS, and its total assets were Rs 4.27

The then government had announced the implementation of NPS in the budget of FY 2003, yet it was left to the choice of the states to adopt it or not. There was no coercion in the matter from the Central Government. Nevertheless, by the year 2005, 27 states had adopted NPS. However, Tamil Nadu and West Bengal have not implemented this scheme yet.

the FTP 2023 comes without a five-year expiry date. The new policy heralds a new era for ecommerce exports and third party trading. It also brings an amnesty scheme to resolve pending disputes of export obligations under EPCH scheme valid up to 30 September, 2023. The FTP 2023 claims to stands on: Incentive to Tax remission; Export Promotion through collaboration with exporters with States and Districts; Trade Facilitation technology and automation and Focus stricts as export hubs or exports under SCOMET framework. The Micro, Small & Medium Enterprises (MSMEs) sector has welcomed substantial reduction in fees for Advance Authorization and EPCG licence

Four MSME dominated towns have been declared as Town of export excellence namely Faridabad (Apparel); Moradabad (Handicrafts); Mirzapur (handmade carpet) and Varanasi (handloom and handicraft). con Valley Bank has shaken the whole world recently.In just 5 days, this bank was declared bankrupt. It is also worth noting here that during the Corona epidemic, when all the sectors of the economy were in a phase of decline, deposits of this bank in America rose exponentially. Then what went wrong that this bank, which was the main source of income for Amarican technology startups with , fell apart? It is worthwhile to mention that this bank was established in 1983 and after 5 years of its supervision on the bank's loan establishment, it was listed on policy so that the economic Nasdag in the US stock market through an IPO in 1988. From 1996, it started banking business in 15 major states of America and since 2008 it expanded its presence in other countries as well.

This move led to shortage of cash in the bank and resulted in the bank being declared bankrupt. In fact, the main reason be-

period, when interest rates were nificantly, suddenly the value too low to maintain per capita purchasing power, American technology startups had a lot of financial investment, which was comparatively much lower they deposited continuously in silicon valley bank in exchange for a good return. As a result, the bank's deposits doubled in the same period. After the pandemic i.e.in the current financial year 2022-23, the US Fed suddenly changed its economic policies and increased US interest rates significantly to strengthen the dollar relatively against all other currencies in the world. The main reason behind this was also to bring down the sky high inflation rate. The financial impact of this policy suddenly fell on the economic policies of Silicon Valley Bank. which was probably neither predicted by the American Fed nor the Silicon Valley Bank. When Silicon Valley Bank was getting a lot of financial deposits from American technology startups, it invested them in American government securities or bonds because the rate of interest in them was quite attractive during that time. Over the past

in the past. During the Corona has raised interest rates sigof investment in government securities or bonds started falling as the rate of interest on them and they were now not attractive. As a result, Silicon Valley Bank started incurring losses on its investment. In this panic condition, when the investor started selling investments in government securities, the deficit increased further and this news discouraged all financial investors and made them to feel insecure. As a result, most investors started withdrawing their financial investments immediately from Silicon Valley Bank. In this context, it is also important to mention that the amount deposited per investor in this bank was 250000 US dollars, which was much higher than small banks. The second main problem with this bank was that the investment in this bank came only from technology companies and for the last few years, technology companies or startups have been facing economic crisis, as a result there was always a restlessness among all of them one year, when the US Fed about their financial deposits.

Banking Policies in the US on the wrong track whether India's banking system is like the American banking system. On this side, it has to be made very clear that India's banking system is completely safe, although in the current financial year, the Reserve Bank of India has also increased the repo rate more than four times so that the level of inflation can be controlled. Certainly, this move of the Reserve Bank of India has caused economic losses to all the banks that had invested in government securities. But this was predicted by India's central bank in 2018 and hence all banks have to keep financial planning equivalent to 2 percent of investment in government securities as a financial fund so that financial security can be provided to investors through it. According to the available data, when interest rates were increased in the first quarter of the current financial year, Indian banks also suffered losses of around Rs 15,000 crore, but they all are safe because they already had financial funds related to it. It would also be appropriate to mention that banking failure is very rare in Indian

Now it is argued in India history and even if an example comes up, immediately after that the policies of the banks are made very transparent by the Indian Reserve Bank and its compliance is followed by all small and big banks. The economic recession of 2006 in America was also due to the economic ruin of one of their big investor banks, but even after that, if America's banking system is not completely transparent till date, then it is a matter of great economic concern. It is often said that the anticipation of America's recession already leads other countries into despair. The positive thing about India's economy is that there is strict adherence to banking policies, whether it is Basel III rules or other important information. All banks are required to comply with all of them. Therefore, it is imperative to say that Indian banking is completely safe and it's the backbone of our strong economy.

fourth quarter of 2022, last year was a successful one for the Indian PC market (desktops, notebooks and tablets), with shipments up 5 per cent to reach 19.6 million units, a new report has said.

While notebook shipments fell by 7 per cent to 11 million units, desktop and tablet shipments increased significantly by 37 per cent and 21 per cent to 3.2 million and 5.4 million units respectively, in 2022, reports market research firm Canalys.

HP led the Indian PC (excluding tablets) market, with more than 30 per cent market share in both Q4 and full-year 2022. Lenovo took the second place but suffered a large shipment decline of 31 per cent in Q4 of 2022. However, the total 2022 shipments for Lenovo were up by 3 per cent on 2021, with its commercial business gaining traction. Dell and Acer took third and fourth place respectively, while Apple secured the final spot in the top five in Q4

in Q4 2022 to take the lead in the Indian tablet market, said the report. "Indian consumers spent on devices in the first half of 2022, but demand quickly tailed off, leading to a weak holiday season for vendors and retailers, "said analyst Ashweej Aithal. Looking ahead, Canalys anticipates that PC and tablet shipments in India will fall by 6 per cent in 2023, to 18 million units. This represents a smaller drop than for the global market, which is expected to contract by 9 per cent.

Apple contribution to 'Make in India' smartphone reaches 25% in value terms

NEW DELHI: 'Make in India shipments from Apple grew 65 per cent (on-year) by volume and 162 per cent by value, taking the brand's value share to 25 per cent in 2022, up from 12 per cent in 2021, a new report has shown.

The contribution of exports in 'Make in India' smartphone shipments reached the highest ever in 2022 both in volume (20 per cent) and value terms (30 per cent), according to Counterpoint Research. Overall, 'Make in India' smartphone shipments declined 3 per cent YoY in 2022 (January-December) to reach 188 million units.

The major factor behind this decline was the softening of consumer demand due to macroeconomic headwinds, especially in the second half of the year

The Committee noted that the Ministry of Heavy Industries (MHI) had sanctioned 520 Charging Stations and Infrastructure for Rs 43 Crore (approx.) Under Phase-I of FAME-India Scheme launched in 2015 and under phase-II of FAME-India Scheme launched in 2019, Rs 1000 Crore has been allocated for supporting charging infrastructure for electric vehicles in the country.

As per the report, MHI sanctioned 2, 877 electric vehicle charging stations in 68 cities and 1576 charging stations across 9 Expressways and 16 Highways under phase-II of

FAME India Scheme.

The report pointed out significant cost escalation on charging stations under the two phases of the FAME scheme. As per the Ministry of Power guidelines, there shall be at least one charging station at every 25 kms on both sides of the Highway and also at least one Charging Station for Long Range/Heavy Duty EVs at every 100 kms on both sides of the

At present, the number of EV charging stations sanctioned under FAME is very meagre as India has about 63.73 lakh km of road network, which is the second largest in the world. The Committee is of the view that the reason for slow pace of installation of the sanctioned charging stations under FAME should be examined.

The Parliamentary panel has noted that as more and more EVs show up on the road, frequently placed smart charging stations would make movement for long distance smoother and faster. Hence existing highways or expressways would be ultimately required to become e-highways. The Committee recommended that MHI should coordinate with other Ministries and charging infrastructure operators to frame a comprehensive plan for rollout of a nationwide public charging

Glittering Gold in India

In the 75 years

of independence, the price of gold has increased manifold. At the time of the country's independence, the price of 10 grams of gold was Rs.88.62 and in the year 1964, its price came down to Rs.63.25. Further, it increased to Rs.10,000/-on 5th May 2006. It again increased to Rs.50,000/- on 22 July 2020 & it went to a level of Rs 62,000/- with Goods and Services Tax (GST) on 20 March 2023 & again, it came down to Rs.61625/-on 31st March 2023.

Here, question arises, why does the price of gold increase? Why its demand suddenly starts increasing? Usually, when the pace of the economy slows down, the traditional means of investment start yielding less and due to the instability of the market, there are chances of sinking of the investment. On the contrary, gold is not affected by the volatility of the market or the sluggishness of the economy. Because of this, when the economy weakens, common people's trust in gold increases and they start investing in gold, due to which its price increases

At the time of independence, India's gross domestic product (GDP) was Rs.2.7 lakh crore, which increased to Rs.135.13 lakh crore in the financial year 2020-21. The first five-year plan started in the year 1951, but it was not very successful in strengthening the economy. The subsequent five-year plans also could not yield the expected



results. However, from the year 1961, growth in the Indian economy started becoming visible. From the year 1950 to the year 1979, the country's GDP was growing at an average rate of 3.5 percent, which was called "Hindu growth rate" in the Indian economy, whereas from the year 1950 to the year 2020, India's GDP growth rate was at an average rate of 6.15 percent. In the first quarter of the year 2010, the GDP rate reached the highest level of 11.40 percent, whereas in the fourth quarter of the year 1979, it recorded the lowest growth of 5.20 percent. In the year 1960, India's per capita income was US \$ 81.3, which increased to US \$ 7332.9 in April 2021.

The annual growth rate of per capita income in the country was 3.1 percent on an average during the financial year 1980-81 to the financial year 1991-92, which increased during the financial year 1992-93 to the financial year 2002-03, which again doubled during the financial year 2003-2004 to the level of 7.2 per year on an average during the financial year 2007-2008.

ernment of India started doing economic reforms, which is still going on today. In the year 1991, several measures were taken to bring positive changes in the areas of foreign trade, tax reform, foreign investment etc., which helped the Indian economy to move forward. It is noteworthy that even during the Corona period and the global recession, GDP is estimated to grow at the rate of 7 percent in the financial year 2022-23. In this way, due to the ups and downs in the economy, the price of gold is also fluctuating. At present, people have lost faith

in other means of investment due to rising inflation, loan interest rates remaining high, global geopolitical crisis, fear of global recession, bankruptcy of banks in USA and Europe etc. And for this reason, a decline has also been registered in the stock to an average level of 3.7 percent market. People are feeling that by investing in gold they can keep their money safe as well as they can get good returns. The thinking of the common people is also correct to a great extent, because in the last 4 years gold has given 100 percent

return to the investors, while bitcoin has given 600 percent, silver 76 percent and copper 37 percent. At the same time, a 50 percent rise has been seen in the stock index during this period.

Central banks of some countries have bought more than 1136 tonnes of gold in the calendar year 2022, which is the highest in any calendar year and they may buy more gold in the coming months to widen the gamut of their deposit base.

The dollar index is seeing a decline again, due to which the demand for gold is expected to remain high. Due to the rise in the price of crude oil, the ongoing war between Russia and Ukraine, the side effects of the Corona pandemic, etc., the inflation is still on higher side and to controlling it, the central banks of many countries are constantly taking strong policy measures.

The Federal Reserve Bank of USA has taken an aggressive stand in the matter from the beginning. It again raised interest rates by 0.25 percent on March 22, 2023. Now, interest rate increased from 4.75 percent to 5.00 percent, the highest level since 2007. It is expected that the Reserve Bank of India can also increase the reporate by 0.25 percent in the first week of April. Due to this, the loan rate of banks will increase further, and the growth rate will be adversely affected, due to which the demand for gold will increase further. Apart from this

looking at the history of 50 years of fluctuations in the price of gold shows that the major fluctuations in the price of gold continue for 4

to 5 years. In India, people's craze for gold has been there since time immemorial, but there is no expected production of gold here. That is why India has to depend on other countries to meet its domestic requirement. Today India imports 45.8 per cent gold from Switzerland, 12.7 per cent from United Arab Emirates (UAE), 7.3 per cent from South Africa and Guinea and 5 per cent from Peru to meet the domestic requirement. India comes second in the world after China in terms of buying gold.

India's trade deficit is increasing due to high import of gold. Therefore, the import duty on gold was increased from 7.5 percent to 12.5 percent to reduce gold imports, as there was a 33 percent increase in gold imports in the country in the financial year 2021-22. However, 833.07 kg of smuggled gold was also seized during this period. The value of gold imports was Rs 37.44 billion, while the value of smuggled gold was Rs.405 crore. After increasing the import duty, gold smuggling in India increased by 47 percent in the year 2022 with 3502 kg of gold seized, which shows that it is impossible to stop Indians from buying gold. Therefore, the price of gold is expected to remain bright in the coming

Rahul Gandhi case: It's time to abolish criminal defamation

he legal and political realms have converged to challenge Congress leader Rahul Gandhi, following a controversial remark he made during the 2019 elections. A Surat court has deemed his comment, "how come all of these thieves have Modi in their names?", defamatory and sentenced him to two years in prison, disqualifying him from the Lok Sabha. The verdict raises legal questions: does the statement defame a specific individual or a group sharing the 'Modi' surname? Precedent suggests that, for defamation, the targeted group must be identifiable, and the individual initiating proceedings must prove personal harm from the alleged statement. It is hard to argue that all individuals with the 'Modi' surname, rather than just the three mentioned, including PM Narendra Modi, can be considered aggrieved parties. Moreover, it remains unclear if the complainant, BJP MLA Purnesh Modi, demonstrated personal harm or injury due to the alleged comment. The maximum sentence raises concerns as well. Laws establish maximum sentences so courts can use discretion to assign proportional punishments. It is debatable whether such a general remark constitutes defamation and, if so, whether it merits the maximum sentence. The judgment's validity will be determined on appeal, but the political consequences for Gandhi, including disqualification from the House and electoral contests, could be long-lasting unless he secures a stay on the conviction rather than just a suspension of the sentence. The criminalization of defamation in India is ironic in a country grappling with criminalized politics, corruption, and hate speech, and its potential to derail a prominent leader's career is concerning. Modern democracies should not consider defamation a criminal offense. The 2016 Supreme Court ruling upholding criminal defamation did not sufficiently consider its chilling effect on free speech, political opposition, and dissent. Opposition parties expressing concern over Gandhi's verdict should include abolishing criminal defamation in their agendas.

The street dogs-human conflict



or about 25,000 years, we have coexisted with dogs. Dogs protect us, and give us emotional support and companionship. They are loyal, friendly and intelligent. We are now witnessing a disintegration of this beautiful bond. Intolerance is growing not only towards dogs, but also cats, cows, birds and other creatures. We then extend the same intolerance towards friends, family, neighbours, co-workers, co-passengers and strangers. It has been proven that when a person is mean to animals, he is also mean to his own species.

Identifying an enemy

Resident Welfare Associations (RWAs) are often the instigators of violence. The person who stands for election in these societies knows that he has no real power: no control over maintenance, electricity, building, sale, rent, or water. What he can control is the choice of guard at the gate, and whether dogs should be allowed inside. Power demands that an enemy be identified, so dogs living there peacefully become the target. And by constantly heckling them, we make dogs nervous. Residents have told the police that the child who was bitten to death in Hyderabad would constantly beat and tease three animals. The residents repeatedly warned the child's father. On top of that, the father, the watchman, had refused to let anyone feed the dogs for three days. Then, the society chairman/secretary targeted the humans who fed the dogs and made the community safe. Then came the mobs, instigated by statements of violence on group chats. When the RWAs go for election, both groups vie with each other on the level of violence they will inflict on animals — whether dogs, cats or pigeons.

Conflicts between humans and dogs are only symptoms of the real problem. Dogs get aggressive when they perceive a threat. They want to protect themselves or their

litter from attacks if they are unwell or hungry, have been forcibly relocated, or have witnessed abuse and neglect. This can be remedied if we are kind to them and follow management rules which have been clearly set out by national and State governments and various courts.

During colonial times, dogs and Indians were disallowed from entering areas of privilege. Both were treated with violence and contempt. Street dogs were routinely killed so that their numbers would reduce. That did not work then, and it will not work now. Nature allows animals to have as many offspring and as frequently as there is space in the environment. If there is a vacuum, it will be occupied by a more inconvenient species, such as rats, mice, mongoose and cockroaches. The London Plague of 1665 was a result of the killing of 2,50,000 dogs and cats. The mice population grew, and 70% of the human population was wiped out by the Black Death pandemic. A similar incident happened in Surat not long ago and we had a plague scare as a result of removing dogs.

Indeed the multiplication of dogs on

the streets must be curtailed. The Animal Birth Control (Dogs) Rules (ABC Rules) of 2001 have been recommended by the World Health Organization and the World Organisation for Animal Health as the only way to bring about a sustained decline in the dog population, incidence of rabies, and aggression in dogs. However, necessary measures have not been implemented by local authorities to adequately and scientifically manage the street dog population. The lack of budget and infrastructure, the prevalence of corrupt and inefficient practices, and the absence of transparency and monitoring were the challenges for two decades. Recently, the Central government issued a new set of ABC Rules that bridge these gaps. Rather than seeking the removal of dogs, the responsible and effective strategy would be for citizens to demand from the municipal bodies an ABC Programme in accordance with the new ABC Rules of 2023.

Adopt native dogs

A proactive approach would be to encourage the adoption of Indian dogs. If one person out of every 100 people adopts a on the roads. The fascination for foreign breeds keeps alive the brisk business of cruel puppy mills and dingy pet shops. Most dogs of foreign breeds in pet shops have parvo or distemper and die within weeks. In 2016, the Central government prohibited the import of pedigree dogs into India. In 2017, it notified Rules for strictly regulating dog breeders. In 2018, following a recommendation by the Law Commission, the Pet Shop Rules were notified to prevent the trade of pedigree dogs. Why has Tamil Nadu allowed over 3,000 illegal pet shops and breeders to exist? No attempt has been made to follow the rules. If pet shops are stopped, most dog-related problems will disappear.

Native dogs have better immune systems and make great pets. If a family adopts a native dog or if caregivers feed and socialise with community dogs and help get them neutered, it would be of service to the community. The importance of people who look after native dogs on the streets has been recognised by our courts, such as by the Delhi High Court in Dr. Maya D. Chablani v. Radha Mittal. Also, in the new ABC Rules, community dog caregivers have peen granted protection from harassment.

Reports of dog attacks must be tested on the benchmark of proof. Recently, it was reported that two children had been killed by dogs in Vasant Kunj in New Delhi. The Mayor clarified that the autopsy report had not been obtained and that the chances of the children being killed by dogs was slim. But by then, outrageous speculation had already been circulated widely as fact. If we claim to be the superior species, we must act responsibly, scientifically and humanely. Anything else will lead to chaos and misery for all species.

HASMUKH ADHIA EXPLAINS WHY PUBLIC ADMINISTRATION SHOULD BE A COMPULSORY PAPER FOR UPSC EXAM

The country needs public policy education



overnment policies are pivotal in deciding the future of a country. Good public policies spur economic growth and public welfare and improve ease of living for citizens. However, there is little interest in public policy education in India. Only a small percentage of policymakers civil service officers — are exposed to the formal study of public policy and public administration. In this context, this article carries a few suggestions which could boost public policy education in India. The phrase 'public management' is used oth public policy and public administration.

The Indian bureaucracy has many talented people working at various levels. However, governance is still perceived to be lagging behind private sector management, in terms of efficiency and effectiveness. This is largely due to lack of training in public management. Over a span of 37 years in the civil service, I have observed that many policymakers are under-equipped to develop effective policies. Until the time I went to IIM Bangalore for public policy education, which was after 20 years of service, I was also an intuitive decisionmaker. But institutional training in public policy changed the paradigm that I was following in my role.

Most executive jobs in the organised sector are in government or government-owned agencies and require an understanding of public management. However, the supply of formal education in public management is inadequate as compared to business management education. As per data from the All-India Council for Technical Education, there are 3,182 institutions with an

of 4.22 lakh in business management programmes, but only about 130 public, private and not-forprofit universities that offer public administration programmes and only 29 insti-

Of these 29 institutions, 17 are private, four are semi-private, and eight are state-funded institutions. In general, the batch size of public policy courses is 20-60.

The reason why universities don't have many programmes of public management is because there are few jobs available for people pursuing such courses. The private sector offers limited opportunities in government advisory roles, consulting and Corporate Social Responsibility. For public sector opportunities, students have to go through competitive exams. Therefore, neither educational institutes nor students find any incentive to prefer public management courses in place of technical or management courses that offer lucrative private sector opportunities.

Further, there are very few civil servants who have got exposure to public management before joining service. Most of them undergo the departmental induction training programme which is focused on the role that they play in their department. They do not learn much about how to make good public policies.



ing 86 from the IAS) went abroad to study public management at the Master's level. Within the country, there are five institutions in which 194 civil service officers have been sponsored by the government for full-time public policy courses in the last three years. Contrast this with 1.3 lakh Group A officers in the Government of India today.

Three suggestions

Given this background, my first sug-gestion is that public management should be one of the compulsory subjects for the UPSC civil service examination. The introduction of a public management paper can either be a substitute for one optional subject or an additional paper. This will help in multiple ways. First, civil servants who join government would have formal education in public management before they enter service. Second, since about five lakh candidates appear for UPSC civil service every year and each one of them will need to prepare for the public policy paper, this creates an opportunity or incentive for universities and private graduate or post-graduate level. Public policy education, research and case studies will get a major boost from this new demand. Third, even if only 10% of UPSC aspirants make it to various government obs, including at the State level, others who studied this subject for the examination would develop better understanding and sensitivity towards complexities involved in public management, making them better citizens as well as effective private sector

Some may wonder whether it is fair to subject. Yes, it is fair and this should not cause any difficulty. According to data of the last three years of UPSC aspirants, on average, 50% of the aspirants preferred an optional subject other than their graduation subject for the UPSC main exam. This indicates their willingness to learn whatever it takes to succeed in the exam.

Reliable data, good policy

The second suggestion is that existing training institutions of the government should have a larger component of public policy as part of induction training. Also, they should build up a case study bank for training.

Third, the government can create certain specialised positions of public policy analysts, to be picked up from the market directly, so that new job avenues for the graduates of public policy programmes can be created.

alman Rushdie's latest novel, Victory City, marks a triumphant return for the renowned author. Following a vicious attack in New York last year, Rushdie reclaims his place in the literary world with this captivating work. 

Trump to be tried on charges relating to hush money to adult film star

NEW YORK: Impacting the 2024 US presidential elections, Donald Trump will become the first former American President to go on trial following his indictment on charges relating to a payoff to buy the silence of an adult film star who claimed to have had an affair with him in 2016.

Manhattan prosecutor Alvin Bragg's office confirmed the indictment by a grand jury on Thursday evening and said Trump's lawyer has been contacted "to coordinate his surrender", which would be an unprecedented event in the history of the US. While the indictment remained under seal, media reports quoting unnamed sources said that there were about 30 separate charges. Complicating the scenario, Trump is a frontrunner for the 2024 elections, just 1 per cent behind President Joe Biden in polls, according to RealClear Politics which aggregates survey results.

He is also ahead of his nearest rival, Florida Governor Ron De-Santis, by 16.8 per cent for the Republican Party's nomination. Under the US constitution, his indictment or even a conviction will not prevent him from running for President. But were he to win in spite of an indictment or even a conviction, the US will be in unchartered territory. Trump said the indictment "is political persecution and elec-



tion interference at the highest level in history". Indian-American member of the House of Representatives member Raja Krishnamoorti said in an email to supporters that "in moments like these, we are reminded that no one is above the law, not even former Presidents".

"We know Trump will use his indictment to rile up his supporters and raise milions for his next presidential bid, ' he added. Trump is also facing two other probes -- one for his role in the January 6, 2016, riot by his supporters who stormed the Capitol that houses Congress, and the second for alleged attempts to interfere with the 2020 election results in Georgia.

According to one of his lawyers, Susan Necheles, Trump would turn himself in to authorities on April 4. In what would be an unprecedented scene, as a former president, Trump is under Secret Service protection and the federal agency would be coordinating the arrest with New City officials and protecting him. If the usual procedures are followed, he would be fingerprinted, photographed and handcuffed and produced before a judge who would decide whether to keep him in custody

or release him. Often in a ritual known as "perp walk", the accused "perpetrator" would be paraded in handcuffs before news cam-

eras and Trump may want it to portray himself as a martyr and rile up his base. According to media reports, Trump has discussed being handcuffed and considered if the sight would rally his supporters. The grand jury proceedings are secret and while the exact charges will not be known till the indictment is made public, he was facing allegations that he falsified the business records about the \$130,000 paid to adult film star Stormy Daniels who claimed to have had an affair with him, and that he violated elections laws through the payoff to buy

The affair, which he has denied, and the hush money

payment are not themselves illegal, and the prosecutors will have to prove that the payments shown as lawyer's fees paid to his former lawyer Michael Cohen who in turn passed on the money to Daniels violated laws on bookkeeping. While that would be a misdemeanour or minor offence. connecting the payments to violations of election finance laws would make it a felony or major crime with a prison sentence that could be of several years. Cohen was convicted in a federal court of election law violations for making the payments to Daniels and \$125, 000 to another woman and sentenced to three years in prison. Federal prosecutors and Bragg's predecessor Cyrus Vance considered bringing a case against Trump, but dropped the idea.

Daniels asserted that the affair took place in 2006 when Melania Trump had a baby. The hush money was paid ten years later on the eve of the 2016 presidential election when Daniels was trying to air it. Under the New York legal system, prosecutors have to convene a grand jury made up of 16 to 23 ordinary citizens who will consider preliminary evidence in secret sessions and vote on an indictment -- that there is a prima facie case to

Response to deterioration of rights in the region exposes an international system unfit to deal with global crises

he failure of global and regional institutions - hamstrung their members – to respond adequately to global conflicts, climate change and global energy and food crises has disrupted an already weak multilateral system, Amnesty International said as it launched its annual assessment of human rights around the world. Amnesty International Re-

port 2022/23: The State of the World's Human Rights found that double standards on human rights abuses taking place around the world fuelled impunity and instability, including deplorable lack of meaningful action on the plummeting human rights record in Afghanistan, inadequate responses to a spiralling economic crisis in Sri Lanka and the refusal to confront the crackdown on dissent and persecution of minorities in ers were used to curtail mass

multiple South Asian countries.

"The Universal Declaration of Human Rights was created 75 years ago, recognizing the inalienable rights and fundamenby the self-interest of tal freedoms of all people. Global economic dynamics and shifting power structures are unleashing chaos in which it is easy to lose sight of human rights. As South Asia sits on the brink of a volatile and unpredictable future, it is important now, more than ever, to keep rights squarely in the centre of all negotiations and conversations," said Deprose Muchena, Senior Director at Amnesty International.

People took to the streets across the region to protest against injustice, deprivation and discrimination, but in most countries including Afghanistan, Bangladesh, India, Nepal, Maldives, Pakistan and Sri Lanka they were met with intense crackdowns and excessive, sometimes lethal, force. In Sri Lanka, emergency pow-

ful crowds protesting against the spiralling economic crisis, causing deaths and injuries. Protesters in Sri Lanka were arrested, arbitrarily detained and charged with terror-related and other offences. In Afghanistan, peaceful

protesters faced arbitrary arrests, torture and enforced disappearance. Police in Ban-

protests. The police used live gladesh used live and rubber bullets, sound grenades and ammunition, tear gas and water cannon against largely peacetear gas to disperse protests by students and workers. In

Pakistan, authorities forcibly broke up peaceful protests by activists and family members of victims of enforced disappearances. Protesting victims of loan sharks in Nepal were met with police baton charges and arbitrarily detained. In India,

a 15-year-old boy and another

protester were shot and killed

by police during demonstrations in Jharkhand state.

Attacks on press freedom persisted in multiple countries. In Afghanistan, journalists faced arbitrary arrest and detention as well as torture and other ill-treatment for reporting that was critical of the Taliban. In Bangladesh, where journalists experienced physical assaults, judicial harassment and other reprisals for their reporting, a draft data protection law threatened to further curtail freedom of expression. Media workers in Pakistan also came under increased pressure as journalists and others were arrested on spurious charges.

The Indian government likewise tried to prevent the human rights situation there from being discussed abroad by imposing international travel bans on human rights defenders and detention without trial. It also used money laundering laws and

other pretexts to harass me- to the right to protest, Amdia organizations and NGOs. In Nepal, comedians were among those who faced prison sentences in relation to their performances. The Maldives parliament passed a law that could force journalists to reveal their sources. Encouragingly,

the Maldives government was

considering amending the law,

but faced strong criticism.

"South Asian countries seem to apply human rights law on a selective basis in a staggering show of blatant hypocrisy and double standards. They only criticize human rights violations when it aligns with their global and regional politics but are mute spectators to similar abuses at their own doorstep just because their interests are at stake. It is unconscionable and undermines the entire fabric of universal human


