Punjab registers a record increase of 2587 Cr in revenue from Excise

CHANDIGARH: Punjab Finance, Planning, Excise and Taxation Minister Advocate Harpal Singh Cheema on Thursday said that the Puniab Excise department has registered a historic Rs 2587 Cr (41.41 percent)increase in revenue during the financial year 2022-23 as compared to the financial year 2021-22. He said that Excise department collected revenue of Rs. 8841.4 Cr from sale of liquor during 2022-2023 against revenue of Rs. 6254.74 Crore during the financial year 2021-22.

Addressing the press conference here at Punjab Bhawan, Finance Minister Harpal Singh cheema dedicated the record Growth of 41.41 percent to the new Excise policy. 

Terror group threatens 30 RSS leaders In J&K FW DESK

The Resistance Front (TRF), considered a front for Pakistanbased terror group Lashkar-e-Taib has issued threats to thirty members of the Rashtriya Swayamsevak Sangh (RSS) in Jammu and Kashmir. The TRF has has threatened largely Muslim leaders who are supposedly associated with RSS.

Punjab's Pollution Pandemic - The Dastardly Devastation of Derabassi

erabassi, a small town in Punjab, has become a hotbed of industrial activity in recent years. With paper mills, stone crushers, and chemical factories setting up shop in the area, there has been a rapid increase in industrialization, and with it, an alarming rise in water and air pollution.

The industrial activities in Derabassi have been identified as a major contributor to the pollution of water and air in the region. These factories discharge a significant amount of chemical waste into the environment and nearby farmlands, contaminating the water bodies and the air around them.

The discharge of untreated and poisonous wastewater

into nearby water bodies and farmlands, especially by some huge paper mills has led to the deterioration of water quality in the area. The chemicals present in the water can harm aquatic life in the adjoining Ghagghar river and seep into the ground, contaminating groundwater sources. 

Honest Government results in facilities to public with increase in revenue : CM Mann

CHANDIGARH: Punjab Chief Minister Bhagwant Mann on Friday said that due to strenuous efforts of the Aam Aadmi government the state has been transformed from 'fiscal deficit' to 'fiscal profit' state by massive generation of revenue. Interacting with the media

persons here at Punjab Bhawan, the Chief Minister said that though the previous governments had always thought of their own vested interests his Government has pulled all plugs to enhance the revenue in state. He said that these efforts have produced desired results as the state has been able to generate maximum revenue. Bhagwant Mann said that the honest government in state has changed the direction of fund flow from private houses of leaders to government exchequer.

The Chief Minister said that though the state government had launched the Excise policy by delay of three months but it has fetched revenue worth Rs 8841 crore in the state. He said that this is Rs 2587 crore more than last year which was roughly an increase of 41.41%. Bhagwant Mann said that the target for next financial year is Rs 9754 crore adding that this will also be achieved.

The Chief Minister said that

the state government has for the first time presented a zero tax budget in the state. He said that this is first of its kind pro-people initiative which will go a long way is ensuring the welfare of people. Bhagwant Mann envisioned that no stone will be left unturned for the holistic development of the state and prosperity of its people.

Dwelling on another agenda, the Chief Minister said that the state has witnessed massive increase in the GST collection. He said that earlier the state was worst performing in GST collection but now with a hike of 16.6% Punjab is one of the top most performing state in GST collection. Bhagwant Mann said that the collection of last fiscal was Rs 18126 crore as compared to Rs 15542 crore of its previous year. The Chief Minister said that

in a landmark initiative the state government has taken a new experiment on giving an exemption of 2.25 % on stamp duty for land registration. He said that due to this in month of March revenue collection has enhanced from Rs 339 crore in February to Rs 658.68 crore. Bhagwant Mann said that as per the feedback of people the exemption has now been extended to April 30.



The Chief Minister said that though earlier PSPCL symbolised loss due to wrong policies of the successive state governments. However, he said that his government has taken unprecedented initiatives to strengthen the this public sector undertaking. Bhagwant Mann said that for the first time in history of state the government has released all the pending subsidy worth Rs 20, 200 crore.

The Chief Minister said that out of this subsidy Rs 9063.79 crore has been given to Agriculture sector, Rs 8285.90 crore has been paid on domestic subsidies and Rs 2911 crore has been provided to industrial sector. He said that the state government has inherited a debt of Rs 9020 crore from previous governments and the state government has is also repaying the inherited loan through instalments worth Rs 1894 crore. Bhagwant Mann said that the state government has so far provided 3538 jobs to the youth in the power sector.

The Chief Minister said that due to strenuous efforts of the state government the power generation in state has enhanced manifolds. He said that already smooth and hassle free supply of coal has started from Jharkhand coal mine. Bhagwant Mann said that the state is heading towards becoming a power surplus state in the country.

The Chief Minister reiterated that the state government is exploring the possibility of

moving to the court for seeking pending funds under the Rural Development Fund from the centre. He said that the Union government is unnecessarily harassing the state by stalling funds worth Rs 30000 crore under the RDF. Bhagwant Mann said that while the state government has completed all the formalities but then also the centre government has deliberately stalled the legitimate funds of the state which is sheer injustice with the state.

Listing the pro-people initiatives taken by the state government, the Chief Minister said that Punjab Government has so far given more than 28, 000 jobs to youth across the state adding that the sole criteria for selection in this entire recruitment process is merit and the entire procedure is being followed in a transparent manner. He said that now these youth have become integral part of the socio-economic growth of state. Bhagwant Mann said that such a whopping number of jobs in merely one year reflect the commitment of the state government to ensure the well being of youth and opening new avenues of employment for them.

Odisha sheds backward tag, takes big economic strides

Despite being at the receiving end of natural calamities like cyclones and floods Odisha's economy continues to grow at a fast clip. According to the latest Economic Survey report, the state's per capita income rose to Rs 150,676 at current prices from Rs 1,27383. Odisha's economy is projected to grow by 7.8 % in real terms during 2022-23 against 7 % at all-India level as per the advance estimates.

In the last 7 years, the state has successively reduced the gap between Odisha's per capita income and per capita income at the all-India level from 31.6 % in 2015-16 to 12 % in 2022-23. The services sector grew at 8.79 % in 2022-23, accounting for 36.2 % of Gross State Value Added (GSVA). The services sector, which accounted for 24.7 percent of total workforce in 2020-21, is gradually moving towards pre-pandemic levels. Trade, repair, hotels & restaurants accounted for the highest

share within the services sector ity. A strict governance approach in the state.

Though hotels, restaurants and air transport were affected largely due to COVID-19 induced lockdown, these services subsectors have recovered immensely since then. In 2022-23, hotels and restaurants grew at 37.1%. These are remarkable achievements when viewed against the backdrop of the 1999 super-cyclone that had dealt a crippling blow to the state's economy.

Odisha back then was among the poorest states in the country and struggled even to pay the salaries to its employees. While the super-cyclone exposed the state's vulnerability to violent natural disasters, Odisha's poor financial health delayed restoration and rehabilitation work.

But the state has witnessed a remarkable turnaround since perience Odisha has not only emerged as a leader in disaster management across but also marshalled its resources carefully and cut down on wasteful expenditure to achieve financial stabil-

since 2000 when chief Naveen Patnaik took charge of the state in the wake of the super-cyclone saw the abolition of unnecessary posts and loss making public enterprises. Downsizing of the work force and rationalization

of expenditure yielded results and the state's economy began to recover and get back into shape. Things have been consistently

improving for the state and today the industrial sector which is the key growth driver of Odisha constituting nearly 41.3 % of GSVA has clocked a growth rate of 6.05 % in 2022-23 in real terms. The key growth driver within industry was the manufacturing sector which although grew at 5.2 %in 2022-23, has grown at 9.1 % since 2012-13 on an annual average basis

According to the latest Ecothen. Having learnt from ex- nomic Survey report the agriculture sector constituting 22.5 % of GSVA in 2022-23 was estimated to grow at 6 % in 2022-23 in real terms, higher than the growth experienced at the all-India level (3.5 %). Nearly 46.8 percent



of the workforce of the state is employed in the agriculture and allied sector. The report also pointed out that Capital Outlay as a percent of GSDP in Odisha was one the highest among the major states of the country creating a solid ground for the private sector to flourish and poost economic activity. Odisha's fiscal management is

among the most prudent in the country and has enabled the state to bring down its poverty levels drastically while creating work opportunities in various sectors including agriculture, industry and service sector. The improve-

ment in the economy has also helped sustain a raft of pro-poor schemes launched by the state government. Initiatives such as Odisha Skill Development Authority, Odisha Livelihood Mission, Mission Jeevika and Mission Shakti are contributing effectively to ensure the participation of more labour force in various sectors including manufacturing and service sectors like health, education, tourism, IT and financial services.

The poverty intensity in the state is low compared to all-India level. This has been possible due to the implementation of several proactive and path-breaking schemes like KALIA, MAMA-TA, BSKY, Odisha Millet Mission, Mission Shakti, and subsidized food grains to the poor. While KALIA provides financial assistance to farmers at all levels, MAMATA offers partial wage compensation for pregnant and nursing mothers so that they are able to rest adequately during their pregnancy and after delivery. As a result of such schemes both child and mother mortality rate in the state has come down significantly. The Biju Swasthya Kalyan Yojana (BSKY) has been catering to the health needs of the poor.

Another important factor contributing to the state's economic growth is the concept of transformative governance which has found expression through initiatives such as Mo Sarkar, an attempt to bring the government closer to the people and ensure transparency in the working of different departments. With improvement in governance and a stepped up drive against corruption the level

of bureaucratic efficiency has gone up and this has paved the way for economic growth.

The improvement in the economy was visible in the budget recently presented in the state assembly by finance minister Niranjan Pujari. The Rs. 2.30.000 crore State Budget for 2023-24 marked an increase of about 15 per cent on the Rs 2 lakh crore budget for 2022-23. In the latest budget the allocation for the health budget crossed Rs 16.000 crore, an increase of 27% compared to 2022-23. The highest increase of 34% was seen in Sports and development of other infrastructure facilities like roads, bridges, airports and railways. The budget earmarked Rs 30,030 crore for education and skills and Rs 6,224 crore for Mission Shakti which aims at

These schemes, made possible by consistent improvement in the state's economy, have not only improved the lives of common people, especially people below poverty line, but also added to the popularity of the Naveen Patnaik-led Biju Janata Dal (BJD) government. 

A prime example is the Centre's announcement of full exemption from basic customs duty for all drugs and food imported for the treatment of rare diseases listed under the National Policy for Rare Diseases (NPRD) and anti-cancer drug Pembrolizumab. This builds upon the benefits previously included in the policy, finalized almost a year ago. To qualify for this exemption, individual importers need to obtain a certificate from specified authorities. Generally, medicines attract a 10% basic customs duty, but certain lifesaving drugs and vaccines receive concessions or exemptions. Exemptions already exist for specific drugs treating Spinal Muscular Atrophy or Duchenne Muscular Dystrophy. Rare diseases are characterized by their low occurrence rate, often resulting in limited drug availability due to insufficient demand. Treatment can be expensive and inaccessible for many patients, with the NPRD estimating annual treatment costs for some rare diseases ranging from Rs 10 lakh to over Rs 1 crore per year for a 10 kg child. Costs typically increase with age and weight, and treatment is often lifelong. Duty exemption will lead to significant savings for patients. Support organizations for patients with rare diseases applaud the move, providing relief and hope to patients and their families in an otherwise challenging treatment landscape. Although rare diseases are defined by their infrequent occurrence, the sheer number of conditions (estimated between 7,000-8,000, with 450 reported in India) and the total affected population (approximately 100 million in India) make it a pressing issue. The NPRD highlights the problem's magnitude and emphasizes the judicious use of scarce resources. The government must ensure its directives are fully implemented while pursuing innovative solutions for this patient group, remaining committed to the goal of affordable healthcare.

The controlled digital lending



The IA has archived more than 735 billion web pages, 41 million books and texts, 14.7 million audio recordings, 8.4 million videos, 4.4 million images, and 890,000 software programs. Within a short span of time, the IA has become a truly global digital library to access information, particularly for persons with disabilities. A substantial portion of the books digitised by IA are outside copyright protection and are accessible without restrictions.

Publishers have alleged that around 3.6 million books, which have also been available to borrow under some conditions, are actually copyrighted. They have been particularly upset by the 'National Emergency Library' that the IA set up at the peak of the COVID-19 pandemic, wherein the IA relaxed the conditions for lending.

The publishers have argued that the IA thus violated the diverse rights provided under copyright law for 127 titles published by them. The IA rebutted by arguing that books under copyright protection are lent only in a regulated manner, through 'Controlled Digital Lending' (CDL), and should, therefore, be considered to be 'fair use' under United States copyright law.

Understanding Controlled Digital Lending The IA's CDL model follows the lending approach generally seen in physical libraries, where if one copy is owned, that



copy can be loaned to one person at a time. So, the IA avails one digital copy of each non-circulating print book it has stored. Also, irrespective of the number of physical copies of that book that libraries participating in the IA's digitisation project own, for the purpose of digital lending it counts as only one additional copy per library For example, if libraries of the All India Institute of Medical Sciences, the Indian Institute of Science, and the National Law School of India University (NLSIU) were partners in the IA's digitisation project and each of these institutions had six physical copies of a particular book on health law, the CDL model would ensure that readers could borrow no more than three copies of that book at a time

But in a decision that can have farreaching consequences for the future of CDL, the district court for the Southern District of New York (SDNY) has ruled in the motions for summary judgments that the IA's activities violated various rights vested on publishers under copyright law, and that the activities do not constitute 'fair use' under the same law.

CDL and the public interest Conversations with librarians indicate

that lending physical copies of books from libraries, including at India's leading universities in India, has been on the decline. But that does not mean the demand for reading books is going down so much as that people's reading habits are changing. Closing physical libraries at the height of the pandemic may have just accelerated this shift. Today, many people prefer to read books on devices such as their smartphones and tablets. The CDL is a positive response to

this trend; it also helps bridge the gap between urban and rural, and the privileged and unprivileged, readers vis-à-vis access to books, because it allows even people in the remotest villages to access books from libraries that are far away.

It is also evident that CDL initiatives ease access to many books that may have gone out of print or may not be available access in many physical libraries. By making books accessible to read-

ers, the CDL invokes enormous public benefits for education, research, and cultural participation. However, the court concluded that the public benefits highlighted by the IA "cannot outweigh the market harm to the publishers". In this regard, the court overlooked some

of the evidence the IA produced with regard to the works in the suit, which indicated that even when the IA was engaging in CDL, the sales of print and electronic copies of these titles from the publisher's preferred platforms were not affected.

While assessing the public benefits vis-à-vis potential economic losses for copyright holders, the court also ignored the insights of the U.S. Supreme Court in Google LLC vs Oracle America, Inc., (2021). In that landmark decision, the court suggested that when determining the potential market effects as part of the 'fair use' analysis, one would have to also weigh the public benefits of copying against potential financial losses for copyright holders.

Though India is yet to have a major CDL initiative, some universities such as the NLSIU have initiated major digitisation projects that can facilitate CDL in future. The outcome in the IA litigation will in turn have considerable ramifications for such initiatives, in India and elsewhere. In addition, even current lending practices in physical libraries could be threatened if other courts followed the SDNY district court's logic, in prioritising the economic interests of just one of the stakeholders over the broader public interest.

It is high time to remind ourselves that the copyright system is not just about protecting the interests of copyright holders, but, equally, about protecting the rights of the users of copyrighted works, and thus the broader public interest.

VINOD THOMAS BELIEVES CARBON TAX CAN PAVE WAY FOR DECARBONISATION AS A WINNING DEVELOPMENT FORMULA It's time to put a price on carbon emissions

n the absence of a price for the use of natural resources such as air and forests, environmental destruction has been part of every country's recipe for boosting GDP growth. But the consequence of this approach has been the relentless emission of carbon, causing runaway climate change. It is time, starting with the biggest economies of the G-20, to agree on valuing nature, including by pricing carbon effluents. India can take the lead, as president of the G-20 this year, in carbon pricing, which will open unexpected avenues of decarbonisation.

All said, any type of carbon pricing faces stiff political opposition. When a new, conservative government took office, Australia repealed the 2012 tax just two years after it was instituted. Recent months have revealed the political pressures on decarbonisation: soaring energy prices led the EU to sell millions of emission permits, causing a 10% drop in carbon prices. Sweden may have handled some of these political constraints as well as any by presenting the carbon tax as part of a igger fiscal package that lowers other taxes and includes new social safety nets. Communicating the idea of wins at the ietal level, even in the presence individual producers' losses, is vital. A high enough carbon tax across China, the U.S., India, Russia, and Japan alone (more than 60% of global effluents), with complementary actions, could have a notable effect on global effluents and warming. it could also pave the way to seeing decarbonisation as a winning development formula. as carbon pricing gains acceptance, the first movers will be the most competitive. India, as president at the G-20 summit this September, can play a lead role by tabling global carbon pricing in the existential fight against climate change.

HDFC Bank garners record Rs 1.5 tn deposits in a quarter target in FY24E, HDFC Bank

MUMBAI: HDFC Bank has exceeded its target of garnering Rs 1 trillion in deposits during a quarter for the first time since it announced its merger with HDFC Ltd in April last year.

During the January-March quarter (Q4) of FY23, the country's largest private sector lender mopped up over Rs 1.5 trillion in deposits. This is a record for the bank, which saw its deposit base touch Rs 18.88 trillion.

According to the bank's disclosure to the exchanges, its deposits grew by 21 per cent year-on-year (YoY) in Q4, a multi-quarter high. Sequentially also, deposits saw a growth -of 8.7 per cent. HDFC Bank's deposit growth is much higher than the industry, which is growing around 10 per cent.

However, the bank has fallen short of its yearly target of Rs 4 trillion for deposits in a financial year. In FY23, the bank Macquarie Capital, in a note. mopped up Rs 3.24 trillion, up 45 per cent compared to last year (FY22). It had earlier garnered over Rs 1 trillion in deposits in a quarter only once since 2015.

RBI pause to policy rate hike is prudent, India remains cushioned against global headwinds: ASSOCHAM

NEW DELHI: ASSOCHAM today welcomed the RBI decision to pause the rate hike cycle, retaining the benchmark REPO rate at 6.5 per cent, stating the Monetary Policy Committee (MPC) has taken a prudent stance in the wake of high level of volatility in the global financial markets and geo-political events.

"Even as the RBI's MPC was reviewing the credit policy for the last few days, ASSOCHAM had made out a strong case for a halt to the rate hike cycle. We must thank Governor Shaktikanta Das and other members of the MPC for responding to our call. In a way, the decision not to go in for any more rate increase would have surprised many as a larger expectation was on 25 basis points rise in the policy rates even as ASSOCHAM remained confident about the RBI striking a balance between reining in inflation and growth," ASSOCHAM Secretary General Deepak Sood said.

He said the policy statement has made a correct reading of the global economy and its possible impact on India which has done well in terms of growth, billed as



the fastest amongst the major economies without losing sight of the inflationary risks.

"RBI's growth projection of 6.5 percent for FY'24 as stated in the policy document, is in complete alignment with ASSO-CHAM assessment. Our forecast of 6.5 percent, as released in our media interaction on April 4, was undaunted by somewhat lower projections of 6.3 percent of the World Bank".

While the fineprint of the RBI policy statement is tilted in favour of further leash on inflation, it is understandable in the face of continuing volatility in the global markets. «Even though Indian banks stand in good stead

without the kind of risks faced by banks in the US or Europe, RBI has cautioned them about any unforeseen spillovers. The peremptory measures speak about the agility of the Indian banking regulator. Besides, our foreign exchange reserves are back to USD 600 billion plus, giving us more cushion to deal with any headwind which may flow eastward», said Sood.

India's world class digital infra worth emulating by many nations: IMF Indian-American prof receives Young Urologist of the Year award

NEWDELHI: India has built a world-class digital public infrastructure which is transforming lives and economy and can be a lesson for many countries to follow, an IMF Working Paper said.

India Stack is the collective name of a set of commonly used digital public infrastructure (DPIs) in India. It consists of three different layers -- unique identity (Aadhaar), complimentary payments systems (Unified Payments Interface, Aadhaar Payments Bridge, Aadhaar Enabled Payment Service), and data exchange (DigiLocker and Account Aggregator). Together they enable online, paperless, cashless, and privacy-respecting digital access to a variety of public and private services, a working paper titled 'Stacking up the Benefits: Lessons from India's Digital Journey' said.


