New Delhi

In a unanimous verdict, the Supreme Court resolved the longstanding power dispute between the Arvind Kejriwal-led Delhi government and the central government regarding the control and transfer of bureaucrats serving the Government of National Capital Territory of Delhi (GNCTD). The court ruled that the GNCTD has control over bureaucrats, except in matters of police, public order, and land.

A five-judge constitution bench, led by Chief Justice DY Chandrachud, has asserted that an elected government must have authority over bureaucrats. The bench noted that the Union Territory of Delhi has a unique character and rejected Justice Ashok Bhushan's 2019 ruling that the Delhi government has no control over services.

Hailing the SC verdict, AAP chief and Delhi chief minister Arvind Keiriwal termed the over services sans...public order, order a "victory of democracy" and his party said it was a "tight slap" on the mission to topple state governments across the country. Kejriwal also expressed his "heartfelt thanks" to the Supreme Court for "doing justice to the people of Delhi" and said the pace of development will increase manifold. AAP Rajya Sabha Raghav Chadha called the verdict a "landmark decision" and said it sends a stern message.

"Satyamev Jayate. Delhi wins. Hon'ble Supreme Court's landmark judgment sends a stern message that officers working with the government of Delhi are meant to serve (the) people of Delhi through the elected government and not unelected usurpers parachuted by Centre to stall governance, namely LG," Chadha tweeted. Holding that the primacy of the Centre in administrative issues would abrogate the federal system and the principle of representative democracy, the bench said if services' are excluded from the legislative and executive domain, then ministers would be excluded from controlling civil

MUMBAI: India's foreign exchange reserves jumped by USD 7.196 billion to USD 595.976 billion in the week ended on May 5, the Reserve Bank of India said on Friday. The overall reserves had

dropped by USD 4.532 billion to USD 588.78 billion in the previous reporting week.

In October 2021, the country's forex reserve had reached an all-time high of USD 645 billion. The reserves have been declining as the central bank deployed the kitty to defend the rupee amid pressures caused majorly by global developments.

During the week ended on May 5, the foreign currency assets, a major component of the reserves, increased by nearly USD 6.536 billion to USD 526.021 billion, according to the latest Weekly Statistical Supplement released by the RBI. Expressed in dollar terms, the foreign



currency assets include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves.

Gold reserves increased by USD 659 million to USD 46.315 billion, the RBI said.



Congress close to attaining simple majority in Karnataka: ABP/C-Voter Exit Poll

NEW DELHI: The muchawaited exit poll conducted by C-Voter for ABP News indicates that Congress, the main opposition party in Karnataka, is tantalisingly close to achieving simple majority in the southern state which went to the polls on Wednesday.

Contrary to earlier projections and many forecasts by political analysts, the ruling BJP is doing much better than expected, though it is trailing the Congress and is unlikely to remain in power. The third force in this triangular contest, the JD(S) is projected to be a distant third and appears to be in danger of becoming a mar-

ginal player in the state. As per the ABP/C-Voter Exit Poll data, the Congress is likely to win between 100 and 112 seats in the elections. A party needs 113 seats for a simple majority in the 224-member Karnataka Assembly. The Congress had won 80 seats in the 2018 Assembly elections. As per the exit poll data, the Congress



is projected to get 41.1 per cent of the vote share, which is up 3.1 per cent as compared to its share in the 2018 elections.

The surprise is the projected performance of the ruling BJP. The C-Voter opinion polls conducted in March and April had indicated strong anti-incumbency sentiments against the BJP government. But the party

seems to have recovered. As per the exit poll data, the BJP is projected to win between 83 and 95 seats. In 2018, the party had won 104 seats. The projected vote share for the BJP is 38.3 per cent, which is 2.3 pert cent better than its 2018 vote share of 36 per cent. With both the Congress and

the BJP gaining in vote share, the loser seems to be JD(S). The vote share for the party is projected to be at 14.6 per cent, which is a 3.4 per cent decline compared to 2018. The party is projected to win between 21 and 29 seats. The election results will be declared on May 13.



Islamabad HC grants two-week protective bail to Imran Khan in corruption case

ISLAMABAD: In a temporary relief to former Pakistan prime minister Imran Khan, a special bench of the Islamabad High Court (IHC) on Friday granted him protective bail in a corruption case. A division bench comprising Justice Miangul Hassan Aurangzeb and Justice Saman Rafat Imtiaz heard the Al-Qadir trust corruption case, a day after the Supreme Court termed Khan's arrest



from the IHC premises on Tuesday as "invalid and unlawful". The IHC's decision to grant Khan a two-week reprieve from arrest came hours after he warned of countrywide unrest if he was arrested again, Geo News reported. Imran Khan, 70, arrived at the court shortly after 11:30 am local time amid tight security and underwent the biometric identification process and other formalities. The hearing was delayed for nearly two hours due to security reasons. Earlier, the two judges left the courtroom amid pro-Khan slogan shouting by a lawyer. The upset judges

later announced that the hearing will resume after Friday prayers Dawn News reported that Khan's lawyers had filed four additional requests which urged the IHC to club all the cases against the Pakistan Tehreek-e-Insaf and to direct authorities to provide details of the cases registered against him. Imran Khan was arrested from the premises of the IHC on Tuesday in the Al-Qadir Trust case after the National Accountability Bureau (NAB) issued an arrest warrant against him. The Al-Qadir Trust corruption case is about the setting up of Al-Qadir University for Sufism in 2019 Sohawa area of Jhelum district of Punjab. Khan is accused of looting Rs 50 billion from the national treasury in the case. The former prime minister, along with his wife Bushra Bibi and other PTI leaders, are facing a NAB inquiry related to a settlement between the PTI government and a property tycoon.

Industrial production growth slips to 5-month low of 1.1 pc in March

category within the Index of **Industrial Production (IIP) is** expected to be marginally weaker for March

NEW DELHI: The country's industrial output grew by 4.4 per cent in March, the slowest in five months, as manufacturing production growth halved from the month before and the capital goods segment saw contraction.

The manufacturing segment, which constitutes the bulk of the index at 77.6 per cent, rose 4.4 per cent in March, almost half the 8.5 per cent rise in February. As many as 12 of the subsectors of manufacturing, with a weight of 30.6 per cent in the Index of Industrial Production (IIP), recorded a year-on-year contraction in March.

However, mining and electricity recorded modest im-

thermal generation, respectively. While mining output rose by 2.8 per cent, reversing the 0.3 per cent contraction seen in the earlier month, electricity generation registered a higher growth rate of 5.9 per cent, up from February's 4.5 per cent.

While March saw a slowdown among all use-based classification groups, a sudden contraction in capital goods output may have dragged IIP growth down.

The capital goods segment within the IIP, which connotes investment, contracted by 1.8 per cent, its worst performance in nine months. The segment had seen a healthy rise of 19.5 per cent in February and had been on a growth run for seven months, fuelling growth.

A sharp contraction in gold jewellery output, a possible fallout of the multi-billion-dollar



contributed to the slowing growth of the consumer durables sector, experts said. Also, the largest segment, primary goods, continued to be plagued y low growth, registering a 2.9 per cent rise in March. Robust growth in aggregate auto

production and a sharp uptick

in coal production would help the prospects of IIP growth in April, said Aditi Nayar, principal economist at ICRA.

"While output growth in FY19 is likely to be better than in FY18 due to expectation of a normal monsoon, robust vehicle sales, infrastructure focus and sectorspecific programmes such as

UIDAI makes online document update in Aadhaar free for next 3 months

Identification Authority of India (UIDAI) has decided to allow residents to update documents in their Aadhaar online free of cost for the next three months.

The decision was taken as part of Digital India initiative, and residents urged to get the benefit of free document update facility on myAadhaar portal. The free service is available for the next three months, i.e., March 15 to June 14, but only on myAadhaar portal and will continue to attract a fee of Rs 50 at physical Aadhaar centres, as in the case earlier.

The UIDAI has been encouraging residents to upload Proof of Identity and Proof of Address (PoI/PoA) documents to revalidate their demographic details, especially if Aadhaar was issued 10 years back and never got updated. This will help in improved ease of living, better service delivery, and enhances authentication success rate.

If there is a need to change



demographic details (Name, Date of Birth, Address, etc), the residents can use regular online update service, or may visit nearest Aadhaar centre. In such cases, normal charges will apply.

During the past decade, Aadhaar number has emerged as a universally accepted proof of identity for residents in India. Nearly 1, 200 government schemes and programs, run by both the central and state governments, are using Aadhaarbased identification for delivery of services. Besides, several other

services by service providers, including financial institutions like Banks, NBFCs, etc are also using Aadhaar to authenticate and onboard customers seamlessly.

As per Aadhaar Enrolment and Update Regulations, 2016; Aadhaar number holders may, on completion of every 10 years from the date of enrolment for Aadhaar, update their supporting documents in Aadhaar, at least once, by submitting POI and POA documents, so as to ensure continued accuracy of their information.


Border Security Force (BSF) have seized drug consignment which was smuggled to India through drone from Pakistan.



The emergence of multiple variants and subvariants, along with the absence of a predictable seasonal pattern, means that the virus can still cause rapid transmission, severe disease, hospitalizations, and even higher mortality rates. Eternal vigilance is crucial to prevent the world from slipping into complacency. To maintain a level of care and readiness, health systems need to remain vigilant and periodically test their capacity to respond to epidemic situations. The established network of genetic sequencing laboratories and the healthcare infrastructure developed during the pandemic should continue to be utilized effectively. Additionally, research and development efforts should not be scaled back. Continued investment in vaccine platforms, drug delivery systems, antivirals, and antibiotics will enable nations to be prepared not only for COVID-19 but also for other emerging infections that may arise in the future. At the individual level, it is important to maintain personal hygiene practices and adhere to vaccination schedules. Following hand hygiene and wearing masks when necessary can help reduce the risk of transmission. The WHO's announcement marks an important milestone in the fight against COVID-19, but it is not a signal that the battle is over. Remaining cautious, vigilant, and prepared is necessary to navigate the ongoing challenges posed by the virus. By staying proactive and continuing to prioritize public health measures, both at the institutional and individual level, we can mitigate the impact of the virus and be better equipped to respond to future health crises.



The ED had on Monday said Anwar Dhebar, the brother of Raipur Mayor Ajaz Dhebar, is the main kingpin in the liquor scam.

Anwar is currently in the custody of the ED. He was caught while trying to run away and escape from the backdoor of a hotel in the early hours of May 6. The ED alleged that Anwar was the main collection agent and frontman of this syndicate. He was allegedly extorting Rs 75 per case as commission from liquor businessmen.

UP to tweak policy for beer retailers



The Uttar Pradesh government is planning to amend its excise policy to rule out confusion and doubts among beer retailers regarding revenue targets. The department has put forth the agenda regarding fixing the monthly target for beer retailers, before the UP government. Under the changed regime, retailers operating beer shops will be expected to achieve 40 per cent of their targets during April-May-June, the peak demand period. From April 1 this year, the excise department, for the first time, had fixed monthly revenue targets for the beer, country liquor, English wine and premium liquor vend owners. Out of the total 29, 523 liquor shops in the state, 5, 544 are into retail beer trade. In the policy, the department has mentioned that beer retailers must generate a 7 per cent, 10 per cent and 8 per cent revenue target in April, May and June.

However, the target was later hiked to 14 per cent by the department for April. Spokesperson of the UP liquor sellers welfare association Devesh Jaiswal said, "It has been three months since the policy was introduced and monthly target was provided. Suddenly, the target for April was increased by two times for April and for May and June too. To highlight the problems, beer retailers issued a memorandum for the Ul

Lucknow district excise officer S.K. Mishra said clarity was offered to beer retailers on multiple occasions.

US-based Invesco further slashes Swiggy's valuation to \$5.5 bn



NEW DELHI: US-based investment company Invesco has further slashed online food delivery platform Swiggy's valuation in its holding to about \$5.5

According to regulatory filings with the US Security and Exchange Commission (SEC), Invesco valued Swiggy's shares at \$3, 305 (as of January 31, 2023) -- down from \$4,759 in October 2022

In October last year, Invesco had already reduced the valuation of its holding in Swiggy to about \$8 billion.

Swiggy had reached a \$10.7 billion valuation in a round led by Invesco in January last year.

The revised valuation represents a massive 49 per cent decrease from the \$10.7 billion valuation. The valuation cut in Swiggy was first reported by TechCrunch.

Swiggy has been preparing to launch its initial public offering (IPO)

The company is yet to make its FY23 numbers public. It clocked a 2.2-times growth in its gross merchandise revenue (GMV) to reach Rs 5, 705 crore in FY22. However, its losses doubled

to Rs 3, 629 crore in FY22 compared to Rs 1, 617 crore in the previous fiscal year.

China and Canada expel each other's diplomats: What led to this low in their strained ties

Allegations of interference from China in Canada aren't new and Canadian PM Justin Trudeau has been criticised for his approach towards the country

China has expelled Canadian diplomat Jennifer Lynn Lalonde on Tuesday, in response to Canada's dismissal of Chinese diplomat Zhao Wei on May 8. Zhao's expulsion had followed recent news reports that alleged his involvement in a plot to intimidate and influence Canadians who criticise

It is believed that Canada's move was based on a 2021 report of its intelligence agency, the Canadian Security Intelligence Service (CSIS), which flagged potential threats to Michael Chong, a Canadian Member of Parliament who had flagged China's human rights record.

On May 8, a statement issued by Mélanie Joly, Canada's Minister of Foreign Affairs, said, "Canada has decided to declare persona non grata. Zhao Wei. I have been clear:

we will not tolerate any form of foreign interference in our internal affairs. Diplomats in Canada have been warned that if they engage in this type of behaviour, they will be sent home." The minister did not cite any specific reason.

China's Foreign Ministry issued its statement the next day, saying, "As a reciprocal countermeasure in reaction to Canada's unscrupulous move. China decides to declare Jennifer Lynn Lalonde, consul of the Consulate General of Canada in Shanghai persona non grata..." In diplomacy, persona non-grata means another country's diplomat has been recalled by their host country. Ties between China and Canada have been strained for some time now. Here is what has happened so far.

What are the allegations of Chinese interference in Canada?

The CSIS report, according to The Globe and Mail, is "an overview of Chinese government foreign interference in Canada, ranging from inves-



tigating a Conservative MP's relatives in China to harassing a mainland Chinese student in Canada who publicly supported Hong Kong's democracy movement." The report also named Zhao and Chong.

Chong said he was not aware of any such plots against him, but that the expulsion of a Chinese diplomat was long overdue given recent issues of China's influence. The Canadian government took its time to decide whether to proceed with the move, with both Joly and Prime Minister Justin Trudeau warning about backlash from Beijing, the AP reported. But allegations of interference from China aren't new

What were the earlier allegations?

After the election of Vancouver mayor Ken Sim this year, The Globe and Mail's reports said China's former

consul general in Vancouver, Tong Xiaoling, sought to "groom" local Chinese Canadian politicians to do Beijing's bidding. Sim, the first Chinese Canadian elected to the post, denied the allegations and said they were simply based on his ethnicity.

In March 2023, Trudeau had an independent investigator appointed to report on whether China attempted to interfere in Canada's federal elections in 2021 and 2019. The PM appointed former governor general David Johnston to study the issue and assess whether a public inquiry was needed.

Another MP, Han Dong, who was a member of Trudeau's Liberal Party, stepped down from the party over claims that he was chosen over other candidates by the party because of the Chinese government's support in federal elections. While the PM then raised general concerns about election interference from Beijing, he denied the possibility of China actually succeeding

in impacting election results. "That doesn't mean that we are not faced on an ongoing basis by attempts at interference in our democracies, both during and before and after an election," he said.

And what led to this state of Canada-China ties?

There have been some major incidents since 2018, thanks in part to then US President Donald Trump's hardening stance on China and trade with the country, as well as Canada and the US's close ties historically. Trudeau's handling of these issues has also been criticised domestically as being too soft. Canada's Indo-Pacific strategy: Wary eye on China, bid to reset India ties

The current state of unease began when in December 2018, Canadian authorities arrested Meng Wanzhou, an executive of the Chinese tech company Huawei and the daughter of its founder Ren Zhenfei. This was at the request of US authorities, who accused the company of misleading it on its transactions with Iran - which was under US trade sanctions.

\$700 million from tourism in the first four months of 2023, an increase of 17.8 per cent from the same period last year, an official said on Monday. Sri Lanka Tourism Development Authority (SLTDA) Chairman Priantha Fernando told media that the country earned \$166.5 million from tourism in April, Xinhua news agency reported.

According to figures from the SLTDA, Sri Lanka has received 335, 679 tourists in the first three months of this year. Fernando said in April that Sri Lanka's tourism industry is aiming to attract 2 million visitors in 2023, as compared to the previous target of 1.5 million, and the SLTDA amended the estimates due to a positive trend in the first quarter of Lanka's leading foreign exchange earners, has suffered a setback due to the Covid-19 pandemic and economic and political crises in the country.

Turkey freezes assets of 8 IS, Al **Qaeda affiliates**



The Turkish Treasury and Finance Ministry decided to freeze the assets of eight people affiliated with Islamic State (IS) and Al Qaeda terror groups, according to ab official gazette. Their assets were frozen over "financing terrorism", the gazette said. The people being sanctioned are Abdulsamet Celik, Amer Onay, Ensari Ersoy, Muhammed Korkmaz, Murat Demir, Sevda Vural, Tarkan Nigdelioglu and Sinan Oksuz, reports Xinhua news agency. The Turkish government designated the IS as a terrorist organisation in 2013, blaming it for a spate of deadly attacks in the country since 2015. Turkey's southern border with Syria has been a major crossing point for Syrians and foreign fighters since the civil war broke out in the country in 2011. The Turkish military launched several cross-border operations in northern Syria to eliminate the IS militants.

On April 29, it killed the IS leader, Abu Hussein al-Qurayshi, in an operation in Syria.

Indians second largest group crossing English Channel: Home Office data Twelve Indian-origin men, women convicted of money laundering in UK

across the English Channel has increased sharply in the first three months of the year, making them the second biggest cohort after Afghans, according to the latest Home Office statistics. Between January 1 and March 31, 2023, the most common nationality arriving via small boat was Afghans (909, 24 per cent) followed by Indians (675, 18 per cent), the new data revealed. A total of 3, 793 people were detected arriving in small boats in the same period, a Home Office statement said, adding that the "crossings are generally higher in better weather.

In 2022, almost half of small boat arrivals were Albanians (28 per cent of the total, although these arrivals occurred mostly between July and September



2022) and Afghans (20 per cent, with their numbers greater towards the end of the year).

The top five nationalities now illegally crossing the Channel in small boats include, Afghanistan, India, Iran, Iraq and Syria.

While the final statistics are due to be published on May 25 this year, a last month Home Office data showed 683 Indians arriving in the country on small boats in 2022, as compared to 67

in 2021. In February this year, Indians allegedly became the third-largest group of migrants entering UK shores illegally after Afghans and Syrians, The Times report said citing Home Office sources. The report had said that about 250 Indian migrants made the perilous crossing in small boats this year alone, outnumbering the 233 who arrived via small boats in the first nine

Sixteen people, including several men and women of Indian descent, have been convicted after a major investigation into a West London-based organised crime group involved in international money laundering and human smuggling, UK's National Crime Agency (NCA) said. Members of the network smuggled in excess of GBP 42 million in cash out of the UK, making hundreds of trips to Dubai and the UAE between 2017 and 2019. According to NCA investigations, the money was profit from the sale of class A drugs and organised immigra-

tion crime. "This has been a long and complex investigation into an organised crime group involved in money laundering on a commercial scale and organised immigration crime. Over a twoyear period, working together

with partners in the UK and abroad, NCA investigators were able to uncover the evidence to secure these convictions, ' NCA senior investigating officer Chris Hill said, Around GBP 1.5 million was seized from couriers leaving the UK but flight analysis, evidence from cash declarations in Dubai, and other material seized by the NCA showed the group had succeeded in transporting far more. In November 2019, following weeks of surveillance, communications and flight data analysis, officers moved in to make arrests, and those charged were prosecuted in two trials at Croydon Crown Court, starting in January 2023.

Gang ringleader Charan Singh, 44, from Hounslow, was among those detained in a series of early morning raids across west London

Along with Singh, Valjeet Singh, Jasbir Singh Kapoor, Jasbir Singh Dhal were found guilty of conspiring to remove criminal property or money laundering. Turkish Foreign Minister Mevlut Cavusoglu has announced that Turkey has decided to relocate its embassy in Khartoum, the capital of Sudan, to Port Sudan, in response to an earlier incident where the Turkish ambassador's vehicle

was targeted by gunfire. "For the safety of our embassy and our colleagues, we decided to move our embassy to Port Sudan, " Cavusoglu was quoted as saying by the semi-official Anadolu Agency, Xinhua news agency reported.

Turkish Ambassador Ismail Cobanoglu had discussed the issue with both the Sudanese army and the paramilitary Rapid Support Forces (RSF) and informed them about the relocation plans, the Turkish minister added.

The decision was made after the official vehicle of the Turkish ambassador was under gunfire hit on Saturday, while no one was wounded in the accident, and the vehicle sustained damage.

After the incident, the RSF and the Sudanese army exchanged accusations. The RSF claimed that the area where the attack occurred was under military control and reiterated its commitment to protecting diplomatic missions in the country. Conversely, the army attributed responsibility to the RSF for the assault.


