# **Court denies Sisodia bail in ED's excise policy case**

NEW DELHI: A Delhi court on Friday denied bail to AAP leader and former Deputy Chief Minister Manish Sisodia in connection with the Delhi excise policy case being investigated by the Enforcement Directorate (ED), holding that that the evidence, prima facie, "speaks volumes" of his involvement in commission of the offence.

Special Judge M. K. Nagpal denied the relief, noting the "serious nature of allegations made and role played by Sisodia in the criminal conspiracy, his connection with the activities relating to generation or acquisition and

The judge also said that the purported medical condition of Sisodia's wife was not a reason to grant him bail in this case. Additionally, he stated that it was impossible to rule out the potential of Sisodia influencing ey witnesses in the case.

The judge noted that the alleged offence against Sisodia was a "serious economic offence of money laundering" and that he has not been accused of committing the offence in his personal

capacity, but rather in his official capacity as a public servant overseeing the Excise Ministry and serving as Delhi's Deputy Chief Minister.

"The seriousness or gravity of the offence and its nature or category, the capacity of applicant in which it was committed, the manner of its commission and also certain other factors like impact of the offence as well as the possible impact of release of applicant on society etc. are the factors which go against the applicant and force this court to decide against his release on bail in the present case,

**NEW DELHI:** Prime Minister Narendra Modi, Union Home Minister Amit Shah, Congress President Mallikarjun Kharge, Congress leader Rahul Gandhi and a host of other leaders condoled the demise of former Punjab Chief Minister and Shiromani Akali Dal chief Parkash Singh Badal on Tuesday.

Badal died late on Tuesday evening. He was 95. Condoling his death, Prime Minister Modi tweeted: "Extremely saddened by the passing away of Sri Parkash Singh Badal. He was a colossal figure of Indian politics, and a remarkable statesman who contributed greatly to our nation. Home Minister Amit Shah tweeted: "The passing away of veteran leader, Shri Parkash Singh Badal Sahab is deeply saddening. His career spanning several decades was dedicated to the welfare of the poor. His demise is an irreparable loss to Indian politics. My heartfelt condolences are with his family and followers."

**NEW DELHI:** Chief Justice of India (CJI) D.Y. Chandrachud said that judges have no business giving interviews to news channels on matters pending before them.

A bench comprising the CJI and Justice P.S. Narasimha took strong exception to sitting Calcutta High Court judge Justice Abhijit Gangopadhyay's interview to a news channel in connection with Trinamool Congress leader Abhishek Banerjee, even as a case concerning the latter was being heard by by the judge

The Chief Justice said: "Judges have no business to be granting interviews to television or whatever channels on matters which are pending before them."

Justice Narasimha queried "how can they, given an interafter expressing dissatisfacview?"

"The judge is speaking about to the overall functioning of the petitioner in these terms in the interview, he is clearly disabled from part icinating anymore, " the CJI added. Additional Solicitor General (ASG) S.V. Raju said it is a huge scam. LUCKNOW: Excise remains a top revenue grosser in Uttar Pradesh for the second consecutive year.

The revenue was higher by 14 per cent as compared to the previous fiscal year (2021-22) when the state registered a collection of Rs 36, 321 crore.

The Uttar Pradesh excise department has created a record generating revenue of Rs 41, 250 crore during the 2022-23 financial year.

The excise revenue collection is not only the highest in the state so far but it has also surpassed all other states in the country. Another major achievement was that not a single death was reported in the state due to consumption of illicit liquor in the past one year.

According to officials, in 2017-18, the department started working to make the excise policy robust as well as flexible to allow more players to make the market competitive.

At that time, UP touched a revenue of Rs 17, 320 crore.

Removal of unnecessary entry barriers brought an increased number of foreign liquor, beer, country-made liquor and alcoholic beverages brands, an official said.

Riding on positive sentiments, the department achieved



the highest compound annual growth rate over the past six vears in the country (by notching 15.5 per cent of mean annual growth)

Additional chief secretary. excise, Sanjay Bhoosreddy said, "While revenue is one part, strong enforcement drives helped us in curbing bootlegging. The Russia-Ukraine war disrupted the supply of soda ash due to which a shortage of glass bottles persisted for three months last year."

"Manufacturing and supply of UP liquor (premium countrymade liquor sold in glass bottles) came to a standstill, otherwise our revenues would have been even higher, " he said.

Excise commissioner, Senthil C Pandian, said that switching

for approvals and compliances brought in more transparency and helped in attracting new companies and players. Without the support from the top level in the government, bringing in reforms in the working of the department

to an end-to-end online regime

would not have been possible. All stakeholders can see the results now, " he said. Six years ago, Karnataka occupied the top spot in the country with the revenue collection of Rs 17, 949 crore (2017-18).

In 2022-23, Karnataka could garner Rs 29, 790 crore through excise duty.

During the same period, Uttar Pradesh took a big leap from Rs 17, 320 crore to Rs 41, 250 crore.

#### **Transparent framework** required for public audit to support privacy in India says Suresh Chandra at the ASSOCHAM Virtual Conference

NEW DELHI: Efforts to establish a comprehensive legal framework for data protection, as well as robust oversight and accountability mechanisms for surveillance and other privacyrelated issues, will be critical in promoting the right to privacy in India said Suresh Chandra Information Commissioner, Central Information Commission, Govt. of India & Former Secretary, Ministry of Law and Justice, Govt. of India while speaking at the ASSOCHAM National Virtual Conference on Policies, Rights and Reforms Information, Privacy & Official Secrets.

"The RTI Act is a practical design and available to citizens with public authority. More power to Central and State Information Commissions for robust mechanism aligned with public interest" he further added. As India continues to grapple with issues of corruption and governance, the RTI Act will likely remain a critical tool for promoting transpar-

ency and accountability. Talking about the digital freedom and helping a common man, Yashovardhan Azad, IPS (Retd.) Former Special Director, Intelligence Bureau; Former Information Commissioner, Central Information Commission, Govt. of India said, "Policies and reforms like Data Protection and RTI Act aims to strike a balance between the need for public access to information and the need to protect sensitive information. Governments and other organizations often enact laws and regulations that limit the disclosure of certain types of information, such as national security or personal information"

At the same time, individuals and organizations have the right to access information that is of public interest. In recent years, there has been a growing focus on protecting individual privacy in the digital age, with many countries enacting data protection laws to safeguard personal information. Overall, policies, rights, and reforms related to information, privacy, and official secrets are crucial for maintaining a healthy democracy and protecting individual rights, he said.

Rajinder Kumar, Managing Partner, Kumar Law Associ-Consultants in his vote of thanks highlighted that provisions outline the specific details of how such policies and reforms should be applied in practice, while appeals mechanisms provide a way for individuals or organizations to challenge decisions made by authorities in relation to these policies. He added, data protection laws may include provisions that require organizations to obtain consent from individuals before collecting and using their personal data, and to implement appropriate security measures to protect this data. The right to privacy is a fundamental human right recognized by international law and many national constitutions said Basudev Mukherjee Assistant Secretary General, ASSOCHAM in his opening remarks.




ndia's Central Bureau of Investigation (CBI) appears to have displayed excessive enthusiasm in filing a case against environmental lawyer Ritwick Dutta and his organization, Legal Initiative for Forest and Environment, for alleged violations of the Foreign Contribution (Regulation) Act (FCRA). The crux of the allegations revolves around the utilization of foreign funds to support legal actions aimed at stalling existing and potential coal-fired plants in India. While it is important to monitor the sourcing and use of foreign funds, it is absurd for the government to criminalize opposition to coal plants when pursued through legal means. India, as a signatory to the UN Framework Convention on Climate Change and various key agreements, has committed to gradually reduce its dependence on fossil fuel sources and achieve a state of "net zero" or primarily non-fossil fuel-based power generation by 2070. India has consistently endorsed reports by the Intergovernmental Panel on Climate Change (IPCC) that emphasize the urgent need to prevent global temperatures from exceeding 1.5°C above pre-industrial levels. This necessitates a 45% decline in global net anthropogenic CO2 emissions from 2010 levels by 2030. However, based on the principles of "Common and Differentiated Responsibility," India maintains its right to rely on coal plants as it is still a developing economy. While renewable energy sources such as solar, wind, and nuclear power are desirable, their cost remains higher than that of fossil fuel power. Coal, a necessary evil, faces delays due to environmental clearances, land acquisition, and rehabilitation issues. Securing funds for new plants is challenging, with multilateral agencies refusing support. Existing coal plants operate inefficiently under lenient environmental regulations to meet power needs. Legal efforts to limit industrial exploitation and ensure fair compensation are vital for democracy. Undermining this bodes ill for India's progress.

# Green bonds foster climate resilience

nergy is the lifeblood of any economy, stimulating economic prosperity and quality of life, ensuring national security and echnological advancement. Fossil fuels, the major source of energy, are not only limited but also unevenly distributed in politically unstable economies, resulting in price instability and global energy security issues. Further, the burning of fossil fuels emits greenhouse gases (GHGs) that contribute to climate change and global warming. Thus, it is increasingly important to divest financial resources from fossil-based sources to green energy-based systems for the transition to a climate-resilient global economy. This is a critical component of global efforts to address climate change, as the scale of the challenge requires significant investment and innovative financing mechanisms. One of the key climate finance innova tions is green bonds. These bonds are fixed-income, long-term financial securities that are used to raise funds to finance or refinance investments, projects, expenditures, or assets helping to address climate and environmental issues. These environmental issues include renewable energy, pollution prevention and control, climate change adaptation, terrestrial and aquatic biodiversity conservation, sustainable agriculture, clean energy transportation, green building and construction, and eco-efficient production technologies, among others.

The rights of green bond holders and obligations of the issuer are captured in the green bond indenture. This indenture includes standard provisions along with a robust green bond framework and its public disclosure and verification. The provisions are prepared following either the Green Bond Principles of the International Capital Market Association or the Climate Bond Standard of the Climate Bonds Initiative (CBI). The former dominates the market due to its liberal approach compared to the latter. Although CBI has set the oldest standard for green bonds, it is not universally recognized as a global standard for determining the environmental friendliness of a bond. Specialized institutions such as Bloomberg, Deloitte, KPMG, and Moody's, among others, expose unethical practices of green bond issuers like "greenwashing." Greenwashing, an act of deceiving the public by showing that the company is environmentally friendly, has attracted the attention of regulators, governments, and industry experts. The green bonds are issued in three structural formats: green revenue bonds, green

default risk. Anecdotal evidence largely suggests that, in the primary market, green bonds offer the issuer pricing that is comparable to that of a non-green equivalent bond. However, green bonds' superior return and liquidity performance are amply evidenced in the secondary markets.

A diverse pool of issuers has entered the green bond market, including governments, banks, financial institutions, and corporations, as well as multilateral (supranational) organizations like the World Bank, International Finance Corporation, Asian Development Bank, and African Development Bank. The growing interest in ESG investing has fuelled the demand for green bonds. Institutional investors, such as pension funds and insurance companies, are the largest investors in the green bond market. The green bond market has also attracted a wide array of globally reputed underwriters, such as JP Morgan Chase, Bank of America, Citi Group, BNP Paribas, Morgan Stanley, Credit Agricole, Barclays, HSBC, ING, and many others. The first multilateral agency green bond was issued in 2008 by the European Investment Bank and World Bank, under the label Climate Awareness Bond, as a structured bond with proceeds dedicated to supporting lending for eligible climate-focused renewable energy projects. However, the first corporate green bond was issued by a Swedish property company, Vasakronan, in 2013. Since hen, the green bond market has grown rapidly over the years, further propelled by renewed investor interest in environmental, social, and governance (ESG) issues. The green bond market experienced a record \$635.3 billion issued in 2021, up from \$15 billion in 2013. According to the Climate Bonds Initiative (CBI), annual green bond issuance could reach \$1 trillion by 2023, which is a frac-

issuance of green bonds worth over \$35 billion. The green bond market is still tiny compared to the global bond market. The growth of the green bonds market is hindered by diverse factors. A recent European Commission research report revealed that the unavailability of standardized terms related to green projects and green bonds, complex review procedures for the bonds, and a lack of investable projects and assets hinder the market's growth. Investors, acting as a segment of market operators, find that green bonds are costly and face difficulties in identifying high-quality green bonds. Issuers bear the additional costs of issuing a green bond due to market fragmentation, uncertainty around green assets, and potential reputational risks. In the external review market, heterogeneity, lack of transparency, and conflicts of interest are some of the major obstacles. Thus, these challenges could lead to consequences such as potential future market disruption from greenwashing, a persistent significant gap between high-quality green bond supply and market demand, and the risk that insufficient investment may be channelled towards projects with a substantial impact. Considering the expected growth of the green bond market, these vulnerabilities are also likely to grow and may increase the risk of high-impact/visible greenwashing incidents, creating serious reputational roblems

However, initiatives such as the Sustainable Finance Disclosure Regulation (SFDR), a pragmatic outlook for sovereign green bond issuance, growth of green bond ETFs, and the inclusion of green bonds into broad market indices may strengthen the market presence of green bonds. Further, wider use of green bonds as a hedging tool at the equity portfolio investors' level, interest rate discounts at the policy level, and long-term sustainability mandates at supranational, national, and local government levels would support green bond market development.

From a policy perspective, the next-gen web is complex. Part of the problem lies with the diverse descriptors employed by experts. Also, the web's immense social relevance is hard to comprehend. Some experts term the third-gen web as 'Web3', while others use the descriptor 'Web 3.0'. For web-tech buffs, Web3 is decenacv-oriented bloc crypto-asset friendly; while Web 3.0 upholds the property of the 'semantic web,' which is powered by Artificial Intelligence (AI). The real point about the semantic web is its ability to recombine information available on different websites to generate new content and knowledge resources that are more authentic and creative. Followers of Web 3.0 claim that their version is endowed with robust capability on the data analytics front. This way, it is argued that Web 3.0 will create far better search engines. Of the two variants, Web3 seeks to radically transform the manner in which data is generated, monetised, shared and circulated. Further, it advocates decentralised data storage systems with the objective of unshackling the oligopolistic grip of technology behemoths over data. Web3 has file-sharing systems such as the Inter-Planetary

File System which are cryptographically protected, more secure and capable of functioning Web3 seeks to overcome the data storage barriers of blockchains. Web3's boldest element is the strategic role it assigns to non- custodial wallets that function as digital passports for users to access blockchain-enabled transaction platforms. These wallets aid the creation of a 'ownership economy,' whereby creators themselves control their content. Fundamentally, they work as the digital proof of identity. Web3 seeks to replace micro-economic organisations with decentralised autonomous organisations (DAOs). At a more macro level, it seeks to create a distributed economic system, where special classes of native digital tokens and cryptocurrencies would form the media of monetary circulation. In general, Web3 platforms would serve to raise the efficiency

of peer-to-peer transactions.

# Indian farmers explore way forward in Era of market-oriented policies

istress in the Fields: Indian Agriculture after Liberalization, edited by Professor R. Ramakumar of the Tata Institute of Social Sciences, is a comprehensive volume that delves into the current state of Indian agriculture. The book consists of 16 essays covering six themes in 500 pages: Land and Agrarian Relations, Investment and Expenditure, Agricultural Trade, Costs, Profits and Incomes, Credit and Insurance, and Agricultural Marketing and Food Security. The essays are heavily datadriven, making the book a valuable resource for scholars and students interested in Indian agriculture.

In his chapter, Ramakumar brings together the major concerns facing India's agriculture sector. Most of the essays in the book focus on the problems and prospects of India's agriculture. For instance, Madhura Swaminathan writes with insight about inequality in agriculture, while S.L. Shetty traces the history of agricultural investment, highlighting the increasing role of the private sector

and the decreasing significance of the public sector. A chapter by Sachin Sharma et al examines the debates around WTO and agricultural support in India, and Awanish Kumar traces the history and recent performance of agricultural insurance. Sukhpal Singh carefully assesses the regulatory aspects of agricultural marketing reforms with reference to contract farming.

While the book is an excellent compilation of essays on Indian agriculture, it does not address some crucial issues. For example, employment in agriculture has supported nearly half of India's workforce in recent years, which is a shocking reversal of the trend that started in 2004, where the total number of workers dependent on agriculture began to reduce. Despite non-farm job growth slowing, workers continued to leave agriculture, leading to an increase in rural distress. Additionally, the real price of food in the economy has been increasing, reducing consumer spending on non-farm products, which has long been a constraint

Operating profit came to 375.4 billion won for the three-month period, a 16.5 percent on-year increase from 322.3 billion won a year ago. Revenue jumped 32.2 percent on-year to 5.35 trillion won.

The earnings beat market expectations. The average estimate of net profit by analysts stood at 396.4 billion won, according to a survey by Yonhap Infomax, the financial data firm of Yonhap News Agency. The stronger bottom line came with the continued upward momentum in the automotive and energy storage system batteries segment, propelled by the releases of new EV models equipped with SUSDI (SAMS

its signature P5 batteries, the battery maker said.

Samsung SDI mainly produces prismatic batteries in the higher end of the EV battery market. It supplies BMW A.G., Volkswagen A.G. and Ford Motor Co. Samsung SDI said it is working on cobaltfree and lithium iron phosphate (LFP) batteries to target the low-to-mid-end EV market and the utility energy storage system (ESS) market to diversify its product lineups. "The EV market has centreed on the premium market so far, but we expect the volume and entry markets where more consumers can buy EVs, will grow rapidly due to the electrification trend led by global automakers, " Son Michael, senior vice president for the strategic marketing team said in an earnings call.



Local governments in China approved more new coal power in the first three months of 2023 than in the whole of 2021, according to official documents.

The approvals, analysed by Greenpeace, reveal that between January and March this year, at least 20.45 gigawatts of coal power was approved, up from 8.63GW in the same period in 2022. In the whole of 2021, 18GW of coal was approved, the Guardian reported. A Chinese Communist Party (CCP) fiveyear plan from 2016 had placed a heavy emphasis on reducing the use of coal and developing clean energy sources.

In 2020, President Xi Jinping, pledged that the country would become carbon neutral by 2060, the Guardian reported. This prompted an era of reduced coal power approvals as local governments sought to keep their local economies in check with Beijing's priorities. A rise in coal power approvals came in 2020 when the five-year plan came to an end, as local governments anticipated even tighter restrictions on coal expansion in the next round. But in 2021, China suffered huge power outages, leading to a dramatic shift in the CCP's energy priorities.

In September, the price of electricity soared as factories reopened to service global demand as the rest of the world emerged from the Covid-19 pandemic.

But the government had capped prices, so many power plants reduced output rather than operated at a loss, the Guardian reported.


