Punjab to construct high-security digital India shows interest in jail near Ludhiana, says CM Mann

Minister Bhagwant Mann on Friday announced the construction of a high-security digital jail over 50 acres of land near Ludhiana for hearing of cases related to dreaded criminals within the jail complex only.

Addressing a gathering after handing over the appointment letters to the newly recruited Jail Warders in Ladda Kothi in Sangrur, the Chief Minister said Rs 100 crore has been approved by the Government of India to set up the digital jail.

He said the judges will have separate cabins in the jail. "The Jail Department will also have its ultra modern office in Mohali for which land has been identified, "the Chief Minister said.

He said that all-out efforts are being made to modernize the police force on scientific lines. He said Punjab Police are being updated to tackle

cyber crime and various new reforms are being introduced.

Likewise, the Chief Minister said several initiatives are being taken for reforming the inmates in jails so that they can learn something in life.

NEW DELHI: Sports Minister Anurag Thakur on Wednesday said a Chargesheet in the case into the allegations of sexual harassment against outgoing WFI Chief Brijbhushan Sharan Singh will be filed by June 15.

Addressing a press conference after a marathon meeting with the protesting wrestlers, Thakur also assured that the elections to the Wrestling Federation of India (WFI) will be held by June 30. Noting that the government has accepted every demand of the wrestlers, he said WFI will also have an internal complaints committee, headed by a woman.

Thakur said the wrestlers had also demanded the withdrawal of cases against various academies and sportspersons as well as not allowing Singh and his associates to participate in the election process. "All these issues were agreed by consensus," the sports minister said. Asked about the wrestlers' demand for Singh's arrest, Thakur said the investigation into the case will be completed and a chargesheet will be filed by June 15.

India repatriates two youth to Pakistan



AMRITSAR: Kissan Guard party repatriated two youths to Pakistan who had entered Indian Territory inadvertently.

In a officIal statement issued

here on June 6, stated that BSF Kissan Party apprehended two Pakistan nationals ahead of border fence, while they had crossed the International Boundary and entered in Indian territory, in the area falling near Village - Naushera Dhalla under District - Tarn Taran. Both of them were identified as Sabib Khan (25), resident of Panchak, district - Toba Take Singh, Pakistan. Whereas the other was Mohhamad Chand district Lahore, Pakistan. During questioning, it was revealed that both the apprehended Pak nationals had crossed over to Indian Territory inadvertently. Nothing objectionable except personal belongings and Pak Currency amounting to Rs. 1000/- (PKR) were recovered from them, said official.

BSF approached Pakistan Rangers and lodged a protest on the matter. Thereafter, on 06th June at about 0100 AM, both the apprehended Pakistan nationals, being an inadvertent border crosser, were handed over to Pakistan Rangers on humanitarian grounds.

Congress slams Modi govt RBI's MPC retains repo rate at 6.5 per cent, projects 6.5% GDP & 5.1% inflation for FY24

Not belying the expectations, the Reserve Bank of India's Monetary Policy Committee (MPC) did not change the repo rate from 6.50 per cent while projecting gross domestic product (GDP) and inflation at 6.5 per cent and 5.1 per cent respectively.

Announcing the decision of the MPC after its three-day deliberations, RBI Governor Shaktikanta Das said on Thursday that the committee unanimously decided to keep the repo rate at 6.5 per cent.

Das said taking into account the economic factors, the MPC has predicted GDP growth at 6.5 per cent in FY24.

Odisha Train Tragedy: Prime Minister Narendra Modi visits train accident site

The death toll in the train tragedy that took place at Bahanaga in Balasore district on June 2 has risen to 288 with nearly 1000 injured and being treated in different hospitals of the state. Efforts are on to identify the bodies, a challenging task. The accident that took place

at Bahanaga bazar railway station, barely 40 kms from Balasore, involved three trains. It all began with the Shalimar-Coromandel Express, which was running towards Chennai, ramming into a goods train that was standing on the same track at the station. The impact of the collision resulted in 15 bogies of Coromandel Express getting derailed and falling on the parallel track.

Things got further complicated as the Yeshwantpur-Howrah Express going towards Howrah was coming on the same track on which the detached and damaged bogies of the Coromandel Express



Howrah Express hit the fallen bogies of Coromandel Express and two of its bogies got derailed in the process.

The impact of the collision between these trains was so severe that not only the derailed bogies got smashed and crushed even the railway track suffered extensive damage for a long distance. By June 3 evening 288 bodies had been officially retrieved from the mangled bogies while nearly 1000 injured persons were

Prime Minister Narendra Modi visited the accident site on June 3 alongwith railway minister Ashwini Vaishnav and union education minister Dharmendra Pradhan. The Prime Minister also visited the Balasore hospital where he met the people injured in the accident which is the biggest railway mishap to have occurred in the history of Odisha.

NEW DELHI: Property of a drug peddler was seized in Bandipora district of north Kashmir on Monday, police said. The drug peddler has been identified as Khursheed Ahmad Waza alias 'Mandela' under NDPS Act. Reports said that a residential plot measuring 1 kanal 1.5 marlas worth a market value of Rs 44 lakh and two vehicles worth Rs 12 lakh have been seized as illegally acquired property through sale of narcotic drugs.

Shockingly, as many as 538 government schools mostly located in rural areas across the state have no toilets in the schools in Haryana state, causing lot of inconvenience to girl students usually seen searching for a lonely place or thick bushes near the school campus to urinate. Information also reveals, nearly 131 government schools in the state have no facility for drinking water, 236 schools across the state do not have electric connection, nearly 321 schools in the state are without having four walls. The importance of a clean ery school cannot be denied, Filthy and unhygienic toilets cause health risks and parents generally demand stringent action against schools that normalise un-



hygienic practices and lack facilities to their wards require to visualise a scenario where there are no toilets at all in case of as many as 538 state-run schools in Haryana are without toilets for girls, whereas 1,047 schools in the state especially in rural areas do not have urinals even for boys which speaks of the fake, tall talk claims by the government for improvement in the infrastructure of education sector in the state under such appalling conditions as well as for the safety of female students as such many drop out because of menstrual hygiene concerns. Having ill-maintained toilets or none at all in many schools is a

problem that is undermining

initiatives to ensure quality

education for all. Clean toilets can help improve the student retention rate. The Haryana report is a wake-up call for the authorities to prioritise this vital issue and penalise schools not paying attention to it. Both government and private schools must redouble efforts in this regard.

Dr Anshaj Singh Director Medium Schools Education. Haryana while talking to media persons said that during currents financial year decision has been taken to have drinking water dacilities in 131 schools, toilets are being constructed in 1585 schools and 236 schools are being provided electric connections for which there is requirement for budget worth Rs 25 lakh. He assured provision for construction of 8240 additional class rooms in such schools, 5630 other rooms for laboratories, computer teaching, libraries and for the staff in schools located in rural areas this year for which budget for amount worth Rs 1784 crore is required, whereas budget for the amount worth only Rs 424.44 crore is vailable during the year 2023-24.

Kaithal, Jind & Faridabad s in Haryana declared 'Red Zone' due to increasing HIV (AIDS) disease

State Health department Haryana expressed concern over fast increasing cases of HIV (AIDS) disease in Kaithal district also has been declared as red zone like Faridabad and Jind districts in the state. The information also reveals that the number of patients suffering from this infectious disease have reached to 2800 patients in the district with the arrival of 373 new patients during this year as compared to 253 cases received during previous year 2022. The number of HIV (AIDS) suffering patients in Jind district has been

identified as 3100 at present highest in 23 districts in the state. According to health department in Haryana, there are as many as 13 ART icentres in Haryana state at presenr providing treatment to patients suffering from HIV (AIDS) free of cost. Information reveals, most of the patients suffering from this dreaded disease have been found between age 20 to 40 years, besides as many as 25 children also detected suffering from this disease in the state. Health department data also reveals that more than 40 patients suffering from HIV (AIDS) have been reported died due to this disease in

past four years because of extremely weak immune system in their body.

Dr Sachin, PMO ART centre at Kaithal told that HIV (AIDS) is highly

infectious disease generally caused due to infection while having sex relationship with a person of opposite sex already suffering from this disease. The other reason for having this disase seen due use of a common syringe by several persons while injecting drugs in the body by injection, usually seen among youths addicted to drugs generally in hostels as well as PG houses. Dr Sachin told that while treating such drug addicted patients we do not stop providing drugs completely but reduce the quantity of drug among victims suffering from HIV (AIDS) but slowly reduce the quantity intake of drug in victim's body who gradually stops taking drugs. He said, awareness for ill effects of drugs among youths is need of hours in the state at present.

CBI PROBE FOR ODISHA TRAIN MISHAP



As the CBI probe into the June 2 Bahanaga triple train tragedy continues the investigating agency is expected to look into multiple dimensions of the mishap including whether KAVACH, the ace security system of the railways, could have averted the mishap that claimed 288 lives officially and left more than 1100 injured. The inquiry was handed over to CBI on the recommendation of the Railway Board as there is a strong suspicion about the possibility of sabotage.

Neither the Shalimar-Coromandel Express nor the Yeshwantpur-Howrah Express, which suffered severe damage in the accident with multiple bogies getting derailed after Coromandel hit a stationary goods train at Bahanaga Bazar railway station leading to a chain reaction, were fitted with KAVACH. This is an indigenously developed Automatic Train Protection (ATP) system by the Research Design and Standards Organisation (RDSO) in collaboration with the Indian industry.

KAVACH is meant to provide protection by preventing trains to pass the signal at Red (which marks danger) and avoid collisions. It activates the train's braking system automatically if the driver fails to control the train as per speed restrictions. In addition, it prevents the collision between two locomotives equipped with functional Kavach systems. The system also sends out SoS messages during emergencies.

However, neither the Shalimar-Chennai Coromandel Express nor the Yeshwanthpur-Howrah Express were fitted with KAVACH-TACS. The Kavach system project is yet to be implemented on the Howrah-Kharagpur-Chennai line which these trains were running on. However, sources said the probe agency has been

"In these circumstances perhaps no technology in the world can prevent an accident," railway officials are believed to have told the probe agency.

Sources said CBI is looking closely into the sabotage angle as railway minister Ashwini Vaishnaw has indicated that the railway board itself is not ruling out such a possibility. The minister also said that the root cause of the accident, which in all probability was caused by the failure of the interlocking system, has been identified and officials responsible for the error have also been identified.

The Central Bureau of Investigation (CBI), which took over the probe a few days ago, has registered a case on the request of the ministry of railways. The agency, among other things, will look into different angles including human error or deliberate attempts to cause the accident. The Odisha government, which has also given its consent for the probe, would be cooperating with the agency officials.



What is MSP? Why it is needed?

In the era of ups and down in the market, the farmers always remain in the loser's side. So, to save the farmers from the power, the BJP-JJP coalition unexpected losses, MSP was made an integral part of India's agricultural price policy. It was declared in 1965 as a tool for agricultural price policy to meet MSP. That's why it becomes

Committee on Economic Affairs (CCEA), Government of India, and Commission for Agricultural Cost and Prices (CACP) decides the MSP of different agricultural produce in India.

Minimum Support Price (MSP) is fixed as the assured price rate at which the government purchases the crop produce from the farmers, when the market price falls down, It acts as a kind of assurance and insurance to protect the farmers.

Broadly speaking, MSP assures farmers that they will get a reasonable minimum price for their crops, no matter how low the market rate goes. Second, they come to know in advance that for which crop the MSP is the more profitable price, on the basis of which they can cultivate the more profitable crop. The government also gets help in policy making and it can attract farmers towards crop diversification by setting higher minimum support price for the agricultural produce they want to be grown more.

But despite the government declaring the minimum support price already, going back on its promise not only raises questions on the credibility of the government, but also betrays the farmers by depriving them of the fixed minimum support price. The recent Kurukshetra Kisan Andolan is the sad result of the government's action of withdrawing from procuring the

sunflower crop at the declared

be guaranteed under the law. Otherwise, it will not take long for the time to come when the farmers will start refusing to give their crops to the government for storage and the government will have to face the shortage of food grains for distribution to the poor at cheaper rates or free of cost, due to which the food security plan of the government may get a setback.

And such a voice has started to echo. Punjab Assembly Speaker Kultar Singh Sandhwan, while addressing a function on crop diversity at Mohali on June 8, said "Diversification is the need of the hour and the Centre needed to understand the importance of MSP. We will need to stop raising questions on MSP. MSP will have to be given, those who raise questions on MSP they are not nationalists. If Adani can understand the importance of MSP, why cannot the government?", reports Indian express.

He further said that MSP needed to be given, "If you want to keep the nation happy, then you will have to keep Punjab happy. If you want Rice, we will give you Rice but you have to give us MSP."

Jammu and Kashmir Govt will no longer control mutton, chicken prices



SRINAGAR: Jammu and Kashmir government has canceled the Jammu and Kashmir Mutton law whereby it controlled mutton and chicken prices.

The decision comes after the Union Ministry of Consumer Affairs, Food, and Public Distribution informed the J&K government that the previous directive was no longer valid

Consequently, the Directorates of Food, Civil Supplies, and Consumer Affairs in Jammu and Srinagar have been instructed

to refrain from issuing or enforcing any pricing-related orders. The issue of controlling mutton and chicken prices in J&K has long been a contentious matter between the government and mutton traders. The recent notification's issuance raises questions about who will now be responsible for regulating the pricing of these commodities.

The cost of mutton has risen by over 50 percent since 2019. Despite a government-approved price of Rs 535 per kg, it was previously sold for Rs 400 per kg four years ago and is currently being sold for Rs 650. The absence of price controls imposed by the government has worried consumers, as they fear that prices may skyrocket in the absence of regulations.

J&K, which imports around 350 lakh kg of mutton primarily from Delhi and Rajasthan, consumes over 600 lakh kg of mutton annually. Prior to the notification, mutton prices in Kashmir were comparatively lower, with Rs 535 per kg, while Uttar Pradesh, Delhi, and Gujarat had prices ranging from $\mathrm{Rs}\ 600$ to $\mathrm{Rs}\ 750$ per kg.



Uncertainty demands stability-growth equilibrium

ndia's Monetary Policy Committee's (MPC) latest verdict reflects a consistent emphasis on battling inflation while maintaining a pause in the Reserve Bank of India's (RBI) monetary tightening. The committee, headed by RBI Governor Shaktikanta Das, continues to pursue a policy focusing on price stability, reinforcing its commitment to address inflation, which is crucial for the country's economic health. The MPC's unwavering focus stems from its mandate to attain a Consumer Price Index (CPI) inflation target of 4%. However, the task of achieving this target has been challenging. Since January 2021, inflation has remained above or nearly at the upper tolerance limit of 6% for 20 out of 27 months. While headline inflation did slow down in March and April, retail price increases still exceed the target and are predicted to remain so for the fiscal year 2023-24, according to the RBI's projections. The MPC projects an average CPI inflation of 5.1% for the year ending in March 2024, highlighting the ongoing struggle to align inflation with the target amidst global uncertainties. Governor Das identified several factors that pose risks to the MPC's inflation predictions. These include the spatial and temporal distribution of rainfall influenced by El Niño, geopolitical tensions, unpredictable international commodity prices, and volatility in global financial markets. The RBI's policy strategy is also influenced by its firm belief in the strength of macroeconomic fundamentals, bolstered by a relentless pursuit of price and financial stability. As Governor Das underscored, policymakers must maintain a laser-like focus on inflation. Price stability is a public good, and achieving lasting disinflation remains an uncompromising objective, particularly in a context of increasing income inequality and high unemployment rates. The MPC's decision to remain vigilant on inflation, even as it holds back on monetary tightening, underscores the importance of balancing growth with stability in these uncertain times.

Climate migration a ticking bomb



me 5 marked the 50th anniversary of World Environment Day which was started by the United Nations in June 1972 at the Stockholm Conference on the Human Environment. Even after 50 years, 40 per cent of the world's population -3.5 billion people - live in areas that are particularly susceptible to the effects of climate change, including water scarcity, drought, heat stress, sea level rise, and extreme events such as floods and tropical cyclones. The World Development Report on Migrants, Refugees, and Societies states, "As the world struggles to cope with global economic imbalances, diverging demographic trends, and climate change, migration will become a necessity in the decades to come for countries at all levels of income"

South Asia houses the world's most impacted climate displacement hotspots, including the Hindu Kush-Himalaya region, coastal areas, island nations, and deltaic and semi-arid regions. Land regions which are prone to high environmental vulnerability include Bangladesh, India, Pakistan, and Sri Lanka affected by sea level rise and coastal floods. While Bhutan, Afghanistan and Nepal are affected by glacial melt and temperature rise, small island nations such as the Maldives face the threat of submersion.

The situation is exacerbated by high population density, poverty, and inadequate infrastructure. By 2050, nearly 216 million South Asians could be displaced due to climatic reasons. In 2020, cyclone Amphan alone displaced five million people across South Asia. In 2015, Nepal's Gorkha earthquake displaced 2.6 million people, and left over 6,00,000 homeless. Over 7.9 million people were displaced by the floods in Pakistan, in 2022.

Costs of displacements

By 2050, globally there could be 1.2 billion climate refugees. In South Asia, there have been over nine million internal displacements in 2020, making it the region having



the highest number of new displacements due to climate change. Climate displacement results in job losses, food insecurity, and an overall overcrowding of resources, creating further migration and incurring other social and economic costs.

Poor economic capabilities reduce the adaptive capacity of communities to climate change events and promote migration. Internally displaced people migrate for better livelihood opportunities, and safety. The economic costs associated with climate migration in South Asia include loss of skilled labour, and reduced productivity in agriculture, fisheries, and forestry. Displacement can also lead to social costs such as the breakdown of social networks and communities, mental health issues, social unrest, and conflict Changes in agricultural patterns and water availability force people to migrate to urban areas. Such rural-urban migration overburdens cities that already operate at capacity. Climate migration creates a multiplier effect on pre-existing threats such as overcrowding, and conflicts over resources sharing. The correlation between climate vulnerability and violence is notable. In 2020, 95 per cent of conflict-related displacements were reported in climate vulnerable countries.

Supporting the climate refugees

Because of disasters ranging from floods to desertification, South Asia would have an estimated 50 million climate refugees by 2050. The importance of improving resistance and resilience by introducing sustainable solutions such as adopting salinity-resistant crops, making coastal areas resistant, and strengthening infrastructure will be deterministic. Such structure gaps need to be corrected to ensure that communities are not forced to migrate. The underlying economic reasons of poverty and poor infrastructure play a crucial role in the efficacy of a climate adaptation method.

Weak policy responses

Despite the alarming magnitude of climate displacement in the region, responses from governments and international agencies have been inadequate. Most countries in South Asia lack comprehensive policies to address climate displacement, and international aid has been insufficient to meet the needs of affected communities. Missed targets of climate funding also hold back developing nations from financing their climate goals and building resilience. Building climateresilient infrastructure and improving diadaptation and mitigation measures.

Governments and international agencies must recognise the severity of climate displacement in South Asia and mitigate its effects. Further, governments in the region must develop targeted policies that address the specific needs of climate-displaced communities. Apart from developing resilience, policies should focus on providing alternative livelihood opportunities and social protection programmes to help affected communities cope with the impacts of climate change.

Implications for COP

Although the "loss and damage" framework developed at COP27, is aimed at supporting most impacted countries which is viewed as an integral part of climate justice, concerns remain on whether wealthy countries would be willing to pay any "liabilities' or "reparations". The amount of funding required, and the designation of funders are questions still unanswered. European countries worry that they may have to bear a large responsibility as oil and gas suppliers such as Saudi Arabia, or a large economy such as China may take refuge under the UN definition of "developing country".

While human mobility could not find its place on the COP agenda, the final COP27 text identified "displacement", "relocation", and "migration" as some of the concern areas that would be addressed by the loss and damage financing. The UNHCR raised the question of refugees and displaced people at the COP27; even after five decades of World Environment Day, climate migrants are yet to find their voice in the global platform.

A global order as technology's much needed pole star



ver since the Dot-com bubble burst in 2000, the rapid scale and pace of development of technology have, radically and disruptively transformed our societies and daily lives. While there is no denying that this has made life easier, it has also thrown up complex challenges that call for a revisit of some fundamental notions in polity and governance.

First, as defined by political theorists, a nation-state is a territorially-bounded sovereign polity. However, this fundamental notion of a nation-state of a geographical unit in which citizens live is undergoing a massive change because of technology. While geographical boundaries are still essential to be safeguarded against physical externalities occurring across the borders of nation-states, i.e. cyber-attacks, which have a ripple effect on the physical boundaries to challenge their socio-economic and political existence. The advent of Web3, massive peer-to-peer networks and blockchains has allowed actors, both state and non-state, to influence areas such as trade, commerce, health and education even while remaining outside of financial and judicial scope.

Second, geography-based rules are no longer easily enforceable simply because of the declining significance of conventional geographical borders in the era of high technology. Now, any form of "virtual activity" is not confined to the realms of the borders of a country; data travel on the chain of the world wide web and spread across the world at speed hitherto unimaginable. More importantly, when such activities fall foul of the laws of a particular



geographically-determined nation-state. it is extremely difficult in the absence of a globally-accepted norm, to enforce the law in that particular geography and book the recalcitrant actors under the laws of the nation-state. It is difficult to collect tion from other geographies. So, when the national sovereignty of countries is challenged by activities beyond their physical boundaries, their existing constitutionally set-up institutions comprising the executive, legislature and judiciary will prove inadequate in tackling them. Further, it is also difficult to establish applicability of any country-specific legislation due to the universal nature of technology, leading to problems in enforceability.

Third, the emergence of newer technologies has exposed the incapacity and inability of the government of the nation-state to administer and regulate these technologies. No longer is the nation-state the only conduit through which multinational corporations, non-governmental organisations and supranational organisations, both legitimate and illegitimate, state and non-state actors, need to operate. These entities have tran-

scended physical boundaries to collaborate with the rest of the world, independent of traditional administrative and regulatory institutions. For instance, topographical maps, which used to be produced by public and military institutions, are now available entirely by private non-state actors, such as Apple or Google Maps.

Governing complexities and technology

On the economic side, "with a valuation of more than \$4,100 billion, the five largest American tech companies (Google, Amazon, Facebook, Apple, and Microsoft) have symbolically surpassed Germany's GDP (the world's fourth largest economy) in terms of valuation". One of the most important levers of these companies is

This means that data "have become the most important raw material of our times, and only a handful of companies now hold unparalleled economic power and influence over it. These are the meta-platforms: their huge size allows them to constantly increase the amount of information they analyse and refine the algorithms they use to influence, if not control, us and our activities". Thus, as reiterated by India in the past at various international fora, "the borderless nature of technology, and, more importantly, anonymity of actors involved, have challenged the traditionally accepted concepts of sovereignty, jurisdiction/regulation, and privacy". In such a scenario, a principle-based global order for technology would help in streamlining the enforceability challenges in the adoption and diffusion of technology and providing guidance to emerging economies on

how to deal with the evolving definitions of their sovereignty. Further, as we have seen in case of the COVID-19 pandemic, the way forward in managing future global pandemics is probably by the adoption of digital health. But what will the meaning of this digital health framework be if we cannot have a data-sharing ecosystem based on privacy, free flow of data, and a global regulatory system trusted by all countries/nation-states, particularly developing countries? Therefore, India needs a data transfer and data privacy law. But these laws, in isolation, will only be able to do so much unless a global principlebased regulation architecture trusted by all countries facilitates it.

I espoused this approach in Parliament al order for the dee Web, crypto, or regulations for cross-border data flow). Even the Finance Minister while addressing a meeting with the International Monetary Fund on the guidelines of a G-20 event on virtual private digital assets, emphasised the need to have a globallycoordinated approach to the regulation of digital assets such as crypto-currencies, given the potential risks they pose to the world's financial ecosystem.

With India, as the current chair of the G-20, this is the perfect opportunity to take leadership in this as it has done earlier in green initiatives such as the International Solar Alliance or the Coalition for Disaster Resilient Infrastructure.

15/2023-Customs issued on June 7, 2023, these changes will come into effect from July 1, 2023. The objective of this measure, as stated in the circular, is to improve efficiency, minimize delays, and support policy-making efforts. Previously, importers were

encouraged to voluntarily provide comprehensive details of imported goods, including scientific names, brand names, and other relevant parameters. Following a recent review

Importers will need to declare ration requirements. These additional qualifiers must be included in all bills of entry filed on or after July 1, 2023

Additionally, for exports falling under chapter 84, the declaration of the surface material that comes into contact with the chemical is now mandatory.

Fake admission letters: Will evaluate each case, Trudeau says on Indian students facing deportation

Assuring the 700 Indian students who are facing deportation from Canada over fake admission letters, Prime Minister Justin Trudeau said they will evaluate each case and the victims of fraud will have an opportunity to demonstrate their situation and present evidence to support their case.

The remarks came as hundreds of Indian students, mostly from Punjab, have been taking on to the streets in Canada saying they were cheated by their immigration consultation agency in India that provided them fake documents, of which they were unaware of. "We are deeply aware of cases of international students facing removal orders over fraudulent college acceptance letters. To be clear, our focus is on identifying the culprits not penalising the victims, Frudeau said during a parliament debate on Wednesday.

"Victims of fraud will have an opportunity to demonstrate their situation and present evidence to support their case, "the Prime Minister said, while responding to Sikh-origin NDP leader Jagmeet Singh's concerns on the state of defrauded students, who are set to be deported his month. "We recognise the immense contributions international students bring to our country, and we remain committed to supporting victims of fraud as we evaluate each case, "Trudeau said.

Singh's NDP is reportedly preparing to introduce a unanimous consent motion in Parliament to cancel removal orders to support these students while also facilitating a pathway to permanent residency for them. It will also



assist students who could face deportation due to bogus enrollment offers. "So my question is... will the Prime Minister stay the deportation of all these students that are impacted and provide a pathway to permanent residency or these students?" Singh asked Trudeau, presenting the case of victims. According to the Canadian Border Service Agency (CBSA), more than 700 Indian students are reportedly facing deportation after finding that their educational institution's admission offer letters were fake. Most of these students had come to the country to study in 2018

and 2019. The fraud was discovered when the students applied for permanent residency in Canada. Brijesh Mishra, a Jalandharbased agent, was responsible for providing fake admission letters, charging students thousands of dollars. PM Modi can become first Indian PM to address US **Congress twice**

US Congress leaders have invited Prime Minister Narendra Modi to address a joint meeting of lawmakers during his upcoming state visit in June, setting him up to become the first Indian leader to this rare honor Washington D.C. affords to foreign leaders.

There is however, no word yet from New Delhi if the Prime Minister has accepted the invitation.

"During your address, you will have the opportunity to share your vision for India's future and speak to the global challenges our countries both face, "House Speaker Kevin McCarthy, Senate Majority Leader Chuck Schumer, Senate Republican Leader Mitch McConnell, and House Democratic Leader Hakeem Jeffries jointly wrote in a letter to Modi on Friday.

This is a bipartisan invitation that underscores the bipartisan support enjoyed by US ties with India, transcending the parties in power on both sides or the occupants of 7 Race Course and the White House.

Prime Minister Modi is coming to the US for his first state visit on June 22 at the invitation of President Joe Biden, with a state dinner, which is being accorded to an Indian leader after 14 years. Then Prime Minister Manmohan Singh was the last, hosted by former President Barack Obama in 2009.

But Modi will have the singular honor for an Indian Prime Minister to address the US Congress twice. His first was in 2016, and that speech is remembered for a formulation that he had used to describe the arduous journey taken by the bilateral "overcome the hesita-

Senators in California voted in favour of a bill that exempts Sikhs from wearing a safety helmet when riding a motorcycle.

The Senate Bill 847, authored by Senator Brian Dahle cleared the state senate this week with a 21-8 vote margin, and will now move to the Assembly.

Addressing a press conference on Thursday after their meeting at the White House, the President said: "There is no issue of global importance, none, that our nations are not leading together and where we're not sharing our common values to make things better."


Biden also thanked the British Prime Minister for his part-

he sudden death of a renowned Cardiologist Dr Gaurav Gandhi has shock the nation. A doctor who has an expertise in performing thousands of heart surgeries dies of massive heart attack. The news of his untimely demise has not only shocked the people of Jamnagar in Gujarat but the entire country.

Dr Gaurav Gandhi, a 41 year old cardiologist in Jamnagar suffered cardiac arrest in the morning of 6 June. He died at the hospital during treatment. His death has once again sparked questions about heart attack in young people as he did not have any symptoms. According to his colleague, Dr Saugata Chatterjee, Assistant Medical superintendent at Guru Gobind Singh Hospital in Jamnagar. Dr Gaurav was physically fit, non smoker and a teetotaler. He had no medical history of heart problem and neither he did he catch any infection of Covid 19. But his sudden deworries of can a normal person are rare in children.

Sudden cardiac arrest is a life

threatening condition where your heart comes to a standstill. Your heart stops pumping blood due to which the body organs are at risk of death. They must constantly receive oxygen. Emergency treatment includes cardiopulmonary resuscitation (CPR) and defibrillation. CPR keeps enough oxygen in your lungs and gets it to your brain until an electric shock restores a normal heart.

According to the Centers for Disease Control and prevention (CDC) around 2000 young, seemingly healthy people under the age of 25 die of sudden cardiac arrest every year in United States. These deaths leave huge impact on lives of their families. It is important to identify risk factors that can help prevent these tragedies.
