NEW DELHI: Foreign Secretary Vinay Kwatra has described Prime Minister Narendra Modi's state visit to the US as "pathbreaking".

He said that technological cooperation was among the key points of discussion between India and US, describing it as one of the most substantive outcomes of the Prime Minister's "pathbreaking" state visit to the US.

"Technology, in particular advanced technology, across all domains ranging from defence to space and energy is one of the most important substantive outcomes, "he told reporters during a media briefing on Thursday evening (US time).

PM's visit to US 'pathbreaking', Punjab CM vows to ensure supply of canal water at the tail end of the last field in the state

Minister Bhagwant Mann on Thursday reiterated the firm commitment of his government to ensure canal water at the tail end of the last field in the state.

In a statement issued here today, the Chief Minister said that the state government is duty bound for this noble cause. He said already due to strenuous efforts of the state government water has reached the far flung areas of Fazilka districts. Bhagwant Mann said that the state government had delivered a promise made to cotton cultivators of the state that canal water will reach their fields from April 1.

Expressing deep concern over the gravity of the emerging situation due to the fast depleting water table, the Chief Minister

said almost all the blocks in the utilisation of canal water can re-

No survivors after Titanic sub wreckage found on ocean floor



The five people aboard a missing submersible died in a "catastrophic" event, a Coast Guard official said on Thursday, bringing a grim end to the massive search for the vessel that was lost during a voyage to the Titanic. "These men were true explorers who shared a distinct spirit of adventure, and a deep passion for exploring and protecting the world's oceans, OceanGate Expeditions said in a statement. "Our hearts are with these five souls and every member of their families during this tragic time." An unmanned deep-sea robot deployed from a Canadian ship discovered the wreckage of the submersible on Thursday morning about 1,600 feet (488 meters) from the bow of the century-old wreck, 2-1/2 miles (4 km) below the surface, U.S. Coast Guard Rear Admiral John Mauger said at a press conference. "The debris is consistent with a catastrophic loss of the pressure chamber," Mauger said. Rescue teams from several countries have spent days searching thousands of square miles of open seas with planes and ships for any sign of the 22-foot (6.7-meter) Titan. operated by U.S.-based OceanGate Expeditions. The submersible lost contact on Sunday morning with its support ship about an hour and 45 minutes into what should have been a two-hour descent. The five people aboard included the British billionaire and explorer Hamish Harding, 58; Pakistani-born business magnate Shahzada Dawood, 48, and his 19-year-old son, Suleman, both British citizens; French oceanographer and Titanic expert Paul-Henri Nargeolet, 77, who had visited the

to nullify Sikh Gurdwaras (Amendment) Bill, 2023 CHANDIGARH: A high-level delegation led by Shiromani

Gurdwara Parbandhak Committee (SGPC) president Harjinder Singh Dhami today met Punjab Governor Banwari Lal Purohit and demanded from him to nullify the Sikh Gurdwaras (Amendment) Bill, 2023, passed by the Aam Aadmi Party (AAP) government in the state Assembly.

The memorandum stated that the interference made by the Punjab government headed by Chief Minister Bhagwant Singh Mann in the Sikh Gurdwaras Act, 1925 and the provisions of the SGPC is unconstitutional, which should not be allowed.



Talking to the media after meeting with the Governor, SGPC chief Hariinder Singh Dhami said the government is going beyond its jurisdiction and complicating

interfered in the Sikh Gurdwaras Act, 1925, by making an issue of Gurbani broadcast in the Legislative Assembly, he stated.

PSPCL meets record 15151 MW demand without any power cut

and 8 hour power supply for the agriculture sector, PSPCL today on Thursday met an all time record demand of 15151 MW without any cut. This is 6, .6 per cent higher than the peak demand of 14207 MW during Mohabatt and Ropar thermal the paddy season.

Puniab was drawing 8826 MW from the northern grid and the state's own gross generation was 6205 MW at the time of maximum demand. only 3.4 days

All the seven available thermal units in the state sector are running and all the private sector thermal units are also operating. Three out of four Raniit Sagar units were running at the time of maximum demand.

Power demand has been rising continuously and PSPCl has been able to meet the demand. Punjab power demand reached 14962 MW

It was on June 19, 2018, that the BJP withdrew support to the J&K coalition government headed by the then Chief Minister Mehbooba Mufti, paving the way for Governor's rule in the then state. Later, former J&K Governor, Satya Pal Malik, dissolved the assembly in



Over five years have passed since then, and there are no signs of the long-awaited as-sembly elections. J&K has been under direct central rule for eight times since 1977.

Following the abrogation of Jammu and Kashmir's special status on August 5, 2019, the region was downgraded to a union territory. The position of the Governor was reduced to that of Lieutenant Governor. However, despite the subsequent delimitation of seats the union territory is still awaiting Assembly polls.

Punjab government's interference in Sikh affairs: Dhami

The Shiromani Gurdwara Parbandhak Committee (SGPC) has rejected the Sikh Gurdwara (Amendment) Bill, 2023 passed by the Punjab government in the Vidhan Sabha.

Addressing the press conference here, SGPC President Harjinder Singh Dhami said that this day will be remembered in black letters in the 103-year long history of SGPC, when the Aam Aadmi Party (AAP) government of Punjab passed an unconstitutional bill by directly interfering in the Gurdwara managements. This will not be allowed to be implemented at any cost, he said. He said that the Sikh community will never forget this attack on the Sikh organization SGPC by the Punjab government in the independent India.

This anti-Sikh move by the Punjab government led by Bhagwant Singh Mann will be answered at all levels, for which, a special general session of the SGPC has been called on June 26 at Teja Singh Samari Hall to decide the outline.

Sikh Gurdwara (Amendment) Bill

The SGPC President said that the community has never tolerated and will not tolerate government interference in Sikh

religion and Sikh institutions. With reference to history, he said that even at the time of establishment of the SGPC, the British government had set up a government committee, which the Sikhs rejected and set up own committee of the community. He said that Road Transport Corporation has been requested not to permit renewal of the registration of all such vehicle which are 15 years old as per Central Motor Vehicle Act 1950 after 1st April 2023 and if need arises the registration of all such vehicles which are of age above 15 years will be cancelled in Haryana state as in case of NCR where the management in Gurugram district cancelled registration of thousands of vehicles above 15 years old plying on roads.

Will not use govt helicopter till I am in Punjab: Governor

words between Punjab Governor Banwarilal Purohit and Chief Minister Bhagwant Mann, the former on Wednesday hit back at the latter on the official use of government helicopter, saying he would not use it.

"I will not use helicopter till I am in Punjab, "the Governor told the media here.

I have been given a helicopter. I used it for official duty and not for personal use and visited the border area in which Punjab officials also accompanied me. Now, I have announced that as long as I am in Punjab, I will not use the Punjab government's helicopter, "Purohit said in a specially organised press briefing.

Justifying his decision, Purohit said that the Chief Minister mocked him in the Assembly and said that the governor "is writing so many love letters".

"These are the words of a CM.

The Governor has the right to seek information from the CM regarding the affairs of the state. I have not asked for his personal details. He has to reply to all my letters as per the Constitution and the Supreme Court order, the Governor added.

A day earlier, the Assembly unanimously passed the Punjab University Laws (Amendment) Bill, 2023, vesting the powers of the Chancellor of state universities with the Chief Minister.

Summarising the debate on

Minister said the state had its own rich culture, traditions and heritage which need to be perpetuated among the younger generations. For this, the educational institutions, especially the universities, could play a vital role. Mann also recalled how the universities had produced great intellectuals, artists and other eminent people in various fields.

The Chief Minister said that to carry forward the legacy, men of high integrity, prudence and repute need to be appointed in the universities as Vice-Chancellors. However, he bemoaned that the Governor, who is not from the state and "not aware of its history and culture, created unnecessary hurdles" in it.

Mann further said it was surprising that the Governor "knew nothing about the state, but was empowered to appoint the Vice-Chancellors, which was unfair".

Purohit and Mann have been at loggerheads for several months now

Last week, the governor wrote to Mann asking him to respond to multiple letters that he had written seeking information on various issues, including on the appointment of Vice-Chancellors for various universities.

In his letter, Purohit told Mann that the Supreme Court had made it clear that the Governor was well within his rights to seek information from the Chief Minister and that by not doing so, Mann would be failing in fulfilling his constitutional duty.

Mann replied to him through a tweet in which he claimed that it was the Governor who "failed to do his constitutional duty when he refused to refer" to his government as "my government" during his address to the Punjab Assembly on the first day of the budget session.

is missing, and there have been no reports of him for two days. Following this, the entire focus of the NIA is now on Pannu.

During the farmers' protest, Pannu released a number of videos asking people to attack the Indian government buildings, including the Red Fort. Pannu, who runs the SFJ movement, has spread terrorism in India. In one week, two deaths of Khalistani operatives have been reported. Avtar Singh Khanda died in the UK, and then Hardeep Singh Nijjar was killed in Canada. These two deaths have shaken the entire network of Khalistani groups. At present, Amritpal Singh Dibrukhad, a supporter of the Khalistani movement in Punjab, is lodged in the Dibrugarh jail.

Nijjar was a close aide of Pannu. He was also an accused in a case of the NIA and

The maximum deficit was 5.9 per cent in the year 2020-21 affected by the Corona epidemic, which was more than the average fiscal deficit of all the states of India. On the other hand the maximum fiscal deficit during the tenure of the previous government was 9.2 per cent. It is also important to mention here that after Corona, the fiscal deficit

down to less than 0.6 percent, while in Rajasthan it has come down to less than 1.9 percent. This proves that Rajasthan has made a remarkable economic recovery after Corona. In terms of revenue generated from its own sources, the state has recorded an average GDP growth of 14.7 percent in the past 5 years, and from 2018-19 to 2022-23, it has experienced a growth rate of 1.5 percent. On the other hand, during the previous government's tenure of 5 years, this growth was only 0.08 percent. Despite these achievements, there have been two negative aspects regarding the economic development of the state. First, the state's capital expenditure is comparatively lower than that of other states. Second, there is higher expenditure on various types of subsidies compared to other states. For instance, in the year 2018-19, the state's subsidy bill accounted for 12.9 percent of the GDP, while the average for all other states was 7.1 percent. By the year 2021-22, this percentage decreased to 10.5 percent in Rajasthan, whereas the average for other states increased to 9.7 percent. This analysis also suggests that in the year following the recovery from the COVID-19 pandemic, the subsidy burden has decreased to less than 0.04 percent on average for all other states, while Rajasthan's subsidy bill has increased to 2.2 percent. This increase is clearly influenced by the political dynamics of Rajasthan's election year. In

For pharma firms, safety must trump profits

he recent incidents of Indianmade drugs causing significant harm and even death to patients worldwide are distressing and demand serious introspection. Two patients in Sri Lanka recently died due to the administration of Indian-manufactured anaesthetic drugs, a first of its kind incident. Last month, Indian-made eye drops led to eye infections in approximately 30 patients and caused blindness in 10, again in Sri Lanka. Earlier this year, similar products caused infections and blindness in the US. These alarming incidents began last year when the WHO associated the deaths of over 70 children in Gambia with Indian-made cough syrups containing lethal chemicals used as cheaper substitutes for propylene glycol. These substances, diethylene glycol and ethylene glycol, should never be present in any medicinal product. Despite WHO's warnings and independent investigations confirming the link between the deaths and the toxic substances, the Indian drug regulator's response has been deeply concerning. Rather than acknowledging the gravity of the situation and taking stringent action against the errant company, it has instead gone on the offensive, defending the company and questioning the findings of the global health body. Such an approach does not inspire confidence or trust. The Indian regulator's failure to put effective measures in place to ensure the safety of drugs produced in India, whether for export or domestic use, is disconcerting. Inspections alone cannot guarantee safety; a systematic and rigorous regulatory framework that prioritizes patient safety over industry facilitation is required. India, often referred to as the 'pharmacy of the global south', can only continue to uphold this title if its drug regulator prioritizes its role as a watchdog. Ensuring drug safety should be its paramount concern, not acting as a facilitator for the pharmaceutical industry. The lives of millions of patients worldwide depend on it. It's high time that India's drug regulator rises to the occasion and fulfills its mandate.

US-Iran nuke deal imminent



ints of interactions between American and Iranian diplomats over the last few months finally became public on June 14 when the Foreign Minister of the Sultanate of Oman, Sayyid Badr Albusaidi, told the media that Iran and the United States were finalising a deal on the release of American prisoners in Iran, and that there was "seriousness" on the part of the two countries to come to a fresh deal on the nuclear issue. An Iranian spokesperson also confirmed that indirect talks between the U.S. and Iran had taken place in Muscat. U.S. interactions with Iran began last year when the U.S. Special Envoy for Iran, Robert Malley, met the Iranian Permanent Representative to the United Nations in New York. After that, the White House Coordinator for the Middle East and North Africa, Brett McGurk, visited Oman in February, March and May, where he met Iran's chief nuclear negotiator on the nuclear issue, Ali Bagheri-Kani, in "proximity" talks.

What the nuclear arrangement entails

Following Mr. McGurk's last visit in May, the Omani ruler, Sultan Haitham bin Tariq Al Said, visited Tehran on May 28-29. He was perhaps carrying a message from the U.S. on a new agreement on the nuclear issue for Iran's Supreme Leader Ayatollah Ali Khamenei. This was in line with the earlier role played by Oman in the run-up to the nuclear agreement in 2015.

Ayatollah Khamenei then addressed this matter publicly on June 11. He did not call for the revival of the earlier agreement but sought a new one which would ensure that Iran's nuclear infrastructure remained in place; he affirmed that Iran had no interest in a nuclear weapon and would cooperate with the International Atomic Energy Agency (IAEA) inspectors.

According to media reports, the pro-



posed agreement, expected to be finalised in a few weeks, will be informal and unwritten — Israel's Prime Minister Benjamin Netanyahu has called it a "miniagreement", while Iranian officials see it as a "political ceasefire". Under the arrangement, Iran will freeze its nuclear enrichment at 60%; it will not attack U.S. military contractors in Syria and Iraq, will improve cooperation with the IAEA's inspectors, and will not provide ballistic missiles to Russia. Iran will also release the three U.S. citizens in its custody.

In return, the U.S. has pledged to avoid new harsh sanctions on Iran, not to seize oil tankers in the Gulf waters, and not pursue anti-Iran resolutions in the United Nations. The U.S. is also expected to defreeze Iran's bank accounts of about \$80 billion in various banks outside the country, and will immediately allow the release of \$7 billion in South Korea and \$2.7 billion in Iraq.

American interests

Since this is an unwritten agreement, the Joe Biden administration will not have to

seek Congressional approval. And, since it does not call for easing of existing U.S. sanctions, the Republicans will find it difficult to attack the deal in the forthcoming presidential campaign. The U.S. has long recognised that the Joint Comprehensive Plan of Action (the Iran nuclear deal) in its original form could not be revived. In the U.S., there were now demands for a broader agreement that would address Iran's development of ballistic missiles, its "malign" role in the region and support for terrorism, matters on which there would be no headway with Iran. U.S. officials had also recognised that sanctions were no longer effective in influencing Iran's

responses to American pressures.

Thus, what the proposed arrangement focuses on are widespread concerns relating to Iran's uranium enrichment programme that had reached 84% and its stockpile of thousands of installed centrifuges. The U.S. military had estimated that Iran was just "several months" from a weapon, while Israeli sources thought it was one to two years away. Iran's progress towards a weapon had led to real concerns

about a region-wide conflagration as Israel, with or without the Americans, was expected to take pre-emptive military action.

Another positive implication from the

Another positive implication from the U.S. and Israeli perspective is that the deal with Iran could end Saudi Arabia's own nuclear aspirations.

What could happen on the ground

Mr. Netanyahu has said that Israel will not be bound by this arrangement. This could be posturing: with their antidemocratic initiatives, both the Prime Minister and his government have much reduced clout in Washington today and are unlikely to garner backing to overturn the deal. Iran is entering into the arrangement with no illusion that it will have a long-term value; at best, it will survive the present Biden administration. But it will help to release billions of dollars that Iran could use to ameliorate the dire living conditions of millions of its citizens. It wil also enable it to continue selling some of its oil in world markets; the U.S. has so far turned a blind eye to these sales to moderate oil prices to the extent possible.

Regionally, the arrangement will facilitate further improvement in Iran's ties with Saudi Arabia, with the prospect of the kingdom's normalisation of relations with Israel being placed firmly on the back burner. Iran also retains the option of continuing to expand its political and accomplishing with Pussis and China

economic ties with Russia and China.

A piquant thought: if the "good faith" arrangement holds through this administration, it could prepare the ground for serious U.S.-Iran engagement on other matters of common concern in Mr. Biden's second term — assuming, of course, that Donald Trump is not then residing in the White House.

RK VIJ CRITICISES THE LAW PANEL'S DECISION TO RETAIN CONTROVERSIAL SECTION 124A IPC, CITES SUPREME COURT ORDERS

It's time to rethink the retention of sedition



ne Law Commission of India in its 279th report, released in April 2023, has recommended retaining one of the most controversial sections of recent times i.e., Section 124A of the Indian Penal Code (IPC) on 'sedition'. The Supreme Court of India, in S.G. Vombatkere v. Union of India on May 11, 2022, had directed all State governments and the central government to keep in abeyance all pending trials, appeals, and proceedings with regard to Section 124A IPC, as prima facie it felt that this Section was not in tune with the current social milieu. The Law Commission, however concluded that it was necessary to retain it as it was useful in countering the threat to India's internal security. The Commission also felt that the Unlawful Activities (Preall elements of the offence envisaged under Section 124A IPC. The Commission also recommended certain procedural guidelines to prevent the misuse of Section 124A IPC.

The Law Commission elaborated on the violence perpetrated by the Maoists under Chapter 6 of the report pertaining to Threats to India's Internal Security'. The Ministry of Home Affairs data, quoted in the report, show that the number of Maoist incidents ranged from 1,533 in 2004 to 509 in 2021 and the fatality varied from 566 to 147 in the same period. It is also undisputed that the central agenda of the Maoists is to capture political power by overthrowing the democratically elected government through a protracted armed struggle and they need to be tackled stringently.

Despite a dip in the overall Maoist violence over the years, Chhattisgarh still reports the maximum number of Maoist incidents. While the number of Maoist incidents registered in



was zero in the years 2015, 2016, 2017, and 2020, and varied from one to a maximum of three in the remaining years between 2014 and 2021. Even the cases registered under the UAPA were close to three per year in the same period. Thus, it is clear that the use of Section 124A IPC in fighting Maoism has been negligible. As the use of Improvised Explosive Devices (IED) and resorting to ambush attacks remain the most potent weapons in the hands of Maoists, the most frequently used provisions are sections under the Explosive Substances Act and the IPC. In some cases, the specially enacted State law, the Chhattisgarh Vishesh Jan Suraksha Adhiniyam (Chhattisgarh Special Public Safety Act), 2005, is applied to curb unlawful activities by the Maoists.

Second, 'unlawful activity' defined under Section 2(1)(o) of the UAPA includes 'any action taken by such individual or association which causes or is intended to cause

disaffection against India'. The punishment prescribed is imprisonment for up to seven years and a fine. The only difference between UAPA is that in place of the words 'Government established by law in India', the word 'India' is used in the UAPA. As the Supreme Court, in a catena of cases, has held that 'criticising government' does not fall within the ambit of sedition, the 'unlawful activity' as defined in the UAPA seems more objective and less problematic. Any hurdle before any such prosecution under the UAPA that requires central government sanction can be removed by tweaking Section 45 of the UAPA to authorise State governments to act as well as grant sanction for prosecution.

As mentioned by the Commission, the United Kingdom abolished the law on sedition by an Act of 2009 citing two reasons: the first being that there are 'sufficient range of other offences' and the second reason being the political nature of the offence. The Indian case is hardly any different from the U.K. one.

Third, the procedural guidelines for con-

ducting a preliminary inquiry to check '... whether prima facie a case is made out and some cogent evidence exists' (as recommended by the Law Commission) are in conflict with established jurisprudence of writing the First Information Report (FIR), and settled by the Constitution Bench of the Supreme Court in Lalita Kumari v. Govt. of Uttar Pradesh and others (2014). So, if information given to a police station discloses the commission of a cognisable offence, the officer-in-charge has to register an FIR and commence investigation. A preliminary inquiry is permissible only in cases (for example, commercial, matrimonial, related to medical negligence or corruption) that do not disclose the basis of a cognisable offence. Even if it is assumed that a case of sedition could fall under such the purpose of such an inquiry cannot be to ensure whether cogent evidence exists to support the allegations. If such a provision is inserted by an amendment to the Code of Criminal Procedure (CrPC) (as suggested by the Law Commission), there is every likelihood of such an amendment being hit by Article 14 of the Constitution and declared arbitrary by the Supreme Court. Similar could be the fate of the provision to mandatorily seek permission from the central or the State government before registering an FIR.

Therefore, it would be more democratic if all State governments and political parties deliberate on the Law Commission's report, and public opinion sought to arrive at a more participative (if not unanimous) and agreeable decision.

Indian MSMEs, start-ups lack access to EU: French Consultant

HYDERABAD: In comparison to big companies, India's startups and MSMEs are few in numbers that have entered the European Union (EU) market, said a French consulting firm.

Matthieu Lebeurre, Partner, TNP-Industry, Data Science and Analytics, TNP India and Associate-Automotive and New Mobility, TNP Consultants France said that around 130 Indian companies have their facilities in France, however MSMEs and start-ups are few in numbers with insufficient access to the bloc. This was discussed at a session organised by the Indo-French Chamber of Commerce and Industry (IFCCI) on 'Market entry to France for understanding how Indian companies can enter the French market'. The event was held on Tuesday in Hyderabad. in collaboration with TNP India, a French Consulting

from Hyderabad is one of the successful Indian companies present in France. But, we have seen that the number of startups and MSMEs lag behind in getting access to the EU. If an enterprise serving under B2C enters the EU, it will have access to more than 500 million customers with good spending power," Lebeurre said.

Europe is supposed to be the largest consumer market, bigger than that of the US and China, he claimed. According to the official, the enterprises working in the defence sector

would have to partner with local companies in France so as to not endure the regulations in place, but companies in sustainability, smart energy, information technology (IT), pharma and even food processing will have faster access to the market.

He further said, "France has a dense start-up ecosystem. The country has invested heavily into research and development creating a favourable environment for Indian companies involved in tech driven industries such as IT, biotech, renewable energy and aerospace.



UK Home Secy urges police to 'ramp up' stop-and-search



In an effort to prevent more knife attacks and "save more lives", UK Home Secretary Suella Braverman has urged the police to "ramp up" the stop-and-search measure, the media reported. In England and Wales, police can stop and search an individual or vehicle if they have "reasonable grounds" to suspect the person is carrying a weapon, drugs, stolen property or something that could be used to commit a crime, the BBC reported. While critics opine the practice disproportionately targets those leave people feeling victimised, the government says that it is a "common sense policing tactic" and the Met Police has described it as a "hugely important power" for protecting the public. In a letter sent to all 43 forces in England and Wales, Braverman on Sunday said the "dangerous culture" of carrying weapons "must be brought to a stop". She also called on forces to publish bodycam footage quickly to stop police facing "trial by social media". "My first priority is to keep the public safe, and people who insist on carrying a weapon must know that there will be consequences. The police have my full support to ramp up the use of stop-and-search, wherever necessary, to prevent violence and save more lives, "the BBC quoted Braverman as saying in the letter.

World leaders attending a summit in Paris tomorrow must ensure that wealthier nations commit to comprehensive debt relief for lower-income nations, including the cancellation of loans and to the scaling up of international assistance to vulnerable states, Amnesty International said on June 21.

Amnesty International is calling on the Summit for a New Global Financing Pact (PACT) to ensure wealthier nations honour previous financial pledges they have failed to meet and adopt new ones which guarantee the rights of people in lowerincome countries. The rights to an adequate standard of living and to social security are enshrined in the 1948 Universal Declaration of Human Rights, as well as the International Covenant on Economic, Social and Cultural Rights, which has been ratified by more than 170 coun-



tries. Article 2 of the ICESCR lenges that require a rethink of obliges states to take steps, including through international cooperation and assistance, to support other states to meet their economic and social rights

"Many vulnerable, lowerincome states have been overwhelmed by economic shocks, debts they cannot pay, and the effects of climate change – a crisis to which they contributed very little, but which is costing people in these countries dearly. These are unprecedented chal-

how the world's financial architecture is set up," said Agnès Callamard, Amnesty International's Secretary General. "The rights of many people in vulnerable countries to access healthcare and social protection are not met at even the most basic level. There is a vital need to provide financial and technical assistance to these countries so that they can scale up social protection schemes to guarantee people's right to an adequate standard of living.



Tajinderpal Singh Toor sets new Asian shot put record

Puniab athlete hurls 21.77m to break his own mark set two years ago and gets emotional after the feat. This achievement just 3 days after losing his grandmother

NEW DELHI: The moment the shot put left Tajinderpal Singh Toor's hands in his third attempt at the interstate meet on Monday, the reigning Asian Games champion knew it was going to be a huge throw. The gentle giant, as he's popularly known on the circuit, let out a roar as everyone waited for the officials to confirm the exact distance he had hurled the 7.26kg metal ball.

A few seconds later, the field officials confirmed his hunch of a big throw. Toor had managed a 21.77m throw, breaking his previous national and Asian record of 21.49m set two years ago. After the distance came up on the board, he closed his eyes and looked up to the skies, remembering his grandmother who passed away just three days ago. "When I realised I broke the record, I got a little emotional. My eyes went moist and I was thinking about her for a moment. I want to dedicate this medal to her," an emotional Toor said after the event.

Toor, who was already the current Asia leader with 21.20m, is the favourite to win gold at the Hangzhou Asian Games to be held later this year. The Punjab athlete has had a tumultuous



couple of years, starting from the Tokyo Olympics where he failed to reach the finals after suffering a wrist injury. He had to undergo surgery later, which kept him out of action for a while. Even on the personal front,

Toor has had to overcome a lot of grief. In December, his wife had to undergo an abortion due to complications. "Kaaafi jhatke lage hain. (I have faced many setbacks) but I always pick myself up and continue. I did not want to come to the interstate meet after I lost my I somehow pushed myself to come here. I also strained my groin area just before arriving here, so it wasn't easy. I just came here believing God will lead the way," said Toor.

For someone who hasn't spoken to or met Toor before, the 150kg, muscular 28-year-old comes off as an intimidating truth. He is one of the warmest

characters on the circuit. "When people see me, they assume I would be a little arrogant but trust me, I am a very calm and kind person. All the aggression s limited to the field," he said.

While dedicating the gold medal and the new continental record to his late grandmother, Toor recalled the time when she would send him money from Canada for his training requirements. "Until I got a job in 2016 with the Indian Navy, she helped me with my expenses. Shoes, kits, everything. She would send money whenever I needed it," he said.

Toor's expenses were much more than the average thrower's due to his enormous build. His extra-large shoes cost him a fortune. "It was so difficult to get US size 13 shoes for myself. Now I order them from abroad but they don't last long due to my weight. The soles go flat within a couple of months," he said.

Toor has been on the circuit for a long time and has seen grandmother, but then this several ups and downs, but has was an Asian Games trial so never regretted taking up sports as a career. The gentle giant feels he was destined to be a sportsperson, especially after his school teachers gave up on him.

"I don't think I could have done anything apart from sports. Teacher maar maar ke thak gaye (teachers gave up on me entirely) and almost every day I would hear, Tajinder Toor, figure. But that's far from the please get out of the class'," he
