# Supreme Court decides to appoint interim DERC Chairperson by August 4, as Kejriwal, Delhi LG fail to reach consensus

The Supreme Court bench headed by Chief Judge DY Chandrachud said on Thursday that it will appoint a DERC chairperson for a brief period on an ad-hoc basis by August 4 as a way out to ensure the statutory body, headless for the past six months, becomes functional. while expressing anguish that nobody cares about the "headless" institution and are "busy in fighting".

Amid the deadlock between the Arvind Kejriwal-led Aam Aadmi Party (AAP) government and Delhi Lieutenant Governor (LG) V K Saxena over the appointment of Delhi Electricity Regulatory Commission (DERC) chairperson, the top court said it will do some homework and appoint someone on a "pro tem basis" to the post.

This comes a day after Delhi chief minister Arvind Kejriwal held a meeting with Lieutenant Governor VK Saxena at the Raj Niwas to pick a candidate for the chairperson of January amid the differences



the DERC. Ahead of the meeting, the Delhi government had furnished three names before the LG. On Monday, the Supreme Court asked the two constitutional functionaries to rise above "political bickering". Chief Justice of India DY Chandrachud urged them to "sit together" and come up with a name. The post of the DERC chairman assumes significance since the regulator decides the power tariff in the national capital. The position has been lying vacant since

charge, citing personal reasons. On June 21, the chief minister recommended the name of retired justice Sangeet Lodha as the new DERC chairperson. However, the Centre through a notification appointed Justice Umesh Kumar (retd) to the post.

## Lok Sabha and Rajya Sabha adjourned amid opposition uproar over Manipur Crisis

Massive ruckus ensued in both the Lok Sabha and Rajya Sabha after the opposition parties demanded Prime Minister Narendra Modi to speak on pressing issues surrounding Manipur, which disrupted the proceedings of the house for a second consecutive day. Meanwhile, Defence Minister Rajnath Singh

said in the Lok Sabha that the

government is ready for a discus-

sion on the Manipur Violence. As soon as the House met, the members of the opposition parties were on their feet. The members, including those from the Congress, DMK and Left, raised slogans and told Speaker Om Birla that "Manipur

is bleeding". The speaker told opposition members that sloganeering will not bring any solution to the problem but only dialogues and discussions can. "You don't want the House to function, you don't want the Question Hour to take place. All other members want the House to run. This is not good. Solutions can be found only through discussions," he

As the opposition did not heed to his requests, Birla asked the Defence Minister to speak. Singh, who is also the deputy leader of the House, said the government is ready for a discussion on Manipur incidents. He said the Manipur situation should be taken seriously and the seriousness of the government was reflected when the Prime Minister himself said that the entire country was feeling ashamed over the Manipur incidents.

Singh said: "We want that there should be discussions on Manipur incidents. I have said this in an all-party meeting and I want to reiterate here that there should be discussions on Manipur incidents".

"But I can see that the opposition is unnecessarily creating problems so that no discussions take place on the Manipur situation. I want to say that the opposition is not serious for a discussion on Manipur as it should have been. We want a discussion on the Manipur situation and there should be a discussion. Opposition should take it seriously," he said.

**NEW DELHI:** Chinese smartphone makers, including Oppo Mobile, Vivo India and Xiaomi Technology, have been found evading taxes worth Rs 9,000 crore in India, Parliament was informed on Friday.

Data shared by the Minister of State for Electronics and IT Rajeev Chandrasekhar in Rajya Sabha showed tax evasion of around Rs 9,000 crore, comprising customs duty and GST, has been detected between 2018-19 and 2022-23. The government has recovered Rs 1,629.87 crore period.

#### Chandrayaan-3 to leave earth orbit July 31, enters Moon orbit Aug 5 **ARUN KUMAR RAO**

The Chandrayaan-3 Launch was proclaimed a success in 16 minutes. Now all we have to wait 40 days to see if India's third Moon mission will be a success. After perfect Launch Chandrayaan-3 starts 40-days trek. To leave Earth orbit july 31, Enter Moon Orbit August 5. Mission life is 1 lunar day (14 Earth days). Carries Lander and a rover with six payloads and propulsion module with one payload.

ISRO's LVM-3 lifted off from Sriharikota at a 2.35pm amidst roars and applause around 10,000 spectators at the spaceport—and millions who eagerly watched the live stream. At 3.01pm, the 'mooncraft" was in the precise transfer orbit of 36,000km x 170km.

PM Narendra modi tweeted from France "It soars high, elevating the dreams and ambitions of every Indian. This momentous achievement is atestament to our scientists relentless dedication. I salute their spirit and ingenuity".

Chandrayaan-3 project director P Veeramuthavel confirmed that all the health parameters of the spacecraft are normal. "The journey has been begun," and "Now for



the critical soft-landing ", he said.

Candrayaan-3 will go around Earth 10 times till July 31, each time scienties carrying out manoeuvres to increase its farthest point from Earth (apogee). The first one will be at 12.05 on Saturday." A scientist said. Once the apogee reaches 1 lakh km, the scientists will perform a "slingshot" to send it on a trajectory to the Moon (tanslunar insertion).

Five and half days later, the craft will enter the critical lunar orbit insertion stage. This will be carried out by firing onboard propulsion systems to get the spacecraft into the Moon's orbit. "The spacecraft's altitude will be reduced to a 100km circular orbit and the landing module will get separated on August 17", ISRO Chairman Somanath said.

## Yamuna again flowing above danger mark in Delhi

**NEW DELHI:** The water level in the Yamuna River has once again crossed the danger mark, reaching 205.35 meters.

It was recorded above the danger level at 7 a.m. on Wednesday morning. An hour later, the water level reached 205.48 meters.

The danger level is 205.33 meters, and the current water level shows that Yamuna is flowing 15 centimeters above the

Officials are expecting an increase in volume due to the current rain in the hilly areas.

On Tuesday night at 8 p.m., it was recorded at 205.3 meters, which was slightly below the danger level. However, due



to continuous rain in the hilly areas, it increased again and crossed the danger level mark.

The Yamuna River broke a 45-year-old record and reached its highest level at 208.65 meters on July 13. As a result of the flood in Delhi, several lowlying areas were submerged, and many roads were flooded.

## Manesar IMT expansion, Haryana introduces no litigation policy -2023 to benefit farmers SATISH HANDA

The state government had notified land measuring approximately 1,810 acres under Section 4 of the Land Acquisition Act, 1894, on January 10, 2011, for the development of Manesar Industrial Model Township (IMT) expansion in three villages Kasan, ,Kukrola and Sehravan in Manesar tehsil. This policy will make land owners had protest against the low compensation for their acquired land.

The state government had notified land measuring approximately 1810 acres under Section 4 of the Land Acquisition Act, 1894, on January 10, 2011, for the development of Manesar Industrial Model Township expansion in villages

Kasan, Kukrola and Sehrawan when the Supreme Court, in April 2011 granted a stay on the acquisition proceedings and the stay was vacated in December 2019 and thereafter the said land was notified under Section 6 of the Land Acquisition Act, 1894, on August 17, 2020

The landowner expressed dissatisfaction on the acquisitions of their land by the government initiated in 2011. Several meetings conducted with the affected land owners brought them unsatisfaction over land acquisition when an assurance was given by the Chief Minister Manohar Lal Khattar during Haryana Vidhan Sabha session on August 9, 2022 that the Rehabilitation and Resettlement Policy 2010 would be revised for this acquisition to ensure appropriate rehabilitation to the landowners, said a government officer as such a specific policy has now been prepared for rehabilitating the land owners whose l1758 acres land was acquired in the three villages Kasan, Kukrola and Sehravan in Gurugram district under Section 4 of the Land was acquired Acquisition Act, 1894 on January 10, 2011. The policy provides an option for receiving better benefits if they submit an undertaking to the government in the prescribed format duly attested by Tehsildar cum Executive Magistrate of Manesar.

# Two migrants injured in second attack on non-local labourers in **South Kashmir in 5 days**

Two non-local labourers were injured after being fired upon by terrorists in Anantnag town of Jammu and Kashmir, on Tuesday evening. This marks the second attack on migrant workers in the region in the past five days.

According to reports, the injured labourers were immediately rushed to a nearby hospital, where they are currently receiving medical treatment. Their condition is stated to be stable.

Police cordoned off the area to conduct a search operation in an effort to apprehend the attackers. The incident has sparked concerns among the migrant worker community in South Kashmir, as it follows a similar attack in Shopian district, south Kashmir, where three labourers were shot at just five days ago

The authorities have urged all residents and non-local workers in the area to remain vigilant and report any suspicious activities to the police promptly.

DSP Yadav said, they found a man sitting on a bike identified as Hussain a member of the gang when he posed as a customer and during interrogation questioning, he revealed that he was from Bangladesh and his two close aides are in the room, when he went up to see other members of the racket and finalise the deal. They revealed that their main work was to get females from Bangladesh and arrange their entry in West Bengal to cross the border illegally and send them to a network of agents in different cities across the country. They used to force girls/women into the flesh trade after luring them with a heavy amount of money. DSP Yadav told media persons how they trapped the trio (members of the gang) admitted to be involved and recorded their statements admitting their

involvement in human trafficking business and arrested them. A case under Section 14 of the Foreigners Act, Section 12 of the Passport Act, and sections 419, 420, 467, 468 and 471 of the IPC was registered at the DLF Phase 3 police station.

Police investigation revealed that during year 2022 as many as 373 females have been identified had to dance at the tunes of gang of three youths and there is no whereabout of the fate of 1140 females and 1426 males most of them working as bound labourers, of them 41 male youths working as bound labourers have been rescued by the police, whereas police has been able to locate 227 females and 313 males so far. # Tamil Nadu woman ends life by jumping in front of bus to get compensation for son's college fees



CHENNAI: Paapaathi had been misled by someone who claimed that her family would receive Rs 45,000 if she dies due to an accident. Struggling to arrange funds for her son's college fees, she chose to end her life.

In a tragic incident that unfolded in Tamil Nadu, a woman committed suicide by jumping in front of a bus. The woman, identified as Paapaathi (45), worked as a cleaning staff at the Collector's office in Salem district. She made this decision due to financial constraints relating to her son's education.

Paapaathi had been misled

by someone who claimed that her family would receive Rs 45,000 if she dies due to an accident. Struggling to arrange funds for her son's college fees, she chose to end her life. The incident, captured on a

video that quickly went viral, has deeply affected netizens. People expressed their sorrow through tweets and comments, questioning the circumstances that drove a mother to take such extreme measures to pay for her son's education.

# RAF silenced women's 'Long Live Manipur' slogan with tear gas in Imphal

The Rapid Action Force (RAF). known for their callous and civilians, once again resorted to extreme measures as they fired tear gas at hundreds of women protesters at Singjamei Bazar in Imphal on Tuesday evening. The protesters, united in their repeated slogans of "Long Live Manipur" and "No Compromise on Territorial Integrity," were silenced by the aggressive actions of the security personnel. The actions of the RAF have resulted in the injury of 19 women, with one among them enduring severe

In a symbolic gesture of hope, the women protesters waved both India's tricolour and the United Nations flags, believing that the security forces would respect these symbols and refrain from attacking them. One of the protesters expressed, "We hold high hopes for peace and unity to

return to Manipur. By displaying the national flag of India and the UN flag, we aimed to convey our desire for peace and normalcy in Manipur to the security forces and the government.

The women had gathered from 2:00 pm at Singjamei Bazar Chingamathak Traffic junction, after they were prevented from proceeding towards the Chief Minister's official residence in Babupara area. Their demand was clear: they wanted long-term solutions to bring peace and normalcy to Manipur without surroundings, where impor- state security forces and the

One of the women protesters explained the motive behind their demonstration, stating that the violence that began on May 3 continues to wreak havoc, resulting in loss of life and property. Normalcy seems distant and unattainable. She added, "We wanted to meet the Chief Minister of the state with the hope that he would take steps to alleviate the suffering we are all experiencing. Unfortunately, the security forces are not giving us the opportunity to meet and express our dire situation to him. This is disheartening and deserves

condemnation from everyone." Among the rally participants were the relatives and loved ones of the nine victims allegedly killed by Kuki militants in the Khamenlok incident. They hoped to submit a memorandum and share their harrowing experiences with Chief Minister N. Biren Singh. However, they were dismayed by the blockades imposed by

Rapid Action Force, preventing their access and leaving them waiting in vain for the Chief Minister to hear their distressing stories.

Expressing their disappointment, the victims' relatives asserted that they would not move an inch until the Chief Minister acknowledged their plight. They expressed that the state government had failed its people, stating, "We have witnessed the blatant incompetence of the government over the past two months. There has been no restoration of peace and normalcy. The hope for a better and once peaceful Manipur seems distant. We must collectively strive to protect our united Manipur from those who seek to divide it. We are prepared to make sacrifices, if necessary, for our state."

Since the outbreak of violence on May 3, similar protests have occurred in various parts of the state, highlighting the inability of both the state and central governments to control the situation.

# **NIA busts Kerala ISIS module** plotting to commit terrorist attacks

NEW DELHI: The National Investigation Agency (NIA) said on Thursday that it has busted a Kerala-based ISIS module with the arrest of a person named Ashif alias Mathilakath Kodayil Ashraf from his hideout near Sathyamangalam in Tamil Nadu.

"We have averted possible terror attacks on places of worship by busting an ISIS module based out of Kerala, the NIA said.

Based on credible inputs and investigation, the NIA conducted a joint operation with the Anti-Terrorist Squad (ATS) of Kerala Police, and searched several locations.

The raids were conducted at three locations in Thrissur and one location in Palakkad that led to the busting of the IS module, which had been conducting reconnaissance missions and conspiring to commit terrorist attacks.

On Tuesday, the NIA arrested Ashif from Sathyamangalam. The next day, searches were conducted in the houses of Ashif, as well as three others, identified as Seyid Nabeel

Ahammed, Shiyas T.S., both from Thrissur, and Rayees from Palakkad. Digital devices and incriminating documents were seized during these raids.

"The module was engaged in raising funds for promoting IS activities and carrying out terror attacks by committing dacoities and other criminal activities. They had already conducted a recce of a few prominent places, including places of worship, in the state. They intended to spread terror and trigger communal divide in Kerala, " said an NIA official. The NIA had registered the case on July 11 under various sections of the Indian Penal Code and the Unlawful Activities (Prevention) Act.

# 'INDIA' unites against BJP's 'nationalism'

n a show of unity and strategic opposition, 26 Indian political parties have coined the acronym INDIA, or Indian National Developmental, Inclusive Alliance, as their collaborative platform. This move is both a reflection of their resolute ambition to achieve a common objective, as well as a rather strained attempt at mixing language and politics. By adopting the country's name as their title, the alliance is attempting a face-off with the Bharatiya Janata Party (BJP) on its own battleground - the field of nationalism. The alliance aims to convey to the electorate that, contrary to the BJP's stance, they represent a more inclusive vision of India. The Congress, by relinquishing any claim for the Prime Ministerial seat should the alliance win the 2024 general elections, has facilitated the formation of INDIA. This is the most cohesive effort to challenge BJP's dominance since 2014. However, there are undeniable inconsistencies within the INDIA alliance, which includes parties that regularly contest against each other in regions like West Bengal, Punjab, and Kerala. The term 'alliance' may thus seem a misnomer. Yet, the shared recognition of a larger political fight is currently INDIA's driving force. Allocating seats among the partners will be a monumental task, even with a mutual commitment to a pluralistic India. Moreover, multiple parties and leaders within the alliance are embroiled in corruption investigations and trials, exposing them to potential coercion or bribery from the BJP. There's evidence of bruised egos and thwarted ambitions, but the resolve to reconvene in Mumbai holds. Despite shifting attitudes towards the BJP and credibility issues, INDIA stands firm. While the BJP's moral standing has significantly deteriorated, it continues to question opponents on issues of dynastic politics and corruption. The opposition's case against the BJP holds substantial weight, yet they must overcome significant hurdles to appeal to the masses and emerge victorious.

# India's data protection law needs refinement

especially true in the face of a task such as drafting and conceptualising a data protection law for over 1.4 billion Indians. The European Union's (EU) data protection law, i.e., the General Data Protection Regulation (GDPR), came into force in the middle of 2018 and achieved widespread popularity as arguably the most comprehensive data privacy law in the world. However, the GDPR has been  $saddled\ with\ challenges\ of\ implementation$ and risks being relegated to the status of a paper tiger. Although the EU's challenges may be due to its unique legal structure, India must guard against the risks of enacting a law that is toothless in effect.

#### Issues around data use

This deliberation becomes increasingly relevant as the Indian government is likely to table India's fresh data protection law in the ongoing monsoon session of Parliament (July 20-August 11). Late last year, the government released the Digital Personal Data Protection (DPDP) Bill, 2022 for public consultation. This is its third recent attempt at drafting a data protection law. While the draft released for public comments was not as comprehensive as its previous versions, news reports suggest that the government may present a Bill that is largely similar. Considering this, critical gaps remain in the DPDP Bill that would affect its implementation and overall success

In its scope and definition, the DPDP  $\operatorname{Bill}$ only protects personal data, that is any data that has the potential to directly or indirectly identify an individual. In the modern data economy, entities use various types of data,



including both personal and non-personal data to target, profile, predict, and monitor users (non-personal data is typically anonymous data that does not relate to a particular individual — for example, aggregate data on products which numerous users look at between 9 p.m. and 11 p.m. on Amazon). Often, this non-personal data when combined with other datasets can help identify individuals, and in this way become personal data, impacting user privacy

For instance, anonymous datasets about individual Uber rides in New Delhi can be combined with prayer timings to identify members who belong to a certain community, which could include their home addresses. This process of re-identification of non-personal data poses significant risks to privacy. Such risks were accounted for in previous versions of India's draft data protection Bill,

in 2018 and 2019, but do not find a place in the latest draft. By not recognising these risks, the DPDP Bill is very limited in its scope and effect in providing meaningful privacy to Indians. A simple and effective solution — as in the earlier versions — would be to add a penal provision in the Bill that provides for financial penalties on data-processing entities for the re-identification of non-personal data into personal data

#### Limited reach of data protection board

Another gap is the inability of the proposed data protection board to initiate a proceeding of its own accord. Under the Bill, the board is the authority that is entrusted with enforcing the law. The board can only institute a proceeding for adjudication if someone affected makes a complaint to it, or the government or a court directs it to do

so. The only exception to this rule is when the certain duties listed by the Bill for users. This is for the adjudication of disputes between the law and users — for example, an obligation on users not to register a false or frivolous complaint with the board, and not between users and data-processing entities.

In the data economy, users have diminished control and limited knowledge of data transfers and exchanges. Due to the ever-evolving and complex nature of data processing, users will always be a step behind entities which make use of their data. For example, a food delivery app can take all my data and sell it to data brokers in violation of my contractual relationship with them. Individually, I may have little resources or incentive to approach the data protection board.

The board, on the other hand, may be in a better position to proceed against the food delivery app on its own — on behalf of all such affected users. This is not a novel suggestion. The Competition Commission of India, which is responsible for the enforcement of India's antitrust law, has the power to initiate inquiries on its own (and utilises it frequently). Again, a simple way to do this would be to have a provision in the DPDP Bill that allows the data protection board to initiate complaints on its own.

These are not the only gaps in the DPDP Bill, but finding solutions to them would help address challenges in implementation in a significant way and make for a more future-proof legislation.



Additionally, permit-holders overseeing multiple vehicles including rental cars and bikes in Goa, have pledged to electrify 30% of their fleet through retrofitting by June 2024, thus contributing to the State's elec-

trification efforts.

Earlier, in his inaugural address, Suman Bery, Vice Chairman, Niti Aayog, highlighted the transformative potential of the Indian EV Industry and its positive impact on both the economy and the environment. He emphasized the role of electric mobility in accelerating India's economic growth along low-carbon pathways and facilitating the nation's net-zero vision for 2070.

Amitabh Kant, India's G20 Sherpa, in a special address at the event, underscored the need to sustain the momentum of electric mobility in India. Emphasizing the seven Cs framework for EVs envisioned by the Prime Minister - Common, Connected, Convenient, Congestion-free, Charged, Clean and Cutting-edge, he urged for 100% electrification of 2-wheelers and three-wheelers, and 65-70% of buses by 2030.

# Over 1000 new crypto coins listed in market in 5 months despite tight regulations

coins have been listed in the market in the past five months, despite tighter regulations on crypto firms, bringing their total to 9,708 in July, a new report showed on Tuesday.

According to data presented by AltIndex.com, 1,023 new cryptocurrencies listed on the market since February. The total number of cryptos increased 75 times between 2013 and 2021, from slightly more than 60 to more than 4,500, according to Statista and Investing.com data.

After the 2021 crypto boom, this figure more than doubled, with the market adding roughly 1,000 new cryptos per month. They reached an all-time high of nearly 10,400 in February



2022, but it was all downhill from there. The crypto winter resulted in one of the most significant drops in the number of available coins and tokens on the market, the report said. As per a data, more than 1,700 digital coins were delisted from

crypto exchanges between February 2022 and February 2023, bringing the total number to 8,685. However, the number of cryptocurrencies significantly increased over the past five months, despite the regulatory twists and ups and downs

in the crypto space.
The venture funding in the cryptocurrency space dropped further to \$2.34 billion in the second quarter (Q2) globally amid a strict regulatory environment around various top-notch crypto exchanges. It was the fifth consecutive quarter when crypto funding nosedived, according to a report in TechCrunch. US regulators sued Binance and its CEO Changpeng Zhao last month for allegedly operating a "web of deception" and filed 13 charges in a federal court.

Binance was also ordered by Belgium's Financial Services and Markets Authority (FSMA) to immediately cease all offers of virtual currency services in

# SBI expects no rate cut from RBI in upcoming monetary policy



**MUMBAI:** The Reserve Bank of India (RBI) is likely to maintain the status quo in the forthcoming monetary policy, said State Bank of India (SBI) Chairman Dinesh Khara on Wednesday. Speaking at CII Financial Inclusion & Fin-Tech Summit, he said, "As a bank, we don't expect rate cut, status quo is likely to be maintained by the RBI." On June CPI inflation,

Khara said that the headline print can be perceived as an aberration. In June, CPI inflation rose to a threemonth high of 4.81% due to spike in food prices. The MPC is scheduled to next meet on Aug 8-10 to which Khara said, "The Monetary Policy Committee (MPC) needs to see the trajectory of inflation." In its June 8, policy review meeting, the RBI left its key interest rate unchanged for a second straight policy meeting but signalled that it wants to see inflation moderate more while keeping an eye on the

Khara said that private capex is moving in the right direction and it will pick up when "capacity utilisation rises". He added that financial inclusion has emerged as a key foundation for socioeconomic empowerment and a critical enabler for the inclusive and holistic growth of the people.

# KYC challenges trouble for small retailers using QR code to accept card payments



**MUMBAI**: Small shopkeepers are facing hurdles in completing know-your-customer (KYC) requirements who are able to accept credit card payments through QR code after the integration of RuPay with UPI, reported in media.

Earlier merchants found the simplicity of UPI easier to use an issuer account for accepting payments. However, to accept credit card payments, they need to follow the payment network's guidelines, which necessitates a merchant KYC process.

This is a significant task for payments companies that have deployed QR codes at small shops throughout the country, according to Arpit Ratan, founder of Signzy, a fintech company specialising in digital customer onboarding after

KYC compliance, reported TOI. While the RBI permits remote KYC verification, its norms are more stringent than those of markets regulator Sebi. Sebi's video KYC norms allow customers to interact with software that employs artificial intelligence for customer identification, and companies can offer this process roundthe-clock, unlike banks that typically operate during specific hours. Ratan told to media that there are suggestions from the industry to make video KYC less stringent, particularly when an underlying bank account is already present. "There are also lot of steps in the present video KYC, which do not seem to add value. For instance, the

# **Current capacity Manufacturing stands**



**NEW DELHI:** Despite global headwinds. India's manufacturing sector has remained positive (April-June) and has found its existing average capacity utilization at around 75%, as per Federation of Indian Chambers of Commerce and Industry's (FICCI) latest quarterly survey revealed. It reflects sustained economic activity in the sector and is the same as reported in the previous quarter.

The survey found that the growth momentum in the Indian economy has continued after the post-pandemic revival in 2021-22. FICCI's quarterly survey assessed the sentiments of manufacturers in nine major sectors — automotive and auto components, capital goods and construction equipment, cement, chemicals fertilizers and pharmaceuticals, electronics and white goods, machine tools, metal and metal products, textiles, apparel and technical textiles, toys and handicrafts and miscellaneous.

Responses were drawn from over 400 manufacturing units from both large and small and medium-sized enterprises segments with a combined annual turnover of over Rs 7.70 lakh crore. The future investment outlook has also improved as compared to the previous quarter as over 56% of respondents, FICCI said, reported plans for investments and expansions in the coming six months.

This is an improvement over the previous survey where 47% reported plans for investments in the next six months. Globally, economic slowdown caused by the recessionary fears in the US. EU and other developed nations coupled with the Russia-Ukraine conflict continue to add to volatilities in the supply chain as well as demand.

The respondents to which FICCI reached out, at the same time, also listed high raw material prices, increased cost of finance, high logistics cost due to high fuel prices, low global demand, high volume of cheap imports into India, highly volatile prices of certain metals among major constraints which are affecting some of their expansion plans.

# UK PM Rishi Sunak's Tories face heavy losses but avert byelection sweep

**LONDON**: British Prime Minister Rishi Sunak on Friday averted a damaging byelection whitewash as the governing Conservatives held on to his former boss Boris Johnson's seat in London, but faced a bruising in two key byelections.

Thursday's three-way byelection was widely pitched as a report card on Sunak's handling of the economy and wider prospects as party leader going into a general election, expected in the second half of next year.

Conservative Steve Tuckwell just about holding on to Uxbridge and South Ruislip, Johnson's seat until he stepped down in the wake of a parliamentary inquiry into partygate inquiry last month, was the only bit of good news for the party.

The Opposition Labour Party overturned a massive Tory majority of over 20,000



to decisively clinch the Selby and Ainsty constituency in northern England, a byelection triggered by the resignation of close Boris Johnson ally Nigel Adams.

"This is a historic result that shows that people are looking at Labour and seeing a changed party that is focused entirely on the priorities of working people with an ambitious, practical plan to deliver," said Labour Leader Keir Starmer.

With the big win, his namesake in 25-year-old Keir Mather overtook Indian-origin Labour MP Nadia Whittome as the socalled "Baby of the House" to become the youngest member of Parliament. It will be a long wait though for him to take his seat in the House of Commons. which is now on its summer recess and resumes only in early September.

In a second bruising for the Sunak-led Conservatives, the Liberal Democrats swept the Somerset and Frome by elections on south-west England. Sarah Dyke, a Somerset councillor with a farming background, secured a dramatic victory by winning 21,187 votes, with Conservative Faye Purbrick left far behind in second place with 10,179 votes.

In her victory speech, Dyke thanked "lifelong Conservative voters" who had voted Lib Dem for the first time, as well as Labour and Green supporters who had "lent" their votes. She said the public had been "let down and taken for granted for far too long" by the Conservatives, with the government "too busy being a circus of chaos".

The byelection was triggered by the resignation of former Tory MP David Warburton, following allegations of drugtaking and sexual misconduct. The Lib Dem leader, Sir Ed Davey, who had campaigned hard in Somerset hailed his party's "stunning victory" which he said shows his party is on course to make a comeback in the region and that the country are "fed up with Rishi Sunak's out-of-touch Conservative government".

In London, the sole Tory win was largely attributed to anger against Labour Mayor Sadiq Khan over his plans to extend the Ultra Low Emission Zone (ULEZ) to outer areas of the UK capital. The policy has proved extremely divisive and it meant the Tory candidate held on to the Uxbridge and South Ruislip seat by just 495

Only two offshore ship incidents were reported in Indian waters during the first half of this year (January-June 2023), compared to three a year ago and a dramatic drop from 10-12 at its peak, Regional Cooperation Agreement on Combating Piracy and Armed Robbery against Ships in Asia (ReCAAP) Information Sharing Centre said in its half-yearly report released on Friday. The two incidents that took place in the first half of this year were on ships anchored or berthed, the

# Trump says expects arrest by federal inquiry into Capitol riot

Former US President Donald Trump said that he expects to be arrested by a federal inquiry into the January 2021 Capitol riot and efforts to challenge the 2020 election results.

He made the remarks on Tuesday in a post on his Truth Social app, claiming that he had been sent a letter "stating that I am a TARGET of the January 6th Grand Jury investigation, and giving me a very short 4 days to report to the Grand Jury, which almost always means an Arrest and Indictment", reports

The former President added that he had been informed of the development by special counsel Jack Smith on Sunday night.

Smith's team has investigated Trump's handling of classified documents after leaving the White House and with managing a sprawling federal investigation into the riot and attempts by the former President and his advisers to "interfere with the lawful transfer of power



following the 2020 presidential

Such an indictment would be Trump's third for alleged criminal offences, including 37 counts brought by Smith's team in June accusing the former leader of mishandling classified documents.

Trump has also been charged in New York City with falsifying business records in 2016 hush money payments to adult film star Stormy Daniels.

He is due to stand trial in that case in March 2024, while a date for the classified documents case is still being contested by the president's lawyers.

#### KARACHI: Three daughters of a Hindu businessman in Pakimarried to Muslim men who first kidnapped them and forcibly converted them to Islam, according to a leading minority rights group in the country.

The head of Pakistan Darewar Itehad, Shiva Kachhi, said that the incident took place in Sindh's Dharki area where Chandni, Roshni and Parmesh Pak military court should not begin trial of civilians involved in May 9 violence without Kumari, daughters of a Hindu businessman, Leela Ram, were first abducted and then forcibly converted to Islam.

The conversion was performed by one Pir Javed Ahmed Qadri and later they were also married to Muslim men," he

Kachhi said despite appeals and pleas from his organisation's platform, the problem of forcible conversion of Hindu girls was continuing unabated with the police and authorities not apprehending the culprits.

He said that the three sisters were married to the same men who abducted them. Kachhi also claimed that the attacks on the Hindu community in the riverine areas have spiked since the Seema Haider incident.

Seema Haider, a Pakistani



woman and a mother of four. sneaked into India to live with a Hindu man, Sachin Meena, whom she befriended through an online game platform.

She was ostracised by her family and neighbours for daring to defy the societal norms of a conservative Muslim country.

Muslim men who kidnapped and converted them to Islam

There have been daily threats from dacoits in the riverine areas to retaliate against Hindus because of this incident, Kachhi said. Last week, a gang of dacoits attacked a Hindu temple with rocket launchers along with adjoining homes belonging to Hindus in the Kashmore area of the Sindh province.

"After the temple of Bhagri's was attacked by some dacoits in Kashmore, the authorities have now sent Hindu policemen

for the security of temples and worship places in Mirpurkhas, Kashmore, Tharparkar, Ghotki, Sukkur, Umarkot and Sanghar,' Kacchi alleged.

He claimed these Hindu policemen had also been sent to riverine areas to hunt the dacoits.

These are poor Hindu people who are serving in low positions in police belonging to different areas of Sindh and the authorities now want them to provide security for the Hindu worship places," Kacchi added.



During the hearing, Chief Justice Bandial countered an argument by advocate Latif Khosa, the counsel for petitioner Aitzaz Ahsan, who equated the existing situation in the country with the reign of former military dictator

General Ziaul Haq. "You can't compare the present era with the era of Ziaul Haq. This is not Ziaul Haq's era, nor is martial law imposed in the country. Even if a martial lawlike situation arises, we will intervene," Bandial said.

Chief Justice Badial then directed that the Supreme Court should be informed before mili-

tary trials of civilians begin. "The trial of the accused in military courts should not begin without informing the SC," he said. Attorney General Mansoor Usman Awan informed the court that a lot of people were involved in the events of May 9, but after exercising caution, only 102 people were pinpointed for court martial.
