SYL is a saga of treachery, betrayal against Punjab and Punjabis by its own leadership: CM Mann

LUDHIANA: Punjab Chief Minister Bhagwant Singh Mann said that the Congress leaders shamelessly sang paeans in favour of Satluj Yamuna Link (SYL) canal through white paper brought on the floor of Punjab Vidhan Sabha in early

Addressing the gathering during the 'Main Punjab Bolda Haan' debate organised here on November 1, CM Punjab said that SYL is a saga of treachery, betrayal and sin against Punjab and Punjabis by its own leadership. He said that while a single act "Inter State River Water Disputes Act, 1956" is applicable throughout India for resolving water disputes among States but, Punjab is the only State where a separate arrangement has been made for the distribution of water between Punjab & Haryana, in the "Punjab Reorganization Act, 1966". Hence, Bhagwant Singh Mann said that the Union Government has always discriminated against Punjab but the leaders



of Punjab brought white paper to justify this treacherous move which is shameful.

CM Punjab further said that as per the Punjab Reorganization Act, 1966, all the assets were divided between Puniab and Harvana in the ratio of 60:40 but the then Prime Minister Mrs. Indira Gandhi vide a notification dated March 24, 1976, divided the Ravi-Beas waters between Punjab & Haryana in the ratio of 50:50 in a forcible manner, which was

against the interests of Punjab. He said that the then Chief Minister of state Giani Zail Singh ignored the interests of Punjab and acted as a puppet of the Union Government. Bhagwant Singh Mann said that not only this, but on November 16, 1976

he also received a cheque of

construction of SYL. Punjab Chief Minister further said that after assuming the charge of state in 1977 Parkash Singh Badal didn't even once

stop the work of giving water to Haryana through SYL. Rather, he said that Badal vide letter

Mann said that this reflected the connivance of these leaders to deprive the state of its waters. no. 23617 Dated July 04, 1978 demanded another Rs. 3 crore for the construction of SYL adding that on March 31, 1979, the then Akali Dal Government received Rs. 1.5 crore from the Government of Haryana for

constructing SYL canal. Chief Minister said that Badal acquired the requisite land for constructing SYL Canal, in a very short period by imposing emergency clauses. He said that the complicity of Akali Dal with the Government of Harvana is also clear from the fact that in the Vidhan Sabha session (Held from March 1, 1978 to March 7, 1978), the then Chief Minister of Haryana Chaudhary Devi Lal said that "Due to my personal relation with Badal, Punjab Government has acquired the land under Section 4 and Section 17 (emergency clause) for SYL canal and Punjab Government is trying its best for this work." Bhagwant Singh

Punjab Chief Minister said that the story doesn't ends here as in 1998 when Parkash Singh Badal again became the Chief Minister, he raised the height of banks of Bhakra Main Line Canal by average one feet with the intention of giving more water to Haryana and took Rs. 45 crore too from Haryana for this purpose. He said that Badal did this sin only for the sake of constructing 'Balasar canal' which was constructed till his farm house by Haryana as reward for his treachery with the state. So, Bhagwant Singh Mann said that in this way, the Badal gave water to Haryana for its own interests and Haryana rewarded him by constructing a canal to their farm. Chief Minister said that it is evident from this, that the then Akali Government was betraying the interests of the people of Punjab as personal interests were preferred over those of the public.

India Targets 20% GDP through Digital Economy b FY26: MoS Rajeev Chandrasekhar



NEW DELHI: India has moved the needle on the digital economy from about 4.5 per cent of the total GDP to a target of 20 per cent by 2025-26 and is at 11 per cent today, said Minister of State (MoS) for Electronics and Information Technology Rajeev Chandrasekhar.

Speaking at the global AI summit hosted by Britain, he said, "India has rapidly digitised its economy in the last eight years, we have moved the needle on the digital economy from about 4.5 per cent of the total GDP to a target of 20 per cent by 2025-26. We are at about 11 per cent today but the digital economy and the innovation economy are growing 2.5 or 3 times faster than the non-digital part of the GDP.

The delegates included international digital ministers, technology sector leaders, top academics and civil society representatives. They discussed shared risks from emerging AI technology and explored mitigations.

Chandrasekhar said the Indian government has maintained that International collaboration such as this (Global AI summit) international conversations between countries, are extremely important as we move forward to shaping the future of tech at a time and in a year where technology is certainly throwing up

Onion prices remained at a high level in the national capital on Monday and were ruling at an average price of Rs 78 per kilogram in the retail market, according to government data.


However, the all-India average price of onion was at around Rs 50.35 per kg while the maximum rate was Rs 83 per kg and modal price was at Rs 60 per kg, as per the data compiled by the Department of Consumer Affairs.

The minimum rate is Rs 17 per kg. Local vendors are selling onions at Rs 80 per kg while the key kitchen item is available at Rs 75 per kg on e-commerce



portals Bigbasket and Otipy. On Saturday, the Centre im-

osed a Minimum Export Price (MEP) of USD 800 per tonne on onion exports till December 31 to boost availability of the vegetable in the domestic market. The USD 800 per tonne MEP translates into about Rs 67 per kg. The MEP is there for all varieties of onion except Bangalore Rose and Krishnapuram onions, and for cut, sliced or broken in powder forms.



An official statement issued on Saturday said that the step to impose MEP will help in maintaining sufficient availability of onion to domestic consumers at affordable prices as the quantity of stored Rabi 2023 onion is declining. Onion from the buffer stock has been disposed continuously since the second week of August in major consumption centres all over the country, and also supplied to retail consumers at Rs 25 per kg through mobile vans operated by NCCF and NAFED.

A total of 4,61,312 road accidents were recorded across India in 2022, resulting in the death of 1,68,491 people and injuries to another 4,43,366 persons, according to the latest data released by the Ministry of Road Transport and Highways (MoRTH). The data claims an increase of 11.9% in accidents, 9.4% in fatalities, and 15.3% in injuries compared to the previ-

Out of the total of 1,68,491 fatalities reported in 2022, 61,038

(36.2 per cent) were on national highways, 41,012 (24.3 per cent) were on state highways and 66,441 (39.4 per cent) were on other roads," it added. Amongst the States, Tamil

Nadu recorded the highest number of road accidents on National Highways in 2022, whereas, the number of persons killed in road accidents was the highest in Uttar Pradesh, the The fatal road accident vic-

tims largely constitute young people in the productive age groups. Young adults in the age group of 18 - 45 years accounted for 66.5 percent of victims during 2022. People in the working age group of 18 – 60 years share 83.4 per cent of total road accident fatalities, the report read.

The annual report said that the two-wheeler riders in total fatality has been the highest (44.5%) during 2022 followed



with 19.5 percent of persons killed in road accidents.

The number of road accidents in 2022 increased by 11.9 percent compared to previous year 2021. Similarly, the number of deaths and injuries on account of road accidents also increased by 9.4 percent and 15.3 percent respectively. Tamil Nadu with 64,105 accidents (13.9 %) reby Madhya Pradesh (54,432 i.e., 11.8%). Uttar Pradesh (22,595 i.e., 13.4 %) topped the States in respect of the number of fatalities due to road accidents followed by Tamil Nadu (17,884 i.e., 10.6%)

The data reads that 'over speeding' constitutes the main violation associated with accidents, fatalities and injuries, in corded the highest number of 2022. "Over speeding" accounts

for 72.3 percent of the total road accidents, 71.2 percent of total deaths and 72.8 percent of total injuries. The number of accidents, fatalities and injuries increased by 12.8 percent, 11.8 percent and 15.2 percent respectively in 2022 relative to 2021. 'Driving on the wrong side' was the second highest cause of the total road accidents during 2022 accounting for 4.9 percent. The other major traffic rule

violations are 'drunken driving/consumption of alcohol and drugs', 'jumping red light', 'driving on wrong side', 'use of mobile phones' etc. registered an increase in 2022 compared to 2021. However, the number of accidents and deaths due to traffic rule violation in 'Others' category showed an increase of 28.3 percent and decrease of 14.4 percent respectively in 2022 relative to the same period last year.

NEW DELHI: A quantity of 161.47 lakh metric tonnes (LMT) of paddy has been procured till November 1 under the ongoing Kharif marketing season, benefitting about 9.33 lakh farmers with minimum support price (MSP) value of Rs 35, 571.14 crore, an official statement said on Thursday.

Rice procurement estimates for Kharif marketing season (KMS) 2023-24 (Kharif crop) are 521.27 LMT out of which 20.76 per cent (108.23 LMT) has already been procured of which major contributors are Punjab (66.42 LMT), Haryana (36.11 LMT), and Tamil Nadu (3.26 LMT), it said.



Information reveals that the accidents recorded in the state during the past six years indicate a large reduction in road incidents.in state witnessed nearly 16% decline in 2020 and 2021 as compared to 2019 due to limited movement of the vehicles on roads during the spread epidemic



accidents and persons died and injured in road mishaps was disappointing. The number of road accidents in the country in 2022 was 4,61,312 in which 1,68,491 accident victims lost lives and 4,43,366 persons sustained serious injuries, witnessing 11.9% increase in road mishaps, 9.4 increase in deaths and 15.3 increase in innured as compared to the previous year. Information also revealed that the major reason for increase in road mishaps was high speed while

data revealed that during the year 2022 more than 66000 accident victims had lost lives because they were driving a two-wheeler without helmets while driving or without seat belt while driving a car. Among other prominent reasons for the accidents were found, driving the vehicle from the wrong side, parking their vehicles at the wrong place and use of mobile phones while driving which identified that 3395 persons were reported dead due to this.

SC issues notice to Centre on plea against provision of SC/ST Act mandating death penalty

NEW DELHI: The Supreme Court on Friday agreed to examine a plea challenging a provision of the SC/ST Act providing for the compulsory punishment of death penalty.
A bench headed by CJI

D.Y. Chandrachud and comprising Justices J.B. Pardiwala and Manoj Misra issued notice to the Centre and sought its response on the plea challenging constitutionality of section 3(2)(i) of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act,

The impugned provision of the Act provides only the punishment for death to the person who gives or fabricates false evidence for an innocent member of SC and ST and if such innocent member be convicted and executed in consequence of such false or fabricated evidence.

This section mandates mandatory death penalty without the exercise of judicial discretion and therefore it needs to be struck down for being ultra vires the Constitution of India and the fundamental tenets of the Constitutional law, "said the plea filed through advocate Jyotika Kalra.

It added that the mandatory death penalty goes directly in contravention of the judgments delivered by the Supreme Court in the cases of Mithu v. State of Punjab and State of Punjab v. Dalbir Singh and therefore, the impugned section mandatorily providing death penalty without any alternative to other forms of punishment be declared as unconstitutional for infringing the guarantee contained under Article 21 of the






Slow growth and rising inflation are key concerns

midst the bustling economic

activity, recent data from India's core industries and manufacturing sector signal a concerning deceleration in economic momentum. The government's provisional figures for September reveal a marked slowdown in the production growth of key infrastructure industries, including cement, coal, steel, and electricity, to a four-month low of 8.1% year-onyear growth, down from 12.5% in August. This deceleration was evident across all but the fertilizer sector, which saw an uptick as farmers prepared for the rabi cropping season. The heavy monsoon rains in September, which exceeded expectations by 13%, likely played a role in dampening demand and production, particularly affecting cement, electricity, and steel industries. A sequential analysis shows a contraction across all eight core sectors, with a notable 4.8% decline from August. Coal production, however, remained a bright spot, with a slight dip in growth but maintaining a robust 16.1% year-on-year pace. The weakening demand, especially for consumer goods, has led to the slowest rise in new orders in a year, with international sales also losing momentum. Alarmingly, less than 4% of the surveyed companies reported workforce expansions, indicating a significant slowdown in job creation within the manufacturing sector since April. Manufacturers are also grappling with accelerated input cost inflation, yet factory gate inflation has slowed, suggesting producers are hesitant to pass on the higher costs amid uncertain demand. Business confidence is waning, with inflation expectations identified as a primary concern that could further dampen demand and production in the coming year. Additionally, the anticipated lower kharif crop output could signal limited support from the agricultural sector, potentially impacting rural incomes. Policymakers are now faced with the daunting task of addressing the dual challenges of slowing growth and persistent inflation, a balancing act that requires strategic foresight and decisive action to sustain economic stability and progress.

Reconciliation over retribution



e image of shattered solar panels in Gaza amid billowing smoke is a grim reminder that peace is a prerequisite for progress. If the political leadership of the world cannot ensure a peaceful present, how do we expect them to protect us from other threats like "global boiling"? Francis Bacon in his essay On Revenge describes revenge as "a kind of wild justice." 'Wild' means raw or not regulated by judicial restraint or civilised conduct. Revenge is an act of retaliation implying an earlier act of provocation. Even if that is the case, and whatever its irrationality, an act of vengeance by the establishment can never be justified like the earlier act. The state can punish an unlawful act through its statutory organs but can it subject an entire community to retribution by mindless annihilation? There cannot be any apology for the perpetrators of violence but the responsibility of the state lies in bringing them to justice as administered by the strong arm of law and not in bulldozing its way in a manner that grinds everything to dust.

Revenge may never be able to settle issues, let alone settle scores. It creates its own vicious cycle, a chain that keeps adding links to an unending series of selfdestructive events. The human mind is designed to react but it also possesses the capacity for restraint. Animals understand risk and restrain themselves if they perceive an action as risky. But take away restraint from a human being and you remove the foundation of social behaviour. The laws of any land, international law and treaties bind people and countries to acceptable conduct. Its absence would lead to disorder and unmanageable conflicts. Nations that



cross the boundaries of civilised behaviour can only give lasting wounds, not lasting solutions, even as they achieve the myopic objective of causing mayhem by taking revenge

Nobody should be forgiven for acts of terror but even the anachronistic Hammurabi code demanded "an eye for an eye" and not the entire human body. Gandhi thought that even that would make all of us blind in the long run. He was not a preacher but a practitioner of non-violence who was ultimately able to defeat the worst form of colonial violence where others who followed retaliatory tactics, were defeated. Recall Gandhi's response in South Africa when a police officer's wife saved him from a violent mob that manhandled him upon his return from India. When asked to lodge a complaint against those who used force against him, he refused because that would fuel acrimony and cause a scar difficult to heal. His accepting their behaviour as a manifestation of deviant conduct not meriting his response had a greater chance of not perpetuating animosity between the two communities.

It is possible that in the real world, this behaviour is dismissed as fictional. It may not be held viable in statecraft too although there are examples where cooperation has lasted longer than divisive action that has invariably led to permanent conflicts. Forces of unity and adjustment provide longer lasting solutions. In the short run, the ability of an individual to subdue his opponent and a nation's success in

subjugating a community might seem as a triumph. Still, it might not be so easily possible to extinguish subterranean sentiments that take their own time to erupt. Inhuman destruction generally leaves cinder that smoulders underneath.

It is the responsibility of the judicial system to punish the offenders and that of governments to find solutions to minimise conflict. Lack of efforts to find consensual solutions gives opportunity to fringe elements to rise and be perceived as crusaders for a cause and creates disorder. This invites the wrath of law thus discrediting the cause and giving the establishment a legitimate ground to retaliate. The champions become the quarries along with the cause and the wave of government retaliation causes more collateral damage nullifying the legitimacy of its action. This is the vicious conundrum of violence that gives those in power, the image of being ruthless, inconsiderate and disproportionate in their response to acts of unlawful aggression by the fringe.

Encounters staged by the police against hardened criminals might be approved by a frenetic crowd but this is not sustainable for a civilised society. The establishment must punish as per due process but not as a desperate avenger.

Retaliation has a strong logic that sounds convincing when passions are inflamed. The forces of evil inflict indiscriminate injury, invite the wrath of the victims and approval for consequential action however disproportionate. We crave instant justice but an exchange involving more innocent deaths can never be fair. Such an exchange does entail unintended casualties of the innocent being used as shields. So, while the first set of deaths were of innocent victims, the second set of innocent unintended victims is a price people are willing to pay in order to carry out a seemingly justified retaliation. In the heat of the situation, nobody has the patience to go to the root of the problem and the manner in which grievances are allowed to take the form of ghastly terror.

One of the strengths of an effective administrator or an empathetic human being is the ability to retain equanimity and restraint in any situation. Those in power cannot act as angry bystanders or the instruments of nemesis due to their inflamed egos. The unreasonable hubris of a sovereign can only lead to retribution, not reconciliation. Dialogue is the only reasonable way forward in a civilised world where might can't determine who is right.

ARUL GEORGE SCARIA BELIEVES AI-GENERATED WORK REQUIRES CAREFUL IP PROTECTION EXTENSION CONSIDERATION

Adapting copyright law for the human element in AI



e Executive Order in the United States, issued by the Biden administration on October 30, on 'Safe, Secure, and Trustworthy Artificial Intelligence (AI)', illustrates the changing attitude of global leaders towards AI regulation. Implementation and the use of AI without the necessary safeguards can have enormous implications for the future of humanity, and the changes in regulatory approaches are a welcome development.

One of the many areas wherein AI has raised tough questions is ownership and enforcement of intellectual property (IP) rights. For example, while generative AI tools such as ChatGPT and Midjourney allow people with minimal creative skills to produce reasonably beautiful outputs with the help of a couple of text prompts, their use has raised a number of copyrightrelated questions. These include whether the use of copyrighted materials, including training data infrii the rights of millions of authors and artists on the Internet. A related query revolves around copyright ownership over output generated by AI, autonomously or with inputs from humans.

A recent decision of the United States District Court for the District of Columbia in Stephen Thaler vs Shira Perlmutter is remarkable because it provides some insights on whether copyright can exist in work autonomously created by AI. In this case. Mr. Thaler owned an AI system named 'Creativity Machine' which he claimed had autonomously created a piece of visual art. In his application for copyright registration before the U.S. Copyright Office, 'Creativity Machine' was mentioned as the author of the work. Mr. Thaler also added that the copyright of the work would be transferred



to him, as the owner of 'Creativity Machine'.

The copyright office rejected the application on the ground that the submitted work lacked human authorship. His pleas to the Office to reconsider its decision were ected on the same rationale. He challenged the rejection before the District Court subsequently. The primary legal question before the Court was whether a work autonomously generated by an AI system could be copyrightable. After reviewing the relevant statutory provisions, case laws, and theoretical justifications for copyright protection, the court concluded that human creativity was essential to copyright protection.

The court's line of reasoning is in tune with the general position of the U.S. Copyright Office thus far vis-à-vis work created autonomously by an AI system. In a document entitled 'Copyright Registration Guidance: Works Containing Material Generated by Artificial Intelligence', released in March 2023, the copyright office had categorically stated that "copyright can protect only material that is the product of human creativity. Fundamentally, the term 'author,' used in both the Constitution and the Copyright Act, excludes

The office also clarified that copyright applicants had a duty to disclose the inclusion of AIgenerated content in any application, followed by detailed guidelines on doing so in registration forms. Recently, it also initiated a public consultation on various copyright-related questions posed by AI.

The case in India

Compare the U.S. episode with the prevailing situation in India. In 2020, the Indian Copyright Office registered a work of art called 'Suryast', for which an AI system RAGHAV Artificial Painting App" was listed as a coauthor. The Copyright Office had previously rejected an application in which the same system had been listed as the sole author. While India has not effected any legislative changes in the Copyright Act 1957, the Copyright Office ignored the human authorship requirement in Indian copyright law when granting registration with an AI system as a co-author.

When the matter became controversial, the office sent a notice to the human coauthor in the application declaring its intent to withdraw the registration. But the data from the Indian Copyright Office website suggests that the work concerned continues to remain registered. The Copyright Office is also vet to articulate mandatory disclosure requirements on the use of AI or even initiate broader consultations on this important issue.

It may also be useful to review the current scenario in light of the recommendations of the 161st Report of the Department-Related Parliamentary Standing Committee on Commerce entitled 'Review of the Intellectual Property Rights Regime in India' (July 2021) The report had suggested reviewing the Copyright Act 1957 and the Patent Act 1970 to "incorporate the emerging technologies of AI and AI-related inventions in thir ambit".

A careful reading of the report suggests some of its recommendations aim to relax the standards for securing copyright and patents. But these recommendations do not appear to be informed by any study of IP-related challenges and needs of the AI innovation ecosystem in India. The committee did not consider the potential adverse implications of such an approach for the startup ecosystem in India. This is alarming.

IP rights confer monopoly protection, and as any monopoly rights can have exwe need to be cautious about extending, in a straightforward way, existing IP protections to AI-generated work. Many of the traditional economic arguments such as the need to incentivise authors and inventors through copyright or patents, do not hold with the autonomous creative output of Al systems, since machines are not influenced by such incentives

In sum, policymakers and courts in India also need to assume a more cautious approach against diluting the human-centricity in copyright law. There needs to be a cautious approach in extending existing IP protections to work generated by Artificial Intelligence





Indians to benefit most as Canada to admit 500,000 immigrants each year



TORONTO: Though Canada will admit 485,000 new immigrants in 2024 as in 2023, it plans to raise the numbers to 500,000 by 2025.

Unveiling immigration plans

for 2024-26, Marc Miller, Minister of Immigration, Refugees and Citizenship, said on Wednesday that immigration levels will be capped at 500,000 from 2026. As India is Canada's biggest source of immigration and students, Indians will be the biggest beneficiary of these levels because they are going to get the lion's share of a record 281,135 newcomers under the economic category and 114,000 under the family category.

Last year, over 118,000 Indians took up Canadian permanent residency (PR), accounting for a quarter of all 437,120 newcomers to Canada. The new immigration targets will push up Canada's population each year by 1.3 per cent. In fact, record immigration levels have helped the Canadian population cross the 40-million mark even as the country faces an acute housing shortage. The Justin Trudeauled government is sticking to high immigration levels despite opinion polls showing opposition to the plan because of the housing crunch.

"Canada will continue to welcome newcomers and ensure that they are supported in their new lives, "Miller added. He however, admitted that immigration levels were being capped at 500,000 because "we recognise that housing, infrastructure planning, and sustainable population growth need to be properly taken into account".

Israeli military names 4 more soldiers killed in **Gaza ground offensive**



The Israel Defense Forces (IDF) on Friday named four more soldiers of the 23 troopers killed in action in Gaza since the launch of the ground offensive into the Hamas-controlled enclave on October 27. The four slain soldiers are Capt Benni Wais (22), Master Sergt (Res) Uriah Mash (41), Master Sgt (Res) Yehonatan Yosef Brand (28) and Sgt Major (Res) Gil Phishitz (39). Since the Hamas launched its massive assault against Israel on October 7. at least 335 Israeli soldiers have died in the fighting. So far, a total of 9, 061 Palestinians have been killed in the war, mostly women and children, while more than 32, 000 people have been injured as a result of the raging violence, according to the latest update by the Gaza Health Ministry. In Israel, there were about 1, 400 casualties with some 5, 400 people injured.

JIH Welcomes UN Resolution for Humanitarian truce, While **Expressing disappointment** over India's Abstinence

NEW DELHI: President of Jamaat-e-Islami Hind (JIH), Syed Sadatullah Husani welcomed the UN General Assembly resolution calling for immediate durable, and sustained 'humanitarian truce' in Gaza Strip and has urged the signatory countries to ensure its immediate enforcement.

Immigration agent denies issuing fake admission letters to Indian students in Canada



TORONTO: An immigration agent, accused of cheating several Indian students of tens of thousands of dollars by issuing fake college admission letters to procure study permits to Canada, has denied charges Brijesh Mishra, who has been

under arrest in a British Columbia jail since June, said he has been scapegoated by dozens of international students from India, the Toronto Star reported.

"They are blaming me to cover their mistakes," Mishra said, making his first public appearance before an immigration tribunal in Toronto via video link on Wednesday. The Canada Border Services Agency (CBSA) has charged Mishra with offering immigration advice without a licence, and with counselling a person to directly or indirectly misrepresent or withhold information from authorities.




