## Electoral bonds: Rs 1-cr bonds take lion's share at 96%, Rs 1K bonds just 0.0001%

tions worth thousands of crores to political parties through nowscrapped electoral bonds may have hit the headlines, but there were also 132 bonds of just Rs 1,000 each bought by individuals as well as corporates, including Behemoth ITC Ltd.

Together, these bonds were worth Rs 1.32 lakh, accounting for a minuscule 0.0001 per cent of the total value of 18,871 bonds worth Rs 12,155 crore, details of which have been made public by the Election Commission of India

On the other hand, as many as 11,671 bonds of the highest Rs 1 crore denomination were purchased in nearly a four-year period beginning April 12, 2019, and they accounted for a whopping 96 per cent of the overall value of all such bonds bought for making donations to various

#### Punjab to get 28 new cyber crime police stations soon



CHANDIGARH: In order to effectively tackle the increasing cyber crimes, Chief Minister Bhagwant Singh Mann-led Punjab Government is all set to establish 28 new Cyber crime Police stations in all the 28 Police districts including three Commissionerates, said Director General of Police (DGP) Punjab Gaurav Yadav here on Friday.

Notably, recognising the critical need to address the challenge of cybercrime effectively, the Punjab Police Department has sent a proposal to strengthen its cybercrime investigation infrastructure capabilities.

DGP Gaurav Yadav, while expressing gratitude towards CM Bhagwant Singh Mann for clearing the proposal to set up Cybercrime Police Stations, said that these Cyber Crime Police Stations will serve as dedicated hubs for investigating and combating cyber-related offences including online financial fraud, identity theft cyberbullying, hacking, and

online scams.

He said that the Police Stations will be equipped with state-of-the-art technology and staffed by highly trained personnel specialised in digital forensics and cybercrime investigation. These Police Stations will work under the supervision of the concerned District SSP/CP and overall monitored by the Additional Director General of Police (ADGP) Cyber Crime. Currently, one cybercrime police station is operational in the state, which was notified in

#### SC refuses to stay fresh appointments to ECI, next hearing on March 21

**NEW DELHI:** The Supreme Court on Friday refused to stay the fresh appointments to the Election Commission of India, made under the legislation which excludes the Chief Justice of India from the process of appointment of the Chief Election Commissioner and the other Election Commissioners.

"Normally, we don't stay a legislation by an interim order, "observed a Bench, headed by Justice Sanjiv Khanna, as it heard a bunch of applications seeking to restrain the Centre from filling the vacancies in the poll panel



in accordance with the Chief Election Commissioner and the other Election Commissioners (Appointment, Condition of Service and Term of Office) Act, 2023. The Act provides that the CEC and the ECs will be appointed

by the President on the recommendation of a Selection Committee consisting of the PM, the Leader of the Opposition (or the largest opposition party) in the Lok Sabha, and a Union Cabinet Minister to be nominated by the PM.

During the hearing, senior advocate Vikas Singh, appearing for a PIL litigant, claimed that the scheduled meeting of ction committee was advanced to Thurs after the apex court on Wednesday agreed to urgently list the matter for hearing on Friday.

The Supreme Court on Wednesday agreed to urgently list on March 15 the pleas seeking directions to appoint the member of the poll body as per the March 2023 Constitution Bench judgment of the apex court requiring the appointment to be done by the President on the advice of a panel comprising the Prime Minister, Leader of Opposition, and the CJI.

On Thursday, the Union government issued the notification for the appointment of former bureaucrats Gyanesh Kumar and Sukhbir Singh Sandhu as Election Commissioners. The decision comes days after the resignation of Election Commissioner Arun Goel ahead of the Lok Sabha elections. The other Election Commissioner, Anup Chandra Pandey retired

#### Haryana Govt moves SC against High Court order on Punjab farmer Shubhkaran Singh's death probe CHANDIGARH: Haryana Government has moved the Supreme Court against an or-

der of the Punjab and Haryana High Court setting up a panel to inquire into a farmer's death during a clash between protesting farmers and the state police. In a special leave petition

filed in the top court, the Harvana Government has challenged the March 7 order of the high court setting up a panel headed by retired HC judge Jaishree Thakur to probe the death of Shubhkaran Singh — a farmer — during a clash between protesting farmers and Haryana security

The committee will be assisted by ADGP (Punjab) Promod Ban and ADGP



(Harvana) Amitabh Singh Dhillon, according to the order. Shubhkaran, a native of Bathinda, was killed and 12 police personnel injured in clashes at Khanauri on the Punjab-Haryana border on February 21. The Punjab government had registered a murder case in a zero FIR in the matter. While hearing petitions on the farmers' agita-

tion, the high court had said it was a sad state of affairs that youngsters were "armed with lathis and at certain places with swords and spears and sharp-edged weapons" and children were "being exposed to violence". The investigation regard-

ing the death of Shubhkaran, 21, cannot be entrusted solely either to Punjab or to Haryana for "reasons obvious as both states have several things to cover up", the HC had said, posting the matter for further hearing on April 10.

The incident took place when some protesting farmers were trying to head towards barricades and were stopped by security personnel from crossing the state border and marching to Delhi.

### **Hindenburg report** aimed to defame India, says Adani



MUMBAI: US short-seller Hindenburg Research's damning report against the Adani group was not just to destabilise the apples-to-airport conglomerate but to also politically defame India's governance practices, said Gautam Adani, chairman of Adani Group.

In January last year, Hindenburg published a report alleging malfeasance by the Adani Group. "Despite the efforts to shake our foundations, we stood firm, not just safeguarding our reputation but also ensuring we remained focused on operations," he said.

### Nayab Singh Saini Govt wins trust vote in Haryana Assembly



### Kharge questions Modi's silence over BJP voices to change constitution...

New Delhi

Congress President Mallikarjun Kharge today questioned Prime Minister Narendra Modi's silence over the demands made by certain BJP leaders, no less than an MP, to change the constitution of the country.

#### Muslim organizations condemn implementation of CAA before Lok Sabha Elections

Muslims organizations issued a statement to express our unified stance against discriminatory legislation that undermines the fundamental principles of equality and justice. We vehemently condemn the enforcement of the Citizenship Amendment Act (CAA) 2019 just before the announcement of general

The act introduces provisions that sabotage the principles of equality and secularism enshrined in the Indian Constitution. Article 14 of the Indian constitution embodies the general principles of equality before the law and prohibits unreasonable discrimination between persons based on religion.

The insertion of Clause (b) in Section 2 of the Citizenship Act, 1955, establishes biased treatment - by mentioning individuals belonging to Hindu, Sikh, Buddhist, Jain, Parsi, or Christian communities from Afghanistan, Bangladesh, or



Pakistan, who entered the Indian territory before December 31, 2014; shall not be treated as an illegal migrant.

The act sheepishly avoids mentioning Muslims infringing the fundamental right to equality and secularism guaranteed by the Indian constitution by selectively granting citizenship based on religious affiliation; thus undermining the principle of equal treatment under the law. This discriminatory legislation threatens the social fabric of the country eroding the foundational principles of inclusivity and diversity.

The approval of the Citizen Amendment Bill by the Indian Parliament created a nationwide uproar and protests from Muslims and other sections of society, who felt an immediate responsibility to protect the Constitution of India.







Beyond the economic metrics, the deal is poised to bring tangible benefits to Indian consumers, including access to cheaper wines and chocolates, and to producers through more affordable machinery. The nuanced approach of linking tariff cuts to investment inflows underscores a strategic patience, with the full fruits of this agreement expected to be assessed two decades hence. The swift conclusion of the EFTA deal is particularly commendable. It not only reflects India's agility in trade negotiations but also its evolving stance on international trade agreements. This shift is evident when juxtaposed with India's recent trade history, including its exit from the Regional Comprehensive Economic Partnership (RCEP) and its cautious engagement with other potential trade partners. Moreover, the EFTA agreement's symbolic value cannot be overstated. It signals India's departure from its previously protectionist trade policies at a time when global trends are veering towards protectionism. The inclusion of non-trade issues such as labor rights, environmental concerns, and gender equality in the agreement aligns India with global best practices and addresses potential concerns of key allies like the European Union. In essence, the TEPA with EFTA countries is more than just a trade deal; it's a strategic maneuver that positions India as a proactive, open, and responsible player on the global economic stage.

**URMILA CHOWDHURY** BELIEVES ENGAGEMENT IS CRUCIAL FOR LEARNING, OFTEN LACKING IN INDIAN CLASSROOMS



### Higher engagement, better learning

Annual Status of Education Report 2023 states that more than 86.8 per cent individuals in the age group of 14-18 are enrolled in educational institutions, but one-fourth of them cannot read a Class 2-level text fluently in their regional languages.

#### A learning deficit

India has been struggling with a learning deficit for years now. And though there is more awareness about this thanks to Pratham's annual surveys, little seems to have changed on the ground. Attendance in public schools tends to be low, so despite children being enrolled in school, many of them don't learn much. This is largely because schools are unable to engage children. Therefore, children and parents see little value in school. Across classrooms, government school teachers attribute poor student learning outcomes to poor student attendance. When students don't show up, teachers lose their motivation and do little to increase the level of engagement with learners, which could in turn motivate students to show up. It's a chicken and egg situation.

Students learn when there is motivation to do so and that happens when classrooms are meaningful and psychologically safe spaces. However, in classrooms across India, the teacher focuses only on the few students who sit in the front rows. The teacher writes questions and often even the answers on the blackboard. The students spend most of their learning hours copying off the board while the teacher leaves the room to do "more important" work. The teacher asks questions, but only a few children generally answer. Otherwise, the class answers in a chorus. The children repeat after the teacher in unison. The teacher asks if everyone has understood and receives an enthusiastic



'yes' in response. But this does not give a sense of how much the students have really learned. This looks and sounds like active learning, but is not, because the children are not cognitively or emotionally engaged. India has a long tradition of rote learning. Many have progressed in life learning this way, but this kind of learning does not serve all students. In any case, with the world changing so fast, children need different skills

#### A two-way communication

Now imagine a classroom where the teacher calls upon every child randomly. Every child is alert, curious, and attentive. The students are allowed to discuss and solve problems with their peers and learn from one another. Every child gets to touch, feel, and use the learning material — whether a maths manipulative, a book, or a science kit. The teacher stays in the classroom while the children work and gives them feedback in real time. The children cognitively engage with the topic. There is a happy buzz of students taking ownership for their own learning. This is student engagement and this is what makes the classroom a meaningful space for every learner.

Unless the teacher participates, student engagement cannot happen. Classroom learning opportunities must be made available to everyone, irrespective of gender, caste, religion, special needs, or disability. When teachers actively engage students in a lesson, learning outcomes improve. This seems like a simple premise. Why then is it so difficult to implement in the classroom? The many problems that plague the education system, including inadequate teacher allocation, poor systemic governance, outdated teaching practices, lack of teacher support and coaching, all contribute to making this hard to implement at scale.

There are many teachers who teach with passion and dedication, despite the challenges. However, even when we have dedicated teachers teaching and good student attendance, children still do not always learn. A part of the problem is that many of these teachers were themselves not taught in an engaging way. So, very few of them worry about whether they are engaging the learner as they don't see it as their responsibility. Teaching is largely seen as a one-way communication with the teacher getting no feedback from the

not know what is going on in the learner's mind and therefore cannot customise their teaching to suit the learner's needs.

#### Teaching the teacher

Teachers have not seen how practices such as questioning are practiced. This is because teacher education and training in India tends to be theoretical. It is conducted in seminar-style and tends to be a one-way communication. There is little opportunity for practice provided to the participants. We must see teachers as learners too and provide them with an engaging learning environment with 70 per cent practice and 30 per cent theory so that training serves a two-fold purpose: teachers get trained, but also experience earner engagement for themselves.

Additionally, there is no one in school to support teachers. All of us need coaching and hand-holding to support us in adopting new behaviour. Even though teaching a vital job, teachers do not get help.

Student engagement is the key to driving better learning, but this is missing from many classrooms. Structured lessons, high quality teacher-student relationships, and student autonomy, i.e. allowing students choices in the classroom result in higher engagement and better learning outcomes. Simple changes in classroom techniques can positively impact the learning environment. In India, we have spent a few years discussing the Right to Education but this is a good time to shift the focus to the Right to Learning. Else, reading every ASER report will only lead to more disappointment.

### It's time to prohibit judges from joining politics



ustice Abhijit Gangopadhyay recently resigned as a judge of the Calcutta High Court and joined the Bharatiya Janata Party (BJP). He said that he was approached by the BJP, and he also approached the BJP, during his tenure as judge. He declared that henceforth, he will be a "party soldier".

While he was judge, Gangopadhyay was often in the news for the wrong reasons. He allegedly gave an interview to a TV channel criticising the West Bengal government and speaking about the school iob-for-bribe case. He created controversy by defying an order of a division bench. Sometimes he had run-ins with lawyers and even fellow judges. While dealing with one of the cases pertaining to Gangopadhyay's conduct, a bench of Chief Justice P.S. Narasimha rightly said that judges have no business giving TV interviews on pending matters. The Chief Minister criticised Gangopadhyay after his resignation saying his judgments will always remain questionable

Former Union Minister Arun Jaitley had once advocated a cooling off period for judges saying "pre-retirement judgments are influenced by a desire for a post-retirement job". When confronted with this suggestion, Gangopadhyay retorted that there is no rule to this effect. He added that he "never gave any political judgment which was politically biased".

#### No legal bar

A member of the Constituent Assembly, K.T. Shah, had suggested that judges of constitutional courts should be legally barred from occupying executive posts. But the Constituent Assembly did not find



favour with this. Implementing external rules to control the judicial behaviour of judges would be antithetical to the idea of judicial independence. This is why India has not legislated over the judicial conduct of judges of constitutional courts.

Acceptance of judgeship is often an act of sacrifice for lawyers as it involves loss of freedom. Restraint becomes the norm, which also reduces the space for personal aspirations. Yet, a judge of the constitutional court gets powers and privileges which others do not enjoy. According to Article 217 read with Article 124(4) of the Constitution, the only way to remove a judge is the almost unworkable method of impeachment by Parliament. Article 215 declares the High Court to be a court of record with contempt power which the judges could invoke. The jurist Alan Dershowitz was

right when he said that "judges are the weakest link in our system of justice, and they are also the most protected".

#### Judicial conduct

Paragraph VIII of the Third Schedule of the Constitution demands a judge-designate to swear inter alia that he will perform his duties without fear or favour, affection or ill-will. The Bangalore Principles of Judicial Conduct (2002) gained international acceptance as indicated by the Judicial Integrity Group. The declaration enlists certain judicial values including independence, impartiality, competence and diligence. It

emphasises the need to eradicate bias or prejudice in the decision-making process. It asks judges to ensure that their conduct "both in and out of (the) court maintains and enhances the confidence of the public, the legal profession, and litigants in the impartiality of the judge and of the judiciary". Clause 2.4 of the declaration is against the judge making comments "that might reasonably be expected to affect the outcome of (a case)." It says that the "judge shall disqualify himself or herself from participating in any proceedings in which the judge is unable to decide the matter impartially". The Code also says, "A judge shall conduct himself or herself in a way that is consistent with the dignity of the judicial office".

The U.S judge, Simon Rifkind, remarked that the courtroom, sooner or later, becomes the image of the judge and that it will rise or fall to the level of the presiding judge. The Supreme Court in C. Ravichandran Iyer v. Justice A.M. Bhattacharjee (1995) said, "To keep the stream of justice clean and pure, the Judge must be endowed with sterling character, impeccable integrity and upright behaviour". In All India Judges' Association v. Union of India (1991), the court spoke of "society's expectation from judicial officers".

There have been similar instances in the past. In 1967, Chief Justice Koka Subba Rao resigned to contest the presidential elections, and in 1983, the Supreme Court judge Baharul Islam resigned to get elected as a member of the Rajya Sabha. But past aberrations do not justify present wrongs. They are no longer good precedents or practices given the globally accepted prinles of the Banga were made later.

#### An opportunity

The present episode, therefore, gives an opportunity to the Chief Justice of India and the Supreme Court to investigate the matter more seriously and evolve methods to avert such judicial aberrations. It could lead to one of the most awaited steps towards reforming the judiciary. The top court must expressly prohibit judges of constitutional courts from taking the political plunge even after they resign. Such acts should be interpreted as a breach of the oath read in the light of Indian precedents and the accepted norms on judicial conduct. There is a need for a judge-made law on the topic since Parliament will hardly act on this issue.

100 pharmaceutical companies in India, observed that 20% of these pharmaceutical companies were being run by first-generation entrepreneurs, 51% pharma companies were being headed by second-generation entrepreneurs, and 25% pharma companies were being run by the third-generation entrepreneurs. Fourth-generation entrepreneurs ran only 3% pharmaceutical companies, and only one company was being run by fifth-generation entrepreneurs! This cannot be attributed to just third-generation curse at present as the history of such pharmaceutical companies in India is less than 125 years old as described in preceding paragraph.

Dr. Parvinder Singh took over the company from his father – Bhai Mohan Singh, and ran it till his death in 1999. But in the third generation - Malvinder Singh and Shivinder Singh, it literally resulted into squandering of a business empire. But Samina Vaziralli (Hamied), third-generation entrepreneur, and niece of Dr. Y.K.Hamied, stepped down from the position of Executive Vice-Chairperson of the company in January 2024. Her younger brother, Kamil Hamied was groomed by the family head as the successor but he had resigned in June 2015 to achieve his personal growth objectives. Parting remarks of Samina Hamied were pertinent when she stated that "a decade ago, they believed that Cipla needed an engaged and active promoter from the next generation to steer and strengthen the company as we built a worldclass leadership team, forayed into new geographies and incubated new businesses.....". In a way, it echoed the feeling that it will lead to separation of 'operational management' of the business from 'family owners' but news on potential stake sale by promoters who own 33.47 per cent in the company led to strengthening the belief in

'three-generation curse'. Even promoters remain fearful of this aphorism. Ajay Sharma as the Director of Shree Baidyanath Ayurved Bhawan shared in one of his addresses that being a third-generation family member in the familybusiness; he had a lot of burden on his shoulders. He drew an analogy to the trinity of Hinduism; Brahma - the creator, Vishnu - the preserver and Mahesh – the destroyer. With this in mind, he posed a question to himself - hey am I Mahesh? Have I been born to 'destroy

what my grand-father created

and my father preserved'? With failure rate during third-generation in his mind, he went on to study 250-odd family businesses. He shared the lessons in the book - How to Thrive in a Family Business: Business Lessons from my Baidyanath Journey. To put it in context, Pt. Ramnarayan Sharma started the manufacturing of Ayurvedic medicines at Baidvanath Dham (in Bihar) in the year 1917. Now, with an existence of more than 107 years, fourth generation entrepreneurs are managing the family business.

Frank Stangenberg -Haverkamp, 11th generation representative and the then Chairman of E. Merck KG, the parent company of Merck, in one of his interview (May 23, 2017 in the Korea Herald) shared important lessons in this context when he stated that they (as a family) 'think in generations, and not in quarters'. He attributed the success of oldest pharmaceutical company to 'unique governance structure' of the company which kept the company under the control (70.3 per cent stake with 153 family members) of the family but separated its 'management from the ownership'. Irrespective of the gender, family members inherit the stake from parents. Family members keep the stake in the form of investment. CEO and CFO are not family members. It is also emphasized to family members that they have not worked for it so they should not forget that. Therefore, they are not entitled to anything, they have just inherited it. And if they want

In India, there has been a close relationship between marriage and gold jewellery since time immemorial. Marriage here is considered incomplete without gold jewellery. There is a tradition of giving jewellery to both the bride and groom during marriage. In marriage, many types of jewellery are given to the bride, while in India there is a tradition of giving gold chain, ring, bracelet etc. to

the groom. Gold is exchanged during the 16 rites of Hindu religion i.e. from birth to death. At the time of birth of a child, he or she is made to wear a gold pendant with a black thread around his waist. Even at the time of Yajnopavit Sanskar, gold ornaments are worn on the child. When bride enters the house for the first time, the mother- ures can be considered merely in-law gifts gold jewellery to an indication, as it is a figure

her daughter-in-law. Not only this, even at the time of death, gold is donated to a Brahmin.

For Indian women, gold is not just a jewel, but a symbol of their well-being, self-respect, and pride. Therefore, they buy gold but never sell it. Cases of selling gold jewellery are seen only in situations of crisis.

In marriage, rich and poor all give gold ornaments to their daughter as per their capacity, but now it has become a problem for the poor to give gold ornaments to their daughter in marriage, because in the last 17 years, the price of gold per 10 grams has increased. There has been a significant increase in price. The price of gold per 10 grams was Rs.10,000 on 5 May 2006, which increased to Rs.50,000 on 22 July 2020 and crossed the level of Rs.62,000 on 20 March 2023 and crossed the level of Rs.66,000 on 5

March 2024. According to the National Statistical Office (NSO), the per capita annual income in India was Rs.33,717 in the financial year 2006-07, while the per capita annual income in the financial year 2022-23 was Rs.98,118. If we convert this annual income into per month, then the average monthly income of an Indian in the financial year 2006-07 was Rs.2,810, which will increase to Rs.8,177 per person in the financial year 2022-23. According to an estimate, in the year 2006, an average of Rs.5 lakh to Rs.10 lakh was being spent on a wedding, of which the share of expenditure on jewellery was usually 20 to 30 percent. Due to the unprecedented increase in the price of gold in the last 17 years, the wedding budget of the lower and middle class has increased significantly, but the income has not increased comparatively as expected. However, this comparison is meaningless because the exact data of everyone's income is not available.

In such a situation, the marriage will take place during the auspicious time of marriage this year, but not everyone will be able to give jewellery to their daughters and sons-inlaw as per their wish, because the Federal Reserve Bank is expected to cut policy rates in the coming months, and loan and deposit interest rates will be reduced. # to dismiss classified documents case



The US district judge in Florida overseeing the federal criminal case regarding former President Donald Trump's handling of classified documents has rejected one of his two motions to dismiss

Judge Aileen M. Cannon issued the ruling on Thursday shortly after the completion of a daylong hearing on Trump's

case, which Trump atnhua news agency ported.

A "motion

to dismiss charges" is a egal request made by a defendant in a crim-

inal case to have the charges against them dismissed. If the motion is granted by the court, the charges are dropped, and the case does not proceed to trial. However, if the motion is denied, the case will continue through the legal process.

Trump's legal team argued that the majority of the charges should be dismissed based on

requests to the Presidential Records Act, a 1978 law which regulates the preservation of information during and after a presidency, contending that the law prevents Trump from being prosecuted.

Trump's lawyers cited other cases where presidents were discovered to have kept classified information and also referenced Special Counsel Robert Hur's choice not to prosecute President Joe Biden for classified material he retained after his vice presidency.

Trump has also asserted that he designated the materials he removed to Mar-a-Lago as personal records while he was still in office, an argument refuted by the office of Special Counsel Jack Smith, who has been investigating Trump.

#### **US House passes Tik-**Tok crackdown law



WASHINGTON: The US House of Representatives on Wednesday passed legislation with an overwhelming bipartisan vote that could lead to the banning of the popular social media platform TikTok. The fate of the app, which is

used monthly by 170 million Americans, now rests with the Senate where some lawmakers have vowed to prevent the law's speedy passage. President Joe Biden, who will have the final say, has said he will sign it into law. The legislation passed with 352 affirmative votes to 65 negative and one vote marked as present. It was introduced by the bipartisan duo of Mike Gallagher, a Republican, and Raja Krishnamoorthi, a Democrat, who head the select committee on China as the chair and ranking member, respectively.

"Today we send a clear message that we will not tolerate our adversaries weaponizing our freedoms against us, "said Cathy McMorris Rodgers, the Republican chair of the House Commerce Committee who advanced the TikTok bill. The legislation requires Tik-

Tok's parent company Byte-Dance, which is based in China and is alleged to have links to the Chinese government, to divest its stake in the company within 180 days of the enactment of

Failure to meet the deadline ould bar TikTok from the app stores of Apple and Google.

The app had mounted a vigorous campaign to defeat the legislation through appeals from its users and influencers. Former President Donald Trump, who had met an American investor in TikTok, famously changed his position and came out in opposition to any effort to ban the app arguing it would make Facebook stronger, which he believes is a bigger threat.

It is getting more and more pronounced with each passing day. Interestingly, Beijing is not directly involved in these two conflicts, yet it is quietly pursuing its global agenda worldwide.

The conflicts in Europe and West

Asia have reinvigorated its impe-

rial agenda, especially when the leadership in Washington fails to pick up the gauntlet, the growing Chinese threat to world peace.

#### The War Agenda

Eleven years ago, an article published by a Chinese website, Sohu, in 2013, continues to remind India and other countries in South Asia about Dragon's strategic designs in the region. The website, believed to be is sponsored by the Communist Party of China (CPC), talks about Beijing's ambitious plans to reconquer lost territories which include Taiwan and India's border state, Arunachal. During the first week of March, the Houthi attack on a cargo ship in West Asia killing crews from the Philippines and Vietnam and the inability of the US-led western powers to restore peace in the region could be attributed to the secret support the terrorists got from China through Iran.

The Chinese foreign office has rejected the allegation that the website has any official support, but it may be noted that Sohu is a Beijing-based online media, search engine, and game service company that has promoted Chinese government propaganda for years. The tech company was chosen as the official sponsor of Internet Content Service for the Beijing 2008 Olympic Games.

Apart from its ambitious plans to subjugate South Asia and the Gulf, Beijing is also directly hitting American interests in Southern and Central America. Much to the annoyance of Washington, China has recently signed longterm oil-purchase deals with Venezuela ignoring American sanctions. It has also rescheduled its loans estimated to be USD

10 billion. In 2023, it had also accorded a warm welcome to the Venezuelan ruler, President
