NEW DELHI: India's Goods and Services Tax (GST) collections soared to an all-time high of Rs 2.1 lakh crore in April 2024, registering a robust 12.4 per cent year-on-year growth, according to data released by the finance ministry. This remarkable achieve-

ment was driven by a strong uptick in domestic transactions, which surged by 13.4 per cent, coupled with an 8.3 per cent increase in imports. After adjusting for refunds,

the net GST revenue for April 2024 stood at an impressive Rs 1.92 lakh crore, reflecting a significant 17.1 per cent growth compared to the corresponding period last year, when the

Indian Startups Raise \$1B in April 2024



NEW DELHI: According to media reports Indian startups raised USD 1.04 billion across 124 deals in April 2024. While funding was lower than the USD 1.18 billion raised in March, it marked a 14 per cent yearover-year increase from USD 912 million in April 2023.

Since January, Indian

startups have collectively raised close to USD 4 billion. At this pace, total funding in 2024 could cross the USD 11 billion raised last year. Only one startup, PharmEasy, raised over USD 100 million in April. Bengaluru continued to lead startup activity with 42 deals contributing 26 per cent of the total funding. Delhi-NCR had 30 deals and Mumbai 26 deals, though the Congress of attempting to Mumbai startups topped the funding amount caste and appeasing its vote nearly a dozen merger and acquisition (M&A) deals, with most undisclosed. Prominent deals included NIIF acquiring a majority stake in iBUS for USD 200 million and Aurionpro acquiring Arya.ai for USD 16.5 million.

RAE BARELI: If there is one Lok Sabha seat in the country that can claim to have the longest association with the Gandhi family, it is the Rae Bareli seat in Uttar Pradesh.

Rahul Gandhi's decision to contest from the Rae Bareli Lok Sabha seat shows that the family still cherishes its ties with this constituency, but it

will not be a cakewalk this time. Situated on the banks of the Sai River, 82 km southeast of Lucknow, Rae Bareli can truly be termed a Congress bastion. but during this period, no member of the Gandhi family was in active politics. From 2004 to 2019 Sonia

Gandhi retained this seat.

Earlier this year, she opted for Rajya Sabha, apparently due to health reasons, and wrote an emotional note to the people of her constituency, chronicling her family ties with them and promising to maintain the relationship.

While Rae Bareli has remained loyal to the Gandhi family in the past decades, the party cadres in the constituency have almost wilted away. Of the five Assembly seats,

four -- Bachhrawan (SC), Harchandpur, Sareni and Unchahar -- are held by the Samajwadi Party while the Sadar seat is held by the BJP. The prolonged absence of the Gandhis from Rae Bareli and the emergence of 'middlemen' who claim to act as a bridge between the people and their leader have driven away most of

the local leaders to other parties.

Assam CM best example of BJP's 'washing machine' tactic: Priyanka Gandhi

Priyanka Gandhi Vadra addressed an election rally in Assam's Dhubri on Wednesday where she launched a sharp attack against Chief Minister Himanta Biswa Sarma, calling him the best example of BJP's 'washing machine' tactic.

Priyanka Gandhi campaigned in the Balijan area under the Dhubri Lok Sabha constituency in support of Congress candidate Rakibul Hussain. "There were serious allega-

tions against the Chief Minister of Assam before he switched sides to the BJP. However, once he joined the BJP, everything was forgotten. The Assam CM is the best example of BJP's washing machine tactic which began from here. Later, the BJP used the same formula in other places as well," she told the gathering.

According to Priyanka Gandhi, the BJP is using the washing machine strategy to fool the people. "First, they speak about cor-

ruption and later they welcome the corrupt politicians into their party and all the allegations suddenly vanish, "she said.

Furnish data on notices & arrests under GST **Act: SC to Government**



NEWDELHI: The Supreme Court has asked the Centre Government to furnish details of issuance of notices and arrests done under the provisions of the Goods and Services Tax, saying it may interpret the law and lay down appropriate guidelines to avoid any harassment of citizens by depriving their liberty. A Special Bench of Justices Sanjeev Khanna, MM Sundresh and Bela M Trivedi, which is hearing a batch of 281 petitions challenging various provisions of the GST Act, Customs Act and the provisions of PMLA, voiced concern over the ambiguity in section 69 of the GST Act that deals with the powers of arrest. The Bench said it would interpret the law to "strengthen" the liberty, if need be, but not allow citizens to be harassed. "You furnish the data on notices issued and arrests made under the GST Act for alleged defaults of Rs 1 crore to Rs 5 crore respectively for the past three years. There can be harassment of people and we won't permit that. If we find there is ambiguity in the provision, we will set it right. Second, people can't be sent behind bars in all the cases,' the Bench told Additional Solicitor General SV Raju, appearing for the Centre. The Bench sought the data after senior advocate Siddharth Luthra, appearing for some of the petitioners flagged the alleged misuse of the powers of the authorities under the GST regime, saying it is curtailing the liberty of individuals. The Bench said, "We want all the data. The GST Council will have those data. If the data is available, we want it before us." The ASG told the Bench he would try to answer the court's queries, when the matter will be heard next on May 9.

Delhi Police lodges FIR over doctored video of **Home Minister Amit Shah**

NEW DELHI: The Delhi Police on Sunday registered an FIR over a doctored video of Union Home Minister Amit Shah, where his statements indicating a commitment to abolishing reservation quotas for Muslims in Telangana, were changed to make it seem that he was advocating scrapping of all reservations.

"We received a complaint regarding the edited video of the Home Minister. Two complaints were received by police, one from the BJP and another from the Ministry of Home Affairs (MHA). Following this, the Delhi Police Special Cell Cyber Wing's IFSO unit filed an FIR, "a source said.

Delhi HC disposes of PIL on deepfake videos, asks poll panel to take action



NEW DELHI: The Delhi High Court on Thursday disposed of a public interest litigation (PIL) seeking measures to curb the spread of deepfake videos during the ongoing Lok Sabha elections, asking the Election Commission of India to address the issue.

The PIL, filed by Lawyers Voice, raised concerns about the potential impact of deepfake content on the electoral process and sought intervention from the court.

A division bench of Acting Chief Justice Manmohan and Justice Manmeet P.S. Arora said that the court could not issue directives in the middle of an election, and instead, directed the petitioner to submit a detailed representation to the Election Commission of India

Stressing the urgency of the matter, it directed the poll panel to expedite the review of the representation and take appropriate action by May 6.

Senior advocate Jayant Mehta, representing the petitioner, said that there is a need for stringent measures to address the menace of deepfake videos, citing their potential to spread misinformation rapidly. However, the court refrained from issuing immediate orders, stressing its trust in the ECI to address the issue effectively.

The PIL had sought specific directions from the ECI to formulate guidelines for verifying video messages, prohibiting the use of deepfake technologies in electoral communications, and collecting data on their usage during the election period.

Moreover, the petitioner rged social media platforms such as Google, Meta, and X to take down and block deepfake content related to political leaders until the declaration of election results. The instances of deepfake videos cited in the PIL included misleading clips featuring Bollywood actors Ranveer Singh and Aamir Khan, as well as political figures like Rahul Gandhi and

Nothing suspicious found so far, says Minister Atishi on bomb threat emails to Delhi schools

NEW DELHI: Following the bomb threat through email at several schools across the city on Wednesday, Delhi Education Minister Atishi said that so far nothing suspicious has been found in any of the schools.

"Some schools have received bomb threats today morning. Students have been evacuated and those premises are being searched by Delhi Police. So far nothing has been found in any of the schools" the Minister said on X. "We are in constant touch with the Police and the schools. Would request parents and citizens not to panic. School authorities will be in touch with parents wherever needed," the

Sanjay Raut MP questions increase in Maha voting percentage after 11 days

MUMBAI: Shiv Sena (UBT) MP Sanjay Raut on Thursday questioned the Election Commission of India (ECI) about the increase in the voting percentages of Phase I and Phase 2 Lok Sabha elections, and asked how it suddenly shot up after so many days. Speaking to the media here,

he said that the hourly and daily voting percentages in all the Lok Sabha constituencies that have voted so far, provided on the Maharashtra Chief Electoral Officer and ECI websites were the latest current data. "However, after 11 days from the Phase I (April 19) and a week after the Phase 2 (April 26) polling, the ECI has released the voting percentages which are much higher than the live data given on the polling dates. Where did the extra votes

come from?" demanded Raut. He pointed out that the voting percentages have changed by 7-10 per cent in many constituencies, though in Nagpur it has reportedly reduced by some points, and the low turnout had rattled the Bharatiya Janata Party. Pointing a needle



low voter turnout, many people had taken note and expressed concerns over the considerable drop in the voting percentages as compared with the 2019 polling data. The very same people are now surprised that the low percentage has shot up in 11 days and has nearly equalled the 2019 poll tally, raising questions. "This is the digital era in a digi-

tal India... Does it take them 11 days to give the voting percentages? We can understand a difference of half or one per cent in the final calculations, but such a huge gap of 7 or 10 per cent or more is difficult to digest, said Raut.



Services need to balance growth with sustainability

recent report by Goldman

Sachs, entitled 'India's rise as the emerging services factory of the world,' offers an ■in-depth analysis of India's burgeoning role in the global services market. Over the past 18 years, following pivotal economic reforms initiated in 1991, India's services sector has not only expanded dramatically but also diversified, encompassing areas from professional consulting to financial services. The report highlights that while global services exports tripled over the last 18 years, India's exports grew at double that rate, reaching nearly \$340 billion last year. Remarkably, India's growth in this sector has been the third fastest globally since 2005, trailing only behind Singapore and Ireland. The country's global services market share surged from under 2% in 2005 to 4.6% in 2023, while its goods exports share saw a more modest increase from 1% to 1.8%. This expansion has provided a crucial buffer for India's external account balances, helping mitigate impacts from vulnerabilities such as high oil import costs. Looking forward, Goldman Sachs projects that services exports could rise to \$800 billion by 2030, slightly under the government's ambitious \$1 trillion target for combined services and merchandise exports. This growth trajectory suggests a significant boost to sectors such as high-end discretionary consumption and real estate. Despite these optimistic projections, the immediate outlook remains cautious. The dominant IT services sector has recently experienced workforce reductions and moderate growth projections, with major players like Infosys forecasting only a 1% to 3% increase in revenue. To maintain its upward trajectory, India must adopt a balanced approach that not only pushes for greater global market access but also fosters innovation in emerging areas like artificial intelligence and blockchain. A regulatory environment that supports rather than stifles innovation will be essential for nurturing new enterprises and ensuring the long-term vitality of India's services sector.



manifesto contains, has also managed to provoke a discussion on wealth redistribution. There is ample evidence to show that inequality in India has been rising. The World Inequality database found that in 2022-23, 22.6% of the national income went to the top 1%, the highest ever since 1922. Wealth inequality is even more stark with the top 1% population having 40.1% share in wealth. It is clear that inequality can no longer be ignored and justified as a collateral to growth. The cost of such unequal growth

The unfairness of some people and a few corporates doing so well while most of the population continues to struggle for decent employment opportunities is becoming more and more obvious. The logic of trickle down and of supporting 'wealth creators' so that more jobs are created and prosperity spreads has failed time and time again not just in India but across the world also. The futility of continuing to depend only on economic growth even at the cost of increasing inequality, for improving the lives of people, is a core political economy question facing countries today. That it is finally becoming an election issue in India must therefore be welcomed, irrespective of what the election outcome in 2024 will be.

The public discussion, especially on social media platforms, has so far mostly been confined to direct redistribution measures of the 'Tax the rich, subsidise the poor' nature. These are very relevant in the Indian context. After all, India not only has a low tax-GDP ratio compared to other middleincome countries (Índia's tax-GDP ratio is 17% compared to 25% in Brazil) but also a regressive taxation structure, where indirect

all tax revenue collection. Furthermore, even direct taxes are not very progressive. For example, the effective tax rate (tax to profit ratio) according to the Receipt Budget 2023-24 was 19.14% for companies that had more than Rs 500 crore profit before taxes compared to an effective tax rate of 24.82% for companies in the group of O-Rs 1 crore profit.

Welfare spending is low

On the other hand, spending on welfare and the social sector is very low compared to other countries. Public spending on health for instance is still around 1.3% of GDP whereas the National Health Policy (NHP) targets achieving 2.5% of GDP by 2025. Despite COVID-19, we have not seen any such massive increases in health expenditures, and going by the current trend, we will not achieve this target. A number of other major budgetary allocations of the Union Government such as for the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA), education, budget for children, show a decline as a proportion of the total expenditure or of GDP. Hence, improving revenue mobilisation in a progressive manner while also increasing spending on areas that directly affect lives of the poor is very much a relevant issue and needs to be paid attention to

However, addressing inequality is also about questioning the nature of growth itself. In a situation where the major source of livelihood for people is through employment, how far can growth that does not generate jobs contribute to development? The kind of growth we have experienced recently has been one that has been accompanied by joblessness as witnessed by a declining employment elasticity of output. Further, there is a rise in profit shares and stagnant real wages. The discussion, therefore, has to be on generating employment not distress self-employment but decent jobs with adequate remuneration. For this, we have to focus attention on more equitable growth where the purchasing power of people also increases. Governments can play a role in this by spending on programmes such as the NREGA and the Public Distribution System. Cash transfer schemes such as the Mahalakshmi scheme

proposed in the Congress manifesto can

At the same time, governments can also contribute to directly creating jobs by filling up all existing vacancies and expanding much needed public services in health, education, nutrition and social security. The quality of jobs, such as of anganwadi workers, accredited social health activists and other frontline workers, also need to be improved with adequate wages and improved work conditions. These direct job creation efforts will not only create employment opportunities for many, especially women, but also contribute to mproving human development outcomes and reduce the burden of unpaid care work on women and free them up for other employment. Further, they can also address the inequality in opportunities and the intergenerational inequality that gets perpetuated due to the unequal access to services such as pre-school education and nutrition during childhood.

An employment-centered growth pattern will be one where government policy focuses on supporting small and medium enterprises that are more labour-intensive in nature, promoting skill training and overall human capital (health and education) along with enabling women to participate in the labour market through measures such as maternity entitlements. childcare, transportation, safe and affordable accommodation and so on. It is only when we address the employment issue that we can address inequality in earnest. On the other hand, as long as growth is of the nature where profits for few is the priority, the employment issue is also likely to remain unaddressed.

K.R. SHYAM SUNDAR EXPLAINS HOW TRADE UNIONS CAN PLAY KEY ROLE IN PRODUCING LABOUR STATISTICS $An \ urgent \ need for \ the \ use \ of \ labour \ statistics$



e reform of labour institutions is always in the air as objective (variables) and subjective (orientation of agencies involved) factors keep changing. In the case of the industrial relations system and labour market (IRS-LM), variables such as product market, technology, trade and investment. and labour institutions such as trade unions, collective bargaining and strikes keep changing. There are two aspects of reforms — substantive issues and procedural aspects.

Social dialogue is an important procedural institutional process to debate and arrive at consensual conclusions which could be used for legal and other policy-oriented actions. In the post-reform period, the government uses social dialogue agency, viz., the Indian Labour Conference (ILC), to reform arguments enrich social dialogue something which has not happened thus far. Social partners have been advocating their "class-based opinions" unbacked by credible data or experience. The ILC has degenerated into a "talking shop".

Labour statistics, unlike economic and industrial data, are not rigorous. For example, the Annual Survey of Industries (ASI) and the National Sample Survey Office produce excellent statistics but have limited information relating to the IRS-LM. The Labour Bureau provides statistics on a range of industrial relations (strikes and trade unions) and labour statistics (contract labour, absenteeism, labour turnover, labour inspections). It mostly provides administrative data, viz., those generated as a part of implementing labour laws. The statistics on work stoppages are collected voluntarily. The composition and the scope of data published by the Labour Bureau has remained virtually the same over the decades.



Reform arguments

Let us look at three reform arguments put forth relentlessly by employers and neoliberal inspection system as a case of "Inspector-Raj" and called for its reforms. This criticism stems probably from their "limited experience". They have complained that State governments hardly sanction applications for retrenchment or the closure of establishments. They also demand a curb on the right to strike and prefer nonunion workplaces. Some academics and global agencies such as the World Bank/International Monetary Fund which have "priors" similar to the reform opinions of employers have published studies "consistently" supporting the benevolent impact of reforms and refuting their obverse. For example, a study by Besley and Burgess (B&B) on the impact of labour regulation in 2004 has been widely used by employers and others to push hire and fire reforms, among others. This is despite glaring weaknesses in the studies using B&B methodology, original or revised. The government has fallen for these "strong prior-based evidence" hook, line and sinker and sought to introduce labour law reforms.

To counter the reform arguments mentioned above, trade unions should have collected the relevant information/statistics on inspection (such as the number of sanctioned and actually employed inspectors, the universe of inspection and actual inspection, the frequency of inspections) and studied them to make informed arguments to support labour inspection — even strengthening them. It is then that social partners and the government

would have realised the poor quality of data on inspections. They would realise that labour inspectors are much fewer in number than the there is no all-India data on labour inspections.

Closure reform

Again, on firing/closure reform, trade unions have not collected data on the retrenchment/ closure applications under Chapter V-B submitted to the labour department, permissions granted/refused by the labour department. These are not published in most States except in Maharashtra for a limited period. The denial of permissions was surely prevalent during the command economy, but is this prevalent in the post-reform period? My study on retrenchments/closures under Chapter V-B in 2001-05 showed that Maharashtra was more liberal in granting permissions for retrenchments/ closures (Impact of Labour Regulations ... in Maharashtra, Bookwell, 2008).

The Industrial Relations Code, 2020 Code on Industrial Relations (CIR) has made legal strikes well-nigh impossible. Illegal strikes carry a heavy penalty. Trade unions could have used the data on strikes and lockouts published by the Labour Bureau which would show that lockouts are more frequent and account for more workdays lost than strikes during the post-reform period. This evidence would have challenged the need for introduc-

ng harsher clauses on strikes in the CIR. Trade unions are well placed to "produce" tatistics on several aspects of the IRS-LM at the establishment level. Employers' organisations such as NASSCOM generate statistics on the IT industry which is used indiscriminately.

India has ratified the Labour Statistics Convention (No.160), 1985 and Labour Inspection Convention (081), 1947. India must generate statistics that are valid, comprehensive and by now that reforms are contested not only by street struggles but also primarily in the realm of ideas where objective data and rich empirical studies are used.

In essence, trade unions should produce labour statistics, do research on IRS-LM, build an active and productive interface with academics and use academic studies to make "evidence-based arguments" in the ILC. Imagine a massive strike demanding good labour statistics! The larger society and the government are bound to stand up and seek reform labour statistics. For once, strikes would enjoy public legitimacy.

Trade unions must resolve to carry out these measures. If nothing, statistical agencies such as the Labour Bureau will be reformed as a result of these pursuits.

Narrative resilience: New book explores identity, expression

alman Rushdie's latest memoir, "Knife," emerges not just as a chronicle of survival but as a profound testament to the power of free expression, woven through the fabric of a life lived under the shadow of a death sentence. Rushdie, whose literary career has been punctuated by both acclaim and controversy, uses his narrative prowess to recount a chilling encounter that could have ended his life but instead reinforced his commitment to storytelling.

The memoir pivots around a terrifying 27 seconds — a brief yet profound moment when Rushdie was attacked by a knife-wielding assailant. He delves into the physical and psychological aftermath of the attack, intertwining his personal recovery with broader reflections on freedom, faith, and the human condition. 500 Micro & Small **Enterprises apply for** Green Investment **Incentives**



NEW DELHI: At least 500 micro and small enterprises (MSEs) have applied for incentives under two key government schemes aimed at encouraging green investments and the circular economy.

This strong response came within just three months of the launch of the Green Investment and Financing for Transformation (GIFT) and Scheme for Promotion and Investment in Circular Economy (SPICE) initiatives in December 2023. reported ET. According to officials, these enterprises are gearing up to embrace eco-friendly technologies and cater to the growing consumer preference for environmentally conscious products. As a testament to the schemes' early success, a staggering Rs 380 crore in loans has already been disbursed to MSEs under these programs.

The GIFT scheme offers a 2 per cent annual interest subvention for five years on loans up to Rs 2 crore to MSEs adopting environment-friendly technologies. On the other hand, SPICE provides capital subsidies to MSEs for brownfield projects, incentivising them to expand or upgrade their existing circular economy projects. Recognising the cash crunch often faced by MSEs, the government is actively demonstrating the tangible benefits of adopting greener and more efficient technologies.

Officials are categorising MSEs into those willing to adopt sustainable practices and those reluctant, with a focused approach to showcasing the long-term savings and advantages, such as reduced energy consumption, to the latter group.

With a combined outlay of Rs 950.5 crore, SPICE will run from FY24 to FY27, while GIFT has an outlay of Rs 478 crore until FY26. These schemes are expected to play a crucial role in facilitating the transition of MSEs towards a more sustainable and circular economic model, aligning with global climate regulations and

FinMin Mulls Requiring Nodal Officers at Banks

FINTECHS FOR LAW ENFORCEMENT LIAISON

NEW DELHI: The Finance Ministry is considering a proposal to require banks and fintech companies to appoint designated nodal officers or key contact points to liaise with law enforcement agencies (LEAs).

This issue was discussed at a workshop organised jointly by the Department of Financial Services and the Indian Cyber Crime Coordination Centre on Tuesday in New Delhi.

The half-day interactive workshop brought together LEAs, startups, fintech firms and other ecosystem partners to foster collaboration in addressing challenges like cybersecurity, financial fraud prevention, regulatory compliance and promoting innovation.

Discussions covered topics such as frauds perpetrated through mule accounts, fintech merchant abuse and potentially developing an indigenous anti-money laundering system tailored to the Indian context.

IMF Highlights Public Investment as Key Driver for India's Economic Growth

NEW DELHI: In its latest Regional Economic Outlook for Asia and Pacific, the International Monetary Fund (IMF) has emphasised the crucial role played by public investment in driving India's economic growth, making it the world's fastest-growing major economy.

The IMF report highlights that while headline inflation in several Asian and Pacific economies may witness further reductions due to lower energy prices, India's disinflation process could be slower due to persistent food price pressures, especially for rice.

Reflecting the positive economic trajectory, the IMF had earlier this month raised India's growth forecast for the financial year 2024-25 to 6.8 per cent, up from the previous estimate of 6.5 per cent.

The growth forecast for 2025-26 remains unchanged at 6.5 per cent. The IMF attributed this upward revision to the resilience of domestic demand, propelled by factors such as public investment.

RBI directs lenders to rectify unfair interest charging practices



NEW DELHI: The Reserve Bank of India (RBI) has instructed regulated lending entities to review and rectify certain practices regarding the charging of interest rates that have been deemed unfair to borrowers.

This directive comes after the central bank's inspections in March 2023 revealed instances where some lenders resorted to non-standard and opaque methods when applying interest charges.

In a statement released on Monday, the RBI outlined several problematic practices identified during the inspections. These include lenders charging interest from the date of loan sanction or agreement execution rather than disbursement, as well as levying inter-

est charges on loans disbursed via cheque from the issue date rather than when the physical check was received by the borrower days later.

The regulator also noted cases where despite only a portion of the month seeing the loan outstanding, certain lenders charged interest for the full month. Additionally, there were instances of lenders collecting installments in advance but still calculating interest on the full original loan amount.

While the 2003 Fair Practices Code guidelines allow pricing freedom for lenders, the RBI stated that the revealed practices violate the spirit of fairness and transparency expected when dealing with

While dreaming of becoming the third-largest economy, it is crucial to understand the reality that India still lags far behind in per capita income. Even after surpassing England to become the fifth-largest economy, there is a clear gap of 20 times in per capita income between the two countries. Moreover, in the past decade, India has only climbed six positions in the global ranking based on per capita income. Currently, out of 189 countries, India ranks 141st in terms of per capita income, while it was at 147th position in 2013-14. In the past decade, per capita income in India has increased from \$1,438 to \$2,389. It is evident that in the past decade, the increase in per capita income has been just over half of the GDP growth, despite GDP more than doubling.

Achieving the milestone of becoming the third-largest capita income won't be easy.

ally, it is crucial to bring the manufacturing sector, which is a significant source of employment, into the mainstream rapidly. It is also worth noting that for the past three decades, the backbone of India's economic development has been the service sector. It has shouldered this responsibility quite effectively. However, today, the rapid economic disparity in India, which symbolizes the gap between poverty and prosperity, is largely due to the service sector. Although the service sector contributes more than 50% to GDP, its share in employment is only between 30 to 35%. Furthermore, it is essential to understand that within the service sector, there are several other sectors whose progress depends on a strong dollar and, consequently, leads to economic growth in the service sector annually. However, this does not contribute to an increase in per capita income. Therefore, alongside increasing GDP, rapid improvement in employment opportunities should also be a major goal. Otherwise, even after becoming the third-largest economy, India will continue to be recognized as a poor country, which would be a bitter truth.

India asks Indian student in US to obey local laws

WASHINGTON: India's Ministry of External Affairs (MEA) on Wednesday urged Indian students enrolled in US colleges and universities to abide by local laws and regulations with regard to the ongoing protests that have swept across American institutions for higher education against Israel's ongoing war in Gaza.

There have been no re-

ports yet of the involvement of Indian students in these protests and the ministry has also said no student or their family has contacted Indian missions for help. "We expect all our citizens at home and abroad to respect local laws and regulations, "MEA Spokesperson Randhir Jaiswal said at a news briefing in New Delhi in response to a question about protests at Columbia University. "So far no Indian students or their families have contacted us for any assistance in regard to disciplinary action which has been taken for their participation in the protest, " he added.

Hundreds of thousands of Indian students are enrolled in US colleges and universities in graduate and undergraduate courses. Many of them desire to work after college and settle



down here. They are unlikely to participate in protests or take part in an action that pits them against the law, which could jeopardize their future.

Protests have spread across US colleges and universities against Israel's ongoing war in Gaza, with students demanding an end to US support for Israel and, as in the case of Columbia University, cutting with businesses and other entities with investments in Israel.

These protests have turned violent in many instances with students taking over parts of the university building as they did in Columbia. Police have arrested scores of students and are breaking up their encampments, as their tents pitched around the campuses are being called.

gladesh has agreed to join an international force that will operate independently of the UN to help restore order in Haiti, which has spiraled into gang-fuelled chaos, according to a UN Spokesperson. Bangladesh is one of the

six countries that have written to UN Secretary-General Antonio Guterres that they will contribute personnel to the Multinational Security Support Mission in Haiti (MSSM), Spokesperson Stephane Dujarric said on Monday.

Invoking the UN Charter provisions for maintaining peace, the Security Council authorised the creation of the MSSM mission to help ameliorate the situation in Haiti by helping its national politi-

cal force.

Having been burnt by its earlier forays into the Caribbean nation, the UN is taking a hands-off approach this time, authorising a force that will operate independently and not as a UN peacekeeping mission.

His appointment has invited reactions within PML-N that the GHQ is controlling the civilian government, which has little say in the policies, but the reaction is being restrained by Nawaz Sharif.

"It is likely that the government may not introduce the cross-border insolvency norms anytime soon," according to a senior government official.

A key reason, as stated by sources, is the realisation that many countries with significant investment ties to India have not adopted the relevant United Nations convention on cross-border insolvency.

Reciprocity between nations is crucial for effective implementa-



1. Can you share with us the journey of transitioning from a nuclear scientist to a champion of social development?

I am a scientist with a doctorate in Nuclear Physics. I took up my first job at Cancer Institute, Chennai. As much as I wanted to work with people who were ailing, I knew that I was not cut out for a job in radiation therapy. This journey bolstered my commitment to serve others and fuelled my

0. What inspired this shift in focus, and how has your background influenced your approach to addressing social issues?

My interactions with the poor while heading Red Cross in Coimbatore and through my extensive experience working with the Government of Tamil Nadu exposed me to a different reality about poverty in India. This gave me the grounding to do social work. I also knew I had to tap into my scientific temper to create an institution that was different from oththat would bring communities out of poverty. 0. Hand in Hand India has achieved remarkable success in empowering rural women and creating job opportunities. What innovative models or strategies have been instrumental in achieving these outcomes, and how do you envision scaling these efforts for even greater

We established our job creation and entrepreneurship model way back in 2004. We had our focus on forming self-help groups, encouraging savings, small scale entrepreneurship and then access to credit. Aside from financial literacy training, we include digital and financialliteracy as a separate module. We conduct awareness camps on social security schemes and connect women to suitable Govern-

ment schemes. We understand that the women need to grow from micro to macro entrepreneurs or as the Government of India now calls it, Lakhpathi Entrepreneurs - so to do this we have business development training with courses developed by IIT Madras. We encourage market linkages through mobile applications and social media for more reach for these entrepreneurs. To take these models to the next level, we have federated women in self-help groups

Q: What advice would you give to individuals and organizations striving to make a positive difference in society, especially in rural areas?

My advice to other organisations and individuals striving to make a difference is to always think long-term and make a long-term plan. When we work with communities and people, we need to keep their requirements in mind - a participatory approach is needed as they are the champions for the initiatives once we exit. Always do small pilots, learn from them and then scale. Invest in good resources and have clarity in project implementation with good monitoring systems in place. Finally, never give up. Like in any business, this sector will also have its challenges. We have to learn to take them in our stride and keep moving forward.
