**NEWDELHI:** Reserve Bank of India (RBI) Governor Shaktikanta Das has expressed optimism about the Indian economy's potential for sustained 8 per cent growth, while emphasising the critical importance of maintaining a vigilant approach to monetary policy.

Speaking at the Annual General Meeting of the Bombay Chamber of Commerce on Tuesday, Das defended the Monetary Policy Committee's (MPC) decision to maintain the 4 per cent inflation target.

He stressed the necessity of avoiding policy errors that could jeopardize economic

SBI raises Rs 10K cr through bonds to fund infra projects



India (SBI) today raised Rs 10,000 crore through its fifth infrastructure bond issuance. The country's largest lender raised the funds at a coupon rate of 7.36 per cent. The issue attracted overwhelming response from investors with bids in excess of Rs 19,884 crore and was oversubscribed by around four times against the base issue size of Rs 5,000 crore, SBI said in a regulatory filing. The total number of bids received was 143, indicating wider participation with heterogeneity of bids, it said. The investors were across provident funds, pension funds, insurance companies, it said. The bonds will be utilised in enhancing long-term resources for funding infrastructure and affordable housing segments, it said.

He was granted bail by the Jharkhand High Court in the money-laundering case linked to a land scam. "I respect the judiciary. The court delivered its order and I am out (on bail). But the judicial process is long,' Soren said. He alleged those who raised their voice against the Central Government were being suppressed. "I will finish the task I started, the war I waged," Soren said. He was arrested by the Enforcement Directorate on January 31.

#### Cab driver dead, 6 injured as portion of roof collapses at Delhi airport's Terminal-1




**NEW DELHI**: A cab driver died and six people were injured after a portion of a canopy at Delhi airport's Terminal-1 collapsed on cars amid heavy rain early on Friday, leading to suspension of flight departures, according to officials.

Delhi Fire Services (DFS) officials said three fire tenders were rushed to Terminal-1 (T1) of the airport after a call about the incident was received around 5:30 am. Besides the roof sheet, the

support beams collapsed, damaging the cars parked in the pick-up and drop area of the terminal. A search operation was conducted to make sure no one was trapped inside the damaged vehicles, they said.

The injured have been admitted to Medanta Hospital near the airport. One of them was rescued from a car on which an iron beam had fallen. He was later identified as Ramesh Kumar, they added

### Delhi LG convenes emergency meeting after rainfall, directs to establish 24/7 control room



All the concerned departments of Delhi government were called for the emergency meeting including Delhi Jal Board, Public Works Department (PWD), Irrigation and Flood Control (I & FC), Municipal Corporation of Delhi (MCD), New Delhi Municipal Corporation (NDMC), Delhi Police, Delhi Development Authority (DDA) and National Disaster Response Force. Raj Niwas officials said the meeting reflected on issues arising out of severe waterlogging, overflow of unsilted drains and backflow of clogged sewer lines in the wake of pre-monsoon rains in the city.

Senior officials from all the concerned departments will be deputed in the emergency room. "Wide publicity of control room number be given for common citizens to make telephonic calls to report incidents of waterlogging." Saxena said.



Saxena also reviewed the preparedness and emergency response of various departments to deal with the situation, as indeed the monsoon season is yet to fully set in, officials added.

The LG taking note of the preparedness expressed the lack of preparedness for the emergency response system in the eventuality of excessive rainfall and resultant waterlogging across the city.

### 10-year-old girl gang-raped, murdered in north Delhi; 2 detained



girl was allegedly gang-raped and killed by her neighbours in north Delhi, and her body was found in an abandoned plot with her head smashed on early Friday, police said.

She was allegedly gang-raped and then killed by her neighbours. Two people have been detained in connection with the case, they said.

The police received a PCR call around 12.30 am on Friday from the victim's father who reported her missing, Deputy Commissioner of Police (outer north) Ravi Kumar Singh said.

The victim's father told the police that he noticed that their daughter was missing at around 9.45 pm. When she did not return home, they began searching for her and called the police, Singh said.

Shortly after the call, the police found the girl's body in an abandoned plot nearby with her head smashed, Singh said.

The DCP said that the locals saw the victim's neighbour Rahul (20) take the girl towards the plot. Based on the father's com-

plaint, Rahul and Devdutt (30) have been apprehended and are being interrogated, DCP said.

The two accused allegedly lured the girl on the pretext of taking her to a nearby eatery and committed the offence, police said.

A case was registered against the accused under sections 363 (punishment for kidnapping), 302 (murder), and 376D (gangrape) of the Indian Penal Code, and the Protection of Children from Sexual Offences (POCSO) Act. Further investigation is under way, the DCP said.

# NEET-UG probe: CBI seeks remand of 4 Godhra-based accused arrested by Gujarat Police

Bureau of Investigation on Friday sought 4-day remand of four of the five persons arrested by the Gujarat Police for alleged involvement in irregularities in the May 5 NEET-UG exam held in Godhra in Panchmahal district.

CBI lawyer Dhruv Malik informed the district court that though the Gujarat Police had conducted a probe earlier, the agency needed the custody of these accused as it is conducting a fresh investigation.

Of the five persons arrested by the Gujarat Police on May 8 and in the subsequent week, the CBI wants custody of schoolteacher Tushar Bhatt, Jay Jalaram School principal Purushottam Sharma and middlemen Vibhor Anand and Arif Vohra. The CBI did not seek remand of education consultant Parsuram Roy. All the five are currently lodged in Godhra sub-jail.

CK Chauhan, Principal District Judge of Panchmahal, expressed apprehension on CBI's remand application saying police or investigative agencies cannot seek custody of an ac-

cused beyond the initial 15 days Jharkhand. He said though the following arrest. Citing a 1992 decision by the to the custody of Panchmahal

Supreme Court in the CBI vs Anupam Kulkarni case, judge Chauhan said new remand after the lapse of 15 days from arrest can be granted only when the accused was hospitalised during that period or he did not cooperate during the initial remand.

The court has kept further hearing on Saturday, when it is expected to pronounce an order on the CBI's remand plea.

On Thursday, a CBI team investigating the NEET-UG malpractices case recorded statements of six candidates who had allegedly paid an accused for helping them clear the medical entrance test held at Jay Jalaram school near Godhra. A CBI team has been camping in Gujarat for the last four days as part of the probe.

A case was registered by Godhra police on May 8 against three persons under Indian Penal Code (IPC) provisions, including criminal conspiracy, cheating and criminal breach of trust, for allegedly trying to help 27 candidates clear the NEET-UG by charging Rs 10 lakh each. On June 23, the CBI filed

a fresh FIR (first information report) against unidentified persons under IPC sections 120-B (criminal conspiracy) and 420 (cheating), among others, amid countrywide protests and litigation by students for a probe into paper leak claims.



#### **Enemy Agents Act to target supporters** of terrorists in Jammu and Kashmir: DGP

**FW DESK** 

Jammu and Kashmir Director General of Police RR Swain announced on Sunday that locals supporting foreign terrorists will be prosecuted under the Enemy Agents Act.

The statement follows a series of attacks over the past two weeks, resulting in ten deaths, including seven pilgrims return-ing from the Shiv Khori temple and a CRPF jawan, along with several injuries.

The incidents occurred between June 9 and 12 in the districts of Reasi, Doda, and Kathua. Two Pakistani terrorists were killed in an encounter in Kathua.

The Enemy Agents Act is noted for its severity compared to the Unlawful Activities (Prevention) Act (UAPA), mandating a minimum punishment of life imprisonment or the death sentence for those convicted.

"This Act is harsher than UAPA. In the act, it's mentioned terrorist associate and acting as an agent of enemy who are coming from outside," DGP Swain said.

DGP Swain stressed that



ized through encounters, their local supporters will face the strictest legal consequences.

"As for as fighters are concerned, they don't fall under ambit of any investigations. They will be killed in kinetic action. But those who support them will be treated as enemy agent. In our Enemy Agents Act, the minimum punishment is life imprisonment or death.. there is no other punishment under this Act," he said.

The DGP also revealed plans to establish special courts for the trials of individuals arrested under this Act.

Regarding the recent terror attacks in the Jammu region, Swain noted that police have made six arrests in Kathua and achieved a breakthrough by apprehending a conspirator while terrorists will be neutralinvolved in the Reasi attack.



### The Emergency's haunting legacy and path forward

he Emergency, imposed on

June 25, 1975, by then-Prime Minister Indira Gandhi and lasting until March 21, 1977, remains a dark chapter in the history of democratic India. The imposition of rule by decree, the suspension of civil liberties and free speech, and the arbitrary actions of the government, including the indiscriminate arrests of dissenters and opposition figures under draconian preventive detention laws, continue to haunt those who lived through its harsh realities. This traumatic period serves as a stark reminder of the essential role democratic institutions play in safeguarding the freedoms and rights of citizens. When Om Birla, the newly re-elected Lok Sabha Speaker, read out a resolution condemning the imposition of the Emergency and calling it an attack on the Constitution, it appeared to be a pledge against the suspension of civil liberties. However, in light of Birla's previous actions—such as the indiscriminate suspension of opposition MPs-and the executive's use of draconian laws to stifle dissent, the resolution seems more like lip service. It appears to be a political tactic aimed at targeting the Congress party rather than a genuine commitment to prevent a recurrence of such authoritarian measures. If the current government truly wishes to move beyond the damages of the Emergency and avoid repeating its grave errors, it would refrain from using similar oppressive measures. Recent actions, such as attacks on the free press, the selective targeting of opposition figures by enforcement and investigative agencies, and the use of preventive detention laws to imprison political prisoners, activists. and journalists without trial, contradict any claims of a commitment to democratic principles. A more assertive opposition in Parliament, a vigilant judiciary ensuring justice for unjustly held dissidents, and a civil society pushing for the withdrawal of draconian laws are essential.

much as it resulted in the numerically largest Opposition in the Lok Sabha. It is perhaps the largest in the history of the House. With the Opposition securing over

234 seats, one also saw the debate on the Leader of the Opposition (LoP) come alive. In the 16th and 17th Lok Sabhas, there was no LoP because under a direction of the Speaker issued in the 1950s, in order to get recognition as a party in the House, it should have a minimum of 10% members in that House (Direction 121).

This direction was issued for the recognition and categorisation of parliamentary parties for the sake of providing them certain facilities in Parliament. But this direction does not deal with the recognition of the LoP. Later, Parliament enacted the Salary and Allowances of Leaders of Opposition in Parliament Act, 1977, which for the first time, defined the term Leader of the Opposition as "the Leader in that House of the party in opposition to the Government having the greatest numerical strength and recognised as such by the Chairman of the Council of States or the Speaker of the House of the People, as the case may be".

The definition shows that in order to recognise a person as LoP, there are two conditions that need to be fulfilled. First, the party should be numerically the biggest one in opposition to the government. Second, that party should be recognised by the Speaker as a party. As mentioned earlier, the Speaker can recognise a party as such only if it has 10% of the strength of the House. In other words, only a party which has 10% of the strength of the House can put forth its claim to the post of LoP. Under the direction cited, a party which has less than 10% members shall be categorised as a group which cannot claim the post of LoP. Thus, the Congress parliamentary party which had only 52 members, in 2019, in the Lok Sabha, two less than 54 which is the threshold, could not get this post.

However the enactment of the 10th Schedule has, in a way, rendered the categorisation of parties into parties and groups by the Speaker/ Chairman (Lok Sabha/Rajya Sabha) irrelevant. Under this schedule, all political parties, irre-



have in the Houses, are "parties". The term 'group' is not recognised by the Schedule. So, in tune with the Schedule, necessary changes in the Leaders of Opposition Act should have been made to enable the Speaker to recognise the leader of the largest Opposition party in the House, irrespective of whether it has 10% Members or not. Anyway, the leader of the Congress party is now the Leader of the Opposition in the 18th Lok Sabha.

#### In the Westminster system

The post of Leader of the Opposition in the Lok Sabha has great political significance. In the British parliamentary tradition, he is called the Prime Minister-in-waiting as he is the one who the king turns to when the incumbent government falls, to form an alternative government. He, therefore, forms a shadow cabinet of his colleagues in his party. It is an interesting feature of the Westminster system of government.

The shadow cabinet is formed under the leadership of the leader of opposition who will be called the shadow prime minister. According to this tradition, the shadow cabinet scrutinises the policies and actions of the government and offers alternative policy. It is called the shadow cabinet because its members mirror the positions of the individual member of the real cabinet.

As members of the shadow cabinet, these Opposition members familiarise themselves fully with the operations of the government. They can seek all relevant information about the entire gamut of the activities of the government. Erskine May, an international authority on parliamentary system says, "The Leader of the Opposition and some of the Leader's principal colleagues in both Houses form a group, known as 'the Shadow Cabinet', each member of which is given a particular range of activities on which it is their task to direct criticism of the Government's policy and administration and to outline alternative policies....

Although we have adopted the Westminster system, the practice of forming a shadow cabinet does not exist in Parliament or State legislatures. The post of the Leader of the Opposition in the Indian Parliament has been a statutory position since 1977. However, this statute does not define the functions of the Leader of the Opposition. Traditionally, he will be a very senior member of the principal Opposition in the House who commands great respect and has wider acceptability among the parties in the Opposition.

#### With change in 2024, the challenges

Since the Opposition in the Indian Parliament is not monolithic and is composed of multiple parties with divergent ideologies and programmes, the role of the Leader of the Opposition is full of challenges. The biggest problem he faces is that he has no power. It is easy for a party in power to attract other parties and keep the alliance together through a power-sharing arrangement. The opposition to the policies and programmes of the government is a major factor which keeps them together. In certain situations, the hope of bringing down the government acts as a unifying factor. In fact, the traditional role of the Opposition is to "oppose the government, to criticize it and to seek to replace it".

In the past 10 years, the Lok Sabha has seen a rather lean Opposition which could not mount any serious challenge to the government. A large majority enjoyed by the ruling party and its intimidatory postures overawed the Opposition which often felt helpless. But the 2024 general

political atmosphere and the demography of the House. It is perhaps for the first time that the Lok Sabha has such a huge number in the Opposition. With over 234 Members in the Opposition benches, the House is almost evenly divided. This has, no doubt, boosted the morale of the Opposition which, to a great extent, can influence the running of the House. It would be reflected in the admission of questions, the content of the answers, debate on Bills, general debates such as the debate on the motion of thanks, urgent matters of public interest, admission of adjournment motions, and reference of Bills to the committees for detailed scrutiny, to name a few

#### The past has lessons

In India too, this healthy tradition can be followed, which will certainly strengthen democracy. Jawaharlal Nehru had created certain traditions such as being present in the House during Question Hour on most of the dates and supplementing the replies given by Ministers whenever he felt that such replies were inadequate. Nehru is said to have pleaded with the Speaker to grant more time to the leaders of the Opposition and he would invariably be present in the House to listen to them. He used to say that it is only from the Opposition members that he would come to know about the real situation in the country, and not from his own party members who would only praise him and not speak the truth. The Indian Parliament evolved in its early stages in such an environment. There is much in the past which can be learned and emulated by the new generation of parliamentarians. Repudiation of the past will take us nowhere. Intolerance towards dissent was never a part of that tradition. The people of India have given the political class a great opportunity to restore normalcy in Parliament. The main function of the Leader of the Opposition is to constantly remind the ruling Benches of the need to normalise Parliament.

### Preventing another NEET fiasco from happening



uring the National Eligibility Cum Entrance Test (NEET) this year, scores and ranks were inflated. As a consequence, many candidates may not get admission to their desired college as predicted based on previous years' scores.

Coaching and admission counselling centres, typically run by business tycoons, have realised that clients, the NEET aspirants, have failed to secure preferred seats despite their advice. However, despite this fiasco, the industry has found a way to enhance their brand value through media and social media coverage. The owners of this trillion-rupee industry, along with the 23 lakh NEET aspirants this year, are up in arms. Their hypothesis is that mapping previous years. In this conundrum, various allegations of cheating and paper leakage, amongst others, have been raised. Despite numerous crackdowns and investigations, paper leakage in medical admission exams remains a persistent issue.

Since its inception, NEET has emerged as the largest exam in the 'One Exam, One Nation' model because of the number of candidates taking the exam, the number of languages the exam is conducted in, and the diversity of various other factors. The quality of education and the college fees payable are critical factors that vary widely. A seat in a top government college with good quality education could cost a few lakhs, whereas a seat in a private college could cost a few crores. Moreover, parents are willing to go beyond their means to secure higher ranks for their children in these competitive exams, as the family's reputation is considered to hinge on this.

Thus, the stakes in NEET are incredibly



accidental or intentional. Therefore, we need strong governance in the form of foolproof and complete Standard Operating Procedures (SOPs) and their compliance. There cannot be any weak link in the chain of operations from setting question papers to conducting the exam to admissions.

However, there are many weak links, as seen from the distribution of the wrong question paper at some centres, for example. Reportedly, some centres distributed the back-up question paper instead of the primary paper. How were both sets — the primary and the secondary/ back- up question papers — accessed almost simultaneously? Were they accessed from banks' strongrooms or another reserve? How was the back-up question paper set taken from the banks' strongrooms without any emergency circumstances or protocols? There are several unanswered questions about the authorisation and attitude of the officials concerned. This seemingly inconsequential event is actually of enormous consequence and could give us an idea of how the exam was

This one error led to a cascade of errors. A wrong question paper was distributed, subsequently taken back along with the Optical Mark Recognition (OMR) sheet, thus creating panic among the candidates. The correct question paper was then distributed, and no additional time was given for the time lost. Then, exceptionally huge grace marks

later scrapped due to a public outcry.

Each of the above demonstrates the need for critical SOPs for complete governance of the exam, which includes several stakeholders such as those who set the question paper, translators, reviewers, the printing press, officials at examination centers, banks strongrooms, and invigilators. Any loose links in this chain have the potential for malpractices. Only proper investigation may reveal

any substantial wrongdoing.

Despite all the above pitfalls, it is commendable that the National Testing Agency (NTA) voluntarily disclosed most of the information, as per Section 4 of the Right to Information (RTI) Act, 2005. Since the declaration of NEET 2024, the NTA has disclosed the most relevant information through its press releases. In addition, the NTA has followed SOPs for disclosure of answer keys, collecting feedback about wrong questions and answer keys, disclosure of the individual OMR sheet,

and self-evaluation of one's score, which seem to have worked with no issues at all.

#### The way forward

It is on record that these SOPs were developed and directed through a decade-long (2006-2015) protracted legal battle by the author of this article in the Supreme Court and High Courts to ensure transparency and develop well-defined rational SoPs for admissions to the prestigious Indian Institutes of Technology (IITs). In one such judgment, the Supreme Court observed in 2011, "In fact the action taken by the appellants in challenging the procedure for JEE 2006, their attempts to bring in transparency in the procedure generated by the several views of experts during the course of the writ proceedings, have helped in making the merit ranking process more transparent and accurate.

However, this alone is not enough for NEET. The NTA should devise SOPs to get stabilised cut-offs, as done by the IITs, avoid inflated scores and ranks, and achieve a long-tail distribution. It should work to replace ad-hocism with welldefined, sound, and secure SOPs. It should follow a professional war-room culture to facilitate quick and sound decision-making during the entire process. As the Supreme Court said in 2011, "The election process requires to be upgraded and fine-tuned year after year with periodic changes..., so that the selection process and examination remain relevant and meaningful."

### New book explores Stalin and Pasternak's art of tyranny

Tritten by Ismail Kadare, the inaugural winner of the Man Booker International Prize (2005), and exquisitely translated from Albanian by his long-time collaborator John Hodgson, "A Dictator Calls" meticulously examines and analyzes 13 versions of a three-minute telephonic conversation between Joseph Stalin and Nobel Prize-winning poet Boris Pasternak on June 23, 1934. The narrative begins with the text from the KGB archives, setting the stage for a deep dive into history.

The timeline is crucial, as the 1930s were tumultuous for Stalin, marked by rising civil and political unrest. If the discontent wasn't enough, being mocked by the poet Osip Mandelstam added insult to injury. Mandelstam's satirical poem, "Kremlin Highlander," performed in 1933 among literary figures, including Pasternak and Anna Akhmatova, led to his exile. Kadare writes, "As he testified later, Pasternak had not waited for the end before interrupting the author [Mandelstam], 'Forget you ever read me that... verse. That's not art, it's suicide. I'm not getting involved with it." This moment exposes the fallibility and anxiety of artists, likening them to dictators in their insecurities. Stalin's call to Pasternak, asking his opinion of Mandelstam and criticizing his cowardly response, haunts Pasternak throughout his life. Kadare asserts, "The particular thing here was that both sides, the state and the writer, were equally deplorable." This exploration of the fraught relationship between a writer's role in a dictatorship and the phenomenon of gossip and curiosity that shapes the writer's image as 'one of the greats' is central

to Kadare's narrative.

The novel begins with a writer protagonist, much like Kadare, who

studied in Tirana and at the Gorky Institute in Moscow, contemplating those three minutes in Pasternak's life because "[they] belonged to the same family, that of writers. This meta approach reduces the distance between the novelist and the writer-protagonist. This is further tested when the protagonist writes a novel "about memory," described as perfect, finished, which meant both beautiful and at the same time dead."

The inclusion of Pasternak in the protagonist's novel brings tension. As Kadare writes, "Moscow ecame unavoidable from the day it became suitable for art, and our relationship through art made it impossible to avoid Pasternak." This tension between the writer and his editor about whether to self-censor or defy the odds to publish the book

is a compelling aspect of the story. Before resolving this question, Kadare deftly shifts focus back to

the infamous call between Stalin and Pasternak. The 13 versions of this conversation underscore the role of curiosity and gossip. Kadare writes, "Anybody who takes the plunge in search of the truth, who thinks at first that thirteen versions are too many, may be the end of the case think that these are insufficient!" This multiplicity of versions helps Kadare explore pressing questions about the art and politics an artist chooses to champion, illustrating the insufficiency of truth that only fiction can unravel.

Kadare's narrative prowess is evident in his ability to weave historical events with fictional introspection, making "A Dictator Calls" a deeply engaging read. The meticulous

conversation, drawn from various sources and interpretations, offers a multi-faceted view of the psychological turmoil experienced by individuals under authoritarian regimes. Each version of the conversation serves not only to highlight the oppressive nature of Stalin's rule but also to reveal the inner conflicts of Pasternak, a poet torn between his art and survival. This dual focus on the tyrant and the artist enriches the narrative, providing readers with a comprehensive understanding of the broader socio-political context Moreover, Kadare's exploration

detailing of the Stalin-Pasternak

extends beyond the historical to the philosophical, questioning the very nature of artistic integrity and courage. He poses a crucial question: can art ever be truly apolitical, or is it inevitably intertwined with the socio-political landscape in which it is created? Through the character of Pasternak, Kadare examines the moral dilemmas faced by artists who, in their pursuit of truth, must navigate the treacherous waters of political oppression.

Even with higher P/E multiple and P/B multiple, Indialisted subsidiaries of Pharma MNCs do not have significant valuation as compared to their parent pharmaceutical companies. For example, relative of AstraZeneca India Pharma Limited was just 0.72% of its parent company's market capitalisation (translated in Rupee terms). It is understandable as parent pharmaceutical companies typically own multiple subsidiaries across various industries and markets. Besides this, parent companies often have more significant financial resources, larger-scale operations, and better access to capital markets. ### No GST on ESOPs by MNCs to staff of Indian subsidiary

**NEW DELHI**: Employee Stock Options (ESOPs) given by foreign companies to employees of its Indian subsidiary at prevailing market value will not attract GST, the CBIC has said. However, ESOP/Employee Stock Purchase Plan (ESPP)/ Restricted Stock Unit (RSU) provided by a foreign company to its India subsidiary employee would come under GST net if an additional amount over and above the cost of securities/shares is charged by the foreign holding company from the domestic arm. This clarification forms part of the 16 circulars issued by the Central Board of Indirect Taxes and Customs (CBIC), following the meeting of the GST Council on June 22. Some Indian companies provide the option to their employees for allotment of securities/shares of their foreign holding company as part of the compensation package as per the terms of

#### **Bad loans declining** to 12-year low: RBI report



MUMBAI: The decline in bad assets of banks to a 12-year low of 2.8 per cent and strong GDP numbers will help in sustaining the growth momentum and withstanding global shocks, said the Reserve Bank's Financial Stability Report (FSR) released on Thursday.

The real gross domestic product (GDP) rose by 8.2 per cent in 2023-24 against 7 per cent in the preceding fiscal, despite muted private and government consumption and external demand conditions acting as a drag.

The FSR report showed that the gross non-performing assets (GNPA) ratio of scheduled commercial banks (SCBs) fell to 2.8 per cent and the net nonperforming assets (NNPA) ratio to 0.6 per cent at the end of March 2024. The GNPA ratio of all SCBs may improve to 2.5 per cent by March 2025, the report noted.

#### GST Council Recommends Biometric **Authentication to Combat Fraud**

move to tackle fraudulent tax claims, the Goods and Services Tax (GST) Council has recommended implementing biometric-based Aadhaar authentication for GST registrations across India.

The decision, announced by Finance Minister Nirmala Sitharaman following the 53rd GST Council meeting on June 22, 2024, aims to curb the misuse of input tax credit (ITC) claims through fake invoices.

The recommendation comes after successful pilot projects in Gujarat and Puducherry, along with a study conducted in Andhra Pradesh. The phased rollout is expected to begin soon, marking a crucial step in enhancing the integrity of the GST system.

Fraudulent ITC claims have been a persistent issue since the GST regime's inception. These scams typically involve the use of fake invoices to claim tax credits without actual supply of goods or services, leading to significant revenue losses for the exchequer.

The Central Board of Indirect Taxes and Customs (CBIC) has identified various methods employed by fraudsters, including direct misuse of invoices, diversion of goods, and circular transac- GST system.

### Centre Maintains Flow of Interest-Free Cash to States for Public Projects

**NEW DELHI:** The Central Government has sanctioned Rs 15,000 crore and released Rs 10,000 crore in untied interestfree capital expenditure (capex) loans to state governments in the current financial year, maintaining a pace similar to the previ-

This disbursement is part of the Rs 1.3 trillion capex support allocated for states in the interim budget for FY25. The initial tranche of Rs 55,000 crore in untied capex loans was made available from April 1. An additional Rs 75,000 crore in reform and project-linked loans

is expected to be rolled out after the new government presents its budget next month. In response to requests from state finance ministers during pre-budget consultations with Union Finance Minister Nirmala Sitharaman, the Centre is considering increasing the untied component of capex loans. This could potentially raise the total allocation to Rs 1.5 trillion for 2024-25, up from the Rs 1.3 trillion provided in the interim budget. If approved, the untied portion could increase to Rs 75,000 crore from the current Rs 55,000 crore.

### India's Current Account SIDBI Pushes for Surplus Hits USD 5.7 Billion in Q4 FY24, First in Ten Quarters

**NEW DELHI:** The Reserve rose to USD 5.4 billion from Bank of India (RBI) reported on Monday that India's current also witnessed an accretion of account balance recorded a foreign exchange reserves to surplus of USD 5.7 billion in the fourth quarter of fiscal year 2024, compared to a deficit of USD 1.3 billion in the same period last year.

For the entire fiscal year 2024, India's current account deficit moderated to USD 23.2 billion (0.7 per cent of GDP) from USD 67.0 billion (2 per cent of GDP) in FY23.

This improvement was at-

tributed to higher net invisibles receipts and a robust expansion in the services trade surplus. Net FDI inflow for FY24 was USD 9.8 billion compared with USD 28 billion in FY23, while portfolio investment recorded a net inflow of USD 44.1 billion against an outflow of USD 5.2 billion a year ago. Overof USD 63.7 billion to the foreign exchange reserves on a balance of payment basis in FY24.

Looking ahead, ICRA projects a slight rise in the current account deficit for FY25, estimating it to remain manageable at 1-1.2 per cent of GDP.

This forecast considers potential widening of the merchandise trade deficit due to domestic demand and higher commodity prices, with an assumed average price of the Indian basket of crude oil at USD 85 per barrel.

Despite this projected increase, the financial outlook appears stable, with expectations of significant foreign portfolio investment inflows in debt, particularly due to bond index inclusion starting from the end of June 2024.

Supermarkets will be required to deal with their suppliers in good faith and prevented from penalising those who complain after the review of the code found that suppliers fear retribution if they raise concerns about

The most severe breaches of the code will be punished with fines worth whichever is greatest out of three times the benefit derived from any misconduct, 10 million AUD (\$6.6 million) or 10 per cent of the chain's turnover in the preceding 12 months.

### Australian govt to penalise North Korea to hold key meeting after signing partnership treaty with Russia



**SEOUL**: North Korea is to hold a plenary meeting of the ruling Workers' Party of Korea (WPK) this week to review policy performances in the first half, amid attention over whether it would discuss follow-up measures to implement a new partnership

treaty signed with Russia. In May, the WPK's politburo decided to hold a plenary meeting of the party's Central Committee in late June to review progress in its economic and other projects in the first half without disclosing other details, such as the date of the meeting, reports Yonhap news agency. North Korea usually holds a party plenary meeting for a few days in June. However, the upcoming gathering draws more attention due to the possibility that it could discuss detailed measures to expand cooperation with Russia following its signing with Moscow of the treaty of compre-

hensive strategic partnership.

Jong-un and Russian President Vladimir Putin held a summit in Pyongyang on Wednesday and clinched the sweeping treaty that calls for providing military assistance without delay if either comes under attack. Article 4 of the 23-point treaty

could be seen as warranting automatic military intervention in the event of aggression on either country. That would amount to the restoration of a Cold Warera alliance for the first time in 28 years since a mutual defence treaty was scrapped in 1996.

The treaty also indicates North Korea and Russia could join hands in resisting international sanctions against Pyongyang's nuclear and missile programs. Article 16 of the treaty calls for both sides to oppose "unilateral coercive measures of an extraterritorial nature."

The new pact specifies science and technology, space, the peaceful use of nuclear power and artificial intelligence as among North Korean leader Kim

Whether North Korea would ratify the treaty at the WPK meeting will also garner attention. Under the North's constitution, an "important treaty" can be ratified or scrapped solely by its leader, Kim, though the Supreme People's Assembly (SPA), the North's parliament, approves ordinary treaties

After this week's party plenary meeting, North Korea is widely expected to hold a key session of the SPA in a bid to revise the constitution. The North's leader earlier called for revising the constitution to define South Korea as the North's "primary foe" and clarify its territorial boundaries, including the maritime border.

Experts said at this week's WPK meeting, Kim may issue a message critical of the United States and South Korea over the allies' joint military drills scheduled for August. Seoul and Washington plan to stage the annual Ulchi Freedom Shield (UFS) in August, which the North has long denounced as a rehearsal for a northern invasion. Separately, the USS Theodore Roosevelt, a US nuclear-powered aircraft carrier, arrived in the southeastern port city of Busan on Saturday in a show of force against North Korea's military

threats.



propagates the idea not only of oneness of mankind, but also of the unity of all beings. It emphasises oneness of the Atman with all life and of all existences with the Divine.

While describing the Supreme Brahman, it has been stated in shloka 13.17 that though appearing as divided among various beings, the Supreme is indivisible. He is the one who is supporting all beings, destroying them; and creating them afresh.

Thus it is evident that all beings arise from the Supreme, are supported by Him and at the time of dissolution are withdrawn into Him. All beings exist in the Supreme. No one stands apart from Him.

Though appearing as divided into multiplicity of beings, the Supreme remains an integral and undivided reality. He is the essence of all creatures. Unity of all beings is, thus, the truth and the apparent multiplicity is an expression of that eternal Oneness of the whole stream

of life has been re-iterated in shloka 13.31 wherein it is stated that when one sees different beings as rooted in the One (Supersoul); and everyone spreading out from that source Absolute (Brahman). In other words, when one understands that the Supersoul, Pramatman, is ever pres-

ent as individual soul, jivatman, in each and every being; he then realises that the diverse variety of living beings are situated in the Eternal One and are born from that source alone. After gaining such spiritual vision, one attains to the Brah-

man i.e. becomes identified

with the Absolute. He then



realises the true nature of the ultimate reality which is nothing else but eternal bliss.

Origin and dissolution of all beings has been analysed in shlokas 7.4 to 7.6. As described in these shlokas, the Supreme Lord, Ishvara has two types of natures namely the material nature (apara prakriti - the lower nature) and the conscious nature (para prakriti

- the higher nature). Everyone takes birth in these two natures. Ishvara is the origin as well as dissolution of whole of the world. Corresponding to the above mentioned prakritis of Ishvara, each individual has two aspects of life, namely the alone, he then attains to the mind-body complex and the soul. Both of these are derived from Him. Source and destination of everyone, thus, remains the same.

> Oneness of the whole stream of life has also been enunciated in shloka 5.18 wherein it is stated that a wise person sees all - a learned and humble brahmin, a cow, an elephant, a dog or an outcast - with an equal eye. In other words, the one en-

dowed with wisdom realises

manifestations of God. He understands that the eternal and unchanging reality behind everybody is the same. Hence, all differences of high and low or even of man and animal vanish. One regards everyone

The theme of oneness of the numerous forms of life has also been stressed in shloka 6.29 wherein it is stated that he whose self is disciplined in yoga (yog-yukt-atman), sees the self abiding in all beings and all beings existing in the self; everywhere he sees the same. To put it simply, when enlightened by yoga, one understands that the same Atman dwells in him and in everyone else. He also realises that everyone is situated in the same Atman. He establishes his oneness with all life.

Not only oneness of the whole flow of life, Krishna has also revealed the unity of all existences. In shloka 6.30, it has been stated that he who sees the Supreme Lord everywhere and sees everything in Him, he never loses sight of Him nor is he ever out of His sight. in all kinds of social and ecothat all beings are different This shloka emphasises on the nomic activities.

profound unity of everything in the all-pervading Ishvara. He remains established in the hearts of those who realise their oneness with Him.

Knowledge about the unity of all beings has been declared to be the true knowledge. It has been stated in shloka 18.20 that the knowledge by which all beings, though appearing divided in different forms, are seen as indivisible and imperishable reality, such knowledge is in the mode of goodness (sattvic gyana).

When freed from all-enveloping darkness of ignorance, one gets true light of knowledge. He understands that every jivatman, the individual soul, is an integral part of Pramatman, the Supersoul, in the same manner as every wave is an inalienable part of the sea. The sameness underlying the multiplicity of creation dawns upon him. He percieves the undivided in the divided and realises the supreme unity of all existences. He is then able to see the Supreme in all and all in the Supreme.

But to recognise the inherent oneness of all existences is not to deny the fact of empirical world, the world of our observance and experience. The physical world of myriad distinctions cannot be and need not be negated, for it is not an illusion. The multiplicity of creation is, in fact, an expression of the material nature (apara prakriti) of the Supreme. But at the same time, one must never forget that the ultimate reality of everyone is the same. The Supreme is present equally in all beings.

When one realises that all of us are sustained by the benevolence of God, he becomes more humane. Once such an attitude is developed, one is a sage, even though fully engaged
